1. Executive Director's Report

None given.

2. Assistant Director's Report

- Assistant Director Waxman reported that the Annual City Census mail went out to 55,397 households on March 11, 2024.
- The Assistant Director reported that School Committee member David Weinstein filed his campaign report. She further stated that notices had not yet been sent to those who have not filed.
- Commissioner Marquardt inquired whether the excise tax billing system's functionality could be replicated
 for the Annual City Census process. The Assistant Director explained that integrating such a system would be
 challenging, as the Voter Registration Information System (VRIS) currently does not interface with other
 platforms.

3. Commissioners' Reports

- Commissioner Marguardt confirmed that 22 Pearl Street is a valid address.
- Commissioner Ward confirmed that 725 Cambridge Street is not a valid address.
- Commissioner Harris reported that on March 11, she and Commissioner King attended the School
 Committee's Buildings and Grounds Subcommittee meeting to discuss holding elections at the schools. The

subcommittee expressed its commitment to collaborate with the Election Commission to accommodate voters in Cambridge on Election Day. Although schools will be opened on September 3, provisions will be made to facilitate voting.

• Commissioner Harris announced her intention to send an email to Mr. Gahant at CRLS concerning the student poll workers. She plans to discuss future initiatives and gather feedback from the student workers.

IV. Action Agenda

Old Business

March 5, 2024 Election Debrief

- Commissioner Marquardt reported that his workers commended the student workers for their excellent performance during the election. He also mentioned that his poll workers had inquired about the possibility of using Poll Pads in future elections. This suggestion was echoed by Commissioner Harris's team, highlighting a widespread interest in the adoption of this technology.
 - o The Assistant Director has agreed to investigate the feasibility of implementing Poll Pads.
- Commissioner Marquardt expressed his gratitude to the police; his team reported that the delivery of ballot scanners was timely on Election Day. He also proposed using the building at 689 Mass Ave as a staging area for election day operations for DPW and police.
- Commissioner Marquardt shared positive feedback from his workers regarding the hands-on tallying training.
- Assistant Director Waxman plans to send an email to the commissioners addressing specific mistakes made on election day. She highlighted an incident where some voters were not properly checked off on the checkin sheet.
- Commissioner Harris reported that she received numerous inquiries about the Ward committees and candidates on the ballot.
- Commissioner Harris relayed a request from one of her precincts for the office to provide highlighters so
 that they can mark the beginning of each street on the check-in list, which could improve the organization
 and ease of use.
- Commissioner Harris reported that she will conduct some research on how other municipalities manage their poll worker applications process. Her goal is to see the feasibility of creating a portal where poll workers can apply to work, complete paperwork and received important message/updates.
- Commissioner Harris noted that Commissioner Ward was appointed to a four-year term on March 18, 2024.
