III. Reports

1. Executive Director's Report

Ms. Ford reported the date of the move will be in June.

Commissioner Ward asked who's doing the move. Ms. Ford responded and outside company. She also stated we will outgrow this space quickly.

Commissioner Marquardt asked if there will be any basement space available? Ms. Ford is exploring the possibility.

Commissioner King asked if the AutoMarks will be stored in the office. Ms. Ford said yes. In addition, with the unvoted ballots, tabulators, poll pads, and tables as well. There will be an outside seating office. She also stated we will use the dock to load up on election day.

Commissioner Ward asked if there was parking and the answer is no.

Assistant Director's Report

Ms. Waxman reported receiving the Campaign Finance Report for Ruth Ryan Allen.

Commissioners' Reports

Commissioner Marquardt reported that apparently the City Council of New Bedford voted against both the Secretary of the Commonwealth and the New Bedford Election Commission that had asked to move their primary election from the first Tuesday in October to the second Tuesday in September to grant them time to do proper mail-in balloting. They voted to keep it in October. Therefore, there is four weeks between the primary and the general election.

Commissioner Stohlman commented on an article focused on laws being considered by the federal legislature that might impact our budget. He asked if this would be talked about in the budget hearing

and Ms. Ford responded no. Stating the budget that was approved by the City Manager is what will be discussed.

Commissioner Marquardt noted that similar things have come up in the past and Ms. Ford has been good at handling those issues. Ms. Ford noted that she has received permission from the City Manager to put additional monies in the budget for ballot questions.

Commissioner Stohlman expressed concern that if law passed it would affect the Commission's budget. Commissioner Marquardt suggested holding off on discussion due to the political spectrum level opposing the law.

Commission King reported that he talked with Vallerie Bond and he will be attending the next meeting of the Cambridgeport group to talk about the election commission and voter turnout.

Ms. Ford asked if the Board is going to conduct in-person training, if so, she needs to find available space and if the Board is going to do recruitment. Commissioners all stated yes. Ms. Ford stated we must pick dates at the next meeting.
