# BOARD OF ELECTION COMMISSIONERS MEETING Minutes of August 4, 2025

The meeting was called to order at 3:04 pm August 4, 2025, in person in the second-floor conference room at 689 Massachusetts Avenue, Present were Commissioner King, Commissioner Marquardt, Commissioner Ward, Commissioner Stohlman, and Assistant Director Lesley Waxman.

#### I. PUBLIC COMMENT

Louise Venden, 10 Rogers St. provided comments regarding difficulty correctly filling out the nomination papers for City Council. She indicated that she had twice submitted the required number of signatures only to have them rejected because the forms were not filled out correctly by the candidate. She mentioned that she did not find this inclusive. She also mentioned that she was not the only candidate or potential candidate to experience these issues. She informed the Commission that she intends to run for City Council as a write-in candidate.

Commissioner Stohlman commented that the requirements for the current nomination papers are spelled out in the City's Charter. He explained that the proposed Charter under review by the Legislature would provide more freedom for the Election Commission to make changes to the form of nomination papers used in City elections.

Melanie Gause, a candidate for School Committee, indicated that she also had issues with her nomination papers for City Council and would also be running a write-in campaign for City Council.

Gary Mello indicated that he wanted to go on the record regarding Ms. Ford and issues he has raised with regard to the Republican nomination process and that their Chair is also a commissioner. Commissioner Marquardt asked Mr. Mello if he would like to submit written comments for the record. Mr. Mello replied that his written notes were largely illegible as well as when he has submitted materials in the past they were not included in the minutes. Commissioner Marquardt commented that the offer stands to submit written comment should he so desire.
