BOARD OF ELECTION COMMISSIONERS MEETING

THE COUNT

Minutes of November 5th to 7th, 2025

The meeting was called to order at 9:05 am on November 5, 2025, at the Citywide Senior Center
Present were Commissioner King, Commissioner Marquardt, Commissioner Ward, Commissioner Stohlman, Executive Director Ford, and Assistant Director Waxman.

I. Action Agenda

The meeting was called to review and process Auxiliary, Write-in and Election Day mail in ballots received. Ballots were removed from the Ballot Boxes by Ward and Precinct and prepared for review by the Commissioners.

For all ballots where voter intent could be determined by the Commissioners, the Commissioners voted to mark voter intent on a Hand Count Tabulation Form. All votes were moved by Commissioner Ward and seconded by commissioner Marquardt and were unanimous (4-0) except for one ballot in 10-2 #3 that was voted to count by a 3-1 vote.

The Commissioners then voted to handle write-in votes for Louise Venden who had run a write-in campaign. The Commissioners voted 4-0 to make Louise Venden Write-In #1 on all hand count tabulation forms

Prior to releasing the results on Friday, November 7, 2025 Executive Director Ford disclosed certain issues with the Preliminary Unofficial Results that were released election night. Certain ballots from the Test Deck were inadvertently included in the calculated Preliminary Unofficial Results. The ballots in question were identified and removed that resulted in a change to the released results.

The Commissioners discussed the issue and Ms. Ford informed them that a full review and report of what happened would be provided.


