#### **Collection Description**:

Family photographs as well as photographs of both the interior and exterior of Mellen family homes in Cambridge. Also included are documents related to one of the homes. Many of the photographs have been attributed to Edwin D. Mellen. Listed below are the addresses and sites that have been documented in the collection. Some images are from unknown locations.

The Mellens were a very prominent family in Cambridge, and their soap business, Curtis Davis & Co., became the American branch of Lever Brothers, the largest soap manufacturer in the world at the time.

# **Historical Note:**

The Mellen family has been a presence in Massachusetts since 1639. The family has been associated with the city of Cambridge since 1845, when building moving and contractor James Mellen (1815-), his wife Sarah Ann (Hilton) Mellen and their young son James, Jr. moved to Cambridge from Charlestown, Massachusetts. Sarah and James had married in 1837 after the death of her first husband and James' brother, David Mellen Jr. (1804-1836), died. James Jr. (1838-1896) worked for his father for a time and then went to work for Curtis Davis & Co. Soap Manufacturers, the maker of the Welcome, Unequal Extra, and White Crest soaps. The business was started by Curtis Davis (1814-1887) who worked for his brother, Eliphalet Davis, also in the soap industry. In 1835 Curtis Davis became partners with Alexander Dickerson. This partnership was later dissolved in 1851. Curtis Davis was also active in Cambridge's municipal government, serving on the board of alderman and the city council.

In 1860 James Mellen Jr. married Curtis Davis' eldest daughter, Christine Van Ness Davis, and in 1864 he became a partner in his father-in-law's firm. He was tasked with managing the Boston office at 21 Merchants Row. The company grew and became one of the largest soap manufacturing institutions in New England, with a satellite facility in Reading, Mass.

Upon Curtis Davis' death in 1887, James Mellen Jr. inherited the business. He and his wife owned a house at 33 Washington Street, Cambridge, and a summer house on Boston's North

Shore. They had six children: Edwin Davis, Mary Lizzie, Louisa Maria, Martha Davis, Sarah Agnes, and Nettie Christina, who died prior to her first birthday. Their eldest, Edwin Davis Mellen, was born on November 23, 1861 and attended Chauncy Hall school in Boston. He graduated from the Massachusetts Institute of Technology in 1884 with a degree in chemical engineering. In 1882, Edwin began working for the Curtis Davis & Co. as a chemist and superintendent. He was admitted as a partner upon the death of his maternal grandfather, Curtis Davis.

Edwin married Adele Adams of 11 Shepard Street in 1883 and they had four children, Lucile Christina, Edward James, Richard Adams, and Adele Louise. They moved from 9 Forest Street to 1590 Massachusetts Avenue in Cambridge, a residence known for its technological innovations. For further information on the house's details, see the "An Electric Clock in Every Room" newspaper article, cited below. In 1896 Edwin became sole manager and treasurer of the company after the death of his father. A year later he became associated with Boston businessman Stillman F. Kelley, who became the company's president, and W.H. Lever. W.H. Lever was the owner of Lever Brothers, Limited, an English soap company that manufactured Sunlight brand soap. Edwin died in July 1918 from health issues.

#### **Scope and Content:**

The collection is intellectually organized into two main series - Original Photographs and Documents and Copy Records, although the physical arrangement does not necessarily reflect this structure. The collection is largely comprised of photographs of the Mellen family and their residential homes and neighborhoods. The collection also contains a record of specifications for E. D. Mellen's residence, Greycroft.

Some of the original images are only available as negatives and copy prints have been retained as surrogate records.

Along with these copies, there are photocopied images of available photographs that have a corresponding reference document which contains pertinent information provided by the donor.

<u>A note on one of the houses</u>: Some of the photographs of 305-307 Broadway have been mislabeled as 293-295 Broadway. The inventory list honors the original information but also distinguishes the correct address of the house.

<u>A note on the inventory:</u> Some of the information in the inventory is not reflected on the actual records. This information was extrapolated from duplicate copy prints.
