Granting the Special Permit requested for <u>2447 Massachusetts Ave</u>, <u>Cambridge</u>, <u>MA</u> (location) would not be a detriment to the public interest because:

A) Requirements of the Ordinance can or will be met for the following reasons:

The existing restaurant, Season to Taste, is located at 2447 Massachusetts Avenue and patrons from the area generally arrive on foot rather than in cars, or by public transportation, or car ride services. Much of the restaurant's clientele are from the surrounding neighborhood and the area generates a lot of foot traffic in general reducing or eliminating the need for parking. Increasing the seating to 49 seats will not create traffic congestion.

B) Traffic generated or patterns of access or egress would not cause congestion hazard, or substantial change in established neighborhood character for the following reasons:

The restaurant is in an established commercial zone with existing parking lots in the area and metered parking available. Further, as stated above the patrons will arrive by foot, public transportation, or car service. Increasing the seating will not create additional traffic issues or congestion.

The continued operation of or the development of adjacent uses as permitted in the Zoning

Ordinance would not be adversely affected by the nature of the proposed use for the following reasons:

For the same reasons as stated above, adjacent uses will not be negatively impacted.

Nuisance or hazard would not be created to the detriment of the health, safety, and/or welfare of the occupant of the proposed use or the citizens of the City for the following reasons:

For the same reasons as stated above, the parking relief will not cause health, safety or welfare issues to the occupant or the citizens of Cambridge.

For other reasons, the proposed use would not impair the integrity of the district or adjoining district or otherwise derogate from the intent or purpose of this ordinance for the following reasons:

For the same reasons as stated above, the parking relief will not impair the integrity of the district or adjoining districts or otherwise derogate the intent of the ordinance.
