This meeting was held remotely in accordance with Chapter 107 of the Acts of 2022 signed into law on July 16, 2022.

Decisions: All decisions were 3-0, unless otherwise indicated, and were by roll call.

Public Testimony Matters

1. Application #204656 The Village In Harvard Square, LLC d/b/a Joe's Pizza, 8 Brattle Street, has applied for a new Common Victualler License with seating for 30 inside, and inside occupancy of 60, and 16 patio seats on the public sidewalk with proposed hours of 10:00 a.m. to 3:00 a.m. all days. Anthony Cosentino as manager of a premises described as: Restaurant located on ground floor with kitchen, dining room, one entrance and one exit.

Present: Attorney James Rafferty; Ian Lafkowitz; and Anthony Cosentino.

Documents Considered: Application and documents attached thereto.

Summary: This location used to be Mimi's corner for a generation, a popular news stand at Harvard Square. It then became &Pizza, which also had bakery. &Pizza has left the location. The proposed licensee is a concept from New York which started in 1975 in Greenwich Village. They have a reputation for being open for kids and residents of the Village when no one else would. Their original concept and their success comes from being open during all of its operating hours, 7 days of the week, when there is a snowstorm or blackout. They know the students keep crazy hours and they want to provide accessibility for students and others. There is an intent to bring back late night food operations and vitality to Harvard Square.

Decision: Granted.

2. Application #205139 Museum of Science, 1 Science Park, Common Victualler All Alcohol License #11392 for a Change of Officers/Directors and Change of Manager to William Doane Jr.

Present: William Doane Jr.

Documents Considered: Application and documents attached thereto.

Summary: William Doane has experience in the food and beverage industry. Has not been the manager of record on an annual liquor license before but has been on various one day licenses while

working at Boston Children's Museum. Doane had no disciplinary issues with the local board while operating the one day licenses. Doane is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Has received ServeSafe training in the safe service, sale and delivery of alcohol, and will provide proof of it after the hearing. Doane provided supplemental information as to their CORI and may need to either provide it in affidavit form to comply with the ABCC requirement (or get the current documentation notarized).

Decision: Granted.

3. Application #205404 President & Fellows of Harvard College d/b/a Cambridge Queen's Head Pub, 45 Quincy Street, Educational All Alcohol License #11622 for a Change of Manager to Smitha Haneef.

Present: Smitha Haneef.

Documents Considered: Application and documents attached thereto.

Summary: Smitha Haneef has experience in the food and beverage industry. Has not been the manager of record on a liquor license below but in previous role managed a club license and had oversight of the manager of record. Haneef is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Haneef provided TIPS as proof of training in the safe service, sale and delivery of alcohol. Haneef intends to be the manager of record of Queen's Head and The Pub and will split time between both locations. Both locations will have other managers on duty on a daily basis.

Decision: Granted, pending submission of name, email and phone number of person in charge when manager of record is not present.

4. Application #205405 President & Fellows of Harvard College d/b/a The Pub, 1585 Massachusetts Avenue, Educational Malt & Wine License #11450 for a Change of Manager to Smitha Haneef.

Present: Smitha Haneef.

Documents Considered: Application and documents attached thereto.

Summary: Incorporated by reference and made a part hereof the testimony provided in the previous matter.

Decision: Granted, pending submission of name, email and phone number of person in charge when manager of record is not present.

5. Application #201289 HRB MA Holdings, LLC d/b/a Hyatt Regency Cambridge, 575 Memorial Drive, All Alcohol Innholder, has applied for an Alteration of Premises to: 15 Floors and basement, 479 sleeping rooms, 1 restaurant w/ cocktail area and terrace on 2nd floor, terrace on 3rd floor, 1 banquet room on 14th floor, 1 banquet room on 16th floor, 7 meeting rooms on 1st floor, 3 meeting rooms on 2nd floor.

Present: Melissa Green.

Documents Considered: Application and documents attached thereto.

Summary: This is as a result of a partial renovation that resulted in creating more rooms and decreasing meeting room space. The location previously had 470 rooms, a total of 505 beds for a maximum occupancy of 705. Now they are increasing to 479 rooms, 512 beds, and 768 occupants.

Decision: Granted.

6. Disciplinary Curlocom, LLC d/b/a Plough and Stars, 912 Massachusetts Avenue, Common Victualler All Alcohol License #11685, for allegedly permitting disorder, disturbance, or illegality on a licensed premise, to wit, Overcapacity on November 19, 2022 in violation of M.G. L. c. 138, §§ 23 and 64 and Rules and Regulations of the City of Cambridge Board of License Commissioners 2.3, 2.5, 5.1, and 9.

Present: Investigator Tyler Bubenik; Gabriel O'Malley and Michael O'Leary.

Documents Considered: Hearing notice and any documents attached thereto; and file.

Summary: At approximately midnight on the morning of November 19, 2022, Bubenik observed 80 occupants inside the premises, which has a maximum licensed capacity of 60. After alerting the doorman of the situation, the door was held while the capacity was gradually reduced over a period of approximately 30 minutes until compliance was achieved. The egresses were not blocked.

O'Malley acknowledged operating over capacity and stressed they take the issue very seriously and are concerned by what happened. The doorman on duty has been there for many years and is usually conscientious and focused. This was an honest mistake due to various factors including the Harvard Yale football game. That type of game leads to business but also an uptick of people coming in and out and more frequently than their usual crowd. The customers go in and out more and pop out for a smoke and managing the door is more challenging because it is a faster pace. That night they also had a band playing with more musicians than usual (9), which were not counted towards the capacity. The doorman took a short bathroom break and no one covered the door during that time, and approximately about 9-10 people came in during that period. Clearly should have made provisions and making sure that someone was manning the door. They take this very seriously and so does the landlord. They have communicated with the staff who also take it very seriously. O'Malley stressed the last time they were found in violation was about 7 years ago, and they were given a warning. O'Malley requested leniency.

It was noted for the record that Plough and Stars has been operating for a significant number of years and Cambridge Police and Cambridge Fire have never had any issues with Plough and Stars. It was also noted that in 2018 they applied and received an increase in licensed capacity to 96 which was later reduced back to 60 due to plumbing fixtures.

Decision: Violation, warning.

7. Disciplinary Casella Waste Services, holder of Solid Waste Hauler License #14070, for alleged violations of CMC 8.16.080(e) – Loading and Unloading, December 23, 2022 at approximately 6:30 a.m., and December 31, 2022 at approximately 8:00 a.m., both in the vicinity of 2235 Massachusetts Avenue.

Documents Considered: Hearing notice and any documents attached thereto; file; and waiver of hearing.

Summary: John Tognazzi, operations manager for Casella, submitted a waiver of hearing on January 23, admitting to the violations as noticed and read into the record. Board accepted the admission of guilt.

Decision: Violation on two counts, \$300 fine per violation for a total fine of \$600.

8. Disciplinary Republic Services, holder of Solid Waste Hauler License #14078, for alleged violations of CMC 8.16.080(e) – Loading and unloading, on November 17, 2022 at approximately 5:50 a.m.; November 30, 2022, at approximately 6:00 a.m.; December 6, 2022 at approximately 4:05 a.m.; and December 30, 2022, at approximately 5:45 a.m., all in the vicinity of 1575 Cambridge Street; and on January 11, 2023 at approximately 5:45 a.m. in the vicinity of 9-11 Chester Street.

Present: Investigator Tyler Bubenik. No one appeared for Republic Services.

Documents Considered: Hearing notice and any documents attached thereto; and file.

Summary: Notice of hearing sent, confirmation on file. A resident of Leonard Avenue submitted multiple reports that Republic Services collected waste outside of the allowable hours at 1575 Cambridge Street on multiple dates. Also, a resident of Chester Street reported that a Republic truck collected waste at 9 Chester Street on January 11, 2023, at approximately 5:45 a.m. There was media attached to the complaints showing the violations. Republic has a significant disciplinary history, including at these locations.

Decision: Violation (5 counts), \$300 fine per violation for a total fine of \$1,500. Issued \$100 hearing fee for failure to appear. A notification as to the violations will also be sent to the property owners and/or management companies of the locations where the violations occurred.

9. SNV Application #207651 Benjamin McConchie on behalf of Erland Construction for 1/21/23 – 4/15/23 (no alternate date specified), at 101 Smith Place, from 7:00 a.m. to 9:00 a.m. on Saturdays, as-needed, for steel erection and detailing using cranes and welding equipment. The variance

is sought to maximize daylight hours and favorable weather conditions in the interest of public and worker safety.

Present: Investigator Tyler Bubenik; and Jack Tommey and Benjamin McConchie.

Documents Considered: Application and documents attached thereto.

Summary: This is being requested for worker employee safety. The work requires the iron workers to walk on beams. This becomes exponentially more dangerous after daylight hours. Starting at 9:00 a.m., would take the 8 hour shift to 5:00 p.m. but the daylight is gone between 3:30 and 4:00 p.m. The crane is on site at all hours and it will be running at 7:00 a.m. There will be no deliveries made until after 9:00 a.m. They have previously applied and been granted variances at this location with no complaints from abutters.

Decision: Granted with the condition that no deliveries can be made prior to 9:00 a.m.

Administrative Matters

Unless otherwise indicated, all the below listed matters were considered and voted upon by the Board without public testimony. They were decided upon by the Board members' individual review of the papers/applications/matter before them. The summary of what is considered by the is the identifying information of the matter as listed herein.

10. Application #207353 President and Fellows of Harvard College d/b/a Harvard University / Adams House - Randolph Hall, 53 Bow Street, Innholder/Lodging House License #44905, has renovated the premises and applied to update the room and occupancy from 119 rooms and 168 occupants to 144 rooms and 159 bed and occupants.

Decision: Granted.

11. **Correction of Board Vote** [Disciplinary Matter Heard 9/14/22] Landscaping for alleged violations of CMC 8.16.081.1(b) and 8.16.081.2(c) – operating a leaf blower without a permit (failure to adhere to cease and desist letter sent July 21, 2022), and CMC 8.16.081.2(a) - Operating a blower during a prohibited period, at approximately 1:30 p.m. on August 23, 2022, 50 Follen Street. Board found a violation on all counts, upon receiving subsequent documentation, the company does not meet the criteria of a commercial leaf blower operator. The matter is on to vacate the finding of a violation of CMC 8.16.081.1(b) and 8.16.081.2(c).

Summary: When this matter was heard, no representative for God's Miracle Landscaping appeared. Since the matter was properly noticed, the hearing proceeded. After the hearing and notice of the Board's vote went out, the Board received an application from God's Miracle for a leaf blower permit. God's Miracle do not have more than 1 employee. Per our Ordinance, a permit is only required when there are 2 or more employees. Therefore, God's Miracle is not required to obtain a permit prior to operating leaf blowers, although they must comply with all other provisions of the Ordinance.

Decision: Vacated finding of a violation of CMC 8.16.081.1(b) and 8.16.081.2(c) and removed fine issued for that violation; affirmed all other findings and fines as previously issued. The statement of reasons shall reflect the change/clarification in vote.

12. Correction of Board Vote [Disciplinary Matter Heard on 9/29/22] S & J Landscape and General Services, Leaf Blower Permit #155154, for alleged violations of CMC 8.16.081.2(a) — operating leaf blowers during a prohibited period, and 8.16.081.2(e) — using blower which exceeds allowed noise emissions, on August 30, 2022, at approximately 1:00 p.m., at 568 Green Street. Board found a violation on the matter as presented. However, when it voted, it only counted one count. The Board found violations of two counts, and thus, it is on to consider whether it will issue fines on both counts.

Summary: When the Board voted on this matter, there was no testimony disputing the violations as noticed. The Board accepted all testimony as facts and voted for a violation. It was missed that there were two counts of violations – operating during a prohibited and operating a leaf blower with sound emissions beyond what is allowed per the Ordinance.

Decision: Reaffirmed finding of violation on two counts, amended fine issued to \$300 per violation for a total fine of \$600; affirmed all other findings and fines as issued. The statement of reasons shall reflect the change/clarification in vote.
