## **BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES**

Friday, December 1, 2023, 10:00 a.m. By Remote Participation via Zoom

This meeting is being held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Board Members (All Present): Nicole Murati Ferrer, Christine A. Elow, and Thomas Cahill, Jr.

Staff Member Present: Chris O'Neil.

**Decisions:** All decisions were 3-0, unless otherwise indicated, and by roll call.

1. [Matter was added to the agenda at the hearing; this was an application that had been continued on 11/14/23 to the 12/1/23 meeting, but was inadvertently left out of the posted agenda.]

**Application #245333** AUM Management Corp. d/b/a City Market, 1695 Massachusetts Avenue, to transfer the Wine and Malt Package Store License currently held by KA & SI Enterprises, Inc. d/b/a City Market #74916, to it at the same address. Mahin Jawwad as Proposed Manager of Record of a premises described as: Two floors, 1,250 square feet with one room on each floor. Two entrances and two exits.

**Present:** Attorney Matthew Porter; and Mahin Jawwad.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Testimony of November 14, 2023 was incorporated by reference and made a part hereof. Mahin Jawwad has experience in the food and beverage industry as a cashier and has never been the manager of record on a license before. Jawwad is familiar with the rules and regulations of the Board, ABCC, and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol and is TIPS certified.

**Decision:** Granted with the condition that during the hours when the store is open but alcohol sales cannot be made by law, the aisles containing alcohol must be secured and made inaccessible by locked gates and the coolers containing alcohol must be locked. [Need TIPS certificate]

The proposed premises would be: Restaurant on first floor of building consisting of approx. 1,670 sq. ft. with dining room, kitchen, storage, and two bathrooms. One means of ingress and two means of egress.

**Summary:** This is to remove the outdoor area on the public way. Licensee explained the operation got "too big" with the indoor and outdoor area. They did not have enough servers to cover all the spaces. Hence, they would rather shrink to take care of restaurant and its patrons.

**Summary:** This is work that they would normally during allowable hours, but to accommodate the surrounding businesses they are asking to do it after hours (that way the businesses do not have their water shut off during their regular business hours). Specifically, the request came from the abutting science building which remains operational until 11:00 p.m. The Board note other abutting buildings were the Police Headquarters and a Charter School.

**Summary:** This is to run the heating equipment for two buildings on 36-64 Whittemore Ave. The equipment will maintain temperature inside the building to ensure integrity of the work being performed and provide freeze protection. The units may run constantly or sporadically, as it is all contingent upon the weather. It would be for what is known as buildings 2 & 3. Building 2 will have 4 heaters and it is the closest to the public way. Per the manufacturer, the decibel level of each does not reach 60 dBA at the lot line. Building 3 will only have 1 heater. It is approximately 160 feet away and on private side. This is a larger unit and is louder, measuring at 70 dBA. The larger unit is needed as it is a larger area. They tried to find the option that would use as little fuel and resources as possible.

**Decision:** Granted.
