## BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA

Thursday, December 14, 2023, 10:30 a.m.

*This meeting is being held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.*

**Decisions:** All decisions were 2-0, unless otherwise indicated, and by roll call.

### Public Testimony Matters

**1. Consideration of Renewal** Shanti Boston, LLC d/b/a Shanti, 7 Broad Canal Way, Malt and Wine Common Victualler License #11557, to consider whether to reject the renewal application, or in the alternative to cancel the license, based on the information that the business is closed, is a no value, non-transferrable license, business does not have authority to occupy the premises, and there is another business seeking to operate at the premises, G. L. c. 138 §§ 16A, 23, 64 and 77, and G. L. c. 140.

**Present:** No one appeared on behalf of Shanti Boston, LLC.

**Documents Considered:** Hearing notice and any documents attached thereto; and file.

**Summary:** [Matter was given a second call at 10:54 a.m.] This is a no value, non-transferrable license. During renewals Solmon Chowdhury represented they had been closed but wanted to move the license to a different location in Cambridge. They represented the holder would still be Shanti Boston, LLC and Chowdhury as the sole member (as is now the case). In the meantime, we have received an application for a new business at the location. The new applicant has applied for a common victualler license only right now but wanted to apply for alcohol (due to deadlines and the existing license and to start operating since their lease is already active), they decided to move forward with the CV only. There is no quota for § 12 licenses at this time. There is no prejudice to Shanti Boston to not approve this renewal and/or in the alternative to cancel the license.

**Decision:** Renewal rejected, fee paid will be reimbursed, and/or license cancelled for non-use.

**2. Consideration of Renewal** 286 Franklin Street, Inc. d/b/a Andala Coffee House, 286 Franklin Street, Common Victualler License #12351, to consider whether to reject the renewal application and/or suspend or cancel the license for operating without a Certificate of Inspection and failure to obtain one, G. L. c. 140, and the Board's Rules.

**Present:** Sami Herbawi; and Branden Vigneault, ISD.

**Documents Considered:** Hearing notice; file; and Inspectional Services Department report.

**Summary:** [Second call given at 10:57 a.m.] Certificate of Inspection #156343 has been pending since 5/7/23 – fee has not even been paid even though became active in 7/23. CI has not issued because there was work done to the hood, installation of new, bigger fan, and that has not been inspected by electrical inspector and mechanical permit has not been applied for or approved. The matter has been pending since 2022. The inspection for the CI also showed there were other issues with the site such as blocking egresses. The installation of a bigger fan also necessitates a Fire suppression permit from the Fire Department – the Fire Prevention Unit. This is a life safety issue.

**Decision:** Indefinitely suspend the license and not approve the renewal until such time as all pending matters are resolved, all permits filed and approved, the premises reinspected, and the CI issued.

**2. Consideration of Renewal** Checkraise, LLC d/b/a Lord Hobo, 92 Hampshire Street, Common Victualler All Alcohol License #11365, to consider whether to reject the renewal application for failure to provide payment (or substitute payment) of the renewal fee within the statutorily and/or Board's required timeline, G. L. c. 138, §§ 16A, 23, 64 and G. L. c. 140.

**Decision:** No vote, matter taken off agenda (substitute payment received).

**3. Application #250689** Max Gouveia, Milano Construction, for a Special Noise Variance on 12/17/23 – 12/22/23 (Alt. 12/18/23 – 12/22/23) at 30 JFK Street, from 8:00 p.m. to 5:00 a.m. the following morning, beginning for the week on Monday night and ending on Friday morning, to install a fire protection line using an excavator, jackhammer, dump truck, and air compressor. The variance is sought in the interest of minimizing impacts to water service, as well as vehicular traffic.

**Present:** Max Gouveia, Project Manager, Milano Construction Corp.; Billy Cooke, Site Supervisor, Milano Construction Corp.; Chris McGue, Subcontractor, McGue Excavation; Tim Mansfield – Architect, CambridgeSeven; David Blumsack – Owner/Representative; and Investigator Tyler Bubenik.

**Documents Considered:** Application and any documents attached thereto.

**Summary:** McGue excavating to install a new fire protection line about 5 foot deep trench and into the building to install a new sprinkler line. Matter was discussed with DPW and it was agreed the work should be done at night to minimize traffic disruption and ,making sure no one walked over the trench. The work will take a maximum of 5 nights, but they will probably will be done in 4 (it is all weather dependent). The shoring is done during the day.

**Decision:** Granted.

**4. Application #251293** Elise Martignetti, Eversource, for a Special Noise Variance on 12/14/23 – 12/29/23, at 176 Alewife Brook Parkway from 9:00 p.m. until 5:00 a.m. the following morning, beginning for the week on Monday nights and ending on Friday mornings, to install a gas main using

excavation equipment, jackhammers, saws, backhoes, and dump trucks. The variance is sought as the Massachusetts DCR is directing the work to take place during overnight hours.

**Present:** Investigator Tyler Bubenik. [No one appeared on behalf of the applicant]

**Documents Considered:** Application and any documents attached thereto; history of site; and previous testimony received.

**Summary:** Investigator Bubenik informed the Board that upon follow up with applicant, AJ Ortiz, project manager, informed they were unaware of the application. There was no further information received and no one appeared on behalf of the applicant.

The Board discussed this would constitute the fifth extension of a project to install a gas main on Alewife Brook Parkway. Sean Grant of Mass DCR has indicated that while it is technically possible to perform the work during daytime hours, the State prefers that it occurs overnight. There have been significant noise complaints received as to this site. We have granted the variances in the past with conditions of no use on legal holidays or eve of legal holidays. We have a significant number of residents in the area, families included. The timeline sought encompasses various religious holidays it also has school vacation week. The residents need and are entitled to some peace and quiet and even though there is work being done during the day.

**Decision:** Denied.

**Decision:** Granted.

The event is advertised on social media and there is a charge to attend, it is open to the public and therefore a one-day alcohol license is needed. Applicant was also asked whether there would be sale or consumption of cannabis and they represented there is never any sale of cannabis and that there would be no consumption of cannabis at the event. Applicant was advised the one-day alcohol license was needed, and so they submitted the #252015 to cover all aspects. There is also a change to the expected attendance to 250, which is within the allowable capacity for the space. At this time we are still waiting for the applicant to provide proof of Diaspora Exp Corp’s non-profit status. Otherwise, the license can only issue for malt and wine.


