License Commission general hearing

Massachusetts Avenue, basement conference room.

Before you are the Commissioners: Acting Chair Arthur Goldberg, Police Commissioner Robert Hass and Fire Chief Gerald Reardon.

APPLICATION: PRESIDENT AND FELLOWS OF HARVARD COLLEGE

EXECUTIVE DIRECTOR ELIZABETH LINT: And first matter is the application: President and Fellows of Harvard College, holder of an open air parking lot license at 41 Holyoke Street for 19 parking spaces, has applied for an increase of 18 parking spaces for a total of 37.

ACTING CHAIR ARTHUR GOLDBERG: Good evening. Could you please identify yourself for the stenographer?

ERIKA JOHNSON: My name is Erika Johnson, E-R-I-K-A, J-O-H-N-S-O-N.

JOHN NOLAN: John Nolan, N-O-L-A-N.

ACTING CHAIR ARTHUR GOLDBERG: Okay.

Could you please tell us why you're here?

ERIKA JOHNSON: Sure. We're in the process of consolidating some of the parking lots we have on campus and some of the spaces we have

that are in the process of being demolished because of construction on campus.

We intend to build out an additional number of spaces at the -- what we call the MAC 5 parking lot. And so, we're before you today looking to amend our existing license to add an additional 18 spaces.

EXECUTIVE DIRECTOR ELIZABETH LINT: I thought it was 19.

ACTING CHAIR ARTHUR GOLDBERG: It says --

ERIKA JOHNSON: We have 19 spaces currently. We're looking to add 18 spaces for a total of 37.

ACTING CHAIR ARTHUR GOLDBERG: These are all outdoor spaces? This is not a parking garage?

JOHN NOLAN: Right.

ACTING CHAIR ARTHUR GOLDBERG: And I'm told you have an allowance of parking spaces by

Traffic and Parking rules. And this number, since you're -- some are increasing in some areas. So you're still within that total limit even with this increase?

ERIKA JOHNSON: Yes. There will be no net gain of parking spaces on campus.

ACTING CHAIR ARTHUR GOLDBERG: Will there be any construction involved at all with this?

JOHN NOLAN: Yes, there will be. So we'll be pushing out into the quad in terms of accomplishing in this. I can show you some drawings, if you would like.

ACTING CHAIR ARTHUR GOLDBERG: Sure.

JOHN NOLAN: Basically, we will be taking -- pushing out into the quad about 21, 23 feet, we'll basically be lowering the grade a little bit.

And we'll also be installing a water retention system relative to the City of

Cambridge's requirements for water retention.

Our plan long-term, too, is to improve the condition of that quad. It gets a lot of water, and it poorly drains right now. And so, it ends up being, in many cases, a mud bowl.

It will be a little bit of time before we do that because the university is planning to renew Winthrop House next year, beginning next summer. So it wouldn't make any sense for us to start that improvement until that construction is done.

However, we also plan on improving the sidewalk conditions there. And in the back of the MAC is the additional space for a sidewalk and on the other side will be a better handicap accessible pathway.

In addition, we have to take down some trees because they're not in great shape anyway. We'll be adding 8- to 9-inch caliber trees, a

substantial cost to that.

The area now that we're going to be going into the MAC is kind've a real slope and really isn't very usable from the student's perspective.

We'll also be adding some additional bike parking. Adding and improving the lighting in that area with LED lighting, similar to the way it is on the other side of the MAC.

So we really think it's a really nice improvement.

ACTING CHAIR ARTHUR GOLDBERG: Questions?

POLICE COMMISSIONER ROBERT HAAS: No questions.

ACTING CHAIR ARTHUR GOLDBERG: Is anyone here for the Medes?

So no one is here for No. 3, 645

Cambridge Street, and I think we can either deny this or just continue it, but we didn't get a request for a continuance, I don't think.

EXECUTIVE DIRECTOR ELIZABETH LINT: We

did not.

And this particular location had an application in the last hearing by Pronto Cafe, which was approved by the Board, and there was a letter of intent from the landlord.

ACTING CHAIR ARTHUR GOLDBERG: So we don't understand this application --

EXECUTIVE DIRECTOR ELIZABETH LINT: Exactly.

ACTING CHAIR ARTHUR GOLDBERG: -- because it's for the exact same location that someone else was approved for last week.

HAVIGIL CORPORATION

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: Havigil Corporation d/b/a Sante's Mobile Cafe has applied for an annual vendor/peddler license to operate a mobile food truck at Cambridge Discovery Park every other Thursday from 11:00 a.m. to 3:00 p.m.

ACTING CHAIR ARTHUR GOLDBERG: Could you identify yourself and spell your name, please?

STEVEN GILMAN: Yes. My name is Steven with a V, S-T-E-V-E-N, Gilman, G-I-L-M-A-N.

ACTING CHAIR ARTHUR GOLDBERG: Could you tell us about your application.

STEVEN GILMAN: Yeah. So we have permission from the Bullfinch Companies to operate every other Thursday at their facility in Cambridge Discovery Park. We have been there

twice already for the temporary one-day permit and we're seeking an annual license.

We're also hoping that the annual license might allow us to operate other places in Cambridge, although it's my understanding that we need permission from property owners anyplace we're going to be, that the city does not allow food trucks to operate on public streets. Is that true?

 $\label{eq:ACTING CHAIR ARTHUR GOLDBERG: I believe}$ that is true.

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

STEVEN GILMAN: But there was special events we do. We have the Head of the Charles coming up. So I don't know if I have to apply for that, or we still have to get the temporary license.

CHIEF GERALD REARDON: Most Head of the Charles is on DCR property.

STEVEN GILLMAN: I see.

CHIEF GERALD REARDON: You would have to go through DCR.

STEVEN GILMAN: So, I suppose, for the purposes of this annual license, it would be to operate at the Cambridge Discovery Park.

ACTING CHAIR ARTHUR GOLDBERG: I think

your application only was for Cambridge Discovery

Park, isn't that right?

STEVEN GILMAN: It was, yeah.

CHIEF GERALD REARDON: Where in the Discovery Park? Is it in the back section? Where you do setup?

ACTING CHAIR ARTHUR GOLDBERG: Where will

the food preparation be done?

STEVEN GILMAN: Done at our licensed commissary in Needham.

ACTING CHAIR ARTHUR GOLDBERG: So there won't be food preparation on the truck itself?

ACTING CHAIR ARTHUR GOLDBERG: Okay.

What sort of equipment do you have on the truck?

Do you have refrigeration?

STEVEN GILMAN: Yep.

STEVEN GILMAN: No.

ACTING CHAIR ARTHUR GOLDBERG: Heating elements?

STEVEN GILMAN: Yep. So we have a double-door cooler. We have two sandwich units. We have a fryolator, a grill, triple-bay sink and a handwashing station.

ACTING CHAIR ARTHUR GOLDBERG: Hand...?

STEVEN GILMAN: Handwashing station.

CHIEF GERALD REARDON: So has your truck

already been inspected by Cambridge?

STEVEN GILMAN: It has.

CHIEF GERALD REARDON: And the Fire

Department did the propane inspection?

STEVEN GILMAN: Yes, that too.

CHIEF GERALD REARDON: I would assume you would on a one-day license.

EXECUTIVE DIRECTOR ELIZABETH LINT: We have it for this.

ACTING CHAIR ARTHUR GOLDBERG: What type of food would you be serving?

STEVEN GILMAN: So it varies a little bit, depending on season. We have been doing salads, wraps and smoothies. And as we're getting to colder months, we'll move away from smoothies to soups, but the salads are always going to be a core part of it.

ACTING CHAIR ARTHUR GOLDBERG: And do you have experience operating a food truck? Have you done this for awhile?

STEVEN GILMAN: Yeah. So my background is actually in IT. I had an IT company for the past ten years. And I'm partners with my cousin and he has 20 years' experience in the restaurant business, went to Johnson & Wales, managed several other places, had his own catering company for a little awhile. So he has been running the truck for the past three months or so that we have been in operation.

ACTING CHAIR ARTHUR GOLDBERG: What is his name?

STEVEN GILMAN: Scott Haviland.

ACTING CHAIR ARTHUR GOLDBERG: Scott...?

STEVEN GILMAN: Scott Haviland,

H-A-V-I-L-A-N-D.

ACTING CHAIR ARTHUR GOLDBERG: Anything

further?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

Actually, we only have information on Scott. So if you're going to be on the truck, we'll need a copy of your state peddlers permit as well background check.

STEVEN GILMAN: No. I'm just taking care of the business, the development side of things.

EXECUTIVE DIRECTOR ELIZABETH LINT: That's fine.

CHIEF GERALD REARDON: How many other trucks are working up there now, do you know?

STEVEN GILMAN: I believe we're the only one.

CHIEF GERALD REARDON: I haven't seen a -- I hadn't seen a flurry of them up there.

STEVEN GILMAN: No. It's funny. We started off in Needham, and one of the management teams from Bullfinch came down -- they have an

office in Needham -- and they said, "You guys would be a great fit for Cambridge." I also have a cousin who works there, so she kinda helped us get in there. They have a cafeteria, but the people who work there really want some other options outside the cafeteria. So we'd be there more often if it wasn't for the fact that they need to kinda keep food trucks away to keep the cafeteria in business.

ACTING CHAIR ARTHUR GOLDBERG: You mentioned that you have a commissary in Needham?

STEVEN GILMAN: Yes.

ACTING CHAIR ARTHUR GOLDBERG: Are they licensed by Needham?

STEVEN GILMAN: Yes.

ACTING CHAIR ARTHUR GOLDBERG: What kind of license do they have, a CV?

STEVEN GILMAN: I'm sorry?

ACTING CHAIR ARTHUR GOLDBERG: Do you

know what kind of license they have?

STEVEN GILMAN: I can show it to you.

It's a commercial kitchen in a church. And there's a couple other food trucks that use it as well. All kinds of licenses.

Here you go (forwarding).

ACTING CHAIR ARTHUR GOLDBERG: Is this a copy that we can keep?

STEVEN GILLMAN: Absolutely, yeah.

ACTING CHAIR ARTHUR GOLDBERG: Does any member the public wish to be heard on this matter?

Seeing none.

Any other questions?

ACTING CHAIR ARTHUR GOLDBERG: All in

favor?

CHIEF GERALD REARDON: Aye.

ACTING CHAIR ARTHUR GOLDBERG: Three to nothing.

STEVEN GILMAN: Now, is that that effective immediately?

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: Continued from August 27 and September 8, 2015, Wahoo, Inc, d/b/a Genki Ya, Que Tai Duong, manager, holder of a wine and malt restaurant license at 231 Alewife Brook Parkway has applied for a change of manager to David ThanhNang Hoang, new stockholder, transfer of stock and new officer/director.

ACTING CHAIR ARTHUR GOLDBERG: Good

evening.

ATTY MEIHEUI HU: Good evening.

ACTING CHAIR ARTHUR GOLDBERG: Could you state your name and spell your names for the stenographer, please?

ATTY MEIHEUI HU: My name is Meiheui,
M-E-I-H-U-E-I. H-U, last name.

Next to me is David Hoang, D-A-V-I-D, H-O-A-N-G.

ACTING CHAIR ARTHUR GOLDBERG: Thank you.

ATTY MEIHEUI HU: I represent Wahoo, Inc for its application for transfer of stocks, election of new officers and directors and a proposed new manager for the premises located at 231 Alewife Brook Parkway.

Wahoo, Inc d/b/a Genki Ya, there's no change in the operation, there's no change in the menu. Basically, this is an application to elect new officers and the two new stockholders.

ACTING CHAIR ARTHUR GOLDBERG: So there are different things you're applying for, one is a change of manager?

ATTY MEIHEUI HU: Yes.

ACTING CHAIR ARTHUR GOLDBERG: Right?

So, Mr. Hoang would be the new manager?

ATTY MEIHEUI HU: Yes. Mr. Hoang will be the new manager. He has been working at the same location since inception in the year 2000 -- oh, I'm sorry, in 2005 when they first started.

His responsibility will include, in addition to managing the kitchen, he will also manage the staff.

He is currently TIPS certified, but I think I understand in Cambridge there's additional certification required for any manager at a premises where alcohol beverages are served and Mr. Hoang can definitely take that additional certification.

ACTING CHAIR ARTHUR GOLDBERG: Has he managed a restaurant in the past?

ATTY MEIHEUI HU: He has not, but he has been working in the same premises since 2005.

He's familiar with the operation and he is also familiar with the staff there.

ACTING CHAIR ARTHUR GOLDBERG: Okay. So the other thing you're applying for relate to a new stockholder, transfer of stock and new officers.

Could you describe that for us, please?

ATTY MEIHEUI HU: Previously before this transfer, there are two -- three shareholders,

Jason Eyu, Hua Zhao, Z-H-A-O, and a gentleman named Duong, last name D-U-O-N-G.

Mr. Duong is selling entire -- his entire share of 20 percent of the corporate stock. His 20 percent will be picked up by Mr. Hoang, David Hoang here.

And the other is a shareholder, Jason Eyu and Hua Zhao. They will each swap 5 percent of their interest and sell that to additional stockholder Xue Feng Liang. And Xue Feng Liang, after the transfer, they will own ten percent of the stock.

So after the transfer, Jason will own 35 percent, Hua Zhao 35 percent, and David Hoang 20 percent and Xue Feng Liang ten percent.

ACTING CHAIR ARTHUR GOLDBERG: I'm going to ask the stenographer, do you need the spellings?

THE REPORTER: Yes, if she could spell them.

ATTY MEIHEUI HU: Jason, J-A-S-O-N,
E-Y-U. Hua Zhao, H-U-A, Z-H-A-O. And David
Hoang, D-A-V-I-D, H-O-A-N-G. And Xue Feng Lian,
X-U-E, F-E-N-G, L-I-A-N-G.

ACTING CHAIR ARTHUR GOLDBERG: So just

for my understanding, so the two owners now who own 40 percent each, they each own 40, they would be going down to 35 percent each?

ATTY MEIHEUI HU: Yes.

ACTING CHAIR ARTHUR GOLDBERG: So they would still own 70 percent of the stock as opposed to currently 80 percent, and the current owner, who owns 20 percent, would be transferring all of that stock, and the remaining -- the two 40 percent owners will go down to 35 percent each, and the ten percent that they collectively are giving up would also be transferred.

So, now, this license is a no-value nontransferable license, if I'm correct.

So the issue here would be: Do we consider this a transfer of the license for our purposes because it's a nontransferable license.

And I'll open this up for discussion, but my own view on this is that where the current

owners are still retaining 70 percent of the ownership, that I could see my way clear to vote that this is not a transfer of the license. It's a minority -- there is some share of the ownership that is being transferred, 30 percent. But 70 percent is not. And, you know, it's the same restaurant. And so it's a question how we want to interpret the fact that this is a nontransferable license.

POLICE COMMISSIONER ROBERT HAAS: I know we have one other case in a similar situation where we denied the transfer for this reason, plus you're introducing a new stockholder. It's not just a rearranging of stock among these new stockholders, but actually it's a new stockholder in the mix.

In some respects, it is a transfer.

You're transferring to another party that was
never a stockholder in the past.

EXECUTIVE DIRECTOR ELIZABETH LINT: It's the same corporation.

POLICE COMMISSIONER ROBERT HAAS: The same corporation.

POLICE COMMISSIONER ROBERT HAAS: How is the other one different that we had?

Were they transferring completely to a different ownership?

EXECUTIVE DIRECTOR ELIZABETH LINT: I can't remember right at this moment.

But I did discuss this with the ABCC and they said if we sent it in as a new license, they would send it back and tell us to do it as an added stockholder because it's the same corporation.

POLICE COMMISSIONER ROBERT HAAS: Okay.

CHIEF GERALD REARDON: This is the same

corporation, and at the end of the day, we still have two original owners that control 70 percent of the corporation.

ACTING CHAIR ARTHUR GOLDBERG: Uh-huh.

CHIEF GERALD REARDON: I guess I look at it somewhat more of a stock redistribution and adding a small minority partner to this as opposed to a complete transfer.

ACTING CHAIR ARTHUR GOLDBERG: This Board could have a discussion in the future about how to interpret this rule and whether or not you change it in some way. But for now, we're just talking about this particular case.

So do we want to have more discussion or...?

POLICE COMMISSIONER ROBERT HAAS: It seems to me if the ABCC is viewing this as the same corporation and they sent it back when we sent in the application, I think it's a moot

point.

ACTING CHAIR ARTHUR GOLDBERG: Okay.

CHIEF GERALD REARDON: Well, two
mitigating things: It's still the same
corporation and still the majority of the holders
of the stock are there. I think that that's --

ACTING CHAIR ARTHUR GOLDBERG: So I would make a motion that the change of manager be a new stockholder, and transfer of stock and new officers and directors be approved.

POLICE COMMISSIONER ROBERT HAAS: Did we do a background?

EXECUTIVE DIRECTOR ELIZABETH LINT:
Background checks are fine.

ACTING CHAIR ARTHUR GOLDBERG: Is there any member of the public who would like to comment on this issue?

None.

So the motion is out there. Is there a

second?

POLICE COMMISSIONER ROBERT HAAS: Second.

ACTING CHAIR ARTHUR GOLDBERG: All those in favor?

CHIEF GERALD REARDON: Aye.

POLICE COMMISSIONER ROBERT HAAS: Aye.

Three to nothing. You're approved.

CHIEF GERALD REARDON: For the record, can we make a friendly amendment that 21 Proof training is also required?

Application: Panda Express, Incorporated has applied for a common victualer license at 100 Cambridgeside Place, the food court. Said,

license, if granted, would allow food and nonalcoholic beverages to be sold, served and consumed on said premises with proposed operating hours from 11:00 a.m. to 9:30 p.m. seven days per week.

ACTING CHAIR ARTHUR GOLDBERG: Hi. Could you state and spell your names, please?

TUAN LUONG: My name's Tuan, T-U-A-N, last name Luong, L-U-O-N-G.

CHARMAINE GAORIAN: My name is Charmaine,

C-H-A-R-M-A-I-N-E, last name is Gaorian,

G-A-O-R-I-A-N.

ACTING CHAIR ARTHUR GOLDBERG: Welcome.

Could you tell us about your application?

TUAN LUONG: So the application, we're opening a fast-food restaurant inside of.Cambridgeside Galleria Mall, and we would like to sell -- provide all the Chinese food and a tiny wok kitchen range.

CHIEF GERALD REARDON: What space are you going into? Do you know who was there prior?

What space are you occupying in the mall that left?

CHARMAINE GAORIAN: Villa & Harlow. It was like a salad and sandwich.

CHIEF GERALD REARDON: So you obviously have all the agreements with the Galleria Mall in place?

CHARMAINE GAORIAN: Yes.

CHIEF GERALD REARDON: In terms of the space and any renovations that need to be done?

CHARMAINE GAORIAN: Yes. We're actually looking into opening on October 8. So all the documentations regarding inspections have already been submitted.

ACTING CHAIR ARTHUR GOLDBERG: We had a question on the application. Maybe this has already been resolved. But is there an

owner/manager specifically to this location because that person was not named on the application?

CHARMAINE GAORIAN: The opening manager would be Tuan Luong. And I will be the new unit manager for the Boston area.

ACTING CHAIR ARTHUR GOLDBERG: We need that put on the application.

do.

EXECUTIVE DIRECTOR ELIZABETH LINT: Also the 24 hours is -- our patio seating ends at 1:00.

ROBERT CHRISTENSEN: The barricades or the tables down?

EXECUTIVE DIRECTOR ELIZABETH LINT: The tables.

JULIA BREMNER: That's to 1:00 a.m.?

EXECUTIVE DIRECTOR ELIZABETH LINT: 1:00

ACTING CHAIR ARTHUR GOLDBERG: You do not have an alcohol license, wine or beer or all alcohol, right?

ROBERT CHRISTENSEN: Not yet.

ACTING CHAIR ARTHUR GOLDBERG: So there's no alcohol on the sidewalk?

ROBERT CHRISTENSEN: Right.

ACTING CHAIR ARTHUR GOLDBERG: Anything from the --

ACTING CHAIR ARTHUR GOLDBERG: But normally you're open 24 hours?

ROBERT CHRISTENSEN: 24/7.

EXECUTIVE DIRECTOR ELIZABETH LINT: If they're going to be closed, they're supposed to notify us and the Police Department.

ACTING CHAIR ARTHUR GOLDBERG: Okay. So were you aware of that -- or do you have the date?

KIM COURTNEY: I have the date, if you would like, September 24th.

there had to be a notification process. And we're happy to comply by any notification requirements. We're a 24-hour operation. I think it sounds like this was one instance. We like being open at 24 hours, so I don't foresee this as being any sort of regular occurrence.

ACTING CHAIR ARTHUR GOLDBERG: Okay. I would just stress it is important, obviously, to us and to the city that you comply with the existing regulations, so the fact that you put the seating out there and were told you shouldn't have done that without the permits, and you're

now coming to us, it's a good thing that you're coming to us, but please review the regulations that we have and be sure that you're in compliance with them.

Any questions from any of the Commissioners?

CHIEF GERALD REARDON: Do you have any idea how long it was that the seats were out there before they came in? I mean, are you talking days? Weeks? A month?

ROBERT CHRISTENSEN: I can find out. I don't think that the tables and chairs were purchased when the restaurant was first constructed, so I think they came much later. The restaurant opened in April, so I don't have the exact answer. I don't want to speculate.

company in the beginning of August.
