Board of License Commissioners Board Members Present: Nicole Murati Ferrer, Branville Bard, and Gerard Mahoney

Staff Present: Elizabeth Y. Lint, Executive Director

Public Testimony Matters:

- 1) Application John Pugh, on behalf of Consigli Construction, has applied for a special noise variance from November 15, 2017 through June 30, 2018 from 6PM to 12AM at 1350 Mass. Ave. for: Installation of steel, concrete repairs and concrete demolition at the Dunster Pavilion, Mount Auburn Plaza, and Arcade areas of the building.

Present: No one. This matter was continued to December 13, 2017.

- 2) Application Market Square Jewelers, Inc. has applied for a Second Hand Goods License at 1156 Massachusetts Avenue.

Present: Peter T. Henry, owner.

Documents Considered by the Board: Application and documents attached thereto.

Summary: Mr. Henry stated that this will be his 5th location. He understands that he cannot sell to minors, as well as reporting requirements. Hours of operation will be 10:00 AM to 6:00 PM, but may close at 5, depending on the business.

Decision: Granted (3-0).

- 3) Application Super Target Liquor of Massachusetts, Inc. d/b/a Target, has applied to transfer the Wine & Malt Package Store License at 321 Broadway held by Durmut Corporation d/b/a 7-Eleven. Applicant has also applied for a Change of Location to 564

Massachusetts Avenue. Danielle Bean as Proposed Manager of Record of a premise described as: First floor and basement space consisting of 19,813 SF with five (5) entrances and five (5) exits. The proposed hours of operation are: 8:00 a.m. to 11:00p.m. Monday through Saturday and 10:00 a.m. to 11:00 p.m. Sunday.

Present: Attorney Joe Devlin, Danielle Bean, Team Leader and proposed manager. Ted Marsh, District Team Leader and Jonathan Livingston, Risk Leader.

Documents Considered by the Board: Application and documents attached thereto; floor plan displayed at hearing.

Summary: This will be the 5th location selling alcohol. It is for the convenience of their customers and will have unique offerings. There will be a security guard present at all times. All staff will be TIPS trained. The alcohol will be in 5 to 8 coolers where the orange juice currently is as well as the 2 inner aisles. The area will be roped off during the hours when the store is open but alcohol cannot be sold per state law. The point of sale will not allow alcohol transactions during off hours. The self-service checkouts do not allow for the purchasing of alcohol.

The Board would like to investigate whether a rope is sufficient to block off the alcohol when sales are not permitted.

Decision: Granted (3-0); the Board reserves its right to administratively add conditions to the license regarding the securing of the alcohol during hours when alcohol cannot be sold. The matter of the conditions will be discussed at the next hearing.

- 4) Application Season to Taste Catering, LLC d/b/a Noca Provisions, holder of a Common Victualler License at 156 Rindge Avenue has applied to add Wine & Malt Beverages at said address. Evan Kaps as Proposed Manager of Record of a premise described as: approximately 2,040 SF single story brick building with entrance fronting Rindge Ave. and egress in rear. Seating capacity of 20 with a maximum occupancy of 25 and hours of operation of food service 6:00 a.m. to 9:30 p.m. seven days per week, alcohol service 8:00 a.m. to 9:30 p.m. Monday through Saturday and 10:00 a.m. to 9:30 p.m. Sunday.

Present: Attorney Sean Hope, Evan Kaps, proposed manager, Robert Harris, owner.

Documents Considered by the Board: Application and documents attached thereto, and letters and emails in support of petition.

Summary: The North Cambridge Stabilization Committee supports the application. Alcohol service was requested by their patrons to go along with the CV license. The manager is already TIPS trained. Alcohol service is to start at noon Monday through Saturday.

Decision: Granted (3-0), with amended opening hour of alcohol sales to start at noon Monday through Saturday.

- 5) Application La Dolce Vita Caffè, Inc. d/b/a Bom Café has applied for a Common Victualler License at 1093 Cambridge Street with a seating capacity of 24 and proposed hours of 6:00 a.m. to 10:00 p.m. seven days per week. Pricila Trancoso as proposed manager of record of a premise described as: approximately 900 SF on the first floor with counter, kitchen, restroom, one entrance and two exits.

Present: Pricila Trancoso, proposed manager.

Documents Considered by the Board: Application and documents attached thereto.

Summary: This will be taking over the location of a previous common victualler. There will not be any changes to the type of business, including keeping the same hours. There will be some remodeling.

Decision: Granted (3-0).

- 6) Application Whole Heart Provisions, LLC d/b/a Whole Heart Provisions, has applied for a Common Victualler License at 300 Massachusetts Avenue with a seating capacity of 37 inside, 22 outside seasonal patio on private property, and an occupancy of 67, with proposed hours of 11:00 a.m. to 10:00 p.m. Monday through Saturday and 10:00 a.m. to 10:00 p.m. Sunday. James Di Sabatino as proposed manager of record of a premise described as: One floor, approximately 1,750 SF. Two bathrooms, prep kitchen, food service line, dining room and seasonal patio on private property.

Present: James Di Sabatino and Meghan Goodwin, owners.

Documents Considered by the Board: Application and documents attached thereto.

Summary: This would be the only vegan restaurant in Central Square. They have one in Allston. Hours of operation changed at the hearing to serve breakfast. Capacity: inside seats 37, inside maximum capacity (seating + standing) – 45, and 22 outside seating.

Decision: Granted (3-0).

- 7) Application Fresh Pond Auto Sales, Inc. has applied for a Used Car Dealer Class II License at 307 Fresh Pond Parkway. Eddie Lakkis as proposed manager of record.

Present: Attorneys Regnante and Jesse Schomer appeared with the applicant, Eddie Lakkis, the Architect, Hans Strauch. Jan Devereux, resident.

Documents Considered by the Board: Application and documents attached thereto; plans as shown during hearing.

Summary: This is the old Tokyo location which is in an unkempt condition. The proposed changes to the building and cosmetics were discussed and developed with Cambridge's Community Development Department. The intent is to keep all cars that are for sale inside the building and to use the 11 parking spaces outside for employees and customers. The cars get driven in and out of the building through a side wall that has a door to allow access. The cars would get repairs at the shop next door which is owned by Mr. Lakkis's father. The applicant intends to have about twenty to twenty-five cars but maintains that if someone wants to test drive one they would only have to move one car. The Board expressed concerns that the space was too small for the number of proposed vehicles inside and asked the applicant to confirm the capacity would not be dictated by the building code.

Jan Devereux, resident near area of proposed location, raised concerns about the business plan and compliance with the laws, lights being on all night, unkempt property, and overnight parking.

Decision: Granted (3-0) with the following conditions: (1) Parking lot (total 11 spaces) only to be used by employees and customers of business, and no overnight parking; and (2) must provide specific number of vehicles that will be inside the building – number to be compliant with building code/square footage. Hours of 8AM to 8PM Monday to Saturday and 12-6 Sunday.

- 8) Cancellation T. T. the Bears Place, Inc. d/b/a T. T. the Bears, holder of a Common Victualler All Alcohol License at 18 Brookline Street, pursuant to M. G. L. c. 138, § 77 for non-use of license.

Present: Kim Courtney as attorney for Bonney Bouley.

Documents Considered by the Board: Hearing notice, correspondence received on the issue from May 24, 2017, and all other documents in the file.

Summary: Kim Courtney appeared on behalf of TT's. Ms Bouley was not present. Ms. Courtney informed the Board that her client had not taken any steps to put the license to use and had turned down the \$35,000.00 offer she received for the purchase of the license. Ms. Courtney read a statement into the record (although the Board asked if she wanted to submit the statement, Ms. Courtney declined and mentioned she would email as she had written on it; the statement was not emailed to the Board). Ms. Courtney requested the Board purchase the license at issue for \$215,000.00.

Decision: The Board (3-0) cancelled the license for non-use. The Board denied (3-0) the request to purchase the license.

Administrative Matters:

All the below listed matters are considered and voted upon by the Board without public testimony. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda.

- 9) Wheelings Brattle, LLC d/b/a Beat Brasserie, holder of entertainment license number 10125, has applied to add a DJ and comedy show to their existing license.

Decision: Granted (3-0).

- 10) Cinderella's Restaurant, 901 Main Street, holder of license number ACH03213, has turned in the alcohol license.

Decision: Board acknowledged/license cancelled (3-0).

- 11) Further discussion of Boards decision regarding the matter of Michael Gervais, non-renewal of his hackney license.

Summary: This was placed on the agenda to allow Commissioner Bard to express his reasons on the record for denying renewal, as he had been interrupted at the hearing. The Board, upon being interrupted once again by members of the public, explained this was part of their deliberation. The Board reiterated its decision was based on Mr. Gervais's inconsistent statements at the hearings, the nature of the complaints, his behavior, and inconsistency with Officer Szeto's report, as well as other police reports and information contained in the prior statement of reasons.

Decision: Board denied (3-0) Mr. Gervais's appeal and reaffirmed the denial of the renewal of his hackney license.

- 12) IBD Ltd. d/b/a Darwin's Ltd., holder of license number ACH10165, has applied for a one day amendment to their existing license to close at 6:00 p.m. with a private event from 9PM to 1AM on Sunday, December 10, 2017, for less than 100 people.

Decision: Granted (3-0).

- 13) Zavoo, Inc. d/b/a Evoo/ZA, holder of license number ACH01602, has applied to change their outdoor seating and standing capacity from 110 to 148 seats and 20 standing, on private property.

Decision: Granted (3-0).

- 14) Cambridge redevelopment Authority has granted permission for the following trucks to vend through the end of January 2018 at the corner of 3rd and Binney Streets:

Chicken and Rice Guys, LLC, Monday
Phenix grill, Monday
Mei Mei Street Kitchen, Wednesday

Decision: Granted/acknowledged (3-0). Also, granted/acknowledged as to Sheherazad Food which will be at the location on Thursdays.

- 15) Approval of Renewals submitted (list will be presented at the hearing).

Summary: 176 alcohol renewals were completed and the list will be incorporated in to the record. 100 non-alcohol were submitted.

Decision: Approved (3-0) as to all (see attached list).

- 16) Requests for Extension of Hours on New Year's Eve (list will be presented at the hearing).

Decision: Approver (3-0) as to all (see attached list).

- 17) Administrative Acknowledgements/Changes/Corrections based on information submitted with renewal applications (list will be presented at the hearing).

Decision: Acknowledged/granted as to all (see attached list).

- 18) Consideration of a one-business day grace period until December 1, 2017, at 12:00 p.m. to complete alcohol renewals.

Summary: The Board discussed that due to the new system, which requires the submission of the application online and an approval of the submission prior to payment being allowed to be made, this would grant licensees some relief and the Board time to review all applications submitted.

Decision: Granted (3-0).

- 19) Marc Shulman, on behalf of Patty Chen's Dumpling Room, has advised the License Commission that they have closed at their current location due to construction. It is their intention to reopen at a new location in the summer of 2018.

Decision: Acknowledged (3-0).

20) Cheesecake Factory, Inc. is requesting a change in hours to open at 10:00 AM on Saturdays, which they believe they were originally approved for.

Summary & Decision: A review of the record indicated that they had not previously been granted the 10:00 AM opening hour on Saturday, but they do open at 10:00 AM on Sunday. Granted (3-0).

One Day Applications:

These applications are also considered administratively and there is no public testimony taken or requested. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda. In addition, the documents considered by the Board are the one day application submitted by the applicant and any other supporting document attached thereto. Police detail is required on some based on the recommendation of the signing-off police department.

Decision: Granted (3-0).

22) Erka Gauthier, has applied for a malt and wine license to be exercised at Novartis, 250 Massachusetts Avenue, on 12/8/17 from 5:00 p.m. – 7:30 p.m. for a reception. Expected attendance – 100 people.

Decision: Granted (3-0).

23) William Fuller, on behalf of the Bartending Service of New England, has applied for a malt and wine license to be exercised at Harvard Campus, Maxwell Dworkin lobby, Oxford Street, on 12/1/17 from 4:30 p.m. – 7:00 p.m. for a holiday reception. Expected attendance – 300 people.

Decision: Granted (3-0), with the condition that a police detail is required.

24) Edward O'Connor, has applied for a malt with entertainment license to be exercised at ProPark parking lot, 41 Church Street, on 12/10/17 from 10:00 a.m. – 1:00 p.m. for a Cambridge 5k-Yulefest with patrons dancing, recorded/live music and amplification system. Expected attendance – 4000 people.

Decision: Granted (3-0), with the conditions that: alcoholic drinks must be sold or there must be a limited number of alcoholic drinks associated with the admission charge; and a police detail is required.

25) Charles James, on behalf of Crimsonbikes, has applied for a malt and wine license to be exercised at 1001 Massachusetts Avenue, on 11/30/17 from 6:00 p.m. – 11:00 p.m. for a party. Expected attendance – 150 people.

Decision: Granted (3-0).
