MEETING MINUTES

Board of License Commissioners' Meeting October 24, 2018, 3:00 p.m.

Meeting Started at 3:05 p.m.

Board of License Commissioners Board Members: Nicole Murati Ferrer (present), Branville G. Bard (present), and Gerard E. Mahoney (absent).

Note: All votes, unless otherwise indicated, were 2-0.

Executive Session:

By roll call vote, the Board went into Executive Session to discuss litigation strategy with respect to the appeal known as "Appeal of the Action of the City of Cambridge Licensing Board [sic] for Suspending the § 12 All-Alcohol License of Winding Road LLC D/B/A Abigail's Located at 219 Third St., Cambridge, MA for Five (5) Days."

By roll call vote, the Board voted to close the executive session.

Public Testimony Matters:

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1) Violation Continued from October 3, 2018. Bob Bassill, Local Motion of Boston, for violation of Cambridge Municipal Code 8.16.060(B) - Noise in residential areas or affecting residential property, and 8.16.060(E) – Area noise standards.

Present: Bob Bassill, Local Motion; Bruce Barrows, Local Motion; Andrew Shepardson, VP Bentley University; and Andrea Boyer, Chief Licensing Investigator.

Documents Considered by the Board: Hearing notice and attachments thereto; email correspondence from complainants; current file; and documents provided by Local Motion at the hearing.

Summary: Local Motion has not been able to identify any buses on its fleet which are currently compliant with the Noise Ordinance. They installed additional baffling bus # 435 which brought the emission down 5-6 decibels. The proposal is to change the route to one used by an MBTA bus which

does not pass directly in front of the complainants' home. The other two buses (434 & 436) would be baffled in the same way to bring the emissions down and provided the contract is once again awarded to Local Motion, new buses that are compliant with the Ordinance would be purchased.

Decision: Continued to 11/7/18 hearing. Board approved alternate proposed route provided no issues with TTP and that buses 434 & 436 are baffled like 435.

2) Violation Marco Landscaping, Holder of Leaf Blower Permit #10686, for alleged violation of Cambridge Municipal Code 8.16.081.2(a)- operating during a prohibited period on September 13, 2018, at 10:35 a.m. at 500 Huron Avenue.

Present: Tyler Bubenik, Licensing Investigator.

Documents Considered by the Board: Hearing notice and attachments thereto.

Summary: Matter was provided a second call at 4:03 p.m. No representative from Marco Landscaping showed up and no continuance was sought. The Board proceeded hearing the matter.

Licensing Investigator Bubenik testified he observed an employee of Marco Landscaping operating a leaf blower on September 13, 2018 at 10:35 a.m., at 500 Huron Avenue in violation of the Noise Ordinance.

Decision: Violation, \$300 fine.

3) Application G Street Associates, Inc. d/b/a Grafton Street, 1 Bow Street, holder of Common Victualler All Alcohol License #11668-1, has applied for an Alteration of Premise to include an additional fifty (50) square feet of outdoor seating area.

Present: James Rafferty, attorney; Patrick Lee, applicant representative; and Douglas Payne, resident.

Summary: The request is to add two tables with 2 chairs each at the curbside in front of the restaurant. The area is visible from the inside (bar and hostess stand). The use of the sidewalk and the location has been vetted and approved by the Department of Public Works and City Council. The additional tables will activate an area of the sidewalk that is not currently used and will not adversely affect pedestrian traffic or accessibility.

Mr. Payne, a resident of Cambridge, opposed the application as the area is already congested with a lot of pedestrian traffic. He was concerned about the increase in people walking onto the street, crossing traffic and believes the restaurant has enough outside seating.

Decision: Granted.

Present: No show.

Documents Considered by the Board: Hearing notice and documents attached thereto; and electronic record.

Summary: Second call was given at 4:05 p.m. The Board proceeded as no request for continuance was provided. Sara Asfaha was the host for a wedding reception at the Christian Life Center on September 15, 2018. Alcohol was served and entertainment provided. Although she applied for a license (and it was granted) she failed to pay for it and the event proceeded without a license.

Decision: Violation; matter to be sent to the Law Department for affirmative recovery or other legal recourse.

ADMINISTRATIVE MATTERS

All the below listed matters are considered and voted upon by the Board without public testimony. 13) Epicurean Feast, 55 Wheeler Street, holder of license number 12186-1 has notified the License Commission that the business is closed.

Summary & Decision: This is a common victualler (no alcohol) license. Matter acknowledged, close file and cancel license.

14) Stephen Pridham d/b/a S&D Catering, has applied for a new mobile hawker/peddler license.

Summary: Per the application, they are expected to be at the corner of Massachusetts Avenue and Main Street from 9:15 a.m. – 9:30 a.m., and then 12:00 p.m. to 12:30 p.m. There were some issues that came up in terms of the background check but none which disqualify the applicant from having this license. In addition, he holds a valid state hawker/peddlers license.

Decision: Granted.

15) Holiday Inn Express & Suites, 250 Monsignor O'Brien Highway, holder of Innholder license #10882-1, has applied for a change to their existing license to add 3 T.V.'s in the lobby. (Record #23252)

Decision: Granted.

Attorney Dennis Quilty has requested that the Board reconsider the decision of September 12, 2018 indefinitely suspending the license of Cambridge Craft, LLC d/b/a World of Beer, #11565-1, as they have complied with their legal requirements.

Summary: Although an application has been filed to correct the G. L. c. 138 violations and approved by the Board, pursuant to G. L. c. 138, the violation is not corrected until the changes are approved by the local Board and the Alcoholic Beverages Control Commission ("ABCC"). The ABCC has not yet approved the changes.

Decision: Denied; the indefinite suspension will be lifted when the ABCC gives final approval on changes.

17) Gold Transport, Inc. has notified the License Commission of their intent to transfer medallion #145 to East- West Trans, Inc.

Decision: Board Acknowledges.

18) Vote Deferred from September 12, 2018 hearing: SN KJ, Inc. d/b/a Beauty's Pizza, 187 Hampshire Street, has applied for a new Common Victualler Wine & Malt Beverages License #18674. The proposed hours are 6:00 a.m. to 3:00 a.m. all days with alcohol sales starting after 10:00 a.m. all days and ending at 1:00 a.m. with seating for 20 inside and 28 patio seats on private property. Jigarkumar Purohit as Proposed Manager of Record of a premise described as: 1,250 sq. ft. Italian pizza restaurant with take-out, dine-in, and delivery. One entrance and two exits, and seasonal outdoor seating on private property.

Summary: The matter had been deferred because the applicant was awaiting a BZA decision for a fast food permit. In addition, the applicant had yet to submit three months of financials. The Board has since received notice of the BZA approval and zoning sign-off and the applicant has submitted the required financials from Patel. Noted that the BZA decision was written on the margin and the written decision not yet issued.

Decision: Granted, with the condition that if the BZA approval has conditions those will be made part of the conditions of the license. Also, the license will not issue until the current liquor license attached to the premises is surrendered (which is what the current holder represented he would do).
