Public Testimony Matters:

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Informational Eliot Management Services, Inc. d/b/a Paradise, 180 Massachusetts Avenue, All Alcohol General on Premise License #11695 for an informational hearing for non-use of the license pursuant to, but not limited to, M. G. L. c. 138, §§ 23, 64, and 77.

Present:

Attorney James Rafferty.

Documents Considered by the Board: Hearing notice and attachments.

Summary: Mr. Rafferty stated that his client is looking for a new location for his business to reopen Paradise or similar-type of venue. His client will be looking for a new location until the second half payment of the renewal fee is due. If his client cannot find a new location for the business in that period, he intends to turn in his license.

Decision: If the license has not been surrendered, put to use or transferred within six (6) months, the Board will hold a cancellation hearing for non-use pursuant to G. L. c. 138, § 77.

2. Disciplinary HK Food Group, LLC d/b/a Alden & Harlow/Longfellow Bar at Alden & Harlow, 40 Brattle Street, Common Victualler All Alcohol License #11478 to determine whether you permitted a disorder, disturbance, and/or illegality on the licensed premise, to wit: Overcapacity on January 25, 2019, in violation of M. G. L. c. 138, §§ 23 and 64 and Board's Rules 2.3, 2.5, 5.1, and 9.

Present: Jen Fields, General Manager; Attorney James Rafferty; and Licensing Investigator Tyler Bubenik.

Documents Considered by the Board: Hearing notice and attachments; and file.

Summary: Aside from the noticed matter, during the hearing the allegation of failure to properly complete the crowd manager paperwork was also considered.

Mr. Bubenik testified that he conducted a routine inspection on January 25, 2019 and counted 38 patrons in the Longfellow Bar which has a capacity of 35. The other two floors were compliant. He also found that they did have crowd control managers, but the last three days of paperwork were missing. Ms. Fields explained that they had just opened that week and things were very hectic. Mr. Rafferty explained that there is no bathroom on the first floor, so patrons had gone up to the second floor to use the bathroom there. The licensee is in the process of amending the standing room capacities to accommodate people waiting to use the bathrooms.

Decision: No violation (2-1; Chair Murati Ferrer dissented and voted to find a violation and issue a warning).

3. Disciplinary Middle East Restaurant, Inc. d/b/a Middle East Restaurant/Zuzu/Sonia's, 472 Massachusetts Avenue, Common Victualler All Alcohol License #11691, due to alleged violations of M. G. L. ch. 138 M. G. L. c. 138, §§ 23, 64 and Board's Rules 2, 2.5, 5.1, and 8.1; to wit: (1) 2 Counts - Improper bodily contact (employee on patron) on January 30, 2019 and February 5, 2019; and (2) Service/sale/delivery of alcohol to an intoxicated patron on January 6, 2019, in violation of M. G. L. c. 138, §§ 64-64A, 69 and Board's Rules 2, 2.5, 12B.6, 12B.7; and (3) Failure to call police or an ambulance on February 14, 2019, in violation of M. G. L. c. 138, §§ 23, 64 and Board's Rules 2, 2.5, 12B.6, 12B.7.

Documents Considered by the Board: Hearing notice and attachments; video recordings; documents submitted by Attorney Barrett at the hearing; and file.

Summary: The hearing consisted of multiple complaints and incidents. They are listed in the order discussed.

Incident #1 (January 30, 2019): a female patron reported to the police being punched by a Middle East security staff person when she interjected in his attempt to escort a male patron out of the premises. The security officer was alleged to have been holding the male patron with a chokehold. Investigator Bubenik spoke with the patrons who reiterated what was reported to the police. In addition, the male patron informed Investigator Bubenik that he was placed in a chokehold/headlock

because he did not take off his wristband (he alleged to have been having trouble doing so). There was no video of the interaction and none of the patrons involved appeared to testify.

The Middle East denied the male patron ever being held in a chokehold/headlock or striking the female patron. Security claims to have been surrounded and attacked by 4-5 female patrons as the interaction is ongoing. Security confirmed the interaction was as a result of the male patron refusing to take off the wristband after being asked to leave the premises. It is the Middle East's policy to have patrons remove wristbands when ejected, so they can't come back in. Wrist bands are used to identify under/over 21. This was an all age show. No scissors are used by the staff to take bands off. No police were called to the scene and no one was physically harmed.

Incident #2 (January 31, 2019): Mr. Lopez, a patron, claimed to have been physically assaulted while being removed from the club without reason. A video was shown of the interaction between Middle East security and a detail officer. The video shows that in one of the interactions, a Middle East staff member has Mr. Lopez in a chokehold and tosses him to the ground.

The Middle East explained Mr. Lopez had been previously banned from the club for being disrespectful and overly sexual with young women (15-18 y.o.).

Incident # 3 (February 14, 2019): there was a physical altercation with a vendor/patron (Puffer) and a patron (McDonald). Puffer punched McDonald, and McDonald spat on Puffer. Security intervened and ejected McDonald. Puffer reported he felt Middle East staff was dissuading him from calling the police.

Middle East staff testified they did not dissuade Puffer, but they did not call the police as they believed the situation was diffused and there was not going to be a future conflict.

Incident # 4 (January 1, 2019): an arrest was made of an employee for operating a vehicle under the influence of alcohol and carrying a dangerous weapon. Investigator Bubenik was unable to find proof that the employee was served on the premises and/or that he brought the weapon inside the premises.

It is against Middle East policy for employees to have weapons. Employees are also not permitted to drink on premise. Management conducted their own investigation and found no one had served him alcohol. Two employees testified that the employee was not served alcohol. An employee stated that they went to Green Street after work, where they drank prior to the accident at 3:00 a.m. Mr. Germain stated that he hit his head hard and has no memory of the incident. He stated further that he was not drinking at Middle East. He said he kept his weapon in a lock box in his car.

Incident #5 (March 26, 2019): An 18-year-old girl was transported to the hospital from Middle East due to intoxication. She was not served at Middle East, but she had a wristband that said she was of legal age to drink.

One of the Middle East staff members stated she was admitted to an all age event but was not identified as "of age." The patron was able to obtain a wrist band and enter the premises. Middle East did not conduct an investigation on how she was able to obtain the wrist band.

Mr. Sater stated they accept MA ID's, passports, Military ID's and out of state ID's. They do not accept international ID's. Mr. Sater stated they disciplined the employee referenced in incident #2 by giving him a warning. Middle East staff has engaged in de-escalation training.

Decision:

The Board took the matter under advisement.

4. Application #32683 MSEX, LLC d/b/a Middlesex Lounge, 315 Massachusetts Avenue, Common Victualler All Alcohol License #11535, for a Change of Hours to close at 2:00 a.m. seven nights per week.

Documents Considered by the Board: Application and documents attached thereto; and file.

Summary: The business already has a 2 a.m. Thursday through Saturday. The 2 a.m. is based off requests received from their patrons on the other nights when they host smaller events. Also, for their gay nights which are now more robust due to the lack of other venues in the City with this offering.

Decision:

Granted.

5. Application #32872 Nookie, LLC d/b/a Commonwealth Restaurant, 11 Broad Canal Way, Common Victualler All Alcohol License #11473, to reconfigure the market area and add seating.

Summary: Mr. Postal explained that he wants to reconfigure the market area to give the space a better and natural flow. He will be adding 27 seats. His certificate of occupancy already accounts for the increase in seats.

Summary: Mr. Thompson stated that he has twenty (20) years experience in the restaurant industry. He is TIPS certified and will submit his certificate.

7. Application #29814 McCabe's Porter, LLC d/b/a McCabe's Bar and Grill, 2046 Massachusetts Avenue, Common Victualler All Alcohol License #11498, for a Change of d/b/a to Shine Square Pub. They are also requesting to add foosball, jukebox and one video game to their entertainment license.

Thomas Covert, applicant.

Documents Considered by the Board: Application and documents attached thereto; and file.

Summary: The name change is associated with the disassociation from Bull McCabe's once Mr. Manning, one of the partners, is bought out. The lawyers are still negotiating the terms of the sale which is why there is no current application to change the ownership. The applicant had previously submitted a change of manager application but has since withdrawn it. The applicant also submitted a request to add entertainment categories to the license -1 video machine, 1 foosball table, and 1 jukebox.

Applicant must produce an amended corporate vote that only reflects the change of d/b/a and the ABCC transmittal form for the change of d/b/a only. Applicant stated they would be sent. Zoning has not yet signed off on the additional entertainment categories.

Decision: Change of d/b/a, granted pending submission of a new corporate vote and ABCC transmittal form. Additional entertainment categories granted subject to receipt of zoning approval.

8. Application #32634 LCW Associates, Inc. d/b/a Royal East, 782 Main Street, Common Victualler Wine & Malt License, for a Change of License Category to All Alcoholic Beverages.

Summary: Mr. Fu explained that the reason for the upgrade request is based on clients' requests. He receives the request based on events in the function room and private parties. In addition, diners ask for it. The business has been in operation since 1985 with no disciplinary issues.

9. Application #32802 Transfer of Common Victualler All Alcohol License held by JC.N.A. Boston, Inc. d/b/a Wafuya, 1815 Massachusetts Avenue, to Carlos Group, LLC, d/b/a Ittoku, at the same location. Kentaro Suzuki as Proposed Manager of Record of a premise described as: 2,433 square foot restaurant on first floor with four dining areas, kitchen, sushi counter, 3 exits/entrances inside Porter Exchange.

Documents Considered by the Board: Application and documents attached thereto.

Summary: This restaurant will be a different concept than what currently exists. The group has another restaurant with the same name in Allston, which they are selling. They are retaining the name and concept. The seats (80), entertainment (4 TVs) and hours (10:30 a.m. - 1:00 a.m.) will remain the same. They may seek earlier hours once they open. Mr. Suzuki has been a manager of record before, is TIPS certified and submitted his certificate.

Decision:

Granted.

10. Application #32619 President and Fellows of Harvard College d/b/a Common Spaces, 1350 Massachusetts Avenue, has applied for an Entertainment License for indoor and outdoor spaces to include: Recorded music with amplification; dancing by patrons; dancing by entertainers; live music with amplification; theatrical exhibition, play, or moving picture show with amplification; floor show; dynamic audio or visual show with amplification; DJ; comedy show; karaoke; trivia; magic show; readings of poetry and other works; two pool or billiard tables; fifteen TV's; two cinema screens; and one stage for live performance.

Present:

Diane Gray and Julie Crites on behalf of the applicant.

Documents considered by the Board: Application and documents attached thereto.

Summary: The entertainment license would be for the spaces on the first and second floor as well as the 10th floor (including the areas of the 10th floor not currently licensed to sell alcohol). Entertainment area includes outside as well. The applicant needs to submit Certificate of Inspection for all areas where they plan to exercise license and floor plans with capacity for each space. The entire building is Harvard ID access only – not open to the public.

Decision: Granted subject to submission of floor plans for the first and second floors, Certificate of Inspection from ISD for the first, second and the remaining rooms of the 10th floor.

Decision: This is a duplicate notice of #4.

12. Danny Viola, on behalf of Cambridge Nissan, Inc., d/b/a Cambridge Nissan at 1280 Cambridge Street, holder of used car dealer license #32597, has applied to change their d/b/a to Cambridge Auto Center.

Summary: The request also included a change in corporate name. The application number is #32597, the used car dealer license number is #10636.

Decision: Granted for both change in d/b/a and corporate name.

13. Mohamed Seffo, on behalf of Falafel Palace, LLC, holder of Common Victualler license #12412, has applied for a change of d/b/a to Aleppo Palace, change in seating from 18 to 4, and reduce total occupancy to 14 standing. Applicant #32748

Summary: Basically, what the applicant wants is for the license to reflect the business has only 4 seats and a standing capacity of 10, with a total occupancy of 14.

Decision: Granted 4 seats and 10 standing for a total occupancy of 14.

14. Joe Toomey, on behalf of Walsh Brothers, has applied for a special noise variance from April 1 through July 31, 2019 with alternate dates of April 2 through July 31, 2019 6:00 p.m. to 11:00 p.m. every seven to ten days for concrete finishing work. Applicant #33491

Based on the facts of the case and that the unlicensed entertainment was offered on a Saturday, the suspension should be served on Saturday.

Therefore, the Chair will be sending a letter to the universities asking for a comprehensive list of all dormitories with their names, number of rooms, number of beds, physical address, and E 911 address. A discussion ensued in terms of what would be more appropriate for public safety services – physical or E911 addresses. Physical addresses is what is necessary. Chair will send corrected addresses to E911 (Chair will coordinate with ECC).

18. The Board will discuss their votes of March 13, 2019 for 181 Mass Ave., LLC, d/b/a Oath Craft Pizza, 181 Mass Avenue, Common Victualler Wine & Malt License #11612 and Rangzen Tibet, Inc., 24 Pearl Street, Common Victualler Wine & Malt License #11295.

Summary: Although both matters were heard for similar violations, the difference in the number of suspension days was due to the facts of the case. Oath's changes happened prior to renewal and were deliberate. Oath was advised of the matter during renewals and thereafter through multiple communications. Rangzen was due to the unforeseen and untimely death of one of the members during the renewal period. In addition, the members of Rangzen were traveling to India to take the remains to lay them to rest.
