Public Testimony Matters:

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Disciplinary Howth, Inc. d/b/a People's Republik, 878 Massachusetts Avenue, Common Victualler All Alcohol License #11686, for alleged overcapacity on January 18, 2019, in violation of M. G. L. c. 138, §§ 23 and 64 and Board's Rules 2.3, 2.5, 5.1, and 9. **(Time Stamp: 00:56)**

Present: License Investigator Tyler Bubenik; and Philip Blair, owner.

Documents Considered by the Board: Hearing notice and documents attached thereto; and file.

Summary: Mr. Bubenik testified that he conducted a routine inspection on January 18, 2019 and found there were 123 patrons in the establishment, which is licensed for 99. He did a follow-up on March 2, 2019 and found no violations. Mr. Blair testified that he was not there on the night in question and the person doing the count could have made a mistake. He did not contest the evidence. Mr. Blair contended that his architect said that by code there could be a total of 187 persons inside. The 99 capacity was set by a cap by Chairperson Barnes. He has since reinforced the importance of staying within capacity with his staff and has bought new counters. He has been in business for 21 years and this is the first violation they have had.

Decision: Violation, warning.

Documents Considered by the Board: Application and documents attached thereto.

Summary: Suzanne Sumowski sold her 20% interest in the business to Brian Poe. Poe is the proposed manager of record and will be on the premise 20 hours per week; they have a general manager and manager which will be on site when Poe is not present. Poe is TIPS certified, has been the manager of record of a liquor license without issue.

Decision: Granted. Tips certification must be submitted.

Summary: This application is for a generator needed in advance for a new building and flammable storage. The garage spaces are for a fee. The gasoline listed is only for tanks of vehicles. The building is a dorm for 500 Hult Institute students.

Summary: The changes are as a result of the death of one of the beneficial interest holders. Chunni will own 50% of the business and Lopsang and Dhiki will equally own the other 50%. Dhiki will be the manager of record. She must complete TIPS training. All are American citizens.

There is a patio space which is located on the Northeast side of the building. (Time Stamp: 19:09)

Present: Attorney Caroline O'Connell, Mike Carney and Alec Yerardi, proposed manager and Dante Angelucci, representing the developer. Xavier Dietrich, resident.

Documents Submitted: Application and documents attached thereto.

Summary: The local application has a more descriptive premise description. The ABCC application will be amended to reflect the premise description in the local form. The related Planning Board decision was submitted with the application. The floor plans submitted were provided by the landlord, but they do not contain the architect's specific numbers. Floor plans will be updated.

Business concept is a farm to table restaurant serving burgers. An attitude of gratitude is their belief. The patio is only intended to be for events. There is no street access to the patio. The total square footage for the patio will be submitted. They have been asked to serve breakfast because of the train station and they are interviewing neighbors to determine what the need is in the area to determine their breakfast menu. Mr. Angelucci explained that this is a mixed use building. The neighbors have requested a family style restaurant. There will be some retail on the street level. There will be 3 TV's and background music. Once buildout is complete, a plan showing the location of the TVs will be provided. TIPS certification was submitted.

Xavier Dietrich spoke in opposition to the application and questioned whether a public need was shown.

Decision: Granted.


