Public Testimony Matters:

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. **Disciplinary** Eversource Energy Gas, for alleged violations of Cambridge Municipal Code 8.16.080(F) due to noise complaints on March 12, 2019 and March 18, 2019; and License Commission Investigator documented operation of equipment used in construction outside of permissible hours on March 30, 2019 beginning at 7:15PM near 18 Bates Street. **[Time Stamp: 00:38]**

Present: Licensing Investigator Tyler Bubenik, and Richard Dell'Isola, Eversource.

Documents Considered by the Board: Hearing notice and documents attached thereto.

Summary: Based on complaints received for construction after hours, Investigator Bubenik went to Bates and Avon Streets on March 29, 2019 and observed Eversource performing work after the allowable hours. Investigator Bubenik did not shut down the operation because otherwise the street would be left unsafe. The other noise complaints related to Riley not Eversource.

Mr. Dell'Isola testified they started the work at 1:00 p.m. in consideration of the resident's request to have the work performed on a particular day because of her handicapped child. Although Eversource attempted to finish the work in a timely manner, they could not finish by 6:00 p.m. At that point they needed to continue because otherwise the residents would have been left without heat or hot water.

Decision: No violation.

2. **Disciplinary** La Fabrica Central, LLC d/b/a La Fabrica, 450 Massachusetts Avenue, Common Victualler All Alcohol License #11595, to determine whether on November 10, 2018, an employee of La Fabrica made improper bodily contact with a patron in violation of M. G. L. c. 138, §§ 23, 64, and Board's Rules 2, 2.5, 5.1, and 8.1. **[Time Stamp: 09:08]**

Present: Licensing Investigator Tyler Bubenik; Attorney Bill Kelley; Renato Rodrigues, Manager; Mikhail Druskin, Head of Security; and Cambridge Police Officer Sean Lowe.

Documents Considered: Hearing notice and documents attached thereto; video shown at hearing.

Summary: Investigator Bubenik presented testimony regarding the ejection of a patron on November 10, 2018. Investigator Bubenik also presented video footage of the incident. The video footage was provided by the licensee. No one has been able to identify the patron.

Mr. Rodrigues testified he had encountered the patron at the beginning of the night as a couple of regulars were complaining about him saying he was asking for drugs to purchase. The patron denied the request for drugs and assented to moving from the area of the complainants. The patron was allowed to stay at the premises.

Mr. Druskin, head of security, testified that he was outside monitoring the front door when he observed Paige and another security guard escorting the patron out. They attempted to diffuse the situation but were unable to do so. The detail officer was called to the front, and the patron ended up shoving the officer and running away. Druskin conducted an internal investigation and learned that Paige had been approached by several customers regarding the patron's behavior. He was warned that he would be ejected if he didn't control his behavior. The patron struck Paige, so he was ejected. The staff is instructed to use the minimum amount of force necessary to execute ejection.

Officer Lowe testified that the patron was hostile and uncooperative but not intoxicated. Because of the patron's actions and disruptiveness to the area, Officer Lowe was going to arrest him for disorderly conduct. At that point, the patron pushed him and ran away.

Decision: Board took the matter under advisement.

Present: Attorney Rashi Mangalick, and Josh Huggard, applicant.

Documents Considered: Application and documents attached thereto.

Summary: There were no changes to the ownership, just the COO and a change of manager. Mr. Huggard has been manager of record before with no issues. He is TIPS certified. Old and new organizational charts were submitted.

Decision: Granted. TIPS certification needs to be submitted.

Summary: The request is for a small curb side patio for food only – 4 tables and 8 chairs (all 2 persons-tables). The sidewalk permit has been applied for with the Department of Public Works.

7. Goden Street, LLC d/b/a The Rising, holder of Common Victualler All Alcohol License #11554 at 1172 Cambridge Street, is requesting to change their Sunday opening hour to 8:00 a.m. for breakfast and 10:00 a.m. for alcohol. Application #33965 [Time Stamp: 57:25]

Summary: This application requires notice to abutters, which has not yet been filed/submitted.

Decision: No action. The matter will not be considered until application is completed.

8. Regina Olivieri, on behalf of Shawmut design, has applied for a special noise variance from May 15 through September 14, 2019 with alternate dates of May 15 through September 14, 2019 from 11:00 p.m. to 7:00 a.m. at 1350 Massachusetts Avenue for a crane pick during specified times, 1 or 2 times per week and not continuously. [Time Stamp: 50:50]

Present: Craig Baker and Kyle McKenna, on behalf of the applicant; and Patrick Lee, abutter.

Summary: The variance is for crane picks only to do a roof replacement at the Smith Center. Everything was renovated except the roof. The crane pick would be to bring the equipment up. There would be an hour set up and breakdown with 6 hours of work in between. Mr. Lee said he hadn't heard anything about the project until he received the abutter notification and would like more information from the mitigation team (CSL Consulting) before this is approved. Mr. Lee's restaurant is on Dunster Street. The proposed location for the crane is on Dunster Street.

Decision: No action; matter deferred to May 8, 2019 hearing.

Christopher Delaney, on behalf of Siena Construction, is requesting the Board reconsider their application for a special noise variance on April 15 through May 31, 2019 with alternate dates of April 23 through May 31, 2019 from 12:00 a.m. to 8:00 a.m. at 784 Main Street, for indoor work only, weekdays. Applicant #44305 [Time Stamp: 57:48]

Summary: This is not a request for a reconsideration, rather the Board *sua sponte* has placed the matter again on the agenda as a noise complaint for the work being performed was received. The applicant submitted additional information and stated the variance is to change the sprinkler system for the Royal East restaurant when the business is closed in consideration of the business's needs. The business is in a mixed use building currently occupied by residents.

Decision: Variance revoked; any upgrades to the business's sprinkler systems are to be done during regular construction hours.


