BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES For Meeting of Wednesday, July 17, 2019

Note: All votes, unless otherwise indicated, were 2-0.

Public Testimony Matters

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Application Gezahegn Tegegn, for a new Cambridge Hackney Driver's License.

Decision: Rescheduled – no new date.

2. Application Sisay Seboka, for a new Cambridge Hackney Driver's License. **[Time Stamp:** 2:00]

Present: Sisay Seboka, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Seboka has been a Boston taxi driver and has had no issues.

Decision: Granted.

Application Solene Prince, for a new Cambridge Hackney Driver's License. [Time stamp: 4:34]

Present: Solene Prince, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Ms. Prince is buying medallion #108. She has never been a cab driver but is required to have a hackney license in order to own a medallion.

Decision: Granted.

Note: Matters 4 & 5 were called together.

4. Application #43911 CoffeeShop, LLC d/b/a UpperWest, 1 Cedar Street, B, holder of All Alcohol General On Premise License #11587, has applied for an Alteration of Premise for the removal of approximately 140 square feet. The new premise description would be: Basement level, one floor, two rooms, approximately 1,000 square feet. **[Time Stamp: 6:11]**

5. Application #43910 CoffeeShop, LLC d/b/a UpperWest, has filed an application for a new All Alcohol Package Store License to be exercised at 1 Cedar Street, B. Kim Courtney as proposed Manager of Record of a premise described as: Basement level, one floor, 2 rooms, approximately 140 square feet.

Present: Kim Courtney and Xavier Dietrich, applicants.

Documents Considered: Applications and documents attached thereto.

Summary: The applicants were asked to explain how this application is for a different premises than the application previously filed and denied. They stated that the application is ripe because it is a different premises but, confirmed that it is for 1 Cedar Street, B. Applicants were asked if they had withdrawn their appeal at the ABCC. The applicants responded by asking why that is relevant and did not respond to the question. Applicants did confirm the appeal was still pending. Applicants were questioned as to how the proposed operation complied with the ABCC advisory regarding ownership of § 12 and § 15 in the same premises. Applicants argued that it did, that the advisory did not apply, and that even if the advisory applied, they would comply with it. Applicants confirmed they made amendments to the applications on the day of the hearing and less than two hours prior to the hearing. Applicants argued a floorplan cannot be used to determine the nature and compliance of an operation.

Decision: Denied. Board concluded hearing and denied application for the new package store based on G. L. c. 138, §§ 15A and 23, and Board's Rule 5B.1. Since the alteration of premises application was connected to the § 15 application, for the same reasons and because the alteration would be moot, the hearing on that application was also concluded, and the application denied.

Moreover, or in the alternative, the hearing was concluded, and the applications denied, for the following additional reasons:

- (1) UpperWest's appeals of the denials of the old applications were still pending before the ABCC, and the related administrative processes and appeals were not yet exhausted;
- (2) The new applications did not comply with the ABCC Advisory, the applicants were unable to articulate compliance, and the Board disagreed with the applicants' contentions that they did not need to comply with the ABCC Advisory, or that a

floorplan or their presentation could show how the operation would comply with the ABCC Advisory prior to approval and operation of the business;

- (3) The § 15 application (# 43910) was incomplete, including a failure to provide all documents as required by the Board despite numerous requests to submit them, had some questions on the ABCC application which were not fully answered (i.e. 1, 7 & 10(D)), and the § 15 and alteration of premises applications were untimely and substantially amended on the date of the hearing and less than two hours prior to the hearing, and such amendments did not conform with what was advertised; and
- (4) For all other reasons stated in the Board's Statement of Reasons issued on February 14, 2019 as to the related applications, including but not limited to a lack of public need because there are sufficient other § 15 licenses in the area, and which was incorporated by reference and made a part of the Board's vote.

6. Disciplinary Jet-A-Way Recycling & Waste Disposal, for failure to comply with the Cease and Desist Order of May 20, 2017, by allegedly loading and/or unloading a dumpster on June 12, 2019 at 5:00 a.m. at 1680-1682 Massachusetts Avenue in violation of Cambridge Municipal Code 8.16.080 E. and operating without a license in violation of Cambridge Municipal Code 5.24.010.

Decision: Matter rescheduled to 8/21/19 prior to the hearing.

7. Disciplinary Nicolazzo & Sons Landscape, LLC, for failure to comply with the Cease and Desist Order of December 12, 2018, allegedly operating without a permit in violation of Cambridge Municipal Code 8.16.081.1(1)(b) and 8.16.081.2(c), and allegedly operating on June 19, 2019 at 11:00 a.m. at 14 Craigie Street during a prohibited period in violation of Cambridge Municipal Code 8.16.081.2(a). [Time Stamp: 19:35]

Present: Licensing Investigator, Tyler Bubenik.

Documents Considered: Hearing notice and documents attached thereto.

Summary: Second call was at 4:50 with no one appearing for Nicolazzo & Son. Mr. Bubenik stated that he was on routine patrol on June 19, 2019 and observed an employee of Nicolazzo at 14 Craigie Street operating a leaf blower. Nicolazzo does not have a permit to operate, was operating during a prohibited period, and failed to comply with the Board's order of December 2018.

Decision: Violation for: failure to comply with the Board's order; operating without a permit; and operating during a prohibited period. Issued \$300 fine for each violation for a total of \$900 violation.

8. Disciplinary DMG Food Enterprises, LLC d/b/a 730 Tavern Kitchen + Patio, Common Victualler All Alcohol License #11613, for alleged violation of M. G. L. c. 138, §§ 23 and 64 and Board's Rules 2.3, 2.5, 5.1, and 9 for operating over the licensed capacity on June 12, 2019. **[8:34]**

Present: Licensing Investigator Tyler Bubenik; Attorney Andrew Upton and Davidson Vittero, licensee.

Documents Considered: Hearing notice and documents attached thereto.

Summary: Investigator Bubenik stated that he inspected 730 Tavern on June 12, 2019 during game 7 of the Stanley Cup playoffs. He found that they exceeded their capacity by 24. The staff was very cooperative and reduced the number by 24 to be in compliance with their licensed capacity. Mr. Bubenik reinspected the premise during the City Dance Party and they were in compliance. Licensee did not contest the facts and admitted the private security company hired failed to properly keep count that night. The licensee has hired additional security. This is the first violation since opening.

Decision: Violation, 1 day held in abeyance for 6 months.

9. Disciplinary The Coast Café, LLC, 233 River Street, Alleged Violation of M. G. L. c. 140 and Board's Rules for Operating a Common Victualler without a license in violation of M. G. L. c. 140, § 1, et. seq.; Failure to comply with the License Commission's order of March 18, 2019; and Submitting false information "under the pains and penalties of perjury" on a City Application (ISD Food Handlers Permit). [Time stamp: 27:00]

Present: Anthony Brooks, owner of The Coast Café; Licensing Investigator Tyler Bubenik.

Documents Considered: Hearing notice and documents attached thereto.

Summary: Investigator Bubenik stated that a letter was sent to Mr. Brooks on March 18, 2019, advising him that he needed to apply for a Common Victualler license. He did not do so. Investigation revealed patrons seated in the restaurant and consuming food therein. Mr. Brooks explained his intent was to have a take out only restaurant and was hesitant about applying for a common victualler license because of zoning. He wondered whether stools could be kept on location for patrons to wait while the food is being prepared.

Decision: Violation, The Coast Café, LLC was provided until 7/31/19 to either file an application for a common victualler license or provide in writing its decision to operate as a take-out only establishment. The Coast Café, LLC cannot allow any patron to consume food on its premises unless it obtains a common victualler license.

10. Application #48989 Lesley University, 99-2 Brattle Street, has applied for an Innholder/Lodging House License for 9 rooms with 12 occupants. **[Time Stamp: 33:00]**

Present: Kevin Murphy, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Murphy stated that this is a mixed use building where the lower level and first floor are used by the University for offices, meeting room and storage and the second and third floors are to be used as the dormitory. It was formerly part of the Episcopal Divinity School. The name of the dormitory will be Burnham Hall in the Brattle Campus and consists of a combination of double and single rooms.

Decision: Granted, with the following changes/clarification: d/b/a is Burnham Hall; and premise description will include that the dorm is on the Brattle Campus and has a combination of double and single rooms.

11. Application #48941 Clover Fast Food, Inc., 355 Main Street, Common Victualler Malt License #11496, for a Change of Manager to Robert Christensen. **[Time Stamp: 34:50]**

Present: Robert Christensen, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Christensen is also the manager at 496 Massachusetts Avenue. He has had no issues as manager of record regarding service of alcohol. He provided his TIPS certification. His proof of citizenship needs to be updated.

Decision: Granted, pending submission of proof of citizenship.

12. Application #49416 Club Recreativo Lusitania, Inc., 44 Fifth Street, All Alcohol Club License #11624, for a Change of Manager to Jose DaSilva. **[36;46]**

Present: Jose DaSilva, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. DaSilva has never been manager of record before. He is familiarizing himself with our rules and the laws of the Commonwealth.

Decision: Granted, manager must provide proof of 21 Proof/TIPS Certification.

13. Application #46602 Dunster Street Restaurant Corporation, d/b/a The Hourly Oyster House, 15 Dunster Street, Common Victualler All Alcohol License #11556, has applied for an Alteration of Premise to expand the existing patio by approximately 140 square feet with a total seating for 30. The proposed premise would be: Restaurant with 2 dining rooms, 2 bars, and kitchen on the first floor. Storage in basement. 340 Square foot patio on private property. **[Time Stamp: 38:55]**

Present: Patrick Lee, applicant; Attorney James Rafferty; and Denise Jillson from the Harvard Square Business Association.

Documents Considered: Application and documents attached thereto.

Summary: This is an application to extend the patio which is on private property into the alley next to the building. It is a natural progression of the space. The outdoor area is not visible from the inside. Ms. Jillson spoke in favor of the application.

Decision: Granted with the condition that the area is staffed and supervised by an employee at all times.

14. Application #46600 Grafton, Inc. d/b/a Park Restaurant and Bar, 59 JFK Street, Common Victualler All Alcohol License #11699, for an increase of their patio seating from 16 to 24 on private property. **[Time Stamp: 43:00 and second call at 1:03:06]**

Present: Patrick Lee, applicant; Attorney James Rafferty; and Denise Jillson from the Harvard Square Business Association.

Documents Considered: Application and documents attached thereto.

Summary: This is a request to add 8 seats to the patio on occasion and when they do, the seats will come from the inside capacity of the premises. The total capacity sought is 206. There will not be an increase in overall maximum seating capacity. The square footage is not changing. Ms. Jillson spoke in favor of the application.

Decision: Granted, with the condition that the 8 additional seats are coming from the inside and that the total maximum sitting capacity (inclusive of inside and outside) is 206. The Board will consider a standing room capacity for the outdoor area when the applicant provides a plan with the architect's numbers for the area for both standing and sitting.

15. Klye McKenna, on behalf of Shawmut Construction, holder of Special Noise Variance # 44442, is requesting an extension to the variance until September 25, 2019 with crane hours amended to 12:00 a.m. to 6:00 a.m. [Time Stamp: 46:10]

Present: C.J. Baker on behalf of Shawmut Construction (holder of the noise variance); Tom Lucey, Harvard; Patrick Lee, owner of abutting restaurant and Denise Jillson from the Harvard Square Business Association.

Documents Considered: Application and documents attached thereto, and correspondence submitted regarding the noise variance.

Summary: Mr. Lee stated that he sees no reason to change the hours as it already has a serious impact on local businesses. He said that there is still very poor communication from Harvard. The applicant explained that the extra hour will allow the construction schedule to reduce. The setting and breakdown of the crane is an hour each, so the extra hour allows for more use to the crane. To date the crane pick has not caused any negative impact on the operation of the abutting businesses. There was discussion on adding one additional hour in the morning since most businesses in the area do not open at 6:00 a.m. Ms. Jillson stated the barber shop may be the only business that may be impacted by an extension in the morning hours. Mr. Baker, Tom Lucey and Mr. Lee are to submit an email to Chief Licensing Investigator Boyer by August 2, 2019 with any issues. Depending on the content of the emails and Chief Boyer's investigation into the matter, if necessary, the Board will reconsider amending the conditions and reducing the crane hours during its August 21, 2019 hearing.

Decision: Granted through 9/25/19, with the same conditions as previously established with the exception that the crane hours will be 1:00 a.m. to 7:00 a.m.

16. Application #48562 Mothership Alewife, LLC d/b/a Mothership, 125 Cambridgepark Drive, has applied for a new Common Victualler All Alcohol License. The proposed hours of operation are 10:00 a.m. to 12:00 a.m. all days with seating for 115 inside, total occupancy of 140, 60 seats outside on private property, and total outside occupancy of 90. Steven Postal as Proposed Manager of Record of a premise described as: Approximately 2,500 square foot Restaurant with dining room, bar, two entrances, one exit, and approximately 1,500 square feet seasonal outdoor dining on terrace and patio, located on private property. **[Time Stamp: 1:07:00]**

Present: Steven Postal, applicant; and Attorney James Rafferty.

Documents Considered: Application and documents attached thereto.

Summary: This is in the same building as the Revival Café, but it is a different premise. There has been a significant increase in residential population in the area and a need to activate the area with more businesses, including ones that can provide food and beverages. The menu will be "eclectic" and changing every week. There will be a flip from the lunch concept to the nighttime concept, which will be more centered on food for sharing. The kitchen from Revival will service both Revival and Mothership. The applicant was also requesting background music at or below conversation level and three televisions in the inside. Ms. Jillson spoke in favor of the application.

Decision: Granted, including the request for entertainment of background music and 3 televisions. Manager must provide proof of 21 Proof/TIPS Certification.

17. Application #46117 Yoki Express-Porter, LLC d/b/a Yoki Express, 1876 Massachusetts Avenue, for a new Common Victualler License with proposed hours of 11:00 a.m. to 9:00 p.m. Monday through Friday and 12:00 p.m. to 9:00 p.m. on Saturday and Sunday, seating for 45, a total occupancy of 50, and an Entertainment License for background music and four (4) TV's, to be used mostly as digital menus. Nick Tran as proposed manager of record of a premise described as: 2,000 sq. ft. on the first floor (ground level) and about 1,300 sq. ft. in the basement. Storage on first floor and basement. The business will have speakers and televisions throughout to provide background music. **[Time stamp: 1:18:50 and 1:51:00]**

Decision: No action, applicant did not appear (first call at 4:20 p.m., second call at 5:00 p.m.).

18. Application #30823 Mark Roderick d/b/a Harvard B&B, 50 Irving Street, has applied for an Innholder License for 24 rooms and 50 occupants. **[Time Stamp: 1:19:30]**

Present: Mark Roderick, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Rodercik bought the building but submitted his application prior to getting possession of the building. His intent is to run the business as the previous lodging house. However, it was unclear from the presentation whether Mr. Roderick was applying for the correct license. He stated that there will not be any changes to the current use.

Decision: Deferred to 7/31/19. The applicant will meet with Executive Director Lint to ensure that he has applied for the appropriate license and to ensure that all information is accurate. Licensing Investigator will inspect the premises and confirm the occupancy count. The applicant will be informed as to whether he has to appear at the 7/31/19 hearing.

19. Application #46989 Lin Empire, Inc. d/b/a House of Chang, 282 Concord Avenue, holder of a Common Victualler License #12281, has applied to add Wine & Malt to said Common Victualler License. The hours of operation are to remain 11:30 a.m. to 10:30 p.m. all days and with seating for 50. Jason Lin as Proposed Manager of Record of a premise described as: Approximately 2,000 square feet. Kitchen, two restrooms, dining room and service counter on the first floor. Two restrooms on the second floor. One entrance and two exits. **[Time Stamp: 1:26:45]**

Present: Attorney Meihuei Hu; and Jason Lin and Jenny Wong, applicants.

Documents Considered: Application and documents attached thereto.

Summary: The applicants have been operating since 2015 with no incidents. The location, when they purchased it, had a wine and malt license but the applicants did not want to deal with the "headaches" of alcohol at the time. The patrons continue to request the alcohol and also the applicants wish to provide a more complete service to their customers. There will not be any other changes to the operation.

Decision: Granted with a maximum seating capacity of 48 per zoning.

20. Application #49778 The Veggie Grill, Inc. d/b/a The Veggie Grill, 57 JFK Street, has applied for a new Common Victualler Wine & Malt License. The proposed hours of operation are 11:00 a.m. to 11:00 p.m. all days with seating for 52, and a total occupancy of 59. Rodrigo De Barros as Proposed Manager of Record of a premise described as: Approximately 2,339 square foot retail restaurant space with 8 rooms on first floor consisting of dining areas, bar, kitchen, walk-in coolers, storage rooms, self-order kiosk, and restrooms; one room with public access; two entrances and exits. **[Time Stamp: 1:30:20]**

Present: Attorney Andrew Upton; and Rodrigo De Barros, applicant.

Documents Considered: Application and documents attached thereto.

Summary: This space was previously home to Wagamama, which had a wine and malt license. The applicant has 36 locations across the US, 33 of which are in California. This is a vegan concept and

the menu is 100% plant-based protein. Their concept is a dining experience that is unique and requires wine and malt which pairs well with the food and their customers request it. They have received a special permit for takeout. Mr. De Barros has been manager of record before. The Board noted that although not an issue based on what the applicant has requested, the space is limited to a maximum of 60 seats per zoning.

Decision: Granted with the condition that less than 20% is take-out, and manager must provide proof of TIPS/21 Proof Certification.

21. Application #46097 Chazumba, LLC d/b/a Felipe's Taqueria, 21 Brattle Street, Common Victualler All Alcohol License #11516, has applied for an Alteration of Premise to expand the existing roof deck patio by approximately 1,800 square feet with a total seating for 144 and total occupancy of 259. The proposed premise would be: Food preparation and storage in basement; approx. 2,350 square foot first floor cooking and seating. Approximately 700 square foot mezzanine seating, approximately 2,850 square foot roof deck and 100 square foot seasonal outside patio on the city sidewalk.

Decision: Matter to be rescheduled – new hearing date unknown.

Decision: Granted with amended hours of 4:00 p.m. - 7:00 p.m. per Block Party Permit.

Application # 48449 Cory Shea has applied for a malt and wine with entertainment license to be exercised at Maud Morgan Arts 20 Sacramento Street, on 8/1/19 (rain date 8/8/19) from 6:00 p.m. – 9:30 p.m. for an exhibition reception and community celebration with live music. Expected attendance – 75 people.

Decision: Granted.

34. Application # 49964 Eileen Milligan, on behalf of MIT, has applied for a malt and wine license to be exercised at MIT Museum, 265 Massachusetts Avenue, on 9/20/19 from 6:00 p.m. – 7:30 p.m. for a networking social. Expected attendance – 60 people.

Decision: Granted.

35. Application #50220 Kelly Houten, on behalf of RaceWire, has applied for a malt with entertainment license to be exercised at 62 Pacific Street, on 10/28/19 from 7:00 a.m. – 12:00 p.m. for a 5k fun run with recorded music, dj and amplification system. Expected attendance – 600 people.

Summary: The event is actually on 10/27/19.

Decision: Granted for 10/27/19, and with the following conditions: (1) there must be a limited number (2) of alcoholic drinks associated with the registration price, otherwise/thereafter, the alcohol must be sold; (2) non-registrants must pay for alcohol; (3) no alcohol service prior to 8:00 a.m.; (4) must implement a system to identify minors from adults in attendance; and (5) police detail required.
