#### **Public Testimony Matters**

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Application Juldex Guerrier, for a new Cambridge Hackney Driver's License. [Time Stamp: 01.00]

Present: Juldex Guerrier.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Mr. Guerrier stated that he previously drove a taxi in Revere with no incidents. His Massachusetts driver's license was suspended in 2015 for failure to pay a violation for a stop sign, but it is now active. He is currently looking for a job as a driver.

**Decision:** Granted.

2. Application Mosseye Alemaw, for a new Cambridge Hackney Driver's License. [Time Stamp: 1:23:40]

Present: Mosseye Alemaw.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Mr. Alemaw stated that he has not driven a taxi before. He is looking for a job as a driver. His driver's license has never been suspended.

3. Application Gezahegn Tegegn, for a new Cambridge Hackney Driver's License.

**Decision:** No show at second call. No action. Make sure he will appear before rescheduling.

4. Application Ewinetu Bogal, for a new Cambridge Hackney Driver's License. [Time Stamp: 1:25:23]

Present: Ewinetu Bogal

**Documents Considered:** Application and documents attached thereto.

**Summary:** Mr. Bogal stated that he has never driven a taxi before and is looking for a job. His driver's license has never been suspended.

Decision: Granted.

- 5. Disciplinary Verizon, Inc., 10 Ware Street, for alleged violation of Cambridge Municipal Code (CMC) 8.16.060.
- 6. Application #31871 Continued from June 12, 2019. Verizon, Inc.'s request to further extend/amend Special Noise Variance at 10 Ware Street, to test the generator on August 27, 2019, September 27, 2019 and October 25, 2019, per FCC regulation. Also, to test while implementing sound attenuation baffling to be in compliance with Cambridge Municipal Code (CMC) 8.16.060(E).

**Present:** Johanna Schneider, attorney for Verizon; and Chief Licensing Investigator Andrea Boyer.

**Documents Considered:** Hearing notice and documents attached thereto; current Special Noise Variance; and file.

**Summary:** Verizon is seeking a 90 day extension of the noise variance as they are still working to buffer the sound. However, the last test run showed they were still just above the limit allowed by ordinance. They have been told that if they install a muffler on the exhaust stack of the generator they should be in compliance. They are seeking three additional test dates of August 27, September 27 and October 25. They will provide notice to the neighborhood and test results to Ms. Boyer. Verizon is committed to fixing the problem. When the generator was too loud you couldn't hear the stack.

**Decision:** Continued through October 25, 2019 with the understanding that violation will be resolved by then and the noise violation case would be moot. The case will be closed if noise is ameliorated. Extension granted to October 25, 2019 with the same conditions as originally placed. New special noise variance fee to be paid.

- 7. Disciplinary Loyal Nine, LLC d/b/a Loyal Nine, 660 Cambridge Street, Common Victualler All Alcohol License #11514, for alleged violations of failing to comply with the Crowd Control Manager requirements on July 26, 2019, in violation of 527 C.M.R. 1.00, §§ 20.1.5.6.1 20.1.5.8.4, M. G. L. c. 138, §§ 23 and 64, and Board's Rules 2.3, 2.5, 5.1, 5.7, 8.3, 9.3, 9.4, and 14 and for being over capacity on July 26, 2019, in violation of M. G. L. c. 138, §§ 23 and 64, and Board's Rules 2.2, 2.3, 2.5, 2.7, 5.1 and 9.
- 8. Application #53129 Loyal Nine, LLC d/b/a Loyal Nine, 660 Cambridge Street, Common Victualler All Alcohol License #11514, for a Change of Opening Hour from 8:00 a.m. to 7:00 a.m. Monday through Friday, and an increase of the patio occupancy from 35 to 65.

Present: Licensing Investigator Tyler Bubenik; and Daniel Myers, owner.

**Documents Considered:** Hearing notice and documents attached thereto; documents submitted at the hearing; and file.

**Summary:** During a routine task force investigation on July 26, 2019 Investigator Bubenik visited Loyal Nine and found several violations. They could not find the crowd control manager certification, the paperwork had not been filled out every day, and there were 58 patrons on the back patio, which is licensed for 32. In addition, there were 42 seats on the patio and there should only have been 32.

Mr. Myers was on site that evening. There was also a certified crowd control manager on duty but was unable to produce her certificate. Her certification was submitted at the hearing showing that she was certified on the date of the inspection. There are now 16 certified crowd control managers on staff. Mr. Myers stated further that there is now a checklist that must be filled out every day. That evening there was a group of 10 celebrating after a wedding. The group grew. The patio is quite large, and they only use half of it. This is why they are also applying to increase the occupancy of the patio. They are not increasing the total occupancy of 160 but are redistributing it. The establishment was under the total capacity that evening, which was confirmed by Investigator Bubenik. Guests were immediately brought inside. As to the change in hours the need is to provide food to the business crowd during the weekdays.

**Decision:** Board found (3-0) a violation and issued (2-1) a 1 day license suspension to be held in abeyance for 6 months (Commissioner Bard dissented and voted to issue a warning). Board granted increase of occupancy on the patio for 50 seats on the patio and a maximum occupancy of 65 on the patio. Total seats can never exceed 160, inside and outside. Break in fence in outdoor area must be repaired. Change in hours also approved for food hours only Monday through Friday.

9. Disciplinary A.A. Flori Realty Trust, 64 Dudley Street, Open Air Parking Lot License #14215, for failure to respond to License Commission correspondence of April 25, 2019, and parking more than 9 vehicles on the lot. [Time Stamp: 25:45]

**Present:** No one appeared for the licensee; Investigator Tyler Bubenik.

**Documents Considered:** Hearing notice and documents attached thereto; file; and pictures taken by Investigator Bubenik.

**Summary:** The licensee is currently licensed for 9 parking spaces. Traffic, Parking and Transportation Department informed the License Commission that they have the lot registered for 24 spaces. The licensee failed to respond to inquiries on the discrepancy and Investigator Bubenik's investigation showed more than 9 parking spaces on the lot. There was no confirmation that the licensee received the notification of the hearing.

**Decision:** Board voted to have the Executive Director send a letter via certified mail return receipt requested to license holder scheduling a meeting to discuss the issue. If the license holder does not show up, the license may be revoked.

10. Disciplinary Jet-A-Way Recycling & Waste Disposal, for failure to comply with the Cease and Desist Order of May 20, 2017, by allegedly loading and/or unloading a dumpster on June 12, 2019 at 5:00 a.m. and July 3, 2019 at 3:40 a.m. at 1680-1682 Massachusetts Avenue in violation of Cambridge Municipal Code 8.16.080 E. and operating without a license in violation of Cambridge Municipal Code 5.24.010. [Time Stamp: 26:25]

**Present:** Attorney Ronald Dunbar; Pat Sperduto, CEO; Helen Solorzano, complainant; and Chief Licensing Investigator Andrea Boyer.

**Documents Considered:** Hearing notice and documents attached thereto; and documents submitted at the hearing.

Summary: Chief Boyer testified that on June 12 and July 3, 2019 a pick up occurred behind 1680 – 1682 Massachusetts Avenue, one at 5:00 a.m. and one at 3:40 a.m. Their license had been cancelled in 2013. A cease and desist was sent in 2017, along with information as to how to get permitted. A resident, Helen Solorzano said that there was another pickup this day at 4:00 AM. The Massachusetts Avenue location is a commercial zone but the pickup is happening in a residential zone. The trucks drive down Bowdoin Street and exit onto Hudson. Attorney Dunbar said the cease and desist was issued to Atkinson Whitworth. Mr. Sperduto purchased their assets in August 2018 and was not aware of the cease and desist. In April 2019 Mr. Sperduto purchased the assets of Barry Brothers and took over their routes. They were not aware they needed a license to pick up in Cambridge. They have reviewed the ordinance and all drivers will be prohibited from picking up before 7:00 a.m. They will be installing GPS in each truck to be able to control the pickups. They will be submitting an application for the license.

**Decision:** No violation for the cease and desist. Violation for June 12 and July 3 pickups and for failure to obtain a license. Warning for failure to obtain a license, and \$300.00 fine for each of the 2 pickups for a total fine of \$600.00.

11. Disciplinary Nicolazzo & Sons Landscape, LLC, for failure to comply with the Cease and Desist Order of December 12, 2018, allegedly operating without a permit in violation of Cambridge Municipal Code 8.16.081.1(1)(b) and 8.16.081.2(c), and allegedly operating on June 19, 2019 at 11:00 a.m. at 14 Craigie Street during a prohibited period in violation of Cambridge Municipal Code 8.16.081.2(a). [Time Stamp: 38.17; ]

Present: Investigator Tyler Bubenik; no one for Nicolazzo & Sons.

**Documents Considered:** Hearing notice and documents attached thereto; and file.

**Summary:** Company used to be permitted to operate leaf blowers in Cambridge. Due to the various violations in 2018, the Board voted not to automatically renew the permit and have the company present its application to the Board. The company failed to submit a renewal and were found operating in Cambridge without a permit and during a prohibited period.

**Decision:** Violation for operating without a permit and during a prohibited period, issued a \$300.00 fine for each violation for a total \$600.00 fine. Letter to be sent to customers letting them know they are using a company which is not permitted.

12. Application #50551 Interstate Management Co., LLC d/b/a The Charles Hotel, 1 Bennett Street, All Alcohol Innholder License #10894, for an Increase of Capacity/Occupancy of Noir to 43 seats inside, an inside occupancy of 68, and 24 patio seats on private property. [Time Stamp:38:50]

Present: Attorney James Rafferty; and Alex Attia, hotel manager.

**Documents Considered:** Application and documents attached thereto.

**Summary:** They are only adding 1 seat to the inside capacity and 15 standing in Noir. Patio capacity is remaining the same. There are no other changes.

**Decision:** Granted -43 seats inside, 25 standing inside (the 24 patio seats they already had are remaining the same).

13. Application #51506 Grafton, Inc. d/b/a Park Restaurant and Bar, 59 JFK Street, Common Victualler All Alcohol License #11699, to amend the Entertainment License to include a DJ. [Time Stamp: 39:48]

Present: Patrick Lee, owner; and Attorney James Rafferty.

Documents Considered: Application and documents attached thereto; and file.

**Summary:** This application is to add a DJ to the existing license. The licensee had been previously approved and operating DJ entertainment. By request of the licensee, in November 2017 the DJ was removed as an entertainment category from their license. The licensee has found that it needs the DJ entertainment to service their customers.

Decision: Granted.

14. Application #53343 Harvard Square BBQ Co., LLC d/b/a Smoke Shop, 8 Holyoke Street, has applied for a Common Victualler All Alcohol License. The proposed hours of operation are 10:00 a.m. to 2:00 a.m. all days with seating for 137 inside, and a total occupancy of 162. Andrew Husbands as Proposed Manager of Record of a premise described as: Approx. 5,100 sq. ft. First floor consists of dining, kitchen, storage and bar. Lower level consists of dining, kitchen, storage, and restrooms. [Time Stamp: 42:48]

**Present:** Attorney James Rafferty; Andrew Husbands and Brian Lesser, applicants; Denise Jillson, Harvard Square Business Association.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The restaurant will be going in to the En Boca space and it will be the same operation as the other Smoke Shop restaurants by this group. It is a unique concept for the Harvard Square area. The occupancy and existing floor plan will remain the same. There is a long history of licenses in this location. Opening at 10:00 a.m. on weekends gives them the option to serve brunch and will open at 11:00 a.m. on weekdays. They also applied for 10 televisions in the bar area. The 137 seats inside are the maximum allowed per zoning. Denise Jillson spoke in favor of the application.

**Decision:** Granted with amended hours of 10 a.m. to 2 a.m. weekends and 11 a.m. to 2 a.m. weekdays. 10 t.v.'s also approved. Seats are limited to 137 per zoning.

15. Application #52757 Transfer of the Wine & Malt Package Store License held by Fresh Pond Market Co., d/b/a Fresh Pond Market, 358 Huron Avenue, to FP Market, LLC d/b/a Formaggio Kitchen, at the same address. Valerie Gurdal as Proposed Manager of Record of a premise described as: Ground floor retail food store selling beer and wine, containing approximately 4,000 sf with one exit and one entrance. [Time Stamp: 49:38]

Present: Valerie and Ihsan Gurdal, applicants; and Attorney James Rafferty.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The Gurdals have alcohol licenses at their other locations. The owner of Fresh Pond Market looked for a buyer that would keep the operation of the market as currently exists. There is no pledge of license. The hours of operation are staying the same.

**Decision:** No action – matter continued prior to hearing for applicant's failure to notify abutters.

17. Application # 51900 Sweetcream Foods, Inc. d/b/a Café Luna, 612 Main Street, Common Victualler Wine, Malt and Cordials License #11602, for Pledge of License to Stoneham Bank. [Time Stamp: 54:16]

Present: Matthew Haymer, owner.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The pledge was required by the bank when he went from a line of credit to a fixed loan. There are no other changes.

Decision: Granted.

18. Application # 53160 Highgate Hotels, LP d/b/a Courtyard Boston Cambridge, 777 Memorial Drive, All Alcohol innholder License #10744, for a Change of Manager to Mohamed Hashesh. [Time Stamp: 56:45]

**Summary:** Mr. Hasesh was manager of record in North Carolina. He has significant experience in the industry.

**Decision:** Granted.

Application #46117 Yoki Express-Porter, LLC d/b/a Yoki Express, 1876 Massachusetts Avenue, for a new Common Victualler License with proposed hours of 11:00 a.m. to 9:00 p.m. Monday through Friday and 12:00 p.m. to 9:00 p.m. on Saturday and Sunday, seating for 45, total occupancy of 50, and an Entertainment License for background music and four (4) TV's, to be used mostly as digital menus. Nick Tran as proposed manager of record of a premise described as: 2,000 sq. ft. on the first floor (ground level) and about 1,300 sq. ft. in the basement. Storage on first floor and basement. **Summary:** The restaurant concept is similar to Poke Works – poke bowls and sushi. He already has a location in the Seaport, and he wants to expand to Cambridge. He received BZA approval to operate as fast food.

Decision: Granted.

20. Application #46097 Chazumba, LLC d/b/a Felipe's Taqueria, 21 Brattle Street, Common Victualler All Alcohol License, has applied for an Alteration of Premise to expand the existing roof deck patio by approximately 1,800 square feet with a total seating of 144 and total occupancy of 259. The proposed premise would be: Food preparation and storage in basement; approx. 2,350 square foot first floor cooking and seating. Approximately 700 square foot mezzanine seating, approximately 3,067 square foot roof deck and 100 square foot seasonal outside patio on the city sidewalk. Applicant is also applying for additional Entertainment to include: recorded music above conversation level; live music with amplification; dancing by patrons; and DJ. [Time Stamp: 1:00:15]

**Present:** Tom Brush, manager of record and principal owner; Attorney Kevin Crane; and Denise Jillson, Harvard Square Business Association.

**Documents Considered:** Application and documents attached thereto; documents submitted by applicant at the hearing.

**Summary:** When the space next door vacated, Mr. Brush had the opportunity to expand the roof deck area. The plans were approved by zoning and a new plan signed by the Commissioner of Inspectional Services was provided at the hearing. The applicant also submitted a matrix of the capacity for the entire licensed premises. The maximum occupancy (seating and standing) on the roof deck will be 259. The applicant is seeking to add dancing to the entertainment categories because even though there is no dance floor, he can foresee patrons wanting to dance in place. Although they were not required to do so, they added an additional outdoor stairwell to make egress from the roof deck easier in case of an emergency. They also applied to have the alcohol closing hour (1:00 a.m.) match the food closing hour (2:00 a.m.) to provide more options to the patrons. Denise Jillson spoke in favor of the application in its entirety.

**Decision:** Granted with the capacity as listed on the matrix submitted; also granted entertainment categories; and the 2 a.m. closing hour for alcohol on all days.

21. Application #49620 Hult International Business School, Inc., 10 North Point Boulevard, has applied for a Lodging House License for 292 rooms with 500 occupants. Applicant also has dining space with inside seating for 231, a total occupancy of 257, outside seating for 75, and an outside occupancy of 80.

22. Application #52145 Hult International Business School, Inc., 10 Education Circle, has applied for a Common Victualler License and Entertainment License to include: recorded music above conversation level without amplification; dancing by patrons; live music without amplification; DJ; karaoke; trivia; and 3 TV's. The proposed premise is: Lobby- coffee bar with 35 inside seats, 41 occupancy, and 30 patio seats on private property. Clubhouse- 4th floor student dining café with 196 inside seats, 216 occupancy, 75 outdoor patio terrace seats, with a total occupancy of 80.

**Present:** Attorney Richard Rudman; Attorney Oriana Montani; Jessica Zubart, SVP; and Ben Kolnos, assistant director of dining services.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The address is now 10 Education Circle and the D/B/A for the lodging hosue is Hult House. The hours of both dining areas are 8a.m.-11p.m. There are two dining spaces in the building – the d/b/a for the one on the fourth floor is the Clubhouse, the one on the first floor is 1969. The fourth floor dining space is a cafeteria with a patio that is not open to the public and is only for Hult students and personnel. On the ground floor there is a gulf stream trailer parked in the lobby serving coffee and light food and is open to the public and also has outdoor space.

**Decision:** Granted as to both applications with the following amendments: d/b/a for lodging house is Hult House; d/b/a for 4<sup>th</sup> floor dining space Clubhouse Café; d/b/a for first-floor cafe is 1969; and hours for both dining spaces are 8:00 a.m. to 11:00 p.m.

23. Application #53474 The Veggie Grill, Inc. d/b/a The Veggie Grill, 57 JFK Street, Common Victualler Wine & Malt License (pending approval), has applied for a Change of Manager to Jivar Vatandoust. [1:16:25]

Present: Jivar Vatandoust; and Attorney Joe Devlin.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The application is currently pending at the ABCC. Jivar Vatandoust just moved to Massachusetts and will reside in Massachusetts. He has worked for the entity in another location and has experience with the proper service of alcohol.

Decision: Granted.

24. Application #19063 Fort Point Investments, LLC d/b/a Atmark, 80 Fawcett Street, has applied for a new Garage and/or Flammables License for 250 parking spaces, 2500 gallons of gasoline in the tanks of automobiles, and 20 gallons of Class I. [Time Stamp: 1:21:15]

**Present:** Denis Foster.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This is an existing building and garage. The garage is for tenants, for a fee. The 20 gallons is for snow blowing equipment. The flammables are not for direct consumption.

**Decision:** Granted pending payment of outstanding fee of \$75.00.

#### **Administrative Matters**

All the below listed matters are considered and voted upon by the Board without public testimony. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda. [Time Stamp: 1:39:40]

25. La Fabrica Central, LLC d/b/a La Fabrica, 450 Massachusetts Avenue, Common Victualler All Alcohol License #11595, has filed an appeal to the Alcoholic Beverages Control Commission of the two days suspension issued to it on May 22, 2019, for the matter heard on April 24, 2019. La Fabrica has also requested a stay of the 2-days suspension until the appeal is resolved.

**Documents Considered:** Attorney Kelley's correspondence.

**Summary:** The Board disagreed with the Attorney Kelley's interpretation of G. L. c. 138, § 64 and the case law regarding stays of suspension. Stays are not automatic once an appeal with the ABCC is filed and the Board is entitled to deny a request for a stay on a suspension. Notwithstanding, the Board considered that the stay would be appropriate since the appeal is based on the finding of the violation as well as the discipline issued.

**Decision:** Suspension stayed pending resolution of the appeal.

26. Middle East Restaurant, Inc. d/b/a Middle East Restaurant/Zuzu/Sonia's ("Middle East"), 472 Massachusetts Avenue, Common Victualler All Alcohol License #11691, has filed an appeal to the Alcoholic Beverages Control Commission of the four days suspension issued to it on May 22, 2019, for the matter heard on March 27, 2019. Middle East has also requested a stay of the 4-days suspension until the appeal is resolved.

**Documents Considered:** Attorney Barrett's correspondence.

Summary: Licensee is appealing the findings of the violations as well as the discipline issued.

**Decision:** Suspension stayed pending resolution of the appeal.

30. Application #53019 Mark Johnson, on behalf of the President and Fellows of Harvard College, d/b/a The Harvard Film Archives, 24 Quincy Street, Annual Entertainment License #10989, has applied for a one-day extension of their current closing hour of 11:00 p.m. to 8:00 a.m. on August 31, 2019 into September 1, 2019 for a special all-night film series.

**Decision:** Granted.

31. Reconsideration Application #31133 Consideration of resubmission and affirmation of Board's approval of Improvisation Center of Boston, Inc., 40 Prospect Street, Common Victualler All Alcohol License #11264, change of license type, change of manager and change of officers and directors. The Board will have to consider whether to administratively approve the updated officers and directors which changed after the Board's approval of February 13, 2019 and during Alcoholic Beverages Control Commission's review of the application. [Correction to the agenda, this is a malt and wine only license]

**Summary:** This is a malt and wine license only, and no changes to the type of alcohol served were made or requested.
