Public Testimony Matters

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1) Application #52551 Stoked Pizza Cambridge, LLC, d/b/a Stoked Pizza Co., 1611 Massachusetts Avenue, has applied for a new Common Victualler All Alcohol Beverages License. The proposed hours of operation are 11:00 a.m. to 11:00 p.m. Monday through Saturday and 12:00 p.m. to 11:00 p.m. Sunday with seating for 88 inside, and 32 seats outside on a private property. Toirm Miller as Proposed Manager of Record of a premise described as: Restaurant consisting of approx. 2,375 square feet located on first floor of building, including dining room, bar, three (3) restrooms, kitchen, storage, one (1) entrance, three (3) means of egress, seasonal outdoor patio on private property. Entertainment to include background music only. [Time Stamp: 01:50]

Present: Attorney Adam Barnosky; Toirm Miller and Doug McGregor, applicants; Denise Jillson, Harvard Square Business Association; Eric Quadrino, business owner; and Peter Boden-Friedman, resident.

Documents Considered: Application and documents attached thereto; and correspondence received in support of application.

Summary: This location went through a large scale rezoning in 2016 through 2017. The building is owned by Harvard and near Harvard Law School. This would be the only retail space on the bottom floor of the building, the upper floors are offices for Harvard. The business will help reactivate the area. The applicants have another location in Brookline. They have had no issues there or with the ABCC. In

this location they will be using electric ovens, not wood burning. The menu will be primarily pizza but will have a diverse operation and other options. The concept arises out of their food truck. The space is an empty shell at this time and the applicants expect a Spring 2020 opening. Eric Quadrino and Denise Jillson spoke in favor of the application. Peter Boden-Friedman also spoke in favor of the application but has concerns about noise on the corner. The applicant explained there would be no open windows. The operation is a sit-down concept, no selling of slices, and the outdoor patio is on the sidewalk towards the street (not the residences in the back) with a sit-down server-oriented operation. The entry to the building is towards the center of the building, away from Everett Street.

Decision: Granted.

2) Application #53290 RichGrahams, LLC d/b/a Richards, 1193 Cambridge Street, has applied for a new Common Victualler Wine, Malt, and Cordials/Liqueurs License. The proposed hours of operation are 5:00 p.m. to 10:00 p.m. Tuesday through Thursday and 5:00 p.m. to 10:30 p.m. Friday and Saturday with seating for 40 and an occupancy of 46. Richard Graham III as Proposed Manager of Record of a premise described as: 2800 square feet. The space is 1.5 levels, dining room and bar on the first level and a waiting area up 3 steps behind it. Through the front door there is a small entry-way, with a second door opening into the dining area. Kitchen is semi- open behind the bar and is only accessible through the bar. The waiting area is on the split level of the restaurant space. There are two bathrooms, a dry storage room and a walk-in cooler. Back hallway leading to cellar and rear exit. [Time Stamp: 13:06]

Present: Richard Graham III and Sarah Graham, applicants; Chief Licensing Investigator Andrea Boyer; Jean Graham; Ilger Cakuli; and Dequan Wu.

Documents Considered: Application and documents attached thereto; and correspondence received in support of application.

Summary: This location was previously a restaurant space. It will be an American style, which basically will offer and cook any type of food that came into America. It is a full service restaurant with 34 seats and 6 seats at a bar. They will be closed Sunday and Monday and will have background music only, although may consider adding some live entertainment in the future. The Board pointed out that the applicant may need a variance for live entertainment. Jean Graham and Ilger Cakuli spoke in favor of the application. Dequan Wu spoke in opposition to the application. He stated that he owns the other half of the building and is concerned about noise from a bar. Ms. Graham stated that it will be "food first" and that the bar is secondary. Investigator Boyer stated that the only history of noise at this location was due to a vent, which has been replaced.

Decision: Granted.

3) Application #50668 SUZEQ, LLC d/b/a Mexcito, 350 Kendall Street, has applied for a new Common Victualler Wine, Malt, and Cordials/Liqueurs License. The proposed hours of operation are 11:00 a.m. to 1:00 a.m. all days with no inside seating, and 19 seats outside, an outside occupancy of 21, on a private property. David Zimel as Proposed Manager of Record of a premise described as: 222 sq. ft.

pass through window service. Seasonal outdoor patio seating. No indoor seating. Small service kitchen no cooking on premises. [Time Stamp: 22:10]

Present: David Zimel and Eric Quadrino, applicants; Kimberly Courtney; and Xavier Dietrich.

Documents Considered: Application and documents attached thereto.

Summary: The establishment is currently owned by the applicants as a commissary with a window for take-out. The applicants seek to expand the operation by adding a patio in the summer months only for food and alcohol service. There would be continuous planters around the space with full time staff assigned to the patio, as well as owner presence. Food would be picked up and taken to the patio, but alcohol would be delivered. There would be no alcohol service in the winter. There was much consideration given to the patio and the original plan was reduced from 24 to 19 to be able to enclose it and control it. Kim Courtney spoke against the application based on the license type being applied for and for alleged lack of public need. Xavier Dietrich spoke in opposition to the application for alleged lack of public need. The applicants reiterated they have been in the area over 11 years and have seen the boom in population and density which continues to explode in this area. In addition, there is no other restaurant in the immediate area like theirs.

Decision: Vote deferred to September 24, 2019 while the Board considers the application as filed and/or determines if this operation qualifies as a seasonal license and whether that type of license can be issued.

4) Application #52649 President and Fellows of Harvard College, 64 Linnaean Street, has applied for a Lodging House License for 10 rooms with 10 occupants. [Time Stamp: 32:50]

Present: Alexandra Offiong and Anthony Pucillo, applicants.

Documents Considered: Application and documents attached thereto.

Summary: The name for this lodging house is Currier House Entry Building and has 10 single rooms on the second floor for undergraduate students. It is a small piece of the larger Currier House.

Decision: Granted.

Thomas Whalen as proposed manager of record of a premise described as: 1,400 sq. ft. rectangular ground floor premises with 800 sq. ft. 2nd floor mezzanine. Ground floor is open room with kitchen in front of premises, storage in rear, main entrance/exit facing street with rear emergency exit. 2nd Floor Mezzanine has seating only. Background music from iPod playlist through small speakers in ceiling. [Time Stamp: 37:11]

Present: Harry Nathan Kalyan, General Counsel for the applicant.

Summary: Bluestone is an Australian style French café with a full menu. The company is based in New York. There are 24 locations in New York, 20 in California, 5 will be opening in Boston, others across the country, and this would be the first one in Cambridge. They will be occupying the ground floor and mezzanine. They are not applying for alcohol at this time as it is the company's practice to become a member of the community first prior to applying for/implementing alcohol. They are aiming for a November 2019 opening.

Decision: Granted.

7) Application #50491 Transfer of the Common Victualler Wine & Malt License #11538 held by Shanghai Fresh, Inc. d/b/a Shanghai Fresh, 735 Massachusetts Avenue, to 18 Fresh, Inc. d/b/a Shanghai Fresh, at the same location. The proposed hours of operation are 11:00 a.m. to 11:00 p.m. Monday through Thursday, 11:00 a.m. to 11:30 p.m. Friday and Saturday, and 11:00 a.m. to 10:00 p.m. Sunday with seating for 45, occupancy of 48, and 20 seats outside on the public sidewalk. Mimy Wang as Proposed Manager of Record of a premise described as: Ground level restaurant with patio outside (food only). Entrance through Mass. Ave. Another exit at the back of the building. Kitchen located towards the back of the premise. Basement has storage and prep room. [Time Stamp: 41:55]

Present: Mimy Wang, applicant.

Summary: An email complaint was received stating that very loud leaf blowers were observed at 36-38 Carver Street on July 31, 2019 at 11:45 a.m. Mr. Fetherston stated that he was not there but does not deny the blower was used during a prohibited period. He contacted the crews and told them to cease and desist the use of leaf blowers in Cambridge. The company was also noticed for operating without a permit. The company had been applying for and receiving permits since 2016. The company has applied to renew the permit, but the process is not yet completed.

Decision: Violations for operating without a permit and operating leaf blowers during a prohibited period. Board issued a warning for operating without a permit, and a \$300.00 fine for operating during a prohibited period.

13) Disciplinary Casablanca Services Leaf Blower Permit #10727, for allegedly operating during a prohibited period and during a prohibited time. Specifically, it is alleged that employees used leaf blowers on Saturday, June 28, 2019 from 8:05 a.m. to 8:30 a.m. at 1010 Memorial Drive in violation of Cambridge Municipal Code 8.16.081.2(a) & (b). [Time Stamp: 48:26]

Present: Chief Licensing Investigator Andrea Boyer; and Yacine Ibrahimi, Casablanca Services representative.

Summary: A complaint was received through See Click Fix stating that Casablanca Services was operating leaf blowers on June 28, 2019 at 1010 Memorial Drive, at 8:05 a.m. Saturday work cannot start until 9 a.m. Mr. Ibrahimi stated that they have a new crew. The property manager asked them to clear debris and they did not know they could not use the leaf blowers. They only have two properties in Cambridge and have never had a violation.

Decision: Board voted to find a violation (3-0) and issued a warning (2-1) (dissent: Chair Murati Ferrer voted to issue a fine and hold it in abeyance).

Specifically, it is alleged that employees used leaf blowers on Saturday, June 22, 2019 at 6:55 a.m. in violation of Cambridge Municipal Code 8.16.081.2(a) & (b), and Thursday, August 15, 2019 at 2:55 p.m. at 243 Lexington Avenue in violation of Cambridge Municipal Code 8.16.081.2(a). Present: Olzen Rivas and Fredy Lopez, Lopez Landscaping representatives; and Chief Licensing Investigator Andrea Boyer.

Documents Submitted: Hearing notice and documents attached thereto.

Summary: A See Click Fix complaint was received stating that Lopez Landscaping was observed operating leaf blowers on Saturday, June 22, 2019 at 6:55 a.m. This is a prohibited time and date. Another observation was made on August 15, 2019 at 2:55 p.m. Mr. Lopez stated that he does not work in Cambridge on Saturdays but admitted that the picture of the truck submitted was theirs. It was

ascertained that the regulations regarding leaf blowers were emailed to Mr. Lopez in English, Spanish and Portuguese. In addition, the prohibitions are listed on their permit.

Decision: Board voted to find a violation (3-0) and issued a warning (2-1) (dissent: Chair Murati Ferrer voted to issue a fine and hold it in abeyance).

Note: Chief Mahoney left the meeting (Time Stamp: 1:01:55). From this point until the end of the meeting, all votes were 2-0.

Disciplinary E.C. Hathaway and Associates, for allegedly operating without a permit and during a prohibited period. This was because the evidence presented to the Board was that the dumpsters that was loaded/unloaded was on residential property. However, the after the hearing, information was received that showed the location of the dumpster is on property zoned as commercial. Therefore, under G. L. c. 111, § 31A, the loading/unloading can happen at any time and the time provisions of CMC 8.16.080(E) do not apply. The Board discussed it would not amend any other of the votes it took as to the citations issued to Jet-A-Way.
