Disciplinary Yard Works Landscaping, for alleged violations of Cambridge Municipal Code Noise Control Ordinance 8.16 on September 13, 2019 at 341 Harvard Street, to wit: 8.160.81.1(1)(b) and 8.16.081.2(c) - operating without a permit; and 8.16.081.2(a) - operating during a prohibited period. [Time Stamp: 09:45; second call at 19:00]

Present: Licensing Investigator Tyler Bubenik. No one appeared for Yard Works.

Documents Considered: Hearing notice and documents attached thereto, and see-click-fix report.

Summary: Investigator Bubenik testified that he received a complaint through See Click Fix that an employee of Yard Works was using leaf blowers at 344 Huron Avenue on September 13, 2019. This was during a prohibited time period. In addition, Yard Works is not permitted by the City. They have never appeared when noticed to appear at a hearing and they have overdue fines. Yard Works has been contacted numerous times to apply for a permit and not to operate during prohibited times.

Decision: Violation on each count, issued a \$300.00 fine for each for a total fine of \$600.00. Board also voted to refer the matter to the City Solicitor for affirmative recovery and other appropriate legal action.

Summary: The matter was heard on 9/24/19, the Board voted on it on 10/23/19 when it found a violation on (a) but there was no quorum on (b). There was discussion as to the intent of Mr. Weiner when he called the store regarding the compliance checks.

Decision: Violation (3-0), 2 days suspension for (a). No violation (2-1) for (b), Chair Murati Ferrer dissented and found a violation on (b).

Decision: Granted.

Waiver of Hearing:

17. Matthew Viens, Eversource, for violation of Cambridge Municipal Code 8.16.080(F), construction taking place outside of allowable hours and for violation of special noise variance #55449.

Summary: Typically the special noise variance would be revoked. However, in this case, DPW wants the work to be performed during off hours for public safety issues and concerns.

Decision: Board found a violation and issued a \$300.00 fine.
