1. Disciplinary Fresh Pond Auto Sales, Inc. d/b/a Fresh Pond Auto Sales, 307 Fresh Pond Parkway, holder of Used Car Dealer License #12774, for alleged violations of the conditions of its license, operating without a Certificate of Occupancy, and consideration of license status pursuant to the provisions of G. L. c. 140, § 57-69. [Time Stamp: 00:40]

Present: Attorney Jesse Schomer and Eddie Lakkis; and Chief Licensing Investigator Andrea Boyer.

Documents Considered: Hearing notice and file; photos submitted at hearing and letter from Attorney Schomer submitted at hearing.

Summary: Investigator Boyer testified that she received complaints from residents and Vice Mayor Devereux, and therefore conducted an investigation. There were cars parked in the lot and some were parked overnight and in a lawn area. After cease and desist letter from ISD, investigation showed overnight parking was still occurring. Fresh Pond also never complied with the Board's vote of providing the number of vehicles to be stored inside the premises. Investigation showed vehicles were being stored inside. In addition, there were employees inside the building working on vehicles. The licensee does not have a Certificate of Occupancy. Mr. Schomer said the cars in question outside are primarily owned by the construction workers. Some are owned by Mr. Lakkis and his family, who own the business next door. No cars have been bought or sold. Some have been stored there from the business next door. They are doing cleaning and detailing inside. Mr. Lakkis said that there are no vehicles on site overnight. Mr. Lakkis was not award that there could not be any vehicles in the building without a Certificate of Occupancy. The only people that should be in the building are contractors. The COO has been applied for. The number of automobiles has not been determined. The intent is to have no more than 25, based on the size of the space. This was outlined in the letter submitted by Attorney Schomer. They had a code consultant who said this is an appropriate number of vehicles. There is a question as to how many vehicles can

actually fit in the space. There were many conditions put in place through Community Development that must be complied with, including façade and outside space. Mr. Schomer assured the Board that the vehicles would be removed. The building address is 301, but the mailing address is 317. All construction has been completed and they are ready to open, once COO is received.

Decision: The Board voted to defer disciplinary action until December 18, 2019. If the COO is issued, the License will be issued with all conditions, including 11 vehicles outside and no overnight parking, as well as the number of vehicles allowed to be inside which will be determined pursuant to an affidavit from a licensed professional and after approval from the Board.

Summary: Mr. Fricia explained the license has not been put to use for a number of reasons. First, the architectural firm hired, and which they paid, closed and failed to provide them any money back or the specs for the space. They obtained a new

This was all complicated by the sale of the building and issues with the closing, the new landlord and the mechanical engineer. They now have a building permit and are ready to start construction.
