Public Testimony Matters

1. Application #134251 Paj 2002 Corporation d/b/a 9 Tastes, 50 JFK Street, Common Victualler Wine & Malt Beverages License #11247, for a Change of Manager to Nuanchan Jitjaruek and change of d/b/a from 9 Tastes to Nine Tastes.

Present: James Rafferty, attorney; and Nuanchan (a/k/a Nancy) Jitjaruek.

Documents Considered: Application and documents attached thereto.

Summary: Former manager has suffered a serious injury that prevents them from continuing to serve. Jitjaruek has served as manager of record at Mix-It, is an experience operator and has ownership interest in this license. She is current in her training of safe service of alcohol (will provide). In terms of the d/b/a change, there are no changes in the operation and they just seek to continue with the name but spell out the numeral.

Decision: Granted.

2. Application #132709 Industry, LLC d/b/a Manray, 40 Prospect Street, has applied for a new General On Premises All Alcohol Beverages License. Documents Considered: Application and documents attached thereto; and correspondence from Steve Zakszewski in support of the application.

Summary: This is the location of ImprovBoston which held a General On Premises Malt and Wine License, and previous to that operation there was a full liquor, so there is a presumption of need. Manray closed in 2004 after 20+ years, Holland had always aspired to find an alternate venue for its return. It is intended to be a dance club that is high energy lots of music and no restaurant license attached to it. The location is still under construction. The intent is to serve the need for an entertainment venue in this area which is seeing a revival. They are seeking to have a 2AM closing on all days, open at 5PM Monday through Saturday, and have a noon opening on Sunday. Donald Holland has extensive experience in the business, intends to be an on-site manager of record, and has alcohol safe service training certification (will provide it). Michael Monestime emphasized he was calling from his vacation because places like Manray are institution, and warms his heart that they are re-opening.

Decision: Granted, with the amendments, 2:00 a.m. closing on all days, and opening hour of noon on Sundays.

Summary: This is a transfer within the same location, so there is a presumption of need for the license. This is intended to be a modern Japanese restaurant, offering side dishes and sushi during lunch and dinner. While the concept will be new, the use and operation is very similar to the previous operation and anticipated customer base (similar hours and seats). It will serve the business community and students in the area. It is means to be a casual spot, only cosmetic changes being made to the space. Yasu Sasago, principal owner, worked in Japan with the company and as a chef for a ramen operation in Cambridge. Kazuhiro Aotani, has over 30 years of experience in the food and beverage industry and has training in the safe service and sale of alcohol (need to provide).

Decision: Granted.

Summary: This is a previously licensed location so the public need is presumed. It was always a the intent to open with a liquor license but the location already had a license linked to it. They are now closing the loop by applying to have that license transferred to this business. Right now it is a breakfast and lunch restaurant and adding the license will allow them to become a full service restaurant. The floor plan seemingly the same. The capacity breakdown is 60 seats inside with 10 standing, and 24 seats outside with 5 standing. The hours of operation sought are: 2AM closing hour on all days, 6AM opening hour for food all days, opening hour for alcohol of 8AM Monday-Saturday and 10AM Sunday. Erin Bashllari, has never been the manager of record on a liquor license, but has experience in the industry, is familiar with the rules, laws and regulations and is in the process of obtaining safe service of alcohol certification.

Decision: Granted, with the amended hours of 2AM closing hour on all days, 6AM opening hour for food all days, opening hour for alcohol of 8AM Monday-Saturday and 10AM Sunday.

Summary: The proper permit number is 34124. To different complaints came in about an employee operating on St. John's Road on July 1, 2021. One of the emails had photographs of the incident. Gosdanian said the pictures definitely showed it was his crew with the blower but he questioned whether the photographs could be of another day. The photographs were time stamped. There is a history of violations.

Decision: Violation, \$300 fine.

Decision: Violation, \$300 fine.

Disciplinary BrightView Landscaping, holder of permit #43662, for alleged violations of CMC 8.16.081.2(a) – Operating leaf blowers during a prohibited period, and 8.16.081.2(e) – Noise Emissions limited to 65 dBA on July 20, 2021 at approximately 2:30 p.m. in the vicinity of 320 Charles Street.

Present: Michael Ogilvie -Associate Branch Manager, BrightView Landscaping; and Tyler Bubenik, License Investigator.

Documents Considered: Hearing notice and documents attached thereto; and file.

Summary: While on routine patrol, Investigator Bubenik observed the Brightview employee operating a non-compliant leaf blower during the prohibited period. They have a history of this type of violation and the use of this blower. Oglivie did not contest the violation, apologized and asked for leniency based on the fact that they were using a different crew due to staff shortages and they had failed to train them. Used the violation as training tool.

Decision: Violation both counts, \$300 fine/each for a total \$600 fine.

Present: Chris Coleman, attorney; Hong Zheng, Owner, Dumpling Xuan; Victor Panzieri, Contractor/Project Manager Panzieri Construction; Tyler Bubenik, License Investigator; Seth Diamond, resident; Robson Goulart, resident; Jessica Riley, resident; and Heather Hoffman, resident.

Documents Considered: Hearing notice and documents attached thereto; various emails from residents; and file.

Summary: Based on a call from a resident as to noise emissions from the area, an investigation ensued. Investigator Bubenik took measurements from the resident's lot line on 1/21/21 and found the exhaust to emanate 65 dB(A). Per the Ordinance, the sound levels have a maximum allowable emission of 50 dB(A) during the daytime and 60 dB(A) during the nighttime. On 2/3/21 after receiving confirmation from Victor Panzieri that the matter was resolved, measurements were taken, 52.2 dB(A) (nighttime). After some small adjustments, the next measurement taken on 3/29 was 50.5 dB(A). Although Panzieri had stated a sound barrier would be built, it was not in the works. The documents from the engineers had not been obtained. In May, an incomplete building application was submitted. There was no structural engineer plan or fire safety plan.

Panzieri stated they were waiting for two different engineering companies so that they could compare and chose the best one. He stated that it had been difficult to obtain the proposals, and they were still waiting for one. In a perfect world, they could submit the plan by 9/6, would take three weeks to construct and come into compliance. As to the odor issues, he testified they had ordered an ozone odor elimination system which was expected to be received within the week. He further stated the system would take 2 days to install and one to test.

Various residents testified and submitted statements as to the noise disturbance being deafening and the odor being unbearable. They testified as to the lack of cooperation from the owners and the failure to take any steps to correct the smell issue. ISD confirmed no plan from the business had been submitted to correct the odor issue.

Decision: Violation of Cambridge Municipal Code 8.16.060(b) and 8.16.060(e), license suspended infinitely. The Board will rehear the matter and re-consider its findings during its next meeting of September 2021. If Dumpling Xuan resolves the matter before the next scheduled meeting, the Board may consider the issue at a special meeting. Regardless of the status of the construction or installation of any new systems, Dumpling Xuan is expected to provide the Board an update in the next meeting as to the steps taken to correct the noise and odor issues.

Summary: This licensee closed in 2019 due to a fire on the premises. The intent was to re-open in 2020, but then COVID happened. They renewed their license in 2020 and did not operate it. They also submitted the renewal for 2021 and have not operated the business, have no intent of operating, re-opening or putting the license to use. Pursuant to G. L. c. 138, § 23 (informally paragraphs 6 & 7), there is no reimbursement of license fee once it has been used regardless of how long it was used.
