### Public Testimony Matters

**1. Application #161566** ATE Superfoods 2, LLC d/b/a Vitality Bowls, for a new Common Victualler License with background music to be exercised at 425 Massachusetts Avenue. Proposed premises description: 923 sq. ft. establishment located in Space 2 at Market Central. Kitchen is located in the back of the space and seating is upfront. There is only one entrance at the front. Tim Johnson as proposed Manager of Record. Seating capacity is 11, with maximum occupancy of 15. Hours of operation are 8:00 a.m. – 8:00 p.m. all days.

**Present:** Tim Johnson.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Superfood café specialties are smoothie, and smoothie and acai bowls, salads and wraps. Fast casual healthy food. It is a franchise and waiting for final approval on that process. The construction is done but they are 2-3 months out from opening.

**Decision:** Granted.

**2. Application #167168** Faro Café, LLC d/b/a Faro Café, for a new Common Victualler License with Entertainment License to be exercised at 5 Arrow Street. Entertainment sought is music above conversation level and live acoustical music with amplification. Proposed premises description: Approximately 800 square feet on the bottom floor of the 3-story building. with two rooms inside, one with a coffee bar and tables and the other with just tables. ADA-compliant bathroom in the rear of the space. There is only one public entrance/exit, located in the front of the shop. The back of the space will have a small storage area. Includes outdoor area on the private way. There is a service window facing patio. Henry Hoffstot as proposed Manager of Record. Indoor seating capacity of 24, with a maximum occupancy of 49; outdoor seating capacity of 44 with maximum occupancy 93. Hours of operation are 7:00 a.m. – 7:00 p.m. for food and patio, and 2:00 p.m. – 7:00 p.m. for entertainment.

**Present:** Henry Hoffstot.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Coffee shop and bookstore – community related and climate change and justice. Create a space where they foster conversation on these issues. Expect to host talks. No food production on site, keeping it simple with a super small menu. Hoping to open in late June/early July. The live music – no stage – it will be sporadic, not having it everyday, but rather to have it on occasion to accompany a coffee while seated outside. Need to apply for Certificate of Inspection with Inspectional Services Department.

**Decision:** Granted.

**3. Application #166585** President and Fellows of Harvard College, d/b/a Loeb Drama Center, 64 Brattle Street, General on Premises All Alcohol License #11390, has applied for an Alteration of Premises and Change of Manager. The proposed premises description is: 17,343 SF area including approximately 1,730 SF West Lobby, 49 SF storage area, 7,713 SF main theater area, 2,130 SF West Patio, 570 SF West Vestibule, 1,760 SF Theater, 200 SF East Vestibule, 1,520 SF East Patio, 670 SF East Lobby, and 1,050 SF Main Lobby.

**Present:** Ana Fitzloff.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This alteration is meant to include the entire building not just the lobby and the theater, all public spaces and the theater chamber itself. Expand the footprint where the customers can consume their alcoholic beverages and concession items. Proposed new manager, Ana Fitzloff, has been working at this location for 12 years and has been in the theater industry for a while and has been a bartender and waitress. Never been a manager of record but is aware of the rules, laws and regulations. Has submitted proof of training with regard to the safe service, sale and delivery of alcohol.

Application #167014** Season to Taste Catering, LLC d/b/a Season to Taste, 2447 Massachusetts Avenue, Common Victualler All Alcohol License #11427, has applied for a Change of Location to 1678 Massachusetts Avenue. The proposed premises description is: Approximately 2,500 square feet on the first floor with kitchen, seating, two restrooms. Approximately 1,230 square feet in the basement for storage and prep.

**Summary:** Looking to expand seating so that is why they are seeking to move to a larger location. Expected timeline – middle of May will start the work on the space, end of June they expect to

finish changes by then. Shooting for Labor Day opening. There is currently another business at this location (Mix-It) with an alcohol license, and an affidavit from that business has been provided stating that it will surrender the license upon ABCC approval. Intend to keep the catering license at 2447 Massachusetts Avenue but that license is not linked to the one being transferred. They may seek a Common Victualler down the line for a casual space at 2447, and not sure whether with alcohol. At this point, just concentrating on the new space.

Approx. 3,338 sq. ft. for storage and walk-in in the basement. Approx. 1,014 sq. ft. seasonal outdoor patio on the public sidewalk and parking lane. Proposed seating capacity is 50.

Application #165609** Tasty Burger Central Square LLC d/b/a Tasty Burger Central Square, 21 Prospect Street, has applied for a new Common Victualler Wine and Malt Beverages License with an inside seating capacity of 145, an inside occupancy of 156, outdoor seating on private property for 22, and outdoor occupancy of 30. Proposed hours of operation of 11:00 a.m. to 2:00 a.m. all days. Elizabeth Miller Zolla (aka Betsy Miller) as proposed manager of record of a premises described as: Ground level unit of 21 Prospect Street containing 4,590 square feet at street level in Central Square at the corner of Prospect Street and Bishop Allen Drive. There is a need for the license at this location to bring activity back to that part of Central Square. Tasty Burger has a unique niche in how it operates – it is welcoming and allows people to stay – a community. The location has been vacant for many years, and this can be a strong compliment to the area. The outdoor will provide for community to take place outside. A resurgence in the square. Operator in Harvard Square has proven to be an asset to the community.

The outdoor patio will need to be monitored when operating. Proposed Manager, Elizabeth Miller Zolla (aka Betsy Miller), has experience in the food and beverage industry. Has been the manager of record on a liquor license before with no issues with the local board or the ABCC. Is familiar with the laws, and rules and regulations regard to the sale and service of alcohol. Has TIPS training and it has been uploaded.

**Decision:** Granted 2-0 with the condition that while the outdoor area is operating, there must be managerial staff monitoring.


