BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA Monday, May 2, 2022, 11:00 a.m. By Remote Participation

This meeting was held remotely in accordance with Section 20 of Chapter 20 of the Acts of 2021, signed into law on June 16, 2021. Meeting started at approximately 9:00 a.m.

Decisions: All votes were by roll call vote, 3-0, unless otherwise stated.

Public Testimony Matters

1. **Application #169482** King Street Properties, 87-101 Cambridgepark Drive, has applied for a new Garage and Flammables License for 248 parking spaces, 2,480 gallons of gasoline in the tanks of autos, 2,350 gallons of Class 1, 6,000 gallons of Class 2, 10,230 gallons of Class 3, and 31,000 cubic feet of flammable gasses.

Present: Patrick Conte, attorney; and Shaurya Batra.

Documents Considered: Application and documents attached thereto.

Summary: This is currently under construction. They are expecting a temporary occupancy mid-September. It will be a lease only building, which is almost entirely leased at this point. The flammables for which they have applied are the maximum allowed and the tenants have been secured and their flammables are in line with these maximum amounts. The Flammable and Combustibles Permit is uploaded.

Decision: Granted, flammables are not for direct consumption.

2. **Application #167490** Young Americans, LLC d/b/a Dear Annie, 1741 Massachusetts Avenue, Common Victualler Wine & Malt License, has applied for an Alteration of Premises to include an outdoor seasonal patio on public property on the sidewalk and into the parking lane. The proposed premises description is: Approximately 1,375 sq. ft. on first floor with seating area located in front with one restroom, and one egress; in the rear, kitchen, storage, and one egress. Includes outdoor seasonal patio on the public way, sidewalk curbside and into the parking lane, of approximately 313 sq. ft

Summary: This is meant to mirror Temporary Extension issued due to COVID-19 #118825 but smaller in size and capacity. The proposed seating capacity is 20. Hours of operation for outside meant to mirror the ones for inside. The SSBU has issued. A complaint was received regarding some lose cable which has been resolved. The new plan does not include the space in front of Dr. McEachern's practice.

Decision: Granted.

3. **Application #167480** FPBG, LLC d/b/a Fresh Pond Beer Garden, 168 Alewife Brook Parkway, has applied for a new General On Premises All Alcohol License with seating capacity of 188, and an occupancy of 500. Proposed hours of operation of 11:00 a.m. to 12:00 a.m. all days. Kevin Treanor as proposed manager of record of a premises described as: Approximately 3,750 square foot outdoor space with bar, seating area, game area, and standing area. Containers are going to be used for storage. Applicant is also applying for an Entertainment License to include: Recorded music above conversation level; live music with amplification; theatrical exhibition; floor shows; DJ; karaoke; and comedy show.

Present: Kevin Treanor; Gary Mendoza (architect); and James O'Rourke. Residents: Julia Wang; Michael Monestime; Sarah Diehl

Documents Considered: Application and documents attached thereto. Correspondence received regarding application.

Summary: This is a proposal for a beer garden similar to the ones in Boston where food trucks are brought in on a rotating basis so there will be food and alcohol. The need is in that it is concept that does not exist in Cambridge and in particular at this location where there has been a boom in the number of resident but not in the outlets providing food, alcohol and entertainment. In addition, it is being proposed in an underutilized area of the parking lot. There is a need for people to be outside for food and drink. To address concerns of safety, they will work with the City and landlord to have a pedestrian way and separate parking area with jersey barriers. In addition, the plan presented shows concrete curb path and jersey barriers before the actual seating. There are also three 40-foot containers, on three sides providing a pretty secure area. This will also help with containing the noise that may be generated. In addition, they will have a shed that will secure all electrical panels. In terms of the entertainment they are not envisioning live music everyday but rather on weekend nights with acoustical music or DJs. The applicants want to be good neighbors and will make sure to end entertainment on the earlier side, 9:00 p.m., or if issues of noise arise.

The applicants, Kevin Treanor and James ("Jim") O'Rourke both each have over 30 years experience in the food and beverage industry with good records. Proposed manager Kevin Treanor is familiar with the rules and regulations of the Board, the ABCC and the laws of the commonwealth of Massachusetts regarding the safe service, sale and delivery of alcohol. His training is up to date and he will upload proof of it.

Decision: Granted.

4. **Application #167949** The Comedy Studio, Inc. d/b/a The Comedy Studio, 20 Brattle Street, has applied for a new General On Premises All Alcohol License with seating capacity of 160, and an

occupancy of 180. Proposed hours of operation of 12:00 p.m. to 1:00 a.m. all days. Rick Jenkins as proposed manager of record of a premises described as: The Comedy Studio will occupy a 3,400 square foot parcel of The Abbot, a shopping center under development by Regency Centers at 20 Brattle St., Cambridge, MA. The Comedy Studio will occupy part of one floor. There will be one main room, two toilet rooms, and an office on this part of the floor. There will be one performance stage for stand-up comedians and a sound booth containing audio recording and amplification equipment. Applicant is also applying for an Entertainment License to include: Comedy show; live music with amplification; 3 TV/video screens; and 1 theatrical stage.

Present: Rick Jenkins; Benjamin Dryer; and Daniel Hatch. Denise Jillson, HSBA.

Documents Considered: Application and documents attached thereto. Correspondence received regarding application.

Summary: Rick Jenkins has been in the business for over 20 years and used to present the comedy show at Hong Kong where he won 3 Best of Boston awards. Their focus is on bringing and elevating new talent. The need for the license at this location centers in the loss of entertainment, generally, but specifically in Harvard Square. Comedy clubs traditionally serve alcohol, their intent is to be a theater environment but with drinking and that is what the public want centers around. Rick Jenkins has extensive experience in the industry but has never been the manager of record on a liquor license. He is familiar with the rules and regulations of the Board, the ABCC and the laws of the commonwealth of Massachusetts regarding the sale and service of alcohol and has received training on the topic. He will upload the proof of training. They are hoping to open in September.

Decision: Granted.

5. Informational/Revocation Hearing 2030 Ocean Street, LLC d/b/a Wine & Market, 192 Hampshire Street, All Alcohol Package Store License/Grant #143918 for failure to put the license to use, misrepresentations of the intent of the applicant to open and operate the business, and for brokerage of the license, pursuant to G. L. c. 138, §§ 12, 16B, 23, 64, 70 and 77. The Board may consider revocation of the grant of the license.

Present: Attorney Andrew Upton, attorney; Dan Newcomb; Glenn Lawler, consultant; and Attorney William Kelley.

Documents Considered: Hearing notice and documents attached/referenced thereto; pending application; past application; and previous hearing.

Summary: The Board inquired whether the intent of the applicant of 2030 Ocean Street, LLC was to obtain a "free" license and thereafter broker it. There was discussion on how the purpose of the Liquor Act is to put licenses to use for the public good and need. There was inquiry as to what had transpired is not tantamount to creating a "pocket license." The applicant admitted that he and his partners had applied in multiple municipalities but insisted that the intent was to open regardless of the fact that the negotiation for the sale of the instant license was commenced prior to receipt of the ABCC approval. Attorney Upton stated his client would not surrender and would appeal the Board's decision.

Decision: Violation of the state law, false statements to the Board and within the applications submitted including the applicant's statement signed under the penalties of perjury, hence the license grant was revoked.

6. **Application #167163** Cambridge Liquor Group, Inc., Ruthie's Liquor Store Cambridge, 192 Hampshire Street, has applied to transfer the All Alcohol Package Store License held by 2030 Ocean Street, LLC d/b/a Wine & Market, 192 Hampshire Street. Arian Liton as proposed manager of record of a premises described as: 1st floor retail store of 1,960 sq. ft. with one front entrance/exit and two additional emergency exits. Cellar storage of 1,960 sq. ft. Total sq. ft. of 3,920. The proposed hours are 9:00 a.m. to 11:00 p.m. Monday through Saturday and 10:00 a.m. to 11:00 p.m. Sunday.

Present: Nelson Chang, attorney; and Arian Liton.

Documents Considered: Application and documents attached thereto.

Summary: Due to the Board's vote regarding the revocation of the grant of the license being discussed for transfer, the Board heard the matter as an application for a new license (noting that it may not have one to give at this time since the revocation of the 2030 Ocean Street, LLC license was going to be appealed). Arian Liton has package stores in Boston that have operated without incidents with the local board or ABCC and has an intent to open and operate in Cambridge. Has been looking for a while and has experience in the industry. Has been manager in the past two liquor stores in Boston and has provided proof of training the safe sale and delivery of alcohol.

Decision: Defer, 30 days.

7. **Disciplinary** R&R Landscaping, for alleged violation of Cambridge Municipal Code 8.16.081. Specifically, it has been alleged that employees of R&R Landscaping operated multiple leaf blowers within the same 10,000 square foot area on March 22, 2022 in the vicinity of One Whitmore Avenue, in violation of CMC 8.16.081.1(b), 8.16.081.2(c) – operating without a permit, and CMC 8.16.081.2(f) – Limit of one blower per 10,000 square feet (see: Complainant email, photos).

Present: Joseph Kelley, investigator; Christine Schena; and Rudy Chavez.

Documents Considered: Hearing notice and documents attached/referenced thereto.

Summary: Received a report with attached photos showing two R&R Landscaping workers operating leaf blowers within 10 feet of each other. The landscaper did not contest the violation. Since the date of the violation they have completed the permitting process.

Decision: Violation, \$300 fine for simultaneously operating leaf blowers less than 10,000 sq. ft. apart, and warning for operating without a permit.

Summary: The most recent violation found had a 1 day held in abeyance. During that case we heard how at least one patron attempted to leave the premises with a drink in hand. Even if the bouncer was on bathroom duty, they should have someone cover the bouncer. That is not an excuse.

Decision: Violation, one (1) day suspension on this matter and the one (1) day held in abeyance is also to be served. The two (2) days do not have to be served consecutively as they do not relate to the same incident. Chair or designee be the person that set the dates as per Board policy.
