# BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA Thursday, August 11, 2022, 10:00 a.m. By Remote Participation

**Decisions:** All votes were by roll call vote, 3-0, unless otherwise stated.

# Public Testimony Matters

1) **Disciplinary** John's Landscape Service, Leaf Blower Permit #10678, alleged violations of Cambridge Municipal Code 8.16.081.2(a) – operating leaf blower during a prohibited period on June 30, 2022 and July 28, 2022, at approximately 1:15 p.m. in the vicinity of 334 Harvard Street.

## Decision/Summary: Rescheduled.

2) **Disciplinary** Burns Landscape & Snow Management, alleged violations of Cambridge Municipal Code 8.16.081.1(c) & 8.16.081.2(b) – operating leaf blowers without a permit (failure to adhere to June 28, 2022 Cease and Desist Order) on July 6, 2022, at approximately 8:15 a.m. in the vicinity of 145 Brattle Street.

Present: Damon Krukowski, Complainant; and Investigator Tyler Bubenik.

Documents Considered: Hearing notice and documents attached thereto; and file.

**Summary:** No one appeared for Burns Landscape. Complainant testified as to observations – and employee was operating a leaf blower on July 6 at 145 Brattle Street, Trinity Church. The complainant has spoken to the church in the past to no avail. The complainant feels threatened when he approaches the crew as they are aggressive. At the time, they were just blowing dust from the parking lot. To date the company has not sought a permit.

**Decision:** Violation, \$300 fine and notice of the violation to the owner of the premises/Church.

3) **Informational** Craigie Bistrot, LLC d/b/a Craigie on Main, 853 Main Street, Common Victualler All Alcohol License #11387, for a license informational hearing for non-use pursuant to, but not limited to, M. G. L. c. 138, §§ 23, 64, and 77.

Present: Tony Maws.

Documents Considered: Hearing notice and documents attached thereto; and file.

**Summary:** Closed doors temporarily (or at least that is what they thought) last summer, but were unable to reopen. They have put the business on the market and have been actively showing it. They have seen a lot of interest, and have two offers on the line. *This matter was called and due to the multiple previous hearing where the licensee did not show up, the Board heard the matter upon being called. Towards the end of the meeting, the licensee showed up (explained had trouble connecting) and the Board heard the matter. It vacated its original vote.* 

**Decision:** Provided 6 months to put license to use, otherwise, cancellation hearing for non-use.

4) **Application #180673** LSF Kendall Square, LLC d/b/a Legal Sea Foods, 355 Main Street, C.V. All Alcohol License #133234, for a Change of Manager to Shahrokh Naghibi.

**Present:** Donna Cruz; and Shahrokh Naghibi.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Shahrokh Naghibi has experience in the food and beverage industry, and has been the manager of record on a liquor license before with no disciplinary issues with the local board or the ABCC. Naghibi is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Has training in the safe sale, service and delivery of alcohol and will upload to the record.

Decision: Granted.

5) **Application #184162** Café Spice MIT, Inc., d/b/a Brooklyn Bagel Company, 168 Hampshire Street, has applied for a New Common Victualler Wine & Malt Beverages License with proposed hours of 6:00 a.m. to 11:00 p.m. All days with alcohol service from 10:00 a.m. to 9:00 p.m. and seating for 16 inside, an occupancy of 18, and 12 seats outside. Gopal Rungta as proposed Manager of Record of a premises described as: 900 sq ft on first floor, total of one room, storage & prep kitchen is at the back of the room. Outdoor patio on private property.

Present: Gopal Rungta.

Documents Considered: Application and documents attached thereto.

**Summary:** Applicant has provided: a signed statement attesting that Gopal Rungta has no beneficial interest in the license (this was required because Gopal signed the lease and is not disclosed in the ABCC application as one of the persons with an interest on the license or in the articles of incorporation); confirmation that the space is 850 sq. ft. and that they are not seeking standing capacity; and confirmation that the outdoor area is 275 sq. ft. However, applicant still needs to provide an

amended lease or letter from the landlord attesting that the outdoor area is being leased/provided for their use. Department of Public Works confirmed the outdoor area is all on private property.

This is a husband/wife operation, with Ishita Rungta being the sole beneficial interest holder in the license. Gopal has been a Cambridge resident almost 60 years. They were a part of MIT dining for 14 years and lost it during COVID as well as a CambridgeSide restaurant. The concept is a small café in Cambridge – whole idea is to give students an ambient space, relax, have a coffee, beer/wine, and internet. They intend to be different from other regular bagels cafes. They will offer a lot of vegan options, plant based products. They see a lot of foot traffic in the area and will cater to the heavy pedestrian flow of the commuters as well as the large number of people living in that area. They intend to offer something affordable and good for under \$10. They have been approached by a lot of students in MIT to open in Cambridge, his fusion, and based on this and the feedback from community, is why they decided to open this and make this their retirement.

Gopal Rungta, has 42 years of experience in the food industry and although does not have direct experience in the sale and service of alcohol, is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Will complete a training in the safe sale, service and delivery of alcohol.

**Decision:** Granted, with updated premises description of: 850 sq. ft. on first floor, total of one room, no hood/venting, storage and prep kitchen are at the back of the room. Approximately 275 sq. ft. outside area on private property.

6) **Disciplinary** Zen Associates, Leaf Blower Permit #168363, alleged violation of Cambridge Municipal Code 8.16.081.2(a) – operating leaf blower during a prohibited period on June 23, 2022 in the vicinity of 20 Berkeley Street.

Complainant testified she observed the use of the leaf blowers on June 23 and when she approached they crew they told her it was okay because they had a permit and it was electric. She informed them they could not use it, and they ignored her. The property where the violation occurred is one listed as a property maintained by this company.

**Decision:** Violation, \$300 fine and notice of the violation to the owner of the premises.

**Summary:** It was stated for the record that although the agenda only listed one alleged violations, that was a typographical error – the notice of hearing also included an alleged violation for the use of a non-compliant blower. The Board considered both violations as listed on the hearing notice sent to the business. There is a history of this same violation – the use of a non-compliant blower. This particular case, the violations were observed first-hand by the licensing investigator.

Stephen Santo admitted to the violation, and sought leniency as to the fine. Santo explained the crew that was there that day usually goes to a different City and was unaware of the limitations of the Ordinance. Santo had a meeting with all staff after the incident.

**Decision:** Violation on each of the 2 instances, \$300 fine/violation for a total fine of \$600.00 and notice of the violation to the owner of the premises.

**Summary:** The proper application number is 185258. The hours being sought are 6:00 p.m. to 2:00 a.m. They are seeking the variance because they need to do demolition on the top floor while the existing tenants of building are out. They have tenants on the 10 floors below the 11<sup>th</sup> floor which is the

one they need to demolish. The area they are demolishing is the floor which would be the ceiling space of the occupied floor below and doing the work while the floor is occupied presents a safety and operational concern. They have installed temporary walls to mitigate noise and have agreed to remove the demolition/debris via crane during daytime hours. The Board received a letter in opposition to the application from the property management company of the adjacent building.

**Decision:** Granted with the condition that debris be brought during daytime allowable hours.
