#### **Public Testimony Matters**

1. **Application #190628** Whole Foods Market Group, Inc. d/b/a Whole Foods, 340 River Street, Wine and Malt Package Store License with Common Victualler #11711, for a Change of Officers/Directors.

Present: Attorney Brent McDonald.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Modify officers and director, secretary and director and changes of officers in two of the upstream entities. No changes to the operation.

**Decision:** Granted.

2. **Application #187452** Dante Alighieri Society of Mass, Inc., 41 Hampshire Street, All Alcohol Club License #11626, for a Change of Officers/Directors.

**Present:** Patrick Conte; Salvatore Bramante; and Mariano Zanca.

**Documents Considered:** Application and documents attached thereto; and previous applications.

**Summary:** This application replaces the one previously filed in 2019, and includes a change of manager to Mariano Zanca. Mariano Zanca has experience in the industry, including at this location, is familiar with the rules and regulations of the Board and ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Has TIPS training and crowd manager certification.

**Decision:** Granted as to noticed application and also for filed change of manager application.

**Summary:** Scott Stanford has been working with the company for 32 years. During that time has worked at various locations, including this one, which have alcohol. Stanford is familiar with the rules and regulations of the Board and ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Stanford provided your TIPS certification.

**Decision:** Granted.

4. **Application #189967** Love Art Udon Comm LLC, d/b/a Cloud and Spirits, 795 Main Street, Common Victualler All Alcohol License #89841, to add to their license the following entertainment: recorded music above conversation level with amplification, patrons dancing, live/acoustical music with amplification, floor and light shows of any description, DJ, comedy show, karaoke, and 2 TVs (for a total of 3).

Present: Michael Gander.

**Documents Considered:** Application and documents attached thereto; file; and subsequent plan submitted during the hearing.

**Summary:** They are a small restaurant group and are trying to adapt and survive. Because the entertainment categories are capped in terms of cost, they checked off all; they will not necessarily do it all but wanted the option. The sought change came from the interest and requests from their patrons; they are also doing this with the hope to provide more service to the area, and grow and expand. The entertainment would be on a certain night and pre-planned. The hours are intended to be until 12:30 a.m. but not later than their current closing hour of beyond 1:00 a.m. To accommodate the entertainment, they would remove all the tables and the capacity would remain at the 120 maximum.

**Decision:** Granted.

5. **Application #190288** Massasoit Elks Club, Inc., d/b/a Massasoit Elks Club, 55 Bishop Allen Drive, All Alcohol Club License #11625, to add to their license the following entertainment: recorded music above conversation level with amplification, patrons and entertainers dancing, theatrical, play or moving picture show, live/acoustical music with amplification, floor, light or dynamic shows of any description, DJ, comedy show, karaoke, acrobatic show, wrestling, beauty contest and talk show.

**Present:** Donald Harding; and Richard Harding. Kenneth Reeve.

**Documents Considered:** Application and documents attached thereto; file; and letter in support.

**Summary:** They have been an operating club in Cambridge since 1964. This is a social enhancement to the community. As a social organization, the members continue to have the

conversation about having more entertainment events. This will also help with getting membership to bring in more members and provide more diverse entertainment. They are seeking to be the place for black members of the community who seek a place to socialize and have a community. They are a Black owned social establishments; middle aged people of color can socialize in location with people who look like them.

The hours are intended to be the same as the current operation. They intend to continue to operate as a private club and bring this amenity to their members on a regular basis but also provide them the opportunity to rent it out.

Zoning has a condition that the entertainment cannot take up more than 25% of the floor area, and thus a floor plan showing this is necessary. A letter in support of the application was received. Also, Kenneth Reeve spoke in support.

**Decision:** Under advisement pending submission of floor plan.

6. **Application #170651** Fat Heady, LLC, d/b/a Whitney's Cafe, 37 JFK Street, Common Victualler All Alcohol License #99534, has applied for an Alteration of Premises to include an outdoor patio on public property. The proposed premises description is: Approximately 750 sq. ft. with 1 entrance, 2 exits, and 2 floors. Approximately 253 sq. ft. patio on public property in the parking lane.

Present: Daniel McGuire.

**Documents Considered:** Application and documents attached thereto; and file.

**Summary:** This application is intended to mirror Temporary Extension of Licensed Premises to an Outdoor Area due to COVID-19 #75883 but slightly smaller - 253 sq. ft. with 15 seats. The hours of operations are the same as the indoor hours. Sidewalk Street Business Use Permit ("SSBU") not yet issued, payment of the application due.

**Decision:** Granted pending issuance of the SSBU and subject to any of the conditions and modifications therein and with the condition that while the outdoor area is open and operating, there must be managerial staff dedicated to monitoring it.

7. **Application #57149** Iamb, Inc. d/b/a Central Kitchen, 567 Massachusetts Avenue, Common Victualler All Alcohol License #11661, has applied for an alteration of premises to remove the first floor from the licensed area. The proposed premises description is: Second floor with a 420 sq. ft. kitchen, two bathrooms, and a 1,200 sq. ft. dining area with a bar. The dining area has one entrance on Massachusetts Avenue and a side emergency exit into Modica Way.

**Summary/Decision:** Abutter notifications not sent. Will be placed on future agenda after readvertisement. No vote taken.

8. **Application #187961** Waku Waku 2, LLC d/b/a Waku Waku, 33 Brattle Street, has applied for a New Common Victualler All Alcoholic Beverages License with proposed hours of 11:00 a.m. to 1:00 a.m. all days with seating for 38 inside and 12 seasonal patio seats on the public sidewalk. Henry Wong as proposed Manager of Record of a premises described as: Approximately 1,697 sq. ft. Floor 1 is main dining room, bathroom, and kitchen (683 sq. ft.); Floor 2 is a mezzanine with additional seating (283 sq. ft.); Basement is a storage with no public seating; Approximately 252 sq. ft. patio on the public way, sidewalk curbside. Applicant is also applying for an Entertainment License to include: music above conversation; DJ; and 3 TV's.

**Present:** Attorney Chase Liu; and Henry Wong.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This is going in the old Flat Patties space, there is a presumption of need for at least malt and wine. They will sell ramen – traditional noodles, and the entertainment license is for music/ambience purposes only. It is a very small space, DJ would probably be inside the kitchen – tiny space, 2 feet. Total first floor, probably 10 seats. The 38 capacity includes 7 employees, some of which are back of the house. 13 people on the first floor and 18 on the mezzanine. The proposed patio is 252 sq. ft. but that will need to be changed because the Department of Public Works has requested for a reduction so that the coral is no more than 6 ft. from the building and no more than 5 ft. from the building on the other end where the sidewalk width narrows. Hours of the outdoor area will be the same as the indoors.

Henry Wong has been working with the company for a while now and has extensive experience in the industry. Wong has been the manager of record on a liquor license before with no issues with the local board/ABCC. Is familiar with the rules and regulations of the Board and ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol, and has TIPS certification.

**Decision:** Deferred for the limited purposes of obtaining the SSBU.

9. **Application #187178** AY Restaurants, Inc., d/b/a Mae Asian Eatery, 781 Main Street, Common Victualler All Alcohol License #25132, has applied for an Alteration of Premises to include an outdoor patio on public property. The proposed premises description is: Approximately 1200 sq. ft. and is 1 floor with a basement for storage. The main entrance/exit is in the front of the building. There is an emergency exit in the seating area and another entrance/exit for deliveries and employees in the back of the building through the kitchen. Approximately 200 sq. ft. seasonal patio on public property in the parking lane.

**Summary:** This application is intended to mirror Temporary Extension of Licensed Premises to an Outdoor Area due to COVID-19 #117215. It seeks 200 sq. ft. with 26 seats. The hours of operation are meant to mirror the indoor hours. The SSBU has been issued. Additional information requested as to the barriers was provided prior to the hearing.

**Decision:** Granted with the condition that while the outdoor area is open and operating, there must be managerial staff dedicated to monitoring it.

10. **Application #168995** BL 27 Brattle MA LLC, d/b/a Bluestone Lane, 27 Brattle Street, Common Victualler All Alcohol License #51281, has applied for an Alteration of Premises to include an outdoor patio on public property. The proposed premises description is: 1,400 sq. ft. rectangular ground floor premises with 800 sq. ft. 2nd floor mezzanine. Ground floor is open room with kitchen in front of premises, storage in rear, main entrance/exit facing street with rear emergency exit. 2nd Floor Mezzanine has seating only. Approximately 262 sq. ft. outdoor patio on the public way, sidewalk against the building.

**Summary:** Had a few issues with compliance but all other aspects are now in compliance, have addressed the concerns of the City and final step to get the patio back. This application is intended to mirror Temporary Extension of Licensed Premises to an Outdoor Area due to COVID-19 #75641, but with more capacity - 262 sq. ft. with 12 seat capacity. The floor plan shows one table with one chair but it is to show ADA compliance, the is capacity for 12 seated patrons. The hours of operation are meant to mirror the indoor hours. The SSBU has been issued. There is a need to amend the patio plan to show the width, height and material of the barriers being used on the two sides not covered with the planters or the building.

The service to the outdoor area is by servers, as is indoors. At no time can patrons pick up the alcohol at the register, servers provide it to patrons.

**Decision:** Granted with the condition that while the outdoor area is open and operating, there must be managerial staff dedicated to monitoring it.

**Summary:** For the record this is leaf blower permit holder #10678 and have a disciplinary history. John Tighe, owner of business acknowledged receipt of the hearing notice. Evidence presented

as noticed. The complaint sent shas a video showing the use of the blower. This violation was reported the same day of our last meeting where Tighe represented that this was an issue with onboarding but one they had already corrected. It was also placed on record that there are two other instances of alleged violations during the weekend which are under investigation.

**Decision:** Violation, \$300 fine. \$100 fee assessed for the hearing.

15. **Disciplinary** Simple Greens Landscape for alleged violations of CMC 8.16.081.1(b) and 8.16.081.2(c) – operating a leaf blower without a permit (failure to adhere to cease and desist letter sent July 31, 2020), and CMC 8.16.081.2(a) operating a leaf blower during a prohibited period, at approximately 3:27 p.m. on August 26, 2022, 83-85 Sherman Street.

**Summary:** Board discussed how upon further review and reflection it continues to have safety concerns regarding the use of the back area as a form of regular ingress or egress. The use of the back area as anything other than an emergency egress would cause chaos and presents significant public safety issues.

**Decision:** Vote of August 24, 2022 affirmed. The rear/alley stairway and back door cannot be used as a regular form of ingress/egress, all patrons must enter/exit the premises using the main entrance on Brattle Street. Backdoor and stairways are just for emergency egress.
