BOARD OF LICENSE COMMISSIONERS' MINUTES October 19, 2022, 11:00 a.m.

By remote participation via Zoom in accordance with Chapter 107 of the Acts of 2022 signed into law on July 16, 2022.

Board Members Present: Nicole Murati Ferrer (present), Thomas Cahill, Jr. (absent), and Christine A. Elow (present).

Staff Member Present: Chris O'Neil, Administrative Assistant.

Decisions: All votes were by roll call vote, 2-0, unless otherwise stated.

FIRST SESSION

1. Application #170651 Fat Heady, LLC, d/b/a Whitney's Cafe, 37 JFK Street, Common Victualler All Alcohol License #99534, has applied for an Alteration of Premises to include an outdoor patio on public property. The proposed premises description is: Approximately 750 sq. ft. with 1 entrance, 2 exits, and 2 floors. Approximately 253 sq. ft. patio on public property in the parking lane. *This is a re-hearing of the application – the matter was previously heard and decided by the Board on September 14, 2022. However, after the meeting it was discovered the licensee failed to notice abutters in the manner required by law.*

Decision: Removed from agenda for failure to notify abutters.

2. Application #57149 Iamb, Inc. d/b/a Central Kitchen, 567 Massachusetts Avenue, Common Victualler All Alcohol License #11661, has applied for an alteration of premises to remove the first floor from the licensed area. The proposed premises description is: Second floor with a 420 sq. ft. kitchen, two bathrooms, and a 1,200 sq. ft. dining area with a bar. The dining area has one entrance on Massachusetts Avenue and a side emergency exit into Modica Way.

Present: Gary Strack.

Documents Considered: Application and documents attached thereto.

Summary: This is to remove the first floor as a cannabis business has gone into that space. This will also remove the outdoor area from the premises description as well and also a request for a change of d/b/a to Brick & Mortar. The business operations will not change and will continue to operate in the manner in which it has done so since 2003. This location has a separate entrance and has nothing to do with the cannabis business. They share the rear exit but the path to the fire exit door is different, they are not contiguous spaces.

Decision: Granted.

3. Application #190371 Kendall Green Energy, LLC, 265 First Street, Garage and Flammable License #14288, to amend the flammables stored at the location. Currently have: 50 gallons of gasoline (Class I); 1,250,000 gallons of diesel/no. 2 fuel (Class II); 12,000 gallons of ammonia (Class III); 25,000 cubic feet of ammonia; and 9,000 cubic feet of non-flammable gases. Seeking: [change] 164 gallons of propane and gasoline (Class I); [no change] 1,250,000 gallons of diesel/no. 2 fuel (Class II); [change] 1,012,000 gallons of Reprocessed Cooking Oil/Biofuel and ammonia (Class III); and [change] 25,000 cubic feet of hydrogen. The location is also licensed for 35 parking spaces (350 gallons of gasoline in the tanks of vehicles).

Present: Brian LaPierre; Matthew O'Malley; Don Silvia; Rory Gaunt; and Lt. Chris Towski. Heather Hoffman, resident.

Documents Considered: Application and documents attached thereto. Letters in support of application.

Summary: The change is due to the nationwide decarbonization and their attempt to lower their carbon emissions. They are moving away from #6 oil which is one with high emissions, and now using recycled vegetable oil, which will have a positive impact on the environment. At the Kendall station they have electrical steam, generate electricity to substations and thermal energy which is distributed to their clients at the City of Boston and City of Cambridge. The reprocessed cooking oil is made into biofuel that is carbon neutral, and when you combust it, the air emissions are lower than other fuels. The tank in which it will be stored was built in 1950, and has gone through a rehabilitation process.

There was discussion that although the Cambridge Fire Department does not have an objection as to the storage of the flammables, they are concerned about the intent of the applicant to have the flammables transferred into the tanks, then into trucks and transported to another location/tank. From the Fire perspective it would be like the facility is a tank farm – becoming a place where the fuel is being loaded/unloaded. The applicant said that for now it is their intent to store it at Kendall and supplement their other plants since they have limited storage but eventually all of the fuel is intended to stay on site.

Applicant explained their safety procedures, including annual trainings/retraining, have an oil clean up crew on retainer, have set procedures for any spills, and have a comprehensive off loading process. They also confirmed they do not use the river for cooling.

Decision: Granted, flammables not for direct consumption. Informational Hearing scheduled in two months and any conditions that are required to address CFD concerns will be attached at that point.

4. Application #195438 Formaggio Kendall, Inc. d/b/a Formaggio Kitchen, 94 Hampshire Street, for Transfer of Wine & Malt Package Store License #26468 held by Formaggio Kitchen Kendall, Inc., at the same location. Application also seeks for a transfer of the existing pledge on the license to Cambridge Savings Bank. Proposed Manager of Record Julia Hallman of a premises described as: Retail food store selling beer and wine containing approximately 2,000 sq. ft. with entrance in front and second means of egress in rear. Applicant also seeks entertainment license for background music at or

below conversational level. Hours of operation: Sunday 10:00 a.m. – 5:00 p.m., Monday-Friday 9:00 a.m. – 7:00 p.m., Saturday 9:00 a.m. – 6:00 p.m.

Present: Attorney James Rafferty; and Julia Hallman.

Documents Considered: Application and documents attached thereto.

Summary: Hallman has a long history with the operation and so does the business partner who is part of the proposed new ownership. The operation will remain unchanged, with the exception that right now the closing time on Sundays is 4:00 p.m. and they are seeking 5:00 pm. There is a pledge that will also be assigned. Hallman has 15 years with the company, is familiar with the rules and regulations of the Board, the ABCC and the laws of the commonwealth of Massachusetts with regard to the sale and service of alcohol, and has TIPS certification. Hallman and partner intend to buy the 2 stores in Cambridge and one in Boston. Hallman will be the proposed manager for all 3 and intends to rotate weekly through each store.

Decision: Granted. Applicant has to provide the name, email and phone number of the person who will be in charge of the location when Manager of Record is not on premises.

5. Application #195442 Formaggio Huron, Inc. d/b/a Formaggio Kitchen, 358 Huron Avenue, for Transfer of Wine & Malt Package Store License #52757 held by FP Market, LLC, at the same location. Application also seeks for a transfer of the existing pledge on the license to Cambridge Savings Bank. Proposed Manager of Record Julia Hallman of a premises described as: Ground floor store selling beer and wine containing approximately 4,000 sq. ft. with 1 exit and 1 entrance. Applicant also seeks entertainment license for background music at or below conversational level. Hours of operation: Sunday 10:00 a.m. – 5:00 p.m., Monday-Friday 9:00 a.m. – 7:00 p.m., Saturday 9:00 a.m. – 6:00 p.m.

Present: Attorney James Rafferty; and Julia Hallman.

Documents Considered: Application and documents attached thereto.

Summary: Incorporated by reference and made a part hereof the testimony presented as to the previous matter. As with the other location, the only operational change is Sunday closing hour – from 4:00 p.m. to 5 p.m.

Decision: Granted. Applicant has to provide the name, email and phone number of the person who will be in charge of the location when Manager of Record is not on premises.

6. Application #186566 Mourad Lemhaouri is appealing the denial of the application for a new hackney driver's license. Lemhaouri was licensed provisionally in 2011 for six months and has not been licensed with the City of Cambridge since that time.

Decision: Matter removed from the agenda as there was a deficiency in the hearing notice. The matter will be rescheduled for October 26, 2022.

7. Application #195778 Chad Nixon on behalf of Consigli Construction for a special noise variance for 10/22/22-4/22/23. (Alt. 11/5/22-5/6/23) at 600 Main Street, for sporadic work on Saturday mornings, beginning at 7:00 a.m., to allow for steel erection, steel welding and exterior façade installation during daylight hours. The variance is requested to capitalize on the daylight hours for steel erection and exterior glass installation both being high risk activities.

Present: Gabe Mater; and Investigator Joseph Kelley.

Documents Considered: Application and documents attached thereto.

Summary: Applicant argued that the undue hardship is to ensure employee safety while they perform the work which must be done in the daylight. Applicant described the work as "quiet work" as the tower crane is electric, and deliveries will be after 9:00 am. The intent is not to exercise it every day but to have it to capture the daylight through the winter months for the work on the steel erection and façade. The Board discussed how the timeline of the project does not arise to the level of undue hardship and although employee safety does, the work can be performed during regular construction hours (they may just have shorter days).

Decision: Denied, no undue hardship demonstrated.

8. Disciplinary Nem Kitchen, LLC d/b/a Cicada Coffee Bar, 106 Prospect Street, Common Victualler Malt and Wine License #89941, for allegedly operating overcapacity on September 2, 2022, September 9, 2022, September 16, 2022, and September 23, 2022 in violation of the condition of its license and M.G. L. c. 138, §§ 23 and 64, G. L. c. 140, and Rules and Regulations of the City of Cambridge Board of License Commissioners Rule 2.3, 2.5, 5.1, and 9.

Present: Duong Huynh; Vin Le; and Investigator Tyler Bubenik.

Documents Considered: Hearing notice, any documents attached thereto, and file.

Summary: The Board placed on the record that the correspondence received from Vice Mayor Mallon and ECBA asking for leniency on the matter were not considered in accordance with Board practice.

During a routine inspection of the premises on September 2, 2022, Investigator Bubenik observed the premises to be overcrowded inside and outside and both areas had seats beyond those approved (or per the floor plan). Cicada is licensed for 17 seats inside with 3 standing for a total indoor capacity of 20, and there is a total of 8 seats outside with 0 standing for a total outdoor capacity of 8. On September 2, there were 25 people inside and 25 seats, and outside 28 people and 35 seats. Investigator Bubenik returned on September 9, and there were 25 seats inside and 34 seats outside. In addition, there were 18 people outside. On that day, management informed Investigator Bubenik they did not intend to reduce the number of seats. On September 16, there were 26 seats and 22 people inside, and outside 18 people and 32 seats. On September 23, there were 24 seats inside and 28 seats outside. On October 14, there were 26 people inside and 29 people outside.

On October 18, 2022, Cicada applied with Inspectional Services Department to increase the indoor seating to 26 with 4 standing for a total maximum occupancy of 30, and for the outdoor, a total seating and maximum occupancy of 30 seats. Cicada was advised that a corresponding application would be required for the license increase and that a hearing where abutters are notified would be required due to the previous opposition to the operation, including the previous request to increase the outdoor occupancy.

Duong Huynh testified they do not have storage space and that is what they meant when stating they would not reduce the number of seats. Huynh insisted they have spoken to Commissioner Singanayagam who has approved the increase in capacity (however, the application has not proceeded).

Decision: Violation, three (3) days suspension, two (2) days to be served and one (1) day to be held in abeyance for six (6) months.

9. Disciplinary John Moriarty Associates for alleged violation of CMC 8.16.080(f) – construction activity outside of the allowable hours at approximately 6:30 p.m. on September 30, 2022 in the vicinity of 441 Morgan Avenue.

Documents Considered: Hearing notice, any documents attached thereto, file, and waiver of hearing.

Summary: Waiver of hearing submitted by Superintendent Michael Carucci admitting to the violation.

Decision: Violation, \$300 fine.

10. Application #193991 [AMENDED] Mike Carucci on behalf of John Moriarty Associates for a special noise variance on 10/22/22 - 11/13/22 (No alternate specified) at 441 Morgan Avenue, from 7:00 a.m. to 9:00 a.m. and 6:00 p.m. to 7:00 p.m. on a single consecutive Saturday and Sunday to jump a tower crane using sledgehammers and a crane. The variance is sought to extend the workday to safely accommodate the crane jump, as the process cannot be safely left in an intermediate state. The variance has been modified from its original request of 5:00 a.m. to 10:00 p.m.

Present: Michael Carucci; and J. Donais.

Documents Considered: Application and documents attached thereto; correspondence related to the application; and follow up information and modifications.

Summary: Previously heard and based on feedback from the community and the Board, the applicant went back to the drawing board and provided an updated request. Rather than working from 5:00 a.m. – 10:00 p.m. on a weekend, they seek to work from 7:00 a.m. to 7:00 p.m. Also, it would just be one weekend. Carucci once again represented they do not want to be there on the weekend and will attempt to complete the work during regular weekday hours. When this is used, they will attempt to get everything done on Saturday and if they go into Sunday it would just be for finishing touches and during regular hours. However, if the crane jump work needs to get done on a Sunday (due to bad

weather on a Saturday) they would need to start at the earlier hour. J. Donais spoke in opposition to the variance.

Decision: Granted with the conditions that: it is only valid for one weekend within the dates approved and that on Sunday, if the work required are the "finishing touches" then the hours are 9:00 a.m. – 6:00 p.m.; prior to using it the applicant must email noise@cambridgema.gov; once used, the variance will automatically become moot and cannot be exercised for any other dates; and must be accompanied by a Sunday Work Permit from the Cambridge Police Department.

11. Application #197321 Mike Carucci on behalf of John Moriarty Associates for a special noise variance on 10/19/22 - 12/31/22 (No alternate specified) at 441 Morgan Avenue, from 6:00 p.m. to 11:00 p.m. on two days per week (excluding Sunday), for concrete floor placements using concrete power trowel. The variance is sought to extend the workday to accommodate the full scope of work.

Present: Michael Carucci.

Documents Considered: Application and documents attached thereto.

Summary: The intent is to finish the floor at 1 p.m. and get out prior to 6:00 p.m., concrete finishing however have a lot of variables that can push beyond 6:00 p.m. The applicant withdrew the request to have a variance on Saturday and stated they would only use during the week and a maximum of two days per week.

Decision: Granted as amended, only on weekdays.

12. Application #198290 Mark Brine on behalf of WT Rich Company, Inc. for a special noise variance on 10/19/22-6/28/25 at 197 Vassal Street, to continuously operate generators for site dewatering. The variance is requested to ensure sufficiently dewatering of site per project specifications.

Decision: Matter removed from the agenda as the variance is unnecessary as the sound emissions of the generators are below the allowable ordinance levels.
