**Decisions:** All votes were by roll call vote, 3-0, unless otherwise stated.

**1. Application #186566** Mourad Lemhaouri is appealing the denial of the application for a new hackney driver's license. Lemhaouri was licensed provisionally in 2011 for six months and has not been licensed with the City of Cambridge since that time.

Present: Mourad Lemhaouri; and Officer Benny Szeto.

**Documents Considered:** Application and documents attached thereto; and file.

**Summary:** In 2012, Lemhaouri was licensed provisionally for 6 months with the City. The license was not issued and owner Walid Nakhoul informed the Hackney Unit Lemhaouri had not returned the leased vehicle. It appeared Lemhaouri was operating a gypsy cab. Saugus reported a similar issue and Boston reported Lemhaouri to be licensed with no issues. Lemhaouri did not contest he had issues with the Hackney Unit in 2012 but that he is attempting to do things right this time. There have been no issues since and he is attempting to buy a medallion in Cambridge.
