BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES

Friday, January 12, 2024, 10:00 a.m.

By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Board Members (All Present): Nicole Murati Ferrer, Christine A. Elow, and Thomas Cahill, Jr.

Staff Member Present: Christopher O'Neil.

Decisions: All decisions were 3-0, unless otherwise indicated, and by roll call.

1. Disciplinary Checkraise, LLC d/b/a Lord Hobo, 92 Hampshire Street, Common victualler All Alcohol License #11365, for possible cancellation, revocation or indefinite suspension of the license for the alleged transferring of the beneficial interest of the license without approval, changing manager of record without approval/operating without a manager of record, and/or for making false statements in the license renewal application in violation of G. L. c. 138, §§ 15A, 23 & 64, and 204 C.M.R. 2.01(8), and Board's Rule 5.6.

Decision: No vote/matter taken off agenda.

2. Application #250100 Rebelle Artisan Bagels, LLC d/b/a Rebelle Artisan Bagels, 249 Third Street, for a New Common Victualler License with seating for 20, additional standing room for 55 inside, and 8 seasonal patio seats on public property with proposed hours of 7:30 a.m. to 3:00 p.m. Monday through Friday. Lauren Chubbuck as proposed manager of a premises described as: There is a basement for storage otherwise there is a room for guests, including a public bathroom. Then we have a kitchen, and a room for the sandwich unit. There are no doors in between rooms so no fire hazards.

Present: Lauren Chubbuck; and Darcy Coleman.

Documents Considered: Application and documents attached thereto.

Summary: They are a from scratch bakery, make bagels by hand, hand roll and boil, make cream cheeses from scratch – use local products. They will offer an array of pastries, their most popular one is the homemade pop tarts. They make the pie dough from scratch and icings; homemade style pop tart. Do some sandwich options, but mostly concentrate on offering bagels and cream cheese. They will have a full service coffee bar and will be Kosher. The basement level is not open to the public, it is for employee use only. They will be closed on weekends but will ask to operate on those days if they find that the public need arises.

The applicant, on their own, published an advertisement as to the application on the Cambridge Chronicle on December 29, 2023. They sent notices to the abutters on January 8, 2024.

Decision: Granted, pending an administrative review, if necessary, on February 1, 2024.

3. Application #251896 Teaholic, LLC d/b/a Teaholic, 205 Broadway, for a New Common Victualler License with seating for 15, an inside total occupancy of 19, and 12 patio seats on private property with proposed hours of 9:00 a.m. to 10:00 p.m. all days. Qijun Zheng as proposed manager of a premises described as: Total 960 sq. ft. located on the first floor of the building. The store has two units combined, both with public access. The kitchen and storage is located at the right side unit of the premises. The premises has two entrances in the front and one exit to the garage of the building. It has two ceiling speakers playing music on the left side of the premises which is the dining area.

Present: Qijun Zheng.

Documents Considered: Application and documents attached thereto.

Summary: They will concentrate on boba tea but will also have coffee. Bobba tea mix with milk and tea and refreshers and morning coffee as well. They are hoping to do some desserts too, and offer macaroons and miso cakes. As of now will be ordering from wholesaler but they have an intent to be able to use the kitchen and prepare the goods on site, so they want to continue with the licensing of a common victualler.

Decision: Granted.

4. Application #238623 Dancing in the Dark LLC d/b/a The Cantab Lounge, 738 Massachusetts Avenue, General On Premises All Alcohol License #119855, for a Change of Manager to Kylie Connors.

Present: Adam Barnosky, attorney; and Kylie Connors.

Documents Considered: Application and documents attached thereto.

Summary: The correct application number is 250860. They are changing from Michael Cronin to Kylie Connors. Connors has experience in the food and beverage industry, has been working as general manager at the site since 2021, and provided TIPS as proof of training in the safe service and sale of alcohol. Has not been the manager of record on a liquor license before and is familiar with the rules, regulations and laws regarding the sale and service of alcohol.

Decision: Granted.

5. Application #250159 Colwen Management, Inc. d/b/a AC Hotels by Marriott Cambridge, 10 Acorn Park Drive, All Alcohol Innholder License #10892, for a Change of Manager to Johan Castillo.

Present: Jon D. Aieta, attorney; and Johan Castillo.

Documents Considered: Application and documents attached thereto.

Summary: Johan Castillo has more than 20 years of experience in the industry. Castillo is the current food and beverages manager at the hotel presently. Has never been the manager of record before and is familiar with the rules, regulations and laws regarding the sale and service of alcohol. Provided TIPS as proof of training in the safe service and sale of alcohol.

Decision: Granted.

6. Application #238623 CFH 35 Cambridge Park Drive, LLC d/b/a Craft Food Halls, 35 Cambridgepark Drive, has applied for a new Common Victualler All Alcohol License with seating for 100 inside, an inside occupancy of 240, 20 outside patio seats, an outside occupancy of 40, and proposed hours of 9:00 a.m. to 12:00 a.m. all days. Shaelyn McGory as proposed Manager of Record of a premises described as: 4,261 sq. ft. on the first floor, with kitchen and Storage, main entrance/exit at store front located on Cambridgepark Drive, additional egress into main building not open to the public. Seasonal outdoor patio on private property. Applicant is also applying for an entertainment license to include amplified music above conversation level, live music with amplification, and a DJ.

Decision: No vote/matter removed from agenda.

7. Application #249996 Shan Dong Dumpling House, Inc. d/b/a Dumpling House, 950 Massachusetts Avenue, Common Victualler Wine and Malt License, has applied for a Change of Officers/Directors, and a Change of Stock Interests.

Present: Attorney Brian Lynch; Wenwen Cai; and Qiming (a/k/a Adam) Bing.

Documents Considered: Application and documents attached thereto.

Summary: The two current owners are staying but with lower interests and 4 additional shareholders are being brought in. Adams, original owner and one of the founders in 2013, will remain general manager and on site 5 days a week (they have an approved 7-day operation although currently closed on Tuesdays). Wenwen Cai is the current manager of record and will remain in that capacity. All owners are TIPS and stockholders TIPS certified. There are no changes to the day-to-day operation. Board noted the ABCC may require additional documents regarding the sale of the current interests and issuance of stock.

Decision: Granted.

8. Application #249855 JKFOODGROUP, LLC d/b/a Little Donkey, 505 Massachusetts Avenue, Common Victualler All Alcohol License, has applied for a Change of LLC Manager, Change of Ownership Interest, and Change of Manager.

Present: Attorney Thomas Miller; and Kenneth Oringer.

Documents Considered: Application and documents attached thereto.

Summary: This change comes about due to the parting ways of the founders. Jaime Bissonnette's main portion was purchased by Oringer who will now own 85%. The remainder 15% is held by IOV, LLC. This comes as a result of a loan and within that loan, there was the promise of this 15% ownership interest in the license. IOV, LLC is purely an investor with no voice in the day to day. There will be no changes to the way the licensee operates.

The current ABCC application discloses Wioletta Zywina as the 100% interest holder of IOV, LLC. However, it needs to be updated/changed as Zywina is the 50% holder and the other 50% is under a trust for benefit of Zywina's children. The other update that needs to be made to the application is additional proof of financials (only one month was provided).

Kenneth Oringer has extensive experience in the food and beverage industry, and has been the manager of record on a liquor license before with no disciplinary issues with the local board or the ABCC. Oringer is TIPS certified, which will be supplemented to the application. Oringer will be in and out and plans to spend about 30 hours per week at Little Donkey. Oringer will provide the name and contact information of the manager(s) on site when Oringer is not on the premises. Oringer states the persons in control will be managers that have been with the operation since the beginning about 8 years ago.

Decision: Granted pending submission of updated ABCC application and additional documents regarding IOV's interest and pending submission of information as to other managers on site.

9. Application #249799 Gustazo-Cuban Café, LLC d/b/a Gustazo-Cuban Café, 2067 Massachusetts Avenue, Common Victualler All Alcohol License, has applied for a Change of Corporate Structure, Change of Corporate Name, and Change of d/b/a.

Present: No one appeared for the applicant.

Documents Considered: Application and documents attached thereto.

Summary: This matter was given a second call around 10:56 a.m. This is a change from and LLC to a corporation and then the d/b/a from Gustazo Cuban Café to Gustazo Cuban Kitchen and Bar. The matter arose during the renewal of the application. There are no changes to the operation, interest holders, or anything else. It is purely an administrative change to match state and payroll records. Although the applicant was scheduled to appear, due to the nature of the changes, and that there was no interest holder change and that all papers were in order, the Board proceeded with voting on the application.

Decision: Granted.

10. Application #253164 Caissie Niles on behalf of Turner Construction for 3/14[sic]/24 – 6/7/24 (no alternate specified), at 290 Binney Street, from 6:00 p.m. to 11:00 p.m. on weeknights, for steel delivery, shakeout, and installation using cranes, trucks, generators, hoisting equipment, welders. Additionally, 7:00 a.m. to 11:00 p.m. is requested on 1/15/24 to perform slurry wall installation using hand and welding tools, cranes, trucks, and excavators. The variance is sought to minimize impacts to

and from vehicular traffic on Binney Street and to allow for continuous placement of slurry panels. Also, to ensure worker and pedestrian safety.

Present: Benjamin Paskal; and Investigator Joseph Kelley.

Documents Considered: Application and documents attached thereto.

Summary: This variance will overlap with the slurry wall work on variance #247535. Although variance #247535 will expire by the time this one comes into play, they intend to submit another request to have the slurry wall work continue through June 2024, hence overlapping with the request on this variance.

This variance will allow them to accept deliveries during the second shift 3:00 p.m. – 10:00 p.m. for steel. The main reason is for safety as the delivery is for the large panels for the slurry wall. The proposed start date for this variance is 3/4. As to the request for the 1/15/24, it is to take advantage of the holiday to perform a slurry wall pour that day. They already have a permit from the police for that day for work from 9:00 a.m. – 6:00 p.m.

The Board received no comment as to this particular variance but have received a lot of opposition as to the previously approved ones.

Decision: Granted for 3/4/24 – 6/7/24 and denied as to 1/15/24.

11. Application #253167 Caissie Niles on behalf of Turner Construction for 1/19/24 – 4/13/24 (no alternate specified), at 290 Binney Street, to work continuously on four weekends from 6:00 p.m. on Friday until 7:00 a.m. on the following Monday, for crane assembly/disassembly and steel installation, using cranes, trucks, generators, welders, heavy equipment. The variance is sought in the interest minimizing impacts stemming from road closures to maintain public safety, and to extend hours to allow for the full scope of work to be completed.

Present: Benjamin Paskal; and Investigator Joseph Kelley.

Documents Considered: Application and documents attached thereto.

Summary: Erecting two tower cranes, and each require a 500 ton crane to be directed and the 500 ton crane requires 100 ton crane. Each will take multiple weekends, and the other two weekends being requested because need to mobilize the other cranes. Their intent is not to work around the clock during the weekends being sought. They want to end by 11:00 p.m. on Friday and 7:00/8:00 p.m. on the weekend. However, it all depends on the weather and the work, so if they work later, it is for the main reason to make sure the cranes are properly set up and secured and the area is safe for Monday commute.

Decision: Granted, with the condition that a Sunday work Permit is required.

Administrative Matters

Unless otherwise indicated, all the below listed matters were considered and voted upon by the Board without public testimony. They were decided upon by the Board members' individual review of the papers/applications/matter before them. The summary of what is considered is the identifying information of the matter as listed herein.

12. Application #253302 Samantha Lennon on behalf of MTP Communications for 1/16/24 – 1/17/24 (Alt. 1/22/24 – 1/26/24) at 311 Vassar Street, from 6:00 p.m. until 3:00 a.m. the following morning to perform a fiber optic cable reroute and splice using the power derived from an idling vehicle engine. The variance is sought in the interest of limiting service impacts, as a network shutdown will be necessary to complete the work.

Decision: Granted.

13. Application #252989 Yasser Salahaddine for a new Hackney Driver's License.

Decision: Granted.

14. Application #252339 Ibsa Transportation LLC c/o Ahmed Hamid, 10 Centre Street, Unit 4C, for a new livery license. Ahmed Hamid as sole owner and driver.

Decision: Granted.

15. Board Vote [Matter Heard November 14, 2023] Disciplinary, M&R Hospitality Group, Inc. d/b/a Moona Restaurant, All Alcohol Common Victualler License #11581, 243 Hampshire Street, for allegedly operating with an unapproved floor plan and beyond the approved licensed premises on October 26, 2023, in violation of G. L. c. 138, §§ 23 & 64, G. L. c. 140, and the Board's Rules 2.3, 2.5, 9.1, 9.2, 9.3, 9.4, and 14.

Summary: Upon hearing the testimony received and confirming the timeline of events, including the information provided to the business by the Department of Public Works as to the use of the sidewalk, it is clear that the business did not follow the required protocol but it could have been in part due to miscommunication and misinformation provided to it. On the other hand, there were clear instructions and mandates provided to the business by the License Commission as to the use of the area.

Decision: Violation, one day held in abeyance for nine (9) months.

16. Board Vote [Matter Heard October 25, 2023] Disciplinary La Fabrica Central, LLC d/b/a La Fabrica, All Alcohol Common Victualler License #11593, 450 Massachusetts venue, for alleged violation of G.L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7 – Service/Sale/Delivery of Alcohol to an intoxicated person on June 11, 2023.

Summary: The Board previously discussed this matter and the testimony it heard during the November 14, 2023 meeting. Part of the discussion that day was that the Board did not find the testimony of La Fabrica's staff credible. It is clear that there was overservice of alcohol. Unfortunately, there is insufficient evidence based on the factors required by the law to establish the patrons'

condition at the time of service. Using common sense, there is a clear violation, unfortunately the current state of the law is not based on common sense but rather on very specific criteria for which there is no substantial evidence. Regardless, La Fabrica must do better; they were grossly negligent on the day of the incident. There have been similar situations at this location but due to the nature of the state of the law and the time when our public safety officials respond, no action has been taken. The Board raised there are various things it will seek from the La Fabrica related to the current operation and relative to the situation.

Decision: No violation. Order issued requiring La Fabrica to provide the following information/documents within fourteen days of issuance of decision: (1) A full employee roster; (2) Proof of training in the safe service, sale and delivery of alcohol of all employees on the roster with notations on the ones that may not have it because they are not required to per Board's Rule 5B.10; (3) La Fabrica's procedures as to training of employees; (4) La Fabrica's rules, procedures and policies as to bartenders and servers that may be providing service and sale to the same customer (i.e. at the bar, when you have two bartenders serving the same tab, what is the rule, policy and procedure to ensure the bartenders are communicating with each other as to the person(s) being served on that tab); and (5) What criteria is used to determine whether the police or Fire/EMS services are required to be called.

17. Ratification of Grant Application #250470, Anna's Taqueria, LLC d/b/a Anna's Taqueria, 822 Somerville Avenue, Common Victualler License, with premises described as: Street level restaurant including kitchen, prep room and dining room. 45 maximum occupancy, Anthony Ackil as manager of record, with hours of operation of 10:00 a.m. – 11:00 p.m. all days. This is the same business and operation as what was currently approved, corporation changed.

Decision: Ratified/granted.

18. Consideration of Meeting Minutes December 14, 2023.

Decision: Granted.

19. [Attached to Agenda but Not Listed on Posted Agenda] Consideration of 2024 Renewal Applications Bulk review of renewal applications and of any alcohol license renewals which were not filed, see attached.

Expected attendance – 200.

Decision: Granted.






