Decisions: All decisions were 2-0, unless otherwise indicated, and by roll call.

Public Testimony Matters

1. Application #257221 A and T JCuisine, Inc. d/b/a Manya Jiro, 57 JFK Street, Common Victualler Wine and Malt License #55625, for a Change of DBA to An Nam.

Present: Andy Truong.

Documents Considered: Application and documents attached thereto; and file.

Summary: They are changing the d/b/a because they changed the menu – different type of cuisines and the name was causing confusion. Everything else is staying the same.

Decision: Granted.

2. Application #231081 The Coast Café, LLC d/b/a The Coast Café, 233 River Street, for a new Common Victualler License with 9 seats inside and a total occupancy of 17 with proposed hours of 3:00 p.m. to 8:00 p.m. Wednesday through Friday and 1:00 p.m. to 6:00 p.m. Saturday. The proposed premises is: One floor 400 sq. ft. - 370 sq. ft. of Kitchen and 30 sq. ft. for customer, Front door for customer and Back door for employees. Basement 400 sq. ft. for prep and storage.

Decision: Off agenda – failed to notify abutters.

3. Application #257794 Arrow Street, LLC d/b/a Arrow Street, 2 Arrow Street, for a new Entertainment License for indoors and outdoors to include: Recorded music above conversation level with amplification; Dancing by Patrons; Live music with amplification; Theatrical Exhibitions; Floor Shows; Light Shows; Dynamic Audio/Visual Show; DJ; Comedy Show; Karaoke; Acrobatic Show; Beauty Contest; Wrestling; Talk Show; Magic Show; Readings of Poetry; 4 TV's; Theatrical Stage; and 2 Stages.

Documents Considered: Application and documents attached thereto; and letter in support of application.

Summary: Have been operating under one day licenses for a while with no issues. They are a public charity working out of what used to be the Oberon Theater and an additional floor. They want to continue to provide a space of performing arts to the square and in collaboration with the community. They are making the space accessible to a variety of artists and different types of entertainment forms. They are a place dedicated to innovation and artform. They have spoken to all abutters and all notices went out but not all at the same time and some may have not gotten the notice within the time required.

Decision: Defer to March 26 meeting at which time the Board will discuss any comments received as to the application and vote on it.

4. Application #255841 Vester, LLC d/b/a Vester, 73-75 Ames Street, Common Victualler Wine and Malt License #14019, for a Change of License Category to Wine and Malt Beverages with Cordials/Liqueurs and for an Alteration of Premises. The proposed premises description is: 3,798 square feet on street level with counter, kitchen, storage and dining area. One entrance/exit. 1,366 square foot Mezzanine and office. Approximately 250 square foot patio on public sidewalk.

Present: Nicole Liu.

Documents Considered: Application and documents attached thereto; and file.

Summary: They are expanding the internal footprint into what used to be Dumpling Daughter. They are also adding cordials to the license to have more variety and be able to provide a service to the public. They would like to have the flexibility to stay open until 9:00 p.m. all days (currently open until 7:00 p.m.). They do not see a need to expand the footprint of the outdoor area. They have uploaded an amended floor plan which shows that the total capacity would be 40 on the Vester (current) side and 48 on the expanded area.

Decision: Granted, for alteration of premises, change in license category and increase of closing hour to 9:00 p.m.

5. Applications #257682 and #258025 Just A Start Corporation, 430 Rindge Avenue, for a Garage and Flammables License for 4 parking spaces, 40 gallons of gasoline in the tanks of autos only, and 316 gallons of Class 2 for a generator, and an Open Air Parking Lot License for 229 parking spaces.

Present: Connor Ring; Noah Sawyer.

Documents Considered: Application and documents attached thereto; and file.

Summary: The licenses are for two different addresses. The garage and flammables license is for 430 Rindge Avenue and the open air parking lot license for 402 Rindge Avenue. This is an existing

site but there is a new building with affordable housing and prekindergarten program. Underneath parking is to serve their program. Generator is serving the new structure for life safety features - resiliency. The open air parking lot has been in existence since 1971 but had not been licensed.

Decision: Granted, with amendment that open air parking lot license be linked to 402 Rindge Avenue.

6. Application #255891 Wusong Road, LLC d/b/a Wusong Road, 2 Bennett Street, Common Victualler All Alcohol License #112007, to Add entertainment to the license - Karaoke and Background Music Outdoors.

Present: Jason Doo.

Documents Considered: Application and documents attached thereto; and file.

Summary: The karaoke is only for the inside of the premises. The background music outside would be on the one speaker from the pre-existence owner which used to be mounted on the wall. If approved, when it is reinstalled, they will put a timer on it to ensure it shuts off. The outdoor music is needed as they are in a not ideal area that is noisy. The business's model and theme is immersive experience and they want to continue that unique selling point and experience in the outdoor area. The karaoke would be to offer it on slower nights like Mondays and Tuesdays, improve the downstairs bar area, and provide more livelihood to the square on those days.

Decision: Granted.

7. Application #253901 Overlind Industries, LLC d/b/a The Red House, 98 Winthrop Street, Common Victualler All Alcohol License #111650, to Remove Entertainment Conditions of license: While live entertainment (limited to no more than five (5) acoustic performers and/or musicians with no amplification except one microphone) is operating, the windows and doors must be closed to contain the noise from emanating outside of the indoor licensed premises.

Present: Molly Lindbergh, applicant; Jacob Lazzara, Inspectional Services Department; Carolyn Rider, abutter; and Philip Borden, abutter.

Documents Considered: Application and documents attached thereto; file; and correspondence received regarding the application.

Summary: Application was filed for removal of conditions. The entertainment area was approved on the outdoor private area which is an enclosable area. They have used the area since November (enclosed per conditions) and there have been no reported issues. As warm weather approaches, they want to be able to continue providing the service but with the windows and doors on the private area open (the roof remains in place).

Carolyn Rider, long standing abutter that operates a psychotherapist practice in the abutting building, opposes the removal of the conditions. They explained they have had multiple issues with noise emanating from the premises (none of which were reported to the License Commission) and that the noise is very disruptive to their patients and practice. The practice hours can start as early as early 7:00 a.m. and go until 10:00 or 11:00 p.m. with the routine being more a 9:00 p.m. or 10:00 p.m. closure.

Philip Borden, is a resident at the abutting building on 93 Winthrop Street, and they strongly approve of the removal of the conditions. Evening and weekends seem reasonable and as long as there are set reasonable hours of operation, very supportive, especially as it will attract more people to the area.

Decision: Defer to March 26, 2024.

8. Disciplinary Shojo Cambridge, LLC d/b/a Shojo, Common Victualler All Alcohol License #193948, 425 Massachusetts Avenue, for allegedly operating over the licensed capacity on February 23, 2024 (11:00 p.m.), in violation of G. L. c. 138, §§ 12, 23 and 64, G. L. c. 140, and Board's Rules 2.3, 2.5, 5.1, and 9.

Present: Brian Moy; and Investigator Tyler Bubenik.

Documents Considered: Hearing notice and any documents attached thereto; and file.

Summary: While conducting routine inspections on that day, from the outside of the premises, around 11:00 p.m., Investigator Bubenik observed the business was crowded. The licensed indoor capacity is 59, and Investigator Bubenik counted 90 persons. It took the business 90 minutes to reduce the capacity. When Investigator Bubenik first encountered the door person, they asked what was the capacity inside and the door person stated they did not know. Then when asked what the capacity of the space was, the door person stated they did not know. Brian Moy had to be told multiple times within the 90 minute span that they needed to take active measures to reduce the capacity. It was not until informed that the Fire Department would be called to shut the place down that all patrons were asked to leave the premises and it was repopulated with the maximum number of persons allowed in the space.

Moy testified the door person's lack of knowledge was their mishap for never informing them of the capacity. Moy has started to get updated stamped engineer plans for an increase in capacity. After being prompted as to what corrective actions taken, Moy testified they have talked to staff, met with the head of security to ensure they understand capacity limitations. They have bought two way clickers and also added an application to the phone to keep count. They have told staff where the licenses are posted and noted the capacity.

Decision: Violation, 2 days suspension.

9. Board Discussion Middle East Restaurant, Inc. d/b/a Middle East, 472 Massachusetts Avenue, Common Victualler All Alcohol License #11691, as a follow up to the orders issued to it on the Board's Statement of Reasons of October 12, 2023 relative to the matter heard on October 3, 2023, produced through counsel on January 19, 2024, the following: Security Plan for All Ages Shows and Wristband Process; Plan for Staggered Event Times and Plan for Event Entry and Let Out; Plan for Additional Points of Entry and Alternative Reserved Areas for Patrons Waiting to Gain Entry Rather than Sidewalk; Plan for Service of Alcohol; and Security and De-escalation Procedures.

Summary: The matter was discussed in the previous meeting but since Commissioner Elow had not been present, wanted to ensure to get the full Board's take on what was submitted. The documents seem responsive. The investigators are following up on the expired/not produced alcohol training certificate. No further information required at this time.

Decision: Acknowledged.

10. Board Discussion La Fabrica Central, LLC d/b/a La Fabrica, 450 Massachusetts Avenue, All Alcohol Common Victualler License #11593, as a follow up to the order issued to it on the Board's Statement of Reasons of February 1, 2024, produced through their manager of record various documents and written information in response to the order.

Summary: The matter was discussed in the previous meeting but since Commissioner Elow had not been present, wanted to ensure to get the full Board's take on what was submitted. The documents seem responsive. There were a couple of issues with the alcohol training certificates but the investigators are following up on those. There may be an issue to further discuss with them regarding the communication between bartenders and servers. Also, we may want to discuss items listed for when police, fire or EMS are called. Specifically, items 6-9 state when licensing authorities require it; it should be when it happens or when the business becomes aware of it.

Decision: Schedule informational hearing to discuss materials produced. Meeting to discuss what was written and get confirmation of what they meant with what was written.

11. Application #260021 Efthemios Kotsiopoulus, John Moriarty & Associates, for a Special Noise Variance on 3/22/24-4/29/24, specifically the weekends of 3/22/24-3/24/24 and 4/26/24-4/28/24 (Alternate start date 3/29/24-5/6/24), at 200 Main Street, continuously from 7:00 a.m. - 8:00 p.m. for the mobilization, assembly, disassembly, and demobilization of a crane using diesel engines, back up alarms, power tools, and hammers. The work needs to be done during off-peak hours for public safety concerns and an active construction site at 200 Main Street.

Summary: Considered they are only seeking two weekends.

Decision: Granted only for 3/22-24/2024 and 4/26-28/2024 (and only two weekends within the alternate dates) with the condition that a Sunday work permit is required.

12. Application #260889 Julia Gutierrez on Behalf of Redgate Real Estate for 3/13/24 – 3/15/24 (Alt. 3/16/24 and 3/23/24), at 48 Quincy Street, from 7:00 a.m. – 6:00 p.m. to conduct wind-driven rain resistance testing of the curtain wall and windows using a wind generator that may produce noise levels higher than 86 dBA. The variance is sought as no alternate equipment can be obtained to successfully perform the testing at a lower sound pressure level.

Present: Investigator Tyler Bubenik.

Documents Considered: Application and documents attached thereto; and correspondence received regarding the application.

Summary: We received opposition to this application but there is really no way to do this test otherwise which is for public safety reasons. The applicant updated the application minutes before the meeting and informed Investigator Bubenik that they were able to secure a smaller fan that would do the job. This fan is about 18 decibels less, which represents a 70-80% reduction in noise emissions for the observer.

Decision: Granted.

13. Consideration of Waiver of Hearing Disciplinary - Boston Carting, Solid Waste Hauler License #65459, admitting violations of CMC 8.16.080(e), loading and unloading outside allowable hours, on January 20, 2024 (3:56 a.m.) at 15 Notre Dame Avenue; and at 12 Boardman Street on January 22, 2024 (5:14 a.m.), January 24, 2024 (5:00 a.m.), and February 16, 2024 (4:27 a.m.).

Summary: On March 5, 2024, Michael Barry, VP of Boston Carting/Star Waste submitted a waiver of hearing admitting to the violations as noticed. The business has a significant disciplinary history at 15 Notre Dame.

Decision: Violation, 4 counts, \$300 fine per count for a total fine of \$1,200. The property owners will be sent a notification of the violations and fines issued.
