BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES Tuesday, October 28, 2025, at 9:30 a.m. By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2025 adopted by the Massachusetts General Court and approved by the Governor.

Board Members: Nicole Murati Ferrer (present); Christine A. Elow (present); and Thomas Cahill, Jr. (present).

Staff Members Present: Kris Foster and Chris O'Neil.

Decisions: All decisions, unless otherwise stated, were 3-0, and by roll call.

Public Testimony Matters

1. Application #1184659 Michette, LLC d/b/a Michette, 305 Webster Avenue #100, for a new Common Victualler Wine & Malt License with seating for 20 and a maximum inside occupancy of 25. The proposed hours are (a) Food: 7:00 a.m. – 9:00 p.m. all days; (b) Alcohol: 5:00 p.m. to 9:00 p.m. all days. Thomas Ferte as proposed Manager of Record of a premises described as: 1,400 sq. ft. bakery/cafe on one floor with customer service area and production kitchen. Two entrances and exits. Entertainment will be recorded music at or below conversation level.

Present: Attorney Joshua Levine; Thomas Ferte; and Charles Ferte.

Documents Considered: Application and documents attached thereto; file of existing license holder; and letters regarding application.

Summary: Michette will be a bakery and café serving baked goods, sandwiches, salad, and small plates. Beer and wine will be served at night with small plates. All alcohol will be served by waitstaff.

The applicant has an updated floor plan removing the patio because the landlord does not want it part of the license premises or have alcohol service, because the patio is in a common shared space.

Thomas Ferte has experience in the food and beverage industry, having another bakery in Somerville. They have never been a Manager of Record before. Ferte will obtain TIPS certification as proof of training in the safe service and sale of alcohol.

The Board acknowledged receipt of letters in support of application.

Decision: Granted, with amended premises description to show the total square footage is 1,500.

2. Application #1185876 Urban Hearth, LLC d/b/a Urban Hearth, 1281 Cambridge Street, to transfer the existing Common Victualler All Alcohol License (#203549) held by Turing Tavern, Inc., at the same location. Proposed hours for food, alcohol, and entertainment of (a) Monday – Thursday, 4:00 p.m. to 1:00 a.m.; (b) Friday, 4:00 p.m. to 2:00 a.m.; (c) Saturday, 11:00 a.m. to 2:00 a.m.; (d) Sunday, 11:00 a.m. to 1:00 a.m. Tomassina Erin Jones Miller as proposed Manager of Record f a premises described: The premises consists of 4,400 sq. ft., one floor across two rooms with a basement for storage, office space and prep area. There is one entrance and two exits. Entertainment will be 1 juke box, 5 TVs, DJ, live/acoustical music without amplification, and recorded music both below and above conversation level.

Present: Attorney Matthew S. Porter; and Tomassina Erin Jones Miller.

Documents Considered: Application and documents attached thereto; file of existing licensee; and correspondence received regarding application.

Summary: Urban Hearth will be their second location Cambridge; it will replace the current restaurant which will transition into something else. Urban Hearth has been operating in Cambridge for approximately 10 years with no issues. This will be a fine dining restaurant with jazz music and low acoustic music to accompany dinner. The restaurant will close their retractable walls of windows whenever live music is played. They plan on having a patio but will need to amend the ABCC application and obtain a SSBU application because the patio is on public property.

Tomasina Erin Jones Miller has over two decades of experience in the food and beverage industry, ten of them being at the first Urban Hearth location. They have been a Manager of Record with no history of disciplinary action. Miller has TIPS certification as proof of training in the safe service and sale of alcohol.

Urban Hearth will be obtaining a pledge from Eastern Bank. Miller will correct the application to reflect they will be the 100% beneficial interest holder. Board also raised issue of Miller's multiple names.

Decision: Granted with the amendment that the outdoor area is also included in the premises, the pledge of the license and the condition that when there is entertainment above conversation level the retractable doors/walls are closed.

Summary: This application involves the selling of 33% of the business by Davidson Bettero, 17% to Marcio Figueiredo and 17% to Gina Damasceno. Figueiredo and Damasceno currently each hold 17%. There will be no changes to the business operations and no new owners.

Decision: Granted.

Summary: JNR Concessions LLC is pledging its license to Easten Bank in order to buy the real estate. The license will be collateral for this purchase. There will be no changes to the business operations.

Decision: Granted.

5. Application #1185111 Reins International Massachusetts Inc. d/b/a Gyu-Kaku Restaurant, 16 Eliot Street, Common Victualler Wine & Malt License #11524, for a change of manager to Tipornrat Tangkham and a change of officers/directors.

Present: Tipornrat Tangkham.

Documents Considered: Application and documents attached thereto.

Summary: The Board highlighted several issues with the application. The person authorized to sign the applicant's statement did not do so and the entity vote needs to be signed by the corporate clerk. The Board expressed concern because several international corporations are involved and some have not been disclosed.

Tipornrat Tangkham has experience in the food and beverage industry. Tangkham has not been a manager of record and is familiar with rules, regulations and laws with regard to the sale and service of alcohol. Tangkham has TIPS and Serve Safe and will provide as proof of training in the safe service and sale of alcohol.

Decision: Continued pending submission of amended/corrected ABCC application. If the matter is clerical, the Board will vote on the application administratively at its next meeting, otherwise the applicant will need to reappear.

Proposed hours: 10:00 a.m. to 3:00 a.m. all days. Babu Koganti as proposed Manager of Record of a premises described as: 900 sq. ft. single floor with one restroom and an open kitchen with two entrances and exits serving Take out Italian fast food.

Present: Koushik Babu Koganti.

Documents Considered: Application and documents attached thereto.

Summary: Pasta Dreams Inc. is buying an existing business and nothing will change other than hours of operation. They are applying to stay open until 3:00 a.m. to accommodate students as they are across from a residential neighborhood. They have a similar restaurant in Harvard Square open until 3:00 a.m. and have had no issues with that location.

Decision: Granted.

7. Application #1181712 Eugene F. Lynch Post 30 United American Veterans, 1 Cedar Street, All Alcohol Club License #11627, for an alteration of premises.

Present: Craig Murphy.

Documents Considered: Application and documents attached thereto.

Summary: This Post sold their building while retaining one 1,500 sq. ft. unit in the building's basement. There will be seating for 27, and 33 standing. The operation will remain the same.

Decision: Granted with the amendment on the premises description that the business is on the basement level.

8. Application #1183781 Whisnant A & MacLean R d/b/a Zuzu's Petals, 204 Hampshire Street, Common Victualler Wine, Malt & Cordials License #109172, for an alteration of premises and entertainment license. Entertainment will be live/acoustical music without amplification and trivia.

Present: Alexandra Whisnant and Robert MacLean. Jason Alves, East Cambridge Business Association; Pauline Pavao, resident; Jennifer Sullivan, resident; Ted Swartz, resident; Nelson Pavao, resident.

Documents Considered: Application and documents attached thereto; file; and correspondence received regarding application.

Summary: Zuzu's Petals is seeking to expand from their 204 Hampshire Street location into 202 Hampshire Street. They will add passageways through the connected wall, rather than remove the wall, to maintain a cozy atmosphere. This will increase capacity to 50 people inside, where currently it is 18.

They are planning to put a piano in the new part of the building. Their clientele currently is mostly graduate students, scientists, and European students who come for wines by the glass and desserts.

Jason Alves of the East Cambridge Business Association spoke in support of the application.

Pauline Pavao spoke in opposition to the application. They are direct abutters and are concerned about the noise that entertainment would create. There are regularly people entering their yard, urinating, and passing through the emergency exit door, which opens onto Pavao's property.

Jennifer Sullivan also spoke in opposition to the application. They live at 200 Hampshire Street and are concerned about increased sound, as there already is a lot of noise coming from the establishment. They also do not want the occupancy to increase from 18 to 50.

Ted Swartz further spoke in support of the application. They are the owner of 202-204 Hampshire Street and stated that Zuzu's Petals is a great tenant and has never received any complaints regarding its operation.

Nelson Pavao spoke in opposition of the application. They are concerned about the piano playing and that the emergency exit door will be used as a regular accessway and will be propped open on to their private property.

The owners explained that they have not received a noise complaint in their four years of operation. It is a busy neighborhood with lots of noise but Zuzu's Petals' piano playing and trivia would be reserved for special events only. They do not plan to use the emergency exit door for anything but they are working with the Fire Department to determine the proper use of the door.

The Board recommended that an employee should be watching the exterior of the premises, especially during closing time. It was noted for the record that since opening, the business has had no issues and no complaints as to its operation have been received/filed.

Decision: Granted with the conditions that: soundproofing panels are added to the space; the entertainment is approved for indoors only; live entertainment set up is to be on the 204 Hampshire Street side of the premises; and the side door of 200 Hampshire Street is to be used as an emergency egress only, unless the Fire Department states otherwise upon inspection.

9. Application #1183700 AstraZeneca, 290 Binney Street, for a new Flammables License. 8,300 gallons Class II (Diesel) for direct consumption.

Present: William "Bill" Taber; Grace Rosario; and Brye Cormier.

Documents Considered: Application and documents attached thereto.

Summary: AstraZeneca applied for 8,300 gallons of diesel for a generator for its operation. The Board discussed that they do not need to obtain their own Flammables License, that the owner of the

building should obtain it, which covers all tenants. AstraZeneca only needs a flammables permit from the Fire Department, which it already has. The building owner is currently applying for a Garage and/or Flammables License for the building, including a 529-space garage.

Decision: Denied as moot. The application will be incorporated into application #1184531.

10. Disciplinary E.C. Hathaway and Associates for allegedly operating leaf blowers at 46 Brewster Street on August 22, 2025 without a permit, in violation of CMC 8.16.081.3(6), and during a prohibited period, in violation of 8.16.081.3(1).

Present: Investigator Tyler Bubenik; Damon Krukowski, complainant. No one from E.C. Hathaway appeared.

Documents Considered: Hearing notice and any documents attached thereto; and file.

Summary: Damon Krukowski, the complainant, lives on Brewster Street and stated that there have been multiple violations during the seasonal leaf blower ban. They did not complain over the summer because of potential ICE activity.

Investigator Bubenik explained that E.C. Hathaway has never obtained a leaf blower permit and regardless, they were operating during the prohibited period. They have a sporadic but significant disciplinary history, with the last violation found in September. They have never come into compliance with the leaf blower ordinance.

Decision: Violation (2 counts) \$300 per count + hearing fee (\$100) = \$700. The property owner will be noticed and informed they may also be fined next time.

Note: Matter #38 was called next.
