BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES

Wednesday, June 11, 2025, at 10:00 a.m.

Hearing commenced at 10:01 a.m.

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2025 adopted by the Massachusetts General Court and approved by the Governor.

Board Members: Nicole Murati Ferrer (present); Christine A. Elow (present); and Thomas Cahill, Jr. (absent).

Decisions: All decisions, unless otherwise stated, were 2-0, and by roll call.

Public Testimony Matters

1. Application #1160990 Wendell Campus, LLC, 11 Wendell Street, for an Open Air Parking Lot License for 9 parking spaces.

Present: Nan Jiang.

Documents Considered: Application and documents attached thereto; and file.

Summary: All parking spaces are above ground and all will be for a fee.

Decision: Granted.

2. Application #1164507 Pyramid Cambridge Tenant, LLC d/b/a The Kendall Hotel/Kendall House/Black Sheep, 350 Main Street, to transfer the existing The Firehouse Inn, LLC, All Alcohol Innholder License #10896, at the same address. Anthony Vorres as proposed Manager of Record of a premises described as: Hotel with 8 floors, including garage, and 77 rooms for a total square footage of 40,508. Includes dining room, kitchen, and bar on 2nd floor. Storage in basement. Spa and conference room on 7th floor. Outdoor patio on 1st floor and outdoor roof deck on 7th floor. Applicant is also applying for a Management Agreement with Pyramid Cambridge Management, LLC.

Present: Alexander Furey; Brian Fink; and Anothony Vorres. Aminat Ali, resident.

Summary: This transfer has been kicking around and after some back and forth it appears there is now a comprehensive application that explains how it will work. MIT owns the real estate that the hotel is

located on and Pyramid Cambridge Tenant LLC is the tenant that operates the hotel. Pyramid Cambridge Management LLC will be the manager as detailed in the management agreement. They have to check off management agreement on the ABCC forms.

Tony Vorres has more than ten years of experience in the food and beverage industry and has been a manager of record before with no prior violations before a local board or ABCC. They are familiar with the rules and regulations of the Board, ABCC, and the laws of the Commonwealth of Massachusetts with regard to the sale and service or alcohol. Vorres has a TIPS certificate as proof of training in the safe service and sale of alcohol.

Decision: Granted.

3. Application #1156562 100 Discovery Park DE, LLC, 100 Acorn Park Drive, for a Flammables License for 350 gallons of diesel Class II for a generator.

Summary: An existing 350 gallon generator is on site in a utility closet located on the first floor with exterior access. This is a corrective application.

Decision: Granted.

Summary: All parking spaces are above ground and for a fee in a lease-only building. The fuel is being stored in the vehicles and in an above-ground tank on the first floor; the generator is also located on the first floor.

At the end of the hearing and after the Board's vote granting the application, resident Aminat Ali expressed their concern about the impact the parking would have on the neighborhood parking. They also were concerned that they only received notice of the hearing one week earlier, which was not enough time to confer with neighbors. The Board discussed that Ali's concerns did not affect their earlier vote.

Decision: Granted with the finding that flammables are not for direct consumption.

7. Application #1166063 Massachusetts Institute of Technology d/b/a East Campus House, 3 Ames Street, for a Lodging House License for 265 rooms, 388 beds and 388 total occupants. Rich Hilton as manager of record. This is a previously licensed location that closed due to renovations.

Present: Richard Hilton, David Friedrich, and Annalisa Bhatia.

Documents Considered: Application and documents attached thereto; and file.

Summary: This location went under renovation and there was a reduction as to the number of beds by five as a result of adding accessibility throughout the building. The certificate of occupancy is expected in the middle of July and residents will move in in early August.

The Board requested that the Applicant work with ISD to make the Applicant's certificates of occupancy accessible to the Board on its portal by address, as they are currently under Richard Hilton's name, in order to facilitate future renewals.

Decision: Granted.

8. Application #1157648 Colossal Shrimp LLC d/b/a Darling, 464 Massachusetts Avenue, approved/non-issued Common Victualler All Alcohol License #273712, for a Pledge of License to Eastern Bank.

Present: Attorney Kelly Shanahan.

Summary: Attorney Shanahan appeared on behalf of the applicant. They did not have a status as to the business's opening date and explained the pledge is to assist with the final costs of renovations and opening. The pledge of the license is for a loan to purchase equipment. The loan agreement only has two guarantors (rather than all the members of the LLC) because only those individuals with 20% or more ownership are required to sign as a guarantor.

Summary: This application seeks to change the d/b/a because they had trouble settling on a name at the start of the licensing process but have now chosen this one.

Currently, the establishment serves beer and wine from 5:00 p.m. to 9:00 p.m. three nights a week and they would like to add acoustical and maybe electric guitar background music during that time. They anticipate music may only be one night a week.

Decision: Granted, with entertainment from 5:00 p.m. - 9:00 p.m.

10. Application #1163813 A Pinto's Guest House, LLC, 281 Rindge Avenue, for a Lodging House License for 10 rooms, 10 beds, and 10 occupants. Janesh Pun as manager of record.

Summary: This application is for a two-unit lodging house. Unit one has six bedrooms, three on each floor. Unit two has four bedrooms, three on the first floor and one on the second floor. The units are separated and there is no access between the units. They have started the process to obtain a Certificate of Inspection but have not completed it.

Decision: Granted.

11. Application #1167330 Darragh Lawlor, Suffolk Construction, for a Special Noise Variance for 7/1/25 - 9/30/25 (alternate dates 7/2/25-10/1/25) at 320 Third Street, 6:00 p.m. to 9:00 p.m., Monday through Friday, for deliveries of elevators, curtainwall materials, MEP equipment, and other construction related items using delivery trucks and cranes. The variance is sought to reduce impacts on neighborhood traffic during peak hours and to ensure public safety.

Present: Darragh Lawlor; and Investigator Joseph Kelley.

Documents Considered: Application and documents attached thereto; and file.

Summary: This application is for deliveries only and no construction. Work will be performed Monday through Friday only, and the variance is requested to work around the heavy traffic in the neighborhood caused by other ongoing construction projects. DPW recommended approval so deliveries do not conflict with school.

The Board expressed its concern with how much construction has been happening in the neighborhood but noted that no members of public appeared in opposition to this application.

Decision: Granted with the condition that it cannot be exercised on 7/4/25.

12. Application #1166469 Jason Wright, Eversource, for a Special Noise Variance for 6/12/25 - 8/12/25, (no alternate dates) at 315 Vassar Street, 6:00 p.m. to 7:00 p.m., Monday through Friday, for installing environmental controls, pouring concrete, and assembling new equipment using an emergency generator. The variance is sought to extend the workday to accommodate full scope of work.

Present: Jason Wright; and Investigator Joseph Kelley.

Documents Considered: Application and documents attached thereto; and file.

Summary: Two months are needed to install a generator. A transformer needs to be replaced and the installation is a lengthy process due to the amount of civil work required.

Decision: Granted with the condition that it cannot be exercised on 7/4/25.

15. Board Vote [Matter heard March 25, 2025] **Disciplinary,** JKFoodGroup, LLC d/b/a Little Donkey, 505 Massachusetts Avenue, Common Victualler All Alcohol License #11546, for unapproved changes to the beneficial interest holder of the license and/or failure to complete the process to get changes to beneficial process approved in violation of M. G. L. c. 138, §§ 15A, 23 and 64, and the Board's Rules 2.3, 2.5, 5.5, 5.6 and 14.

Summary: The ABCC confirmed that JKFoodGroup LLC needed to submit two separate applications for these ownership changes; it is unclear where the confusion with the establishment happened. They have now withdrawn their deficient application and submitted two complete applications. The Board discussed whether to find a violation but stay the indefinite suspension until the July 3, 2025, hearing, where the two applications would likely be considered, or whether to continue the matter until the July 3rd hearing.

Decision: Continued to July 3, 2025, hearing.

16. Ratification of the Grant Application #1166096 Boston Coffee Rescue Corp. d/b/a Boston Coffee Rescue, for a Hawker/Peddler License, for a business described as a food truck selling coffee, pastries, soda, smoothies, and lemonade.

Decision: Approved/ratified.

17. Reconsideration of Board Vote Disciplinary R.P. Marzilli, Leaf Blower Permit #1160423, for alleged violations of simultaneous operation of multiple leaf blowers within 100 feet of one another, 8.16.081.3(10), and use of non-compliant leaf blower, 8.16.081.3(9), at 4 Berkeley Street on May 7, 2025.

Summary: This matter was heard at the May 29, 2025, hearing. At that hearing, the Board voted to find one violation of a noncompliant leaf blower. However, upon review, there were actually two violations for noncompliant leaf blowers.

The Board also discussed removing the failure to appear fine because R.P. Marzilli emailed the Board after the hearing to state that they had appeared at the hearing but had to leave before their matter was called. Although the Board was concerned that the only matter addressed in that communication was how to pay the fines not whether there had been corrective action taken.

Decision: Ratified finding of violations with the clarification, that there are two counts of use of non-compliant blowers. Therefore, violation for use of non-compliant leaf blowers, 2 counts, \$300 fine per count, and violation for simultaneously operating the blowers within 100 feet of each other, 1 count, \$300 fine. Total fine of \$900.
