- 1. Continuation from December 21, 2017. Work on Orchard Street which should've been done, must be done at the same time. Eversource to check on progress. Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143**, for the following: **Orchard Street – At Beech Street** and northwesterly from MHC1199, a distance of about 94 feet – conduit.

Beech Street – At **Orchard Street** and southerly from MHC1199, thence turning southwesterly, and ending at MHC27319, a distance of about 81 feet – conduit.

Beech Street – Southwesterly from MHC27319, approximately 80 feet southwest of **Orchard Street**, a distance of about 91 feet – conduit. This work is necessary to supply power to **7 Beech Street** (W.O. #1974483).
