## POLE AND CONDUIT COMMISSION MEETING MINUTES Thursday, August 20, 2020 at 10:00 A.M.

The meeting was held by remote participation via Zoom.

Meeting started at approximately 10:02 a.m.

Commission Members Present (All Present): Nicole Murati Ferrer, Tom Grande, and Terrence James Shea.

License Commission Staff Present: Elizabeth Y. Lint.

Steve Lenkauskas was present as an advisor to the Commission.

## **Noticed Matters:**

Documents considered by the Board: As to all applications, the Board considered, at a minimum, the application submitted to the Board and all documents attached thereto.

Decisions: Unless otherwise indicated, all votes were 3-0. When matters are granted with "typical conditions," the Board is imposing the following conditions:

- Must obtain Electrical Department Utility Permit and Department of Public (1) Works ("DPW") Permits and comply with the provisions therein.
- Must pay sidewalk preservation off-set fee.
- Must coordinate site visit with DPW.
- Must commence work within sixty (60) days of the grant and complete within six (6) months of the date of the approval.
- Must comply with any amendment City agencies make to the issued permits after the (5) Acceptance Without Reservations is filed.
- New Petition (70711) Comcast, 426 E. First Street, Boston, MA 02127, for the following 928 Massachusetts Avenue - From existing Comcast sidewalk vault in front of 930 Massachusetts Avenue, trench easterly 18' in the public way to the PP line of 928 Massachusetts Avenue. Install 1-2" PVC conduit. This will include the removal and replacement of 5 sidewalk panels.

**Present:** Anthony Vatalaro, on behalf of the petitioner.

**Documents Considered:** Application and documents attached thereto.

Summary: There were no concerns with this petition.

**Decision:** Granted with all typical conditions.

New Petition (86174) Comcast, 426 E. First Street, Boston, MA 02127, for the following: 95 Fawcett Street - From existing Comcast Manhole, on Fawcett Street, trench southwesterly 37' to the PP line of 95 Fawcett Street. Installing 1-4" PVC conduit in the public way.

**Present:** Anthony Vatalaro, on behalf of the petitioner.

Documents Considered: Application and documents attached thereto.

**Summary:** This is for a new residential building. There is a large drainage culvert there. They will have to go under it. This will be marked out when they do a site visit.

**Decision:** Granted with all typical conditions, a 4-inch shadow conduit for the City and a site visit.

3. New Petition (86178) Comcast, 426 E. First Street, Boston, MA 02127, for the following: 265 First Street - From existing Comcast Manhole on Second Street, trench 12' Easterly then 54' Southerly to the private property line of 265 First Street. Installing 1-4" PVC conduit in the public way. This will include the restoration of 1 brick sidewalk to same or better condition.

Present: Anthony Vatalaro, on behalf of the petitioner.

Documents Considered: Application and documents attached thereto.

Summary: There were no concerns with this petition.

Decision: Granted with typical conditions and sidewalk area must be milled and paved.

4. New Petition (86182) Comcast, 426 E. First Street, Boston, MA 02127, for the following: 299 Prospect Street- From existing Comcast sidewalk vault in front of 317 Prospect Street, trench westerly 14' in the public way to the PP line of 299 Prospect Street. Install 1-2" PVC conduit. This will include the removal and replacement of 3 sidewalk panels.

Present: Anthony Vatalaro, on behalf of the petitioner.

**Documents Considered:** Application and documents attached thereto.

Summary: There were no concerns with this petition.

Decision: Granted with typical conditions.

5. New Petition (85836) MCI/Metro Access Transmissions Inc, 82B Northside Road, P O Box 600, Charlton, MA 01507, for the following: 500 Main Street - Starting at existing Verizon/MCI Metro MH on Galileo Galilei Way, trench and install (2) 4" conduits (1 conduit for city shadow) 475'+/-south/southeasterly on Main Street to the existing Verizon/MCI Metro handhole in the sidewalk at 500 Main Street.

Present: Bill Conway on behalf of MCI.

Documents Considered: Application and documents attached thereto.

**Summary:** The Verizon manhole could not be located in the sidewalk in front of 500. Mr. Conway explained that there is no conduit available as it is overcrowded. A conduit needs to be added. There may be an issue with the MBTA tunnel in the area. The trench may need to be moved.

Decision: Continued to verify both end points and perform test pits.

6. Continuation from July 16, 2020, to allow the applicant to back to Level 3 for the duct bank. (74897) Crown Castle NG East, 1800 West Park Drive, Marlborough, MA 01581, for the following: Galileo

Galilei Way - Starting at Level 3 MH#0515-2703 on Galileo Galilei Way trench and install (2) 4" conduits 12'+/- northerly to proposed 3'x3' Crown Castle handhole #1. from proposed handhole #1, continue 443'+/- easterly to proposed Crown Castle handhole #2. from proposed handhole #2, continue 105'+/- easterly on Ames Place to the building located at 8 Cambridge Center.

Present: Shawn Alles, for the petitioner.

**Documents Considered:** Application and documents attached thereto.

**Summary:** They reached out to Level 3. They were given permission to intercept their conduit. The letter will be provided. The hand hold will be in front of Ames Street and not down Galileo.

**Decision:** Granted with typical conditions.

7. New Petition (85203) Cambridge Network Solutions, 35 McGrath Highway, Somerville, MA 02143, for the following: First Street - Starting at Utility Pole #12/12, trench and install 14'+/- of (1) 2' PVC conduit in a southeasterly direction in the sidewalk to the building located at 25 First Street.

Present: Jeff Harrington on behalf of the petitioner.

**Documents Considered:** Application and documents attached thereto.

**Summary:** There is also an aerial petition that has been delayed. The pole needs to be looked at to see if it is usable. There are temporary supports on it. There should be one petition submitted for the entire project. It is recommended that there be no excavation. There was also improper notice to abutters which has to be corrected.

**Decision:** Petition withdrawn by petitioner to submit aerial petition.

8. Continuation from July 16, 2020, for further review by the Electrical Department. (75215) Verizon New England, 385 Myles Standish Boulevard, Taunton, MA 02780, for the following: 29 Charles Street - Verizon to relocate pole, P130/7, 40' from its existing location on Charles Street (4A0M0KW).

**Present:** Rick Forman and Jeff Hirsch on behalf of the petitioner.

**Documents Considered:** Application and documents attached thereto.

Summary: This was reviewed by the city electrician. There is a revised drawing showing the pole being reset 11 feet from the existing pole. The recommendation is that it be no more than 15 feet. Verizon was not aware there was a new drawing. Mr. Hirsch said the new drawing was submitted to Paulette Alty at Verizon. A new pole was already installed and not in the proper location. There is no grant of location for it and it must be removed. In addition, Verizon did not have a Dig Safe number.

**Decision:** Continued for a new drawing to be submitted with the path as recommended by the Electrical Department. Order issued to remove the poll that was installed on the public way without a grant of location.

9. Continuation from July 16, 2020, for further coordination, common trench, and updated design. (77327) Verizon New England, 385 Myles Standish Boulevard, Taunton, MA 02780, for the following: Binney Street - Verizon to place new conduit for service to 220 Binney Street (4A0L8WW).

(77331) Verizon New England, 385 Myles Standish Boulevard, Taunton, MA 02780, for the following: Munroe Street - Verizon to place new conduit for service, mainly on Munroe Street, but crossing over Fifth Street and Third Street (4A0L8WW).

**Summary:** A plan profile was requested for Third Street. There must be coordination with the engineer. This is the Volpe project.

(80789) Massachusetts Institute of Technology, 77 Massachusetts Avenue, Cambridge, MA 02139, for the following: Vassar Street - Furnish and install 6 telecommunication conduits with concrete encasement on the south side of Vassar Street from existing telecommunications manhole to existing areaway of MIT Building 32, approximately 250LF. This is a re-routing of an existing MIT telecommunications duct bank.
