This meeting was held by remote participation through Zoom, pursuant to Governor Baker's Executive Order of March 10, 2020, suspending certain provisions of M.G.L. ch. 30A.

**Commission Members Present (All Present):** Nicole Murati Ferrer, Stephen Lenkauskas, and Terrence James Shea.

Matters were called out of the order in which they were listed on the posted agenda. The Board first heard all matters where representatives from the utilities were present and members of the public that wished to be heard.

Documents considered by the Board: As to all applications, the Board considered the application submitted to the Board and all documents attached thereto.

Decisions: All matters granted had, at a minimum, the following conditions (also known as "typical conditions"):

- (1) Must obtain Electrical Department Utility Permit and Department of Public Works ("DPW") Permits and comply with the provisions therein.
- (2) Must pay sidewalk preservation off-set fee.
- (3) Must coordinate site visit with DPW.
- (4) Must commence work within sixty (60) days of the grant and complete within six (6) months of the date of the approval.
- (5) Must comply with any amendment City agencies make to the issued permits after the Acceptance Without Reservations is filed.
- 1. Continuation from September 17, 2020, for site visit, additional information, and common trench. (91127) Comcast, 426 E. First Street, Boston, MA 02127, for the following: Brattle Street (Ash Street Story Street) From Existing Comcast MH, trench easterly 220'+/- installing (2) 4" conduits and 1 new 3'x3' Comcast MH #1. From proposed MH #1, continue 370'+/- southeasterly to proposed 3'x3' Comcast MH #2, and continue the trench 260'+/- southeasterly to Existing Comcast MH at the intersection with Story Street. [Time Stamp: 17:04]

Present: Anthony Vatalaro on behalf of the petitioner.

Documents Considered: Application and documents attached thereto.

**Summary:** Harvard wants a 4" conduit and a 4" will be added for the City shadow. Test pit results were uploaded to the portal. All were clear except #5 but there is room next to the structure found in the ground. The new plan has not been uploaded.

**Decision:** Continued for DPW to review internally and to update the plan. Harvard still needs to petition for the conduit and any laterals. Comcast is responsible for any other laterals coming out i.e. need to apply for common trench.

2. Continuation from September 17, 2020, for verify whether conduits are available and for test pits to be performed. (91132) Comcast, 426 E. First Street, Boston, MA 02127, for the following: 232 – 272 Allston Street - Starting at Utility Pole #9/32 on Allston Street, trench easterly 287'+/- to existing utility Pole #9/28 on Allston Street. Installing (2) 4" conduits. [Time Stamp: 21:55]

Present: Anthony Vatalaro on behalf of the petitioner.

**Summary:** They have permission from Crown Castle to use the conduits in place. The permissions have been uploaded. No excavation is needed. They have a lease agreement.

Decision: Granted.

First Street, Boston, MA 02127, for the following: 125 Munroe Street - From existing Comcast manhole on Third Street, trench 47' westerly to proposed Verizon trench. Join common trench 270' westerly, breaking out 4' southerly to install 1-new 3'x3'x3 Comcast manhole on Munroe Street. Re-join Verizon trench from new Comcast manhole westerly 262' to the property line of 125 Munroe Street. **[Time Stamp: 24:00]** 

**Present:** Anthony Vatalaro on behalf of the petitioner. Rick Forman for Verizon.

**Summary:** This is a common trench that matches up with petition #8, Verizon. This is for the 47 feet outside of the common trench, the manhole outside the common trench, then joining the common trench. Must coordinate with VHB, doing the Volpe project and must have test pits to confirm location. The common trench with Third Street crossing is very congested.

Decision: Continued.

4. Continuation from September 17, 2020. Tolling agreement. (88230) Cellco Partnership d/b/a Verizon Wireless, 118 Flanders Road, Westborough, MA 01581, for the following: 41 Second Street - Proposed installation of a small cell wireless antenna and associated equipment on an existing Eversource utility pole. **Summary:** A tolling agreement was signed on September 17, 2020 so this should not be on yet. They are asked to upload new plans and to see where the fiber was being fed from. The meter socket was eliminated. The fiber run is aerial. Verizon will be coming from the previous pole to this site. There is still an issue with the fee. The \$500.00 that the federal statute allows for does not begin to cover the costs involved. The Law Department will respond.

**Summary:** This is a similar situation to the above agenda item. There is no existing fiber that they can pull from. They will have to run underground conduit from Mass. Ave. Trenching work will be done by Verizon land line. They have to apply along with this application so the whole project can be viewed at once to make sure it is viable. The tolling agreement is still in place.

**Decision:** Continued to give Verizon time to apply.
