# Part I Total Crime

While serious crime in Cambridge has risen 15% when compared with the first 5 months 2012, when measured against the 5-year weighted average for this time frame, only a slight 4% bump has been recorded. The majority of this increase can be attributed to the overall increase in larceny (19%), with 150 additional thefts reported when compared with the first 150 days of 2011. A detailed analysis of all statistics indicates that there were **160 additional property crimes recorded in the first 5 months** of 2012 to register a **16% surge** when placed against the 2011 statistics.

# Part I Property Crime

3 larceny types are driving the increase in property crimes so far in 2012. Larceny from motor vehicles **(+36%)** – 69 additional incidents, larceny from persons **(+55%)** – 54 additional crimes and larceny of bicycles **(+63%)** – 35 more stolen bikes, account for the vast majority of the incline in thefts so far this year. Housebreaks, which increased by **43%** when compared to the First Quarter of 2011, have decreased dramatically over the past two months **(down 39% when measured against May of 2011)** and are now 19 incidents above last year's total.

# Part I Violent Crime

Violent crime has increased 13% (19 additional incidents) when compared to the first 5 months of last year and an upward incline of 8% when placed against the 5-year weighted average. There has yet to be a murder in Cambridge in 2012. Rape is down 8% and robbery has fallen 10% when compared with the first 150 days of 2011. Aggravated assaults have increased 31%, with 26 more incidents than 2011. The majority of the upward spiral of this violent crime can be attributed to a rise in domestic and acquaintance related assaults.

# MURDER

No Patterns

- No murders have been recorded in Cambridge during the first 5 months of 2012.
- Review of Cambridge murders for the prior two years:** For only the fourth time in the past 50 years, there were no murders recorded in Cambridge in 2010. Point in fact; there had not been a murder in the City in over 20 months until the shooting of a 30-year old Cambridge resident near Central Square on March 12<sup>th</sup> of 2011. Over the final 6 weeks of 2011, there were four domestic homicides committed in Cambridge, including the shooting of three family members on Grove Street on December 9<sup>th</sup>. With the suicide of the assailant in the Grove Street incident, and the subsequent arrest of the daughter in a domestic homicide on Elm Street on November 20<sup>th</sup>, only the March 12<sup>th</sup> shooting remains unsolved.
- 27 of the 33 murders in Cambridge since 1995 have been cleared by arrest or by the suicide of the perpetrator, which translates to an 82% clearance rate.



# Unsolved Murders: 1995 to 2011



August 19, 1995, Prospect St

**Lilia Fagundes**, 43, of Medford was shot and killed during an armed robbery in her family owned Azores Market at 3:30 PM on August 9<sup>th</sup>, 1995. The suspect was a juvenile. Despite a number of possible leads throughout the years, this case remains open.

**Colin Burton**, 30, of Dorchester, was shot and killed outside of Hi - Fi Pizza on Mass Ave in Central Square on Sept. 18, 1999. Burton was talking with the occupants of a Ford Explorer when the subject in the passenger seat fired through the window. Two suspects fled the scene. The case remains under active investigation.

**Ian Gray**, 19, of Mattapan, was in an argument outside of the Rhythm & Spice restaurant that spilled out onto Mass Ave on April 5<sup>th</sup>, 2002. A suspect that had left the scene returned with a group of people and a fight ensued. A knife was produced during the altercation and four gunshots were fired, fatally wounding Gray. Cambridge Police investigators are still working this case.



# Unsolved Murders: 1995 to 2011



June 17, 2002, Windsor St.

On June 17<sup>th</sup>, 2002 at 7:00PM, **Ricardo Williams**, 27, of Malden, was found in the driver's seat of a motor vehicle suffering from a gunshot wound to his face. Williams was taken to CCH where he was pronounced dead. This case remains open.

**Jason Ellcock**, 33, of Malden, formerly of Cambridge and father of three, was found with multiple gunshot wounds in front of the driveway to 364 Rindge Ave at 3:05 AM on the night of June 16<sup>th</sup>, 2009. He was pronounced dead at the scene. This incident remains under investigation.

**James Lauture**, 30, of Cambridge, was sitting in a vehicle near Brookline and Watson Streets just after midnight on Saturday, March 12<sup>th</sup>, 2011, when an unknown gunman opened fire. The occupants in the car were able to drive to Central Square. Lauture died from multiple gunshot wounds. The other man in the vehicle who was shot survived. This case remains open.



# RAPE

No Patterns

- Over the first 20 weeks of 2012, there were 11 rapes reported in Cambridge. All but one of these crimes were classified as non-stranger incidents. A blitz scenario rape in late April remains under investigation at the present time.
- 8 of the 23 sexual assaults reported in 2011 occurred on a calendar date prior to that year. This is a trend that we have been observing over the past few years with 25% to 33% of the incidents involving domestic or supervisory positioned assailants as suspects being reported long after the original date of the incident. **2 of the rapes reported in 2012 fit this scenario.**
- **Case Status for the 2 stranger to stranger rapes in 2011:**
  - ❑ Timothy Gayhart was arrested on the morning of July 18<sup>th</sup> and charged with Assault with intent to rape and robbery of a Harvard student on JFK Street. On March 7<sup>th</sup> of 2012, Gayhart plead guilty to these charges and was sentenced to 4 to 6 years in state prison.
  - ❑ On March 13<sup>th</sup>, 2012, a security guard from Hyde Park was indicted by a Middlesex Grand Jury for an assault with intent to rape for an alleged sexual assault the was captured by a surveillance camera on November 11<sup>th</sup>, 2011 in Canal Park.





- When measuring this violent index crime against the 5-year average for the first 5 months of this year, there has been an **increase of 22%**, with 20 additional incidents above the projected average of 89 assaults.
- When compared to the time period between 1/1/11 to 5/28/11, aggravated assaults have increased 31%**, with 26 more incidents than 2012. The majority of this incline in violent crimes can be attributed to a rise in domestic and acquaintance related assaults.

# ROBBERY

*No Patterns*

- The 5-year average for overall robbery in Cambridge for the first 5 months of the year is 54 incidents. From January 1st to the 28<sup>th</sup> of May, 47 robberies were reported to register a 13% decrease below the projected total.
- Street robberies have fallen 7% when measured against both the 5-year average and the 2011 total for the first 5 months of the year, with 3 fewer incidents. There have been only 7 commercial robberies—4 banks and 3 shoplifting incidents that escalated into violent confrontations with clerks at drug stores—over the first 5 months of 2012. Arrests have been made in 3 of the bank robberies.
- On May 9<sup>th</sup>, the Cambridge Police issued the second street robbery alert of 2012. After collaborating with Boston and Brookline, a regional pattern of street robberies similar to a national trend targeting smart phones was identified. In the majority of these incidents across the 3 cities, victims were walking alone late at night talking on their cell phones or listening to music on headphones when they were robbed. Since that alert 3 weeks ago, there has not been a similar incident within the region.





**Street Robbery Hot Spots** - When compared with the first 5 months of 2011, there has been a 7% decline in street robberies from 43 incidents to 40 incidents in 2012 (which is also the 5-year weighted average for this time span). **The major pattern to be identified is the late night smart phone robberies, which is highlighted on the next slide.**





On May 9<sup>th</sup>, the Cambridge Police issued the second street robbery alert of 2012. After collaborating with Boston and Brookline, a regional pattern of street robberies similar to a national trend targeting smart phones was identified. In the majority of these incidents across the three cities, the victims were walking alone late at night talking or their cell phones or listening to music on headphones when they were robbed.

Since that alert 3 weeks ago, there has not been a similar incident in Cambridge.

**4/26, 11:15 PM, Day St.**  
Suspect tackled female and knocked her phone out of her hand. Suspect stood up, grabbed phone, and fled from area.  
**Citizen Alert Issued**

**3/25 1:30-2:00 AM, Kirkland**  
Female was wearing headphones and walking alone when she was knocked unconscious. When she woke her purse was missing.

**5/1, 11:00, Line St. & Magnolia Ave.**  
Suspect approached a male from behind and asked for a dollar. Victim replied no and suspect brandished a hunting knife and removed cash.

**3/16, 11:31 PM, Mt. Vernon St. & Upland Rd.**  
Suspect approached female from behind and stole iPhone from her hands. Victim gave chase, suspect turned around and struck her in the face multiple times.

**4/21, 12:26 AM, Broadway**  
Suspect asked female a question, then struck victim in head and knocked her down stairs. Suspect picked up her phone, but victim retrieved it. Suspect then struck her multiple times, removed the cell phone and fled.

**3/8, 12:08 AM, Brattle St. & Sparks St.**  
Suspect approached female and stopped in front of her, punched her in the head, knocked her down. Suspect stole her cell phone and fled.

**3/26, 11:22 PM, Ellery St.**  
Female was walking listening to headphones. Suspect approached demanding phone, grabbed her shoulders and hit her head against a pole. Suspect continued to hit victim, grabbed her phone and fled. **Citizen Alert Issued**

**4/5, 8:30 PM, 350 Western Ave**  
Female was walking listening to headphones. Suspect approached from behind and grabbed victim's purse. During a struggle, victim was able to hold on to purse and suspect fled.

# BURGLARY

## Emerging Patterns

- Total burglary, the combination of residential and commercial burglary, is up 10% when compared to the 5-year average with 18 additional incidents above the projected total of 194 crimes and up 5% when compared with last year total for the first 5 months of the year with 9 additional burglaries counted. When comparing this property crime with May of 2011, a 30% drop has been registered (11 fewer burglaries counted).
- Commercial burglary has dropped 29% when compared with the first 150 days of 2011, and 10 incidents fewer (-29%) when measured against the 5-year average. There have been 25 commercial breaks in Cambridge in the first 5 months of the year. These incidents have been scattered throughout the City and no discernible spatial or temporal pattern had been identified.
- Nearly 70% of all the housebreaks in Cambridge between January and the end of April were clustered in 4 patterns in Area 4, West Cambridge, Peabody and Cambridgeport. All of these patterns have been interdicted and housebreaks declined by 39% when compared with May of 2011, with 13 fewer incidents recorded. A sporadic series of apartment breaks Area 4 border on Fri and Sat afternoon is being monitored.




# Housebreaks in Cambridge: First 5 Months of 2012

**Peabody** – multiple unit apartment buildings near Cambridge Common have been involved in sporadic series since early January - Friday and Saturday nights

**West Cambridge** - This pattern was probably initiated with a break on the last half on Highland in late February. There have been 5 other Saturday morning last half breaks in the Sparks Street area of West Cambridge. All but 1 of the breaks have been through unlocked rear doors. On 2 occasions, the suspect has tossed away a stolen wallet in close proximity of the latest hit. **Both of these Patterns have now been classified as inactive.**

**Area 4 / Inman** – 27 housebreaks in the 5 months of 2012 - the majority in the first 5 weeks of the year – sporadic activity since the 3<sup>rd</sup> week of February. M.O. is late afternoon breaks through rear doors between Thursdays and Saturday – majority of apartments had multiple roommates with laptops as targets – although this pattern has quieted considerably – 4 incidents in past 6 weeks – **Extra patrols remain in place.**



**Cambridgeport** - housebreaks in 2012 – a majority off these breaks were committed during a 1-night spree of 3 local teens, 2 of which were arrested on the night of March 21<sup>st</sup> and charged with a number of incidents. This series remained dormant until a small cluster in Riverside emerged over the weekend of May 19<sup>th</sup> with 5 breaks through unlocked windows with laptops as the target. **Extra patrols are in place.**



# Housebreaks

## What can we do?

### Police Response Strategy:

- Cambridge Police have deployed extra patrols to the affected areas in order to combat the recent increase in housebreaks.
- CPD is also utilizing plainclothes officers and detectives in the affected areas.
- Citizen Alerts sent to the West Cambridge neighborhood on 3/13 and 4/6.
- Several arrests have been made.



### Citizen Response Strategy:

- Citizens are asked to take the following precautions to protect themselves, their homes, and their belongings from burglaries:
  - Try “**casing**” your own home.
  - **ALWAYS lock your doors and windows.** Many housebreaks have occurred through open windows or unlocked doors.
  - **Leave a light on** when you leave.
  - Install motion sensor lights.
  - **NEVER** prop open the door or let someone in behind you.
  - **Be vigilant.** If you suspect suspicious activity, please report it to the police immediately by calling **617-349-3300**.
  - **Document serial numbers** of all electronics and take pictures of all valuables.
  - **Request a Residential Security Survey** from the Cambridge Police Department. For more info, please call **617-349-3236**.



- Overall, larceny increased by 19% when compared with the first 20 weeks of 2011 and 4% when measured against the 5-year weighted average.
- The increase in larceny from motor vehicles (+36%) can be attributed to a surge in thefts during the snowless First Quarter of this year when compared with the first 3 months of 2011 when there were 70 inches of the ground:
  - When comparing the most recent 4 weeks to the previous 4 weeks, **larcenies from the persons have risen 38% (from 24 to 33 thefts).**
  - This crime type tends to see a notable increase in the Harvard Sq area during late May and throughout June, due to an influx of visitors (and multiple targets) to the city for graduations and festivals.
- So far this year, there have been 91 reported bike thefts in Cambridge, while there were 56 reported through this time frame in 2011 – a dramatic increase that can also be linked to the mild winter.



- Larcenies from Motor Vehicles are **down 12%** when compared with the 5-year average, with **34 incidents below** the norm for the first 5 months of the year. However, when measured against the previous 4 weeks, thefts from MVs skyrocketed 76% with the majority of the surge traced to an abnormally low LMV total for April of 2012.
- There were 66 MV breaks in the Peabody / North Cambridge neighborhoods during the first 2 months of 2012, accounting for 40% of the city-wide total. The CPD focused on these target areas during March. The arrest of 2 career auto prowler thieves on March 13<sup>th</sup>, 2012 slowed the onslaught of this series and 2 other arrests have brought an end to this series.
- **The Cambridge Police are crediting the increased citizen response of locking vehicles and calling in possible suspects as the major factor in interdicting this pattern. Since the end of February, larceny from motor vehicles in these neighborhoods were reduced substantially.**
- **However, over the past 2 weeks, LMV activity was on the rise in Peabody and North Cambridge once again until the arrest of a known criminal from Dorchester on Walker Street on the third weekend of May.**





# Larceny from Motor Vehicle Hot Spots in 2012


**North Cambridge / Peabody** – 66 thefts in the first 10 weeks of year - major patterns along Walden and side street off of Rindge Ave. Series of arrests have cooled this area off – the most recent being on Walker Street on 5/21/12 - breaks into MV on weekend nights has been persistent problem during warm weather months in these areas – be vigilant –lock vehicles.

**Cambridgeport /Riverside border** – 51 LMVs in these 2 neighborhoods - concentrated activity below Allston Street on weekend nights. Arrest of local juveniles in April has tempered activity in this area.

**Area 4 / Inman** - 36 incidents – majority of thefts were between January and March along Main north of Central Square – sporadic activity over past 2 months.

**West Cambridge** – 35 incidents – 200 block of Mt Auburn & Brattle – majority of activity between middle of February to early May – temporal trend of incidents on Sunday during daytime hours.

**East Cambridge** - weekend pattern between First & Third Streets in early March produced this cluster – only 4 scattered thefts in past 10 weeks.





# Larceny from Motor Vehicles

## *What can we do?*

### Police Response Strategy:

- Cambridge Police are focused on prevention of these crimes by increasing officer visibility in targeted areas.
- Citizens are encouraged to take the proper precautions to protect their vehicles and their belongings by doing everything possible to not make their vehicles easy targets.



### Citizen Response Strategy:

- Citizens are asked to take the following precautions to protect themselves, their vehicles, and their belongings from theft:
  - **Take extra care when out doing your shopping.**
  - Make sure all of your car doors are locked when you leave your vehicle.
  - If you are **approached by a suspicious person** while you are in your vehicle, **sound your horn to attract attention.**
  - **NEVER LEAVE VALUABLES EXPOSED IN YOUR CAR.**
    - If you must leave packages or valuables in your car, **place them in the trunk of under a blanket to conceal them**



- When compared to the first 5 months of 2011, larcenies from person are up 55%. Over the last 4 weeks there has been a significant increase of 38%, or 9 incidents. The 5-year average is normally around 122 incidents and is currently up 25%.
- In the past 4 weeks, there have been 33 larcenies from person, up 9 incidents from the previous 4 weeks. The overwhelming majority of these, 55%, have taken place in Harvard Sq. The predominant scenario for this criminal enterprise is the theft of laptops, cell phones and wallets from victims dining in the early afternoon between the hours of **12:00PM and 2:30PM or later in the day from 5:30PM to 11PM.**
- **2 people were arrested in separate dipper incidents on Friday 5/25/12 in Harvard Sq.**





# LARCENY: of Bicycle

No Patterns

- The 5-year weighted average for the first 5 months of the year is 59. At this point in 2011, there were 56 bikes stolen, which is just below the norm. In 2012, however, the lack of cold weather and precipitation has yielded 91 bicycle thefts to date, equaling a 63% increase over last year and a 54% rise over the 5-year average. The majority of thefts are bicycles that are locked but are left out in the open (locked to public bike racks or sign poles, for example).
- It should be noted that 54 of the 91 bike thefts reported thus far in 2012 occurred in April or May, accounting for over half of this year's total.
- More than 2/3 of the 24 bike thefts reported in May took place in the lower half of Cambridge (below Harvard Sq).
- **The neighborhoods that have reported the highest number of thefts this far in 2012 are: Cambridgeport (20), East Cambridge (11), Mid Cambridge (9), and Riverside (9).**



# Larceny of Bicycles:

*What Can We Do?*

## Police Response Strategy:

- Bicyclists stopped for infractions will be reminded to use lights when biking at night, wear helmets under the age of 16, and other safety tips to promote safer biking in the city.



- The projected 5–year weighted average assigned to auto theft for the first 5 months of the year is 65 incidents; there were 51 cars stolen from January to May 28<sup>th</sup> of 2012, translating to a 22% decline. When measured versus the same time period in 2011, there was an increase of 1 auto theft from 50 to 51 incidents.
- The number of vehicles stolen in Cambridge dropped by 11 incidents, or 7%, to 158 incidents in 2011. **This is the lowest auto theft total the City has seen in 50 years. This is a record low for a city that used to see staggering auto theft numbers – in 1974 there were 5,203 cars reported stolen.**
- Very few auto theft patterns have been identified in the recent past. Hot spot clusters have been observed in and around the neighborhoods of Central Square – Area 4, Cambridgeport and Riverside—but no definite spatial or temporal trend has been identified in 2012.
