

Draft Updated Combined Sewer Overflow (CSO) Control Plan Fall 2026 Public Hearings Timing and Agenda

The City of Cambridge, the City of Somerville, and the Massachusetts Water Resources Authority (MWRA) are proud to present the Draft Updated Combined Sewer Overflow Control Plan (Draft Plan). With an estimated investment of \$1.3 billion to be paid for by all 43 Sewer Service Area communities, the Draft Plan will dramatically reduce CSOs across Alewife Brook, the Mystic River and the Charles River and, even in the face of increased precipitation driven by climate change, is projected to eliminate CSOs in a 2050 Typical Year.
