Re: Illicit Discharge Detection and Elimination Investigation Progress - Permit Year 4

Dt: September 16, 2022

This memo summarizes the progress made on the IDDE catchment investigations during the Year 4 reporting period of July 1, 2021, through June 30, 2022.

Due to the COVID-19 pandemic dye testing of residential buildings had been put on hold during 2020 and into 2021. In July of 2021 dye testing resumed to full capacity with residential buildings now being tested.

Catchment investigations continued based on the City's revised priority ranking. Two catchments were identified for investigation based on the dry weather outfall sampling: D33 Blanchard Rd and D46 Acorn Park Dr.

Below is the summary of the dry weather work and/or dye testing conducted in each catchment area currently under investigation.

DeWolfe (D21) Drainage Area

During the Year 3 investigations a correction at 1640 Cambridge St was verified with a post correction dye test and dry weather manhole inspections. During year 4 additional work was conducted downstream. The east inlet of D21DMH2025 was inspected and cleared by the follow-up dry weather work.

Dye testing was conducted at the addresses identified during the Year 3 investigation for when testing of residential buildings would be able to resume. Two partial direct illicit connections were identified during permit year 4. They were confirmed with CCTV (64 Highland Ave and 6 Marie Ave) during permit year 5 (7/13/2022). During permit year 4 we also identified one *potential* partial direct illicit was identified with CCTV outstanding (36-38 Dana St), and two partial no dye founds were identified (29 and 67 Dana St); the remaining test results were legal (See Appendix A).

Broad Canal (D07) Drainage Area

No dry weather manhole inspections were performed in this area by SDE between July 1, 2021, through June 30, 2022.

Dye testing was conducted on several addresses in this area while bypasses were set up on the storm drain that was observed as standing water during the dry weather work investigation in Year 3.

• 80, 90, 105, 115, 120, 145 and 150 Broadway all tested legal

Jackson Place (D38 - CAM401a) Drainage Area

Additional dye testing was conducted at 2 Cambridge Park Drive as part of a follow-up on the contamination found at S72CMH0095 during the Year 3 investigation. All dye tests results were legal.

After dye testing, reinspection was conducted on the unmapped inlet in S72CMH0095. Results still showed contamination was present. Next steps are to CCTV the unmapped inlet to determine the origin.

- Test kit results: Ammonia=1.0 mg/L, Surfactants=0.5 mg/L, Chlorine=1.52 mg/L
- Lab results: E. coli= 70.83 MPN/100ml, Ammonia= 0.743 mg/l, Surfactants= 0.120 mg/l

Flagg St (D19) Drainage Area

No work was performed in this area by SDE between July 1, 2021, through June 30, 2022.

SDE will attempt to reinspect the standing water pipe segments in this area during a future extended period of dry weather. If the standing water is still present, the area will have to be cleared through dye testing.

University Rd (D27) Drainage Area

No dry weather work was performed in this area by SDE between July 1, 2021, through June 30, 2022.

Two addresses, 980 Memorial Dr and 20 University Rd, adjacent to standing water found during the Year 3 investigations, were identified for dye testing. Multiple tests were complete at both buildings and all results were legal.

Matignon Rd (D44) Drainage Area

No dry weather work was performed in this area by SDE between July 1, 2021, through June 30, 2022.

One address, 64-66 Matignon Rd, adjacent to standing water found during the Year 2 investigations was dye tested and the result was legal. One address, 26-27 Alewife Brook Parkway, is the last outstanding building adjacent to the standing water in this



area. SDE and the City will continue to attempt to gain access to this address for dye testing.

Sparks St (D31) Drainage Area

No dry weather work was performed in this area by SDE between July 1, 2021, through June 30, 2022.

Dye testing was conducted at addresses identified during the Year 2 and Year 3 investigations for when testing on residential buildings would resume. One *potential* illicit was identified through dye testing and the remaining addresses all tested legal.

- 3 Gray Gardens West tested dye in both sewer and drain. CCTV of sewer and drain mains completed by City Contractor February 2022. CCTV of sewer and drain laterals is outstanding.
- Sewer manhole S45SMH8615 (located near 3 Gray Gardens West) dye tested legal with no dye seen in the downstream drain D31DMH4050 after 30 minutes
- SDE attempted but was unable to gain access to 76-76A Sparks St for testing

Addresses that tested legal are listed in the table below:

*SDE will re-dye test #91 Garden Street based on results of CCTV which indicate suspect lateral connections despite dye testing legal

During Year 2 Healey Street was flagged as *potentially* having infrastructure defects allowing sewage to leak into the storm drain based on SDE dye testing. Some CCTV was completed as a result during Year 3 by the City's CCTV Contractor. One remaining segment of the drain was televised during Year 4 also by the City's CCTV Contractor. Additional investigation is required to determine the origin of the leak prior to making repairs.

During Year 2 #2 Hemlock Street was identified as a *potential* illicit connection based on SDE dye testing (1st floor toilet not legal). Some CCTV of sewer and drain mains was performed during Year 3 by the City's CCTV Contractor. CCTV of the mains was completed during Year 4 (October 2021) revealing major defects in the mains. CCTV of the sewer lateral for #2 Hemlock is outstanding.

Cambridge IDDE Progress Update



Blanchard Rd (D33) Drainage Area

A thorough dry weather work investigation was conducted in this area, the results of which are summarized below.

- Cleared streets: Thingvalla Ave, Cushing St, Locus St, part of Holworthy St, Fountain Ter, part of Huron Ave and Blanchard Rd
- Standing water streets: St Sauveur Ct, Corcoran Ln and part of Holworthy St
- Contaminated streets: May St, Lawn St and part of Huron Ave. Details of the contaminated pipe segments are listed in the table below:

Addresses for dye testing were identified based on the contamination found at D33DMH1090 and the standing water found at the upstream manholes ACCESS104 and ACCESS105. All test results were legal.

Sewer manhole S60SMH0240 (located near 40 St Sauveur Ct) dye tested legal with no dye seen in the downstream drain ACCESS105 after 30 minutes however, when 18 Corcoran Ln was dye tested, dye was seen in sanitary sewer manhole S60SMH02040 via the southwest inlet. Dye was first seen entering into the inlet of the manhole (this building appears to be the only building upstream of the this manhole). Dye also appeared to infiltrate through either the manhole wall or through the concrete on the top of the bench. This result may indicate that the sewer lateral could exfiltrate and contaminate the nearby drain. CCTV of this lateral is the suggested next step.



- SDE attempted but was unable to gain access to 61-63 May St for testing (SDE and the City will continue to attempt to access this building)
- See Appendix C for all buildings that tested legal

Acorn Park Dr (D46) Drainage Area

A thorough dry weather manhole inspection investigation conducted in this area found standing water throughout. Manholes D46DMH0150, D46DMH0115, D46DMH0180, DMH460102, D46DMH101 and outfall D46OF0000 were all observed as standing water. Cleaning and CCTV is planned for winter 2022/23.

No dye tests were performed in this area by SDE between July 1, 2021, through June 30, 2022.

Fainwood (D01) Drainage Area

This area is a non-MS4 drainage area as it ends up going to a combined sewer system. Investigations in this area were conducted as part of future sewer separation work. Dry weather work was conducted on two manholes in this area: D01DMH5532 and D01DMH5580

- Northwest inlet of D01DMH5580 was cleared (no contamination found)
- Southwest inlet of D01DMH5580 and Northwest inlet of D01DMH5532 had visual evidence of sewage

Addresses for dye testing were identified based on the dry weather work findings.

- 18 and 27 Fainwood Circle tested dye in both sewer and drain. CCTV of the laterals is pending
- 5, 16, 20 and 21 Fainwood Circle tested legal
- SDE attempted but was unable to gain access to 25 Fainwood Circle for testing. CCTV of the lateral is pending

Walden Square (D37) Drainage Area

This area is a non-MS4 drainage area as it ends up going to a combined sewer system. Investigations in this area were conducted as part of future sewer separation work. Dry weather work conducted in this area found that almost all pipes/manholes were clean.

- East inlet of D37DMH1600 was inaccessible for full inspection
- D37DMH1610, D37DMH1625 and D37DMH1645 were cleared

Due to the inaccessibility of the East inlet of D37DMH1600, addresses adjacent to this pipe segment were identified for dye testing.

1-2, 3 and 4-5 Walden Square Rd all tested legal
