Re: Illicit Discharge Detection and Elimination Investigation Progress - Permit Year 7

**Dt:** June 20<sup>th</sup>, 2025

This memo summarizes the progress made on the IDDE catchment investigations during the Year 7 reporting period of July 1, 2024, through June 30, 2025. Catchment investigations continued during Permit Year 7 based on the City's priority ranking:

- Two (2) MS4 catchment investigations commenced and were completed during Permit Year 7 (D33A and D52\_1)
- Thirteen (13) MS4 catchment investigations are ongoing from prior years (D07, D08, D09, D15, D19, D21, D27, D30, D31, D33, D36, D38, and D46)
- Eight (8) more MS4 catchment investigations commenced during Year 7 and are ongoing (D02, D03C, D13, D16, D28, D34, D40, and D52\_2.

The sections below summarize the progress of catchment field investigations during Permit Year 7, including dry weather junction manhole inspections, dye testing, CCTV, and dry and wet weather screening. The following bullets summarize other efforts made by the City to facilitate the IDDE program.

- Leaking Laterals: During Permit Year 7, the City successfully implemented its researched strategy for lining sanitary laterals and eliminated one (1) illicit discharge caused by a leaking lateral. The lateral was lined by a City Contractor from the building cleanout using a UV-cured liner. The post-lining dye test confirmed the lateral is no longer leaking into the drain. The City plans to continue implementing this lateral lining approach in future permit years to eliminate illicit discharges confirmed to be caused by leaking laterals.
- Submerged Drains/Standing Water: During Permit Year 7, the City\_moved forward with its initiative to plug drains and pump out extensive standing water in areas where traditional IDDE has been inhibited. Submerged drains have significantly impeded the progress of IDDE catchment investigations in several areas currently under investigation. A Standard Operating Procedure (SOP) was drafted and the City initially identified three catchments to pilot this approach, including D19, D28, and D46. As the City worked through the development of the SOP for the pilot, both D46 and D28 were eliminated from the list of candidates. It



was determined that D46 was not going to be cost-effective compared to dye testing. For D28, SDE re-checked drains to confirm standing water extent prior to pumping and found differing conditions that led to most of the catchment being cleared by manhole inspections. Catchment D19 presented its own unique challenges which will push it into Permit Year 8 (larger than anticipated volume of water, long lead time for manufacture of plugs for the drain size, and nearby school combined with one-way roads limiting plug install options).

- Certified Letters for Access to Perform Dye Tests: The City and Stantec developed and sent letters via certified mail to homeowners not responding to SDE's dye test attempts at the end of Permit Year 6. Stantec and the City continued to send certified letters to building owners in D15, D16, D21 and D34 throughout Permit Year 7, increasing SDE's dye test entry rate. A "violation" letter was also developed during Permit Year 7 to be used when the first certified letter is not successful. The violation letters includes stronger language and mention of potential enforcement actions. Violation letters were mailed to five (5) building owners during Permit Year 7.
- <u>Phase II Map</u>: The City and Stantec updated catchment boundaries during Permit Year 7 as follows:
  - Added sub-areas for interconnections between catchments D10/D11/D12/D16,
  - Updated catchments around Jerrys Pond, including D52\_1, D52\_2, D52\_3, D52\_4, and D52\_5,
  - Updated catchments around Fresh Pond including D33 and D34 based on detailed review of topography,
  - Updated boundaries for D08 and D09 (MIT area) based on detailed records review, and
  - Updated catchment boundaries based on development projects: D03C, D40. D55.
  - o Resolved overlaps with DCR-MS4 areas throughout the City.
  - Re-categorized one outfall (D23) as an outgoing interconnection to DCR's MS4 system, based on discussions with DCR.

## **COMPLETE CATCHMENT INVESTIGATIONS - MS4:**

The following catchment investigations were determined to be complete by the end of Permit Year 7: D33A Blanchard Rd and D52OF0110.

#### D33A Blanchard Rd Drainage Area

Dry weather manhole inspections commenced and were completed during Permit Year 7. No evidence of illicit contamination was discovered. SDE completed dry weather outfall screening on September 17, 2024, and the outfall was observed dry. SDE completed wet weather outfall screening on 1/6/2025 and 5/23/2025. Positive test kits were cleared by lab sampling, and the catchment is considered complete.



- Samples for certain POCs were erroneously omitted during the initial wet weather outfall screening, necessitating a second screening later in the Permit Year.

## D52 1 Drainage Area

This catchment is small, and one dry weather manhole inspection was completed during Permit Year 7. A dry weather outfall inspection was completed on May 12, 2025, and the outfall was observed to be dry (no flow). SDE completed a wet weather outfall screening on 5/23/2025. Sampling results did not meet likely sewer input indicators; therefore, the catchment investigation is considered complete.

## **ONGOING CATCHMENT INVESTIGATIONS - MS4:**

#### D02 - Lechmere Canal Drainage Area

IDDE investigations commenced during Permit Year 7. Dry weather manhole inspections revealed extensive standing water at the downstream end of this catchment largely caused by the flat terrain near the Lechmere Canal. A large volume of flow originating from a basement sump pump of 39 Sixth St was observed upstream and sampled in D02DMH0085 (E), D02DMH0080 (NE), D02DMH0070 (NW), D02DMH0060 (N). The pipes had positive test kits but were cleared by lab sampling. D02DMH0050 (NW) had positive test kits and lab samples confirmed contamination. Subsequent manhole inspections identified backflow in D02DMH0050 (NW), and it was determined the initial lab sampling was taken from standing water. Thus, the data should be disregarded. Nonetheless, building dye tests will be prioritized around D02DMH0050 (NW) in Permit Year 8 due to standing water.

This catchment area is not a candidate for the plug and pump protocol because of the volume of flow entering the system. Buildings were identified for dye testing based on their proximity to the standing water observed and building dye tests were subsequently conducted. All building dye test results were legal, except for two inconclusive tests at 95 First St where dye was seen in neither the sanitary sewer nor the storm drain. Two mainline sewers are present in the road and only one was observed, necessitating the need for a retest. It should be noted that a Taco Bell kitchen slop sink and washing station were tested, and these fixtures often drain to oil and grease separators, reducing the efficacy of the dye tests. A certified letter was mailed to the homeowner of 103 Seventh St on 3/25/2025 because they refused entry to SDE while performing building inspections. Additional manhole inspections and building dye tests will be prioritized in Permit Year 8.

## D03C - North Point Drainage Area

IDDE investigations commenced toward the end of Permit Year 7. Manhole inspections identified a small extent of standing water at the upstream end of the catchment area and pipes with positive test kits, which were cleared by lab samples, further downstream. Additional manhole inspections will occur in Permit Year 8, and building dye tests will be conducted as necessary.

## D07 - Broad Canal Drainage Area

No manhole inspections or building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

The City continued coordination with a developer related to a leaking sewer lateral at 55 Broadway that was identified during Permit Year 4. In Permit Year 6, the developer confirmed the building is vacant and slated for demolition. During Permit Year 7 the building was demolished. The City is awaiting confirmation from the developer that the leaking lateral was cut and capped as part of demolition.

The City and its contractors reassessed the IDDE investigations already completed during prior permit years and plan to reinspect upstream manholes during Permit Year 8. Manhole inspections previously identified significant standing water in the upstream end of this catchment area and thus it is a potential candidate for the City's plug and pump program. Manhole inspections and follow-up dye tests will be prioritized during Permit Year 8.

## <u>D08- Massachusetts Avenue @ Memorial Drive Drainage Area</u>

No manhole inspections were performed in this area by SDE between July 1, 2024, through June 30, 2025.

Dry weather manhole inspections in Permit Year 6 identified a significant extent of standing water largely caused by flat terrain and the water level of the receiving waterbody. A few buildings in an upstream residential area were dye tested during Permit Year 7, all of which were legal. The limitations of the plug and pump program are not fully known, and it is unclear if this catchment will be suitable given the dimensions of the mainlines. The City will continue to implement its plug and pump program in Permit Year 8 and determine its efficacy in this catchment area. Potential reinspection of submerged manholes and dye testing may take place in this catchment area during Permit Year 8.

#### D09 - Danforth St Drainage Area

No manhole inspections or building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.



Manhole inspections during Permit Year 6 identified extensive standing water and thus is on the list of catchments to plug the drains and pump out extensive standing water. Ownership of storm drain infrastructure was reviewed during Permit Year 7, as some pipes are owned by MIT. The catchment boundary was updated accordingly.

## D13 - MOB Highway Drainage Area

IDDE investigations commenced during Permit Year 7. Dry weather manhole inspections identified standing water at the downstream end of the catchment, and one two-inch PCV pipe, D13DMH0240 (NW), was observed flowing and sampled. The test kit values were high, but the pipe was cleared by lab sampling. Biotic material was observed in the pipe, likely causing higher ammonia values. Buildings were identified for dye testing based on their proximity to the standing water observed and will be prioritized in Permit Year 8.

## D15 - Pearl St Drainage Area

IDDE investigations commenced toward the end of Permit Year 6 and were completed during Permit Year 7. During Permit Year 6, manhole inspections identified standing water in upstream ends of the catchment due to pipe geometry and excessive sedimentation. The City cleaned the pipes and SDE reinspected these pipes. The subsequent manhole inspections identified dry pipes and were cleared by sandbagging. One pipe was still observed with standing water and additional manhole inspections downstream identified more standing water. Buildings in the proximity of these manholes were identified for dye testing. Building dye tests were conducted throughout Permit Year 7, and Stantec sent certified letters to homeowners who were unresponsive to SDE's initial efforts to perform building inspections on May 15, 2025.

D15DMH1070 was not located during Permit Year 6 manhole inspections but was located at the end of Permit Year 7. Flow was sampled with positive test kit values. Dye testing was conducted throughout Permit Year 7. All results were legal and additional building dye tests will be prioritized in Permit Year 8.

#### D16 - Pleasant St Drainage Area

Dry weather manhole inspections commenced during Permit Year 7. Manhole inspections identified standing water in upstream manholes, and D16DMH1050 (NW) was observed flowing and lab samples were collected. Lab data indicated the presence of an illicit connection. Buildings were identified for dye testing based on their proximity to the contaminated pipe. Building inspections were conducted throughout Permit Year 7 but no illicit discharges have been identified. Stantec sent certified letters on October 17, 2024, to homeowners who were unresponsive to SDE's initial efforts to perform building inspections. All adjacent buildings were dye tested, and additional lab samples were



collected for Total and Human Bacteroides to confirm contamination in this segment of pipe. The lab samples again confirmed the likelihood of an illicit connection.

CCTV footage taken prior to Permit Year 7 identified a steady drip from a storm drain lateral originating in the direction of 10 Laurel St. SDE dye tested each toilet in the building in November 2024 to confirm none are plumbed to the roof drain and all dye tests were legal. The drain was cleaned, and both the drain and the sewer were televised. No infrastructure issues were observed. SDE conducted a building dye test on May 2, 2025, concurrent with the CCTV of the storm drain mainlines and building sanitary sewer lateral to pinpoint potential infiltration. No infiltration was observed. SDE conducted another dye test during a rain event on May 22, 2025, concurrent with CCTV of the storm drain mainline and the building sanitary sewer lateral to confirm no infiltration occurs during rain events. The dye test was legal.

An upstream catch basin on River St was observed with standing water in the outlet. The City will disconnect the catch basin from the storm drain on Laurel St in Permit Year 8. Follow up manhole inspections at D16DMH1050 (NW) will be completed during Permit Year 8 after the construction is completed. Additional manhole inspections and subsequent building dye tests will be prioritized during Permit Year 8.

#### D19 - Flagg St Drainage Area

No building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

Dry weather manhole inspections during previous permit years identified extensive standing water, largely caused by terrain and the water level of the receiving water body. The City marked the area as a candidate for the plug and pump program. The City and SDE periodically checked the water level in the drains throughout Permit Year 7 to determine the extent and volume of standing water needed to be pumped out. The extent of water remained consistent and even increased upstream, but D19DMH1005 was observed with flow towards the end of the Permit Year 7, and lab results (*e.coli* 1400, ammonia 1.70 mg/L, surfactants 0.130 mg/L) confirmed low levels of contamination.

The City will continue to move forward with the plug/pump pilot for this catchment during Permit Year 8.

#### D21 - DeWolfe St Drainage Area

The City followed up on three (3) buildings that were identified as potential internal illicit connections during prior Permit years. Please reference Progress Report Year 6 for



further information on these addresses. One (1) of the buildings required additional follow-up, and updates are as follows:

64 Highland Ave: The City coordinated with the residents to make the appropriate
plumbing repairs required to eliminate the internal illicit connection. SDE returned
after the illicit was eliminated and performed two (2) post-correction dye tests on
9/5/2024. The tests confirmed the previously illicit discharge stack had been
corrected. Dry weather manhole inspections were completed downstream on
10/22/2024 and the pipe was cleared of contamination (dry sandbag).

Manhole inspections from Permit Year 6 identified standing water with possible visual evidence in an upstream end of the catchment area, and SDE conducted follow-up building dye tests in Permit Year 7. SDE observed dry conditions in the same manholes while conducting building dye tests and reinspected these manholes. Most pipes were cleared (dry sandbag), and one had positive test kit results and was confirmed with lab sampling. The City sent certified letters on October 23, 2024, and March 18, 2025, and May 15, 2025, to homeowners who were unresponsive to SDE's efforts to perform building inspections. SDE performed building dye tests throughout Permit Year 7, and two (2) buildings require further testing, which will be prioritized in Permit Year 8.

The results of all other dye tests conducted during Year 6 were legal.

#### D27 - University Rd Drainage Area

No building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

SDE commenced building inspections during Permit Year 7. All dye tests were legal, and additional building dye tests will be prioritized during Permit Year 8.

## <u>D28 - Brewer St Drainage Area</u>

No building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

Extensive standing water in this catchment had been identified during prior Permit Years and is largely caused by terrain and the water level of the receiving waterbody. The catchment area is small and the City reserved it as the pilot for the plug and pump program. The City coordinated with its contractors to acquire the necessary plugs and developed an SOP for this work. The City also coordinated with DCR to obtain a permit to access manholes in their right of way. SDE periodically checked the water level in the drains during Year 7 to determine the extent and volume of water needed to be pumped out



During inspections on March 13, 2025, SDE observed a high volume of flowing water in the upstream end of the catchment area. The flow was sampled, and test kits were clean, but revealed high chlorine values. Lab samples were also clean. The City inspected upstream of the flow and discovered and repaired a water main break. SDE returned to reinspect the manholes. Most were cleared by sandbagging, but one was identified with standing water. Buildings were identified for dye testing based on their proximity to the standing water and will be prioritized during Permit Year 8.

The City determined this area is no longer suitable for the plug and pump protocol and moved forward using D19 Flagg St as the pilot catchment area instead.

## D30 - Willard St Drainage Area

No manhole inspections were conducted in this area by SDE between July 1, 2024, through June 30, 2025.

The construction ongoing during Permit Year 6 was concluded and building inspections briefly resumed during Permit Year 7. SDE conducted three (3) legal building tests. The City re-evaluated the need for building inspections after completing the drain rehabilitation. No illicits were identified during the construction and the City determined no further building dye tests are required at this time. SDE conducted a dry weather outfall inspection on December 4, 2024. The outfall and downstream pipe segments are submerged therefore screening took place at an upstream location which was dry (no flow). A wet weather outfall inspection is needed to close out this catchment area.

#### D31 - Sparks St Drainage Area

No manhole inspections were completed by SDE between July 1, 2024, through June 30, 2025.

Three (3) potential illicit connections identified during prior Permit years were pursued during Year 7 as follows:

• 3 Gray Gardens West: Stantec sent a certified letter to the homeowner on April 30, 2025, and the City reinitiated the effort to line this lateral. Rapid Flow televised the lateral on 6/9/2025 from the cleanout and observed it to be failing, with most sewage leaking into the soil. Rapid Flow then installed a new cleanout and completed sewer lateral lining 6/13/2025. Post correction dye tests resulted in dye observed in both the drain and the sewer. It was discovered that the internal plumbing under the basement slab connecting to the new lateral is in



poor shape and needs to be repaired as well. It is also possible that there are infrastructure defects in the road that are contributing to contamination.

- Healey St: During Permit Year 6 the City continued planning and coordination
  efforts with its remedial Contractor to complete test pits along Healy St sewer
  main to determine the cause of bulges observed in the sewer that was re-laid
  with PVC in FY2015. This is the next step required to address the sewer
  infrastructure defects and is anticipated to occur during Permit Year 8.
- 2 Hemlock St: During Permit Year 6 the City continued planning and coordination efforts with its remedial Contractor to rehab the sewer main (and line the sewer lateral for 2 Hemlock St if defects are identified). This work is anticipated to occur during Permit Year 8.

After rehab on Healy and Hemlock is complete, SDE will perform follow up dye testing and manhole inspections to confirm the illicit discharges were eliminated. Additional planning and coordination with the homeowner will be required to eliminate the illicit discharge at 3 Gray Gardens West and follow up manhole inspections, building and sewer dye tests will be prioritized in Permit Year 8. Subsequent manhole inspections will also confirm the potential illicit connection revealed by CCTV footage at 91 Garden St.

#### D33 - Blanchard Rd Drainage Area

No dry weather manhole inspections and no building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

During Permit Year 4, 18 Corcoran Ln was identified as a potential leaking sewer lateral tied directly to a sewer manhole. Dye was not seen in the drain during the 18 Corcoran dye test but was observed leaking into the sewer manhole (not thru invert). There is development work ongoing in this area which impacts the sewer and drain systems. Follow-up manhole inspections will be conducted following the completion of the development work to confirm if the issue has been resolved.

#### D34 - Normandy Ave Drainage Area

IDDE investigations commenced during Permit Year 7. Dry weather manhole inspections identified significant extents of standing water, flowing lines with positive test kit hits cleared by lab samples, and flowing lines with positive test kits confirmed by lab sampling. Buildings were identified for dye testing based on their proximity to pipes with contaminated flow and standing water. Four (4) buildings were identified as potential illicit connections and were pursued as follows:

42 Sunset Rd: An initial building dye test on December 2, 2024, revealed dye in
the sewer and in the storm drain. Dye was seen in the sewer first, and with
greater intensity. SDE conducted additional dye tests between December and
March, concurrent with CCTV of the mainlines and building laterals to
pinpoint plumbing issues. Thus, it was confirmed that there are no direct illicit
connections, but the sewer lateral is leaking. On March 28, 2025, the sewer



lateral was lined, and a building dye test was conducted with dye observed in the sewer only. A follow-up manhole inspection was completed, identifying positive test kit values confirmed by lab sampling. Additional building tests and subsequent manhole inspections are required and will be prioritized in Permit Year 8.

- 27 Normandy Terrace: An initial building dye test was completed on October 9, 2024. Dye was only seen in the storm drain, but it was unclear if this was the result of a direct illicit connection, severely damaged lateral or infrastructure defects in the mainlines. SDE conducted additional dye tests on April 2, 2025, concurrent with CCTV of the building's sanitary lateral to pinpoint plumbing issues. The storm drain was 50% submerged and could not be televised, however a push camera was extended to the end of the sanitary lateral and dye was placed in upstream storm and sewer manholes. Thus, a direct connection was confirmed. The City is coordinating with the homeowner to eliminate the illicit connection, anticipated Permit Year 8. Additional manhole inspections and building dye tests will be prioritized in Permit Year 8 following elimination of the illicit connection.
- 7/9 Normandy Ave: Two initial building dye tests were completed on September 26, 2024, resulting in a partial not legal result. SDE conducted another dye test on October 2, 2024, and confirmed all basement fixtures drain into a sump, where an ejector pump leads into the main stack (legal connection). The ejector pump does not turn on, and dye water exfiltrates from the sump and enters the drain. The City coordinated with the homeowner to make corrections to their internal plumbing. SDE returned on May 8, 2025, and performed a post-correction dye test, which was legal. The basement fixtures now connect to a functional ejector pump, which discharges to the main stack. No fixtures connect to the leaky sump. Downstream manhole inspections are required and will be prioritized in Permit Year 8 pending correction at 1/3 Normandy Ave.
- 1/3 Normandy Ave: SDE conducted a building dye test on September 30, 2024, and dye was seen with full intensity in the storm drain and medium intensity in the sewer. Later, there was a sewer backup at this address while conducting sewer mainline cleaning. SDE will conduct additional building dye tests in Permit Year 8 concurrent with CCTV of the mainlines and building laterals to pinpoint plumbing issues.

Additional building dye tests were completed but all results were legal. Stantec sent certified letters to homeowners who were unresponsive to SDE's initial efforts to perform building inspections on May 15, 2025. Further building dye tests and manhole inspections are required and will be prioritized in Permit Year 8.

#### D36 - Alewife Quadrangle Drainage Area



No dry weather manhole inspections and no building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

The City and its contractors reassessed the IDDE investigations already completed during prior permit years and identified manholes that require rescreening. Ongoing construction occurring during the initial sampling added water to the storm drain and could have contributed to contamination. Construction was ongoing for much of Permit Year 7, limiting SDE's ability to rescreen select manholes. Dry weather manhole reinspections, and as needed building dye tests will occur in Permit Year 8.

## <u>D38 - Jackson Place Drainage Area</u>

IDDE investigations continued from previous Permit Years. SDE completed dye tests at the three (3) outstanding buildings in this catchment. 310 and 312 Rindge Ave tested legal, but an illicit connection was confirmed in the rainwater holding tanks at 130 Cambridgepark Drive. Initial dye tests of 130 Cambridgepark were legal, but visual evidence was observed in storm drain manholes, and isolated to the outlet of rainwater holding tanks. The tanks discharged during manhole inspections and flow with positive test kits was confirmed with lab sampling. Olfactory and visual inspections of the access points to the holding tanks were conducted, and soap suds and a musty odor was observed.

The owners of the building confirmed the illicit connection of one sanitary waste stack and one laundry waste stack coming from an apartment and informed the City the stacks have been corrected. The City is coordinating next steps with the property manager. Manhole inspections and building dye tests will be conducted in Permit Year 8. Pending resolution at 130 Cambridgepark Drive, a wet weather outfall inspection is required to close this area.

#### D40 - Harrison Ave Drainage Area

IDDE investigations commenced during Permit Year 7. Dry weather manhole inspections identified clean pipes (dry sandbag) and extensive standing water at the downstream and upstream ends of this catchment. The standing water is largely caused by terrain and the water level of the receiving waterbody. Manholes were reinspected throughout the year and similar extents of standing water was observed. This catchment is a candidate for the plug and pump program.

No building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

#### D46 - Acorn Park Dr Drainage Area



One manhole inspection was conducted in this area between July 1, 2024 and June 30, 2025. A flowing line was sampled revealing low test kit values and was cleared by lab sampling.

Dry weather manhole inspections during previous Permit years identified extensive standing water at the downstream ends of this catchment, largely caused by terrain and the water level of the receiving waterbody. Thus, this area was initially planned to be inspected as part of the Cities' plug and pump program. While reevaluating the cost to plug and pump the drains during Permit Year 7, the City determined it would be more cost effective to perform building dye tests. All building dye tests were legal. Wet weather outfall screening is required to close out this catchment area.

## D52 2 Drainage Area

Manhole inspections commenced during Permit Year 7. This catchment is small, and a dry weather outfall inspection was sufficient to clear the catchment. SDE conducted an outfall inspection on May 20, 2025. The outfall was observed with standing water, and one of the upstream inlets was flowing and subsequently sampled, while the other inlet was cleared by sandbagging. The flow had low positive test kits and was cleared by lab sampling. A wet weather outfall inspection is required to close this catchment area.

See Appendix A for details on the dry weather outfall screening.

## **ONGOING CATCHMENT INVESTIGATIONS - NON-MS4:**

#### D01 - Fainwood Circle Drainage Area

This area is a non-MS4 drainage area as it discharges to a combined sewer system. Investigations in this area were conducted as part of future sewer separation work. No dry weather manhole inspections and no building dye tests were performed in this area by SDE between July 1, 2024, through June 30, 2025.

Based on prior years dye test results, three (3) building sanitary laterals and two (2) drain laterals were televised during February and March 2023. Defects were observed and the sanitary laterals were added to the City's lining contract. The city is coordinating lateral lining during Permit Year 8. SDE will conduct follow up manhole inspections and building dye tests as needed.

#### D32 - D32CMH0210 Incoming Interconnection

The City identified an incoming interconnection from Mount Auburn Hospital's private drainage system that discharges into the City's combined system separately from the permitted connection. SDE inspected D32CMH0210 and observed standing water. Future inspections will be prioritized during Permit Year 8 when the water level of the receiving water body is lower.
