As in-a weekly email to the community that outlines what we can expect?	Response by: The City of Cambridge General schedule posted on site bulletin boards. When work starts ramping up, weekly updates will occur with construction schedules and updates. That said, it is a little difficult to pin down what is happening when and where on the site. The team does work when deliveries and weather allow, so we will try to be specific in our updates, but we can't be specific with for example at 2PM something is happening. If the weekly e-mails become too redundant, we might start posting on the project page.

Response by: Perkins Eastman We're just designing this down, but we're hoping it will be a ballasted area, but we wouldn't be going higher than the gym. In some areas the solar panels are right on the roof, and others it is ballasted.

Response by: The City of Cambridge It would be rather difficult due to building the building while having the fields open. Brian Santos: I agree with that, summer isn't right for planting, we'd time that for Spring and late Fall.
7	From: Peggy Barnes Lenart The playground areas at Tobin were well used, good amenities Is there more specific info about the playground access hours and size for the community? Any water features with shade?	Response by: Traverse Landscape Architects Each of the playgrounds in the video would be accessible to the community. There are large openings within the fencing, all open similarly to the way it was used prior. For example, when kids are out at recess, community members may have shied away from using the playgrounds during that time. There is some separation from outside play areas and outdoor learning spaces. No splash parks anticipated in the current design. Shade structures and shade trees are being provided in specific playground areas.

Response by: Perkins Eastman We are studying the acoustics for all of the spaces very closely with our Acoustics consultant, dining which could be used for meetings, professional development space, and heart of school on the 3rd floor, as well as the Gyms. Response by: The City of Cambridge Storm water facility, bio swales, playing fields, all will be public works responsibility. When it comes to snow plowing, it is our expectation that DPW would be responsible for plowing pathways and entryways. Other areas would be the schools responsibility.
13	From: Anonymous Attendee With projections for more heat waves, please consider some outdoor water features for community as was in the previous Tobin playground. Very appreciated and used in the previous Tobin playground space. Thank you for considering community comments.	Response by: The City of Cambridge We are only at 60% CDs so there is still a chance for those features to be included.
14	From: Joyce Hackel What is the timeline for the landscape and tree planting. Will that all wait until 2025?	Response by: WT Rich Yes, we're hoping for fall of 2024, but most likely Spring and Fall of 2025. Brendan Roy, with as large of a landscape package as this school has I hope for 2024, but most likely 2025.
15	From: Anonymous Attendee Multi-use paths - ideas about safe design for bikes and pedestrians, e.g., width and marking of "lanes"?	Response by: Traverse Landscape Architects The multiuse path from Concord & Fern to Vassal will be 12' wide with a 2' shoulder on either side. Some areas where we're working with fitting in buffers like near the Armory it might be a little less than 2' shoulder, but they will be asphalt with a dashed line down the center per what the City of Cambridge wants to see.
16	From: Jay Yesselman Sorry I just got here. When do you expect demolition to occur?	Response by: The City of Cambridge Abatement will start November and December. Demolition will start in January. We'll make sure to give plenty of updates, via flyers and bulletin boards with weekly activities.
