- \$300,000 appropriation


Project Background

- One of many ways the City of Cambridge will celebrate the Nineteenth Amendment Centennial in 2020
- Related event series will host City events and promote regional events through August 2020

Project Goals

- Recognizing complex history of the suffrage movement
- Telling a representative story of the 19th Amendment
- Embracing past, present and future of American democracy
- Selecting a prominent site that demonstrates the significance of this project



Site Selection

- June November 2019: Site Selection
 - Robust Committee process
 - 8 potential locations reviewed
 - Site visits to 5 locations
 - Meetings with key stakeholders for 2 preferred sites
- November 2019: Cambridge Common selected as site
 - Historical Commission must approve final artwork
 proposal




Artist Selection

- April 29, 2020: Finalists Present to Community
 - Artists will present at public meeting and answer questions about proposals
- May 13, 2020: Selection Committee meeting to select winning proposal




