#### 1. Call to Order

Chair Yasmin Padamsee Forbes called the meeting to order at 6:04 p.m.

#### 2. Public Comment

No one was recording the meeting and members of the public were not present.

### 3. Review and approval of January 2021 Minutes

The Commission reviewed the minutes from the January 7th meeting. Commissioner Callender moved to approve the minutes, seconded by Commissioner Stack.

## 4. Executive Director's Report

Attorney Investigator (AI) Carolina Almonte updated the members of the Commission on the latest cases. Since the January meeting, no new cases opened but one case closed. Currently, there are four pending cases, of which half of the cases involve a claim of discrimination in housing and the other half a claim of discrimination in employment. In the housing complaints, the claims are based on the person's source of income, national origin and family status, respectively. In the employment complaints, the claims are based on national origin, age and gender identity. The closed case involved a claim of discrimination in housing based on the person's disability.

AI Almonte also provided a brief summary of the finding from the HUD Performance Assessment. Project Coordinator (PC) Rosa updated the Commission on staff training and activities. PC Rosa and former ED Schlacter met with the City Manager for the Budget Hearing. PC Rosa attended a webinar by Lawyers for Civil Rights Boston on Sustainable

Cities and Language Access. PC Rosa has joined the Language Justice Working Group for the Family Policy Council. Through that work, PC Rosa met with Welcoming America and Nancy Tauber, Executive Director of the Family Policy Council.

## 5. January 2020 meeting follow up

- Acting Interim ED from Law Department has not yet been announced. CHRC staff will inform the Commission once it is finalized.
- Commissioner Callender informed the Commission that she participated in a workshop by the Attorney General on how criminal records can be sealed by mail-in applications.
- Co-Chair Padamsee Forbes attended a meeting of the Asian American Commission of Boston to see how their meetings were run.

## 6. New Business

Members of the Commission brought up issues they have experienced accessing information about vaccine distribution and using the State's website. Concerns on whether the State is collecting data about communities of color were also discussed. Commissioner Selk directed the members to access data by race on the Department of Public Health website or to email her directly with any question on what the State is doing in response to COVID19 and vaccine distribution.

PC Rosa will be meeting with her counterpart at the Community Development Department, Emily Solomon, on launching the story journal for Fair Housing Month in April. Work on the Story Journal is in progress.
