

# Cambridge Human Rights Commission Thursday, November 8, 2018

### 1. Call to Order

Chair Chanta Bhan called the meeting to order at 6:07 p.m. No one was recording the meeting.

# 2. Public Comment

Tyler Oringer from the Cambridge Chronicle was present.

## 3. Review and approval of October Minutes

The Commission reviewed the minutes from the October meeting and unanimously approved them with edits to add Attorney Investigator Acloque as the author of the Commission's Sample Letter to Respondent Attorney Regarding Mandatory Training for Repeated Violations of Anti-discrimination laws. Another edit was made to reflect the date and place of the November Commission meeting. Commissioner Mercedes Evans moved to approve the minutes, seconded by Vice Chair Joshua Stadlan and Commissioner Bonita Cox.

# 4. Executive Director's Report

ED Schlacter updated the members of the Commission on cases. Since the October meeting, two cases opened, and four cases are pending. Three cases closed. The pending cases involve allegations of discrimination in places of public accommodation and in housing based on race and disability. The cases that were closed concerned allegations of discrimination in housing based on age and disability. ED Schlacter updated the Commission on staff training and activities. Attorney Investigator Acloque and a number of CHRC Commissioners attended the Implicit Bias discussion featuring Harvard Professor,

Mahzarin Banaji, on October 17, 2018, which was very well attended by members of the community and City Staff. ED Schlacter attended the NEPT Planning Meeting for a December housing resources event; Vice Chair Joshua Stadlan tabled at a housing information session event hosted by the Cambridge Community Development Department; and Attorney Investigator Acloque partnered with the Massachusetts Commission Against Discrimination on November 6, 2018 to provide "Preventing and Addressing Housing Discrimination" training to a repeat Respondent Property site. ED Schlacter also attended an Integrating Communications, Assessment and Tactics Training at the Cambridge Police Headquarters on October 23, 2018. Both ED Schlacter and Attorney Investigator Acloque attended a statewide fair housing coalition meeting in Worcester in October 2018.

# 5. October meeting follow up:

- Baby U Lead Law/Family Status discrimination

  - Commissioner Nadia Davila stated that she would reach out to the program. A discussion was had about the Commission conducting outreach to parents during the program's Saturday classes from January to March 2019.
- Commissioners shared their feedback and overall favorable impressions of the discussion. The event was very well attended by the larger Cambridge community. Following this event, the City has planned a city-wide community forum called "Cambridge Digs Deep" to share feedback, build trust, and engage in dialogue across difference. The forum is scheduled to take place on Wednesday, November 28, 2018 at the Fletcher Maynard Academy Gymnasium from 5:30 8:00 p.m.
- LGBTQ+ Commission/Mayor's Office October Town Hall event with a youth focus on October 11, 2018 in the City Hall Sullivan Chamber at 6:00 p.m. The LGBTQ+ Commission researcher informed ED Schlacter that the event was well attended and that the LGBTQ+ Commission shared best practices with the audience. CHRC Commissioners and Commission staff were unable to attend the event.
- Connecticut Human Rights Commission Guidance on Non-discrimination in Hiring Veterans

This discussion was postponed due to Commissioner Kuong Ly's absence.

### 6. New Business:

• Nominations for Chair/Vice Chair for 2019

Nominations are due by December 2018. Self-nominations are accepted. The Commission can decide between having a co-chair or a chair/vice-chair model. The new Chair will begin his/her role in January 2019.

Online Discrimination Intake Form

The English version came online on May 30, 2018. The form is currently being translated into Spanish and Kreyol and will be finalized by the IT Department. The translated versions are expected to be online by November 13, 2018.

The Fair Housing Ordinance is still awaiting legislative ruling on the City's Home Rule petition, and therefore has not yet been approved.

# • Outreach at CDD/Housing Inclusionary Information Meeting

Vice Chair Joshua Stadlan tabled at a housing information session event hosted by the Cambridge Community Development Department and shared his impressions of the effectiveness of conducting outreach at the event.

# • CHRC contact "postcards" for Commissioners

ED Schlacter distributed CHRC post cards for Commissioners to share with their groups to increase awareness about the CHRC's services.

# • Outreach to CRLS Guidance Counselors

The discussion was postponed due to Commissioner Michael Kourabas' absence.

## • Potential New Sites for CHRC Presentations

Chair Chanta Bhan provided ED Schlacter with the contact information of a social worker at Cambridge Hospital so that the Hospital can determine whether it would like to have a presentation from the CHRC.

# • Outreach to Properties that have had multiple complaints alleged against them in recent years, for education

Attorney Investigator Acloque discussed the training that she led at a Respondent site, in partnership with the Massachusetts Commission Against Discrimination, and stated that the training was well-received.
