

2026–2027 DHSP Afterschool Programs

Monthly Tuition Rates

- Monthly tuition rates are based on family income, household size, and the number of days a child is enrolled each week.

Payment is due the first week of each month.

- Tuition is paid by check or money order.** Please make checks payable to City of Cambridge and write your child's full name on the memo line.

- Tuition is free for 6th–8th graders.

- Fletcher Maynard Academy (FMA) and Dr. Martin Luther King Jr. (MLK) Community Schools have different monthly tuition rates that reflect the fewer number of hours the two programs operate each day.

- Sibling tuition discount:** If a family has more than one child enrolled in DHSP afterschool programs, the household's highest tuition fee is be paid in full each month. Additional tuition fees of equal or lesser value are 50% off. *The discount is not applicable to 6th–8th graders enrolled in CYP's afterschool programs who receive free tuition.*
