## LGBTQ+ Commission – YOUTH WORKING GROUP

Meeting Minutes January 8, 2025 Location: Zoom

- 1. Call to order
- 2. Assign minute taker (Bill)
- 3. DCF (Mass. Dept. of Children & Families) Presentation
  - Some New Business was moved up the agenda so Bourin & Karen could present
  - Presentation by Bourin You, the recruiter for LGBTQ+ welcoming families, and Karen Manna, the foster care ambassador for LGBTQ+ welcoming foster homes. They introduced us to the foster care system in Massachusetts & how it works. Their goal is to build more foster care homes in Massachusetts that are LGBTQ+ affirming.
    - Foster parents fall into three categories: Kinship; Unrelated; Pre-adoptive
    - All potential parents must be LGBTQIA+-affirming
    - Massachusetts is "Canon Family First" state
    - Karen & her husband have been foster parents for 23 years
    - Q: "How can we help you?" A: This meeting is a good first step. We can share information back & forth. We can collaborate on tabling at events. We can publicize their efforts in our newsletter.
    - [ ] Action Item Bill: Get blurb for newsletter from Bourin
    - Q: "Can we get a copy of your slides?" A: No, but Bourin can send a summary.
    - [ ] Action Item Bill: Get summary of slides from Bourin

- Q: Do you have many single foster parents? A: Of 40 families in the office now, about half are single parents.
- Q: Of the different outcomes (foster-to-adoption, stay with same foster parents, go home, move from one foster household to another, etc.), what typically happens? A: Most eventually go home, but it can take a long time. Unfortunately, some do "bounce around" the system. They need more foster homes.
- Q: Would it be useful to (or do you already) do queer-specific introductions or gatherings? A: Not yet, but they are willing to come to anything, and are open to collaboration.
