# BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES Wednesday, March 9, 2022, 2:30 p.m. By Remote Participation

This meeting was held remotely in accordance with Section 20 of Chapter 20 of the Acts of 2021, signed into law on June 16, 2021. Meeting started at approximately 2:30 p.m.

**Decisions:** All votes were by roll call vote, 2-0, unless otherwise stated.

#### **Public Testimony Matters**

**1. Application #161215** New England Auto Group, Inc, 235 Western Avenue, for a New Used Car Dealer's License (Office Only).

**Present:** Andrew Upton, attorney; and Ameer Alshukri, applicant.

**Documents Considered:** Application and documents attached thereto; and explanatory statement from applicant.

**Summary:** The intent for this business is to be an office based and to obtain a Wholesale Used Car Dealer License, which allows the applicant access to auto auctions in order to buy and sell cars dealer to dealer via auctions. By having the license the applicant can also buy vehicles from auction to export. Although the applicant holds a New Hampshire license, it cannot be used for his intended business. The general concept is to wholesale and transport automobile dogmatically and internationally from office via virtual tools including accessing to auctions, transportation platforms, and CRM. He intends to buy the cars, transport them directly to dealers or oversees and all via internet with none of the cars coming into or being stored in Cambridge. The way the law is written in Massachusetts, he cannot operate without a license from the municipality from which he is operating.

**Decision:** Under advisement.

The hours of operation would be 12:00 p.m. – 11:00 p.m. Street and Sidewalk Business Use Permit ("SSBU") has been issued. Denise Jillson spoke in favor of the application.

The market portion of the business has hours of Monday - Friday 6:00 a.m. – 9:00 p.m., Saturday and Sundays 7:00 a.m. – 8:00 p.m. Within those hours, theu intend to operate the alcohol within the statutorily allowed hours.

**Decision:** Granted subject submission of missing articles of organization for LLC, and releases from the DOR and DUA. Also with amended hours, Monday - Friday 6:00 a.m. – 9:00 p.m., Saturday and Sunday 7:00 a.m. – 8:00 p.m. the market and the opening hour for alcohol will be the statutorily allowed hour of 8:00 a.m. Monday – Saturday and 10:00 a.m. on Sunday. Closing hour for alcohol will be the same as the market. There will be a condition on the license that when the store is open but alcohol cannot be sold, the aisles and coolers with alcohol must be secured with gates/locks.

Application #143352** 261 SRC, LLC d/b/a Source, 27 Church Street, C.V All Alcohol License #63767, for an Alteration of Licensed Premises to include a Seasonal Outdoor Patio in the City Parking Lane. **Summary:** The need to upgrade to an all alcohol license is based off regular customers' requests. These are customers that walk to the store and live in nearby vicinity. The intent is to continue serving the community with a one stop shop location. The owners have made significant changes to the store since they took it over and the accolades in the letters of support regarding the applicant's fitness and character are evidence of it. There is no intent to sell nips or singles. There will be no changes to the current hours of operation and the market's current configuration is not going to change, rather some of the extra liquor inventory will be replaced with more varied inventory.

**Decision:** Granted with the condition that no nips or single are sold.

Application #154040** Amelia's Trattoria II, LLC d/b/a Amelia's, 111 Harvard Street, Common Victualler All Alcohol License, has applied for an Alteration of Premises to include an outdoor patio on private property. The Board confirmed with DPW that there have been no grease

trap issues associated with the business. The outdoor area has been operating under the temporary for 2 years with no licensing violations and no complaints.

**Decision:** Granted with the condition that when the store is open but alcohol cannot be sold, the aisles and coolers with alcohol must be secured with gates/locks.

**10. Application #159882** RCH, LLC, d/b/a Mr. Bartley's Gourmet Burgers, 1246 Massachusetts Avenue, Common Victualler License #106424, to add Seasonal Outdoor Seating in the City Parking Lane.

Present: Josh Huggard. Denise Jillson, HSBA.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This is meant to mirror the set up approved through a temporary extension due to COVID-19 #118290. Going from the current approved patio on the sidewalk to the parking lane with 14 seats on the sidewalk and 16 seats on the street. The hours of operation are meant to be the same as inside. The SSBU application has been filed but the permit has not been issued. Denise Jillson spoke in support of the application.

**Decision:** Granted.

**11. Disciplinary** Fat Heady, LLC, d/b/a Whitney's Café, 37 JFK Street, Common Victualler All Alcohol License #99534, for allegations of violating the City of Cambridge Mask Order and certain provisions of the law related to the referenced license. Specifically, whether on February 24, 2022, an employee of Whitney's was not wearing a face mask over their nose and mouth, as required by the current City of Cambridge Face Mask Order, in violation of G. L. c. 138, §§ 23 and 64, and Board's Rules 2, 13 & 14.

**Summary:** A warning letter was previously sent on December 13 for at least one employee not wearing a mask on December 10. Bubenik testified that when he entered the premises he saw McGuire at the bar with no mask or face covering on (or even on his person). Bubenik confirmed McGuire was not the person who he observed to not wearing a mask on December 10. McGuire testified he wears a handkerchief but takes it off from time to time due to a medical condition (sleep apnea). McGuire testified he was restocking the bar when Bubenik entered and that all other employees were wearing masks at the time.

**Decision:** Under advisement.

**12. Application #161333** Fat Heady, LLC d/b/a Whitney's Café, 37 JFK Street, Common Victualler All Alcohol License #99534, for a Change of Closing Hour to 2:00 a.m. Thursday Through Saturday and to add Live Entertainment with Amplification.

**Summary:** They want to be able to provide live acoustical music all days. The area needs the amenity and the business concept allows for it. The 2:00 a.m. closing hour request is to accommodate the need. Denise Jillson spoke in support of the application.

**Decision:** Granted.

**13. Application #128376** One Linkage, LLC d/b/a One, 1759 Massachusetts Avenue, Common Victualler License #13380, to add Seasonal Outdoor Seating in the City Parking Lane.

Present: Yan Lin. David Johnson, business abutter.

**Documents Considered:** Application and documents attached thereto. Correspondence received regarding application.

**Summary:** This is meant to mirror the set up approved through a temporary extension due to COVID-19 #85058 but with a smaller footprint – just the parking spot in front of the premises, and 9 seats. The intended hours of operation are meant to be the same as indoors. They will be lowering the barrier and replacing it with one that is compliant with the current policy which requires the height to be 42 inches or less. The abutter notification was sent late. David Johnson spoke in favor of the application so long as the barrier is lowered to 42 inches.

**Decision:** Defer due to abutter notification.

SNV #163863 Jarrod LaRocco on behalf of Bond Civil & Utility for 3/9/22 - 5/27/22 (Alt. 3/10/22 - 5/30/22) at 145 Broadway, from 6:00 p.m. to 7:00 a.m. the following morning on weekdays, to perform utility work, strictly on an as-needed basis, related to the Kendall Culvert Project using excavators, pile drivers, compactors, trucks, generators, compressors, and other civil construction

**Summary:** This variance was previously granted for the same reason as this one is sought - to reduce impacts to the public and utility users. The Department of Public Works has asked that the variance be granted but that they are notified prior to it being exercised since the intent is that the variance is not always going to be needed for the time being requested.

**Decision:** Granted with the conditions that 1) No work is to take place on legal holidays, 2) Prior to exercising the variance, the Department of Public Works must be notified, 3) The number of times the variance is exercised cannot exceed eight (8).
