35. Matter Taken Under Advisement December 1, 2022 Application #200526 - Chad Nixon on behalf of Consigli Construction for 1/9/22 to 2/17/22, at 600 Main St, Monday through Friday from 6:00PM to 12:30AM. Using welding machines and a crane to erect a stairway inside of the building. Variance is being sought because this is a high-risk activity that cannot be performed during normal construction hours as it would be the other construction workers at risk.

Summary: When this was heard, there was concern that the applicant had not shown undue hardship. In addition, the Department of Public Works ("DPW") had raised some concerns that there was no need for the variance, but then additional comments seemed to have indicated otherwise. DPW did not clarify their comments to the Board. Notwithstanding, the Board discussed there was no undue hardship. The applicant stated that if the work was done during regular hours, then other crews could not work in the area on other matters. It is a scheduling issue. The installation can occur during regular hours so long as that is the only thing done at the time.

Decision: Denied as there is no undue hardship. The work can be completed during allowable hours.

36. Matter Taken Under Advisement December 1, 2022 Application #201336 - Mark Petitto, on behalf of Turner Construction for 12/5/22 to 3/4/22 at 600 Binney St. from Mon to Fri (6:00PM to 6:00AM), Saturday (7:00AM to 6:00PM), Using Lull, bobcats, dumpster set up and pick-ups, scissor lift, trucks for interior demolition of walls, ceilings, flooring, MEPs inside 300 Binney. Day Care and tenants currently occupying floors 1 through 4 of 300 Binney St. Variance is being sought due to night shift work needed to perform the interior demolition work without impacting the Day Care and tenants.

Summary: Since the matter was heard, the applicant has provided additional information including representing that the demolition indoors will only be done with hand tools. In addition, the building envelope will remain closed with no removal of windows. Finally, the applicant agreed to remove the debris from demolition starting at 7:00 a.m. This is an occupied building with tenants, including a day care and thus the variance is required for the safety of those individuals.

Decision: Granted, in part, with conditions: (1) for interior demolition only with hand tools; (2) debris cannot be removed during variance hours, only during allowable hours; (3) building envelope will remain closed with no removal of windows; and (4) variance cannot be exercised on 1/2, 1/16, 2/20. Denied as to Saturdays.
