CHAIR ANDREA JACKSON: And your

relationship to the applicant?

KAREN CAIAZZO: I'm the manager of 02

Yoga. Mimi is the owner.

CHAIR ANDREA JACKSON: You are looking to

change your hours?

KAREN CAIAZZO: Yes.

CHAIR ANDREA JACKSON: The hours stated

by Ms. Lint, would those be correct?

KAREN CAIAZZO: Those are correct.

opportunity therefore, cancel any license issued

under this chapter if the licensee ceases to

conduct the licensed business.

CHAIR ANDREA JACKSON: Good evening.

ATTY JOE DEVLIN: Good evening.

CHAIR ANDREA JACKSON: State your name for the record spelling your last name and if you can speak up over our loud air system.

ATTY. JOE DEVLIN: I'm Joe Devlin,

D-E-V-L-I-N. I'm an attorney from the Demarcus

Law Offices in Lynn, Massachusetts. I represent

Bertucci's Restaurant Corp., and with me is John Testa, T-E-S-T-A, who is the area director for Bertucci's, which includes the location in Cambridge.

CHAIR ANDREA JACKSON: And we're here this evening as a result of this was on a prior agenda in which we received a request, I think it was initially to hold the license as inactive status.

We had several questions at that time but no one from Bertucci's was at the hearing. As such, we placed it on the agenda this evening for a revocation of the license.

Do you want to address that?

ATTY JOE DEVLIN: Yes. We submitted a reconsideration in the form of a letter for our request for inactive status.

Both the company and myself want to apologize that we weren't here on the 22nd. I

miscommunication, and we were waiting for the license administrator at Bertucci's to calendar the date for us.

I actually really think the problem is the long-term vice president of Human Resources who oversaw this for the entire time I have been representing Bertucci's, but for a long time since beyond that, left the company around March 12. And then Sandra Wooden (phonetic), who is the compliance person at Bertucci's, got moved to another department. She still is handling it. She was beside herself. She wanted to come here tonight. She is a veteran, a National Guardsman. She's one of the few people I let calendar on my calendar, including people in my office. And she just couldn't make it because she has a child. It is not within her job description either. But she was very, very apologetic, as am I.

CHAIR ANDREA JACKSON: That's fine.

Let me ask you this: Bertucci's closed in August of 2013, why was there such a lapse in time in terms of when the restaurant closed and then requesting to hold the license in inactive status?

ATTY JOE DEVLIN: Lack of knowledge.

Originally, right away, Sandra did send an email to Chris O'Neil saying that they had closed. And sometime there later, I think in October, they received a notice saying, you know, you are closed, you have to let us know what is going on by November 8, I believe.

And they sent in an email to Ms. Lint and said we were in the middle of a sale and transfer should be forthcoming shortly.

They have had four offers on this location. Three of them have been accepted.

One of them is extremely recent, being last

night. We forewent one of the offers. It is a Korean buyer, who is in Korea right now, and I talked to his counsel yesterday afternoon, and the P&S is agreed to. We just don't have a signed one. So we decided to go with a secondary offer for \$125,000. Another experienced licensing counsel, Matt Fogelman, he's probably been before you, Matthew and I have not communicated, but he has my P&S and he said to me his client -- we have not communicated on the phone. He sent me an email saying, My client has it and is reviewing it. My client has a signed lease. Which is what my client wanted to find out from him to see what could be eliminated as far as problems.

There's a seven-day requirement to negotiate, sign the P&S, and the offer, and then a 14-day requirement to file the application.

Matt's aware of it and he's capable of complying

with that. So there's a short time limit on this new offer.

CHAIR ANDREA JACKSON: So the original offer that we were aware of, Ms. Lint, was the one that the buyer was being represented by Andrew Upton?

EXECUTIVE DIRECTOR MS. LINT: Yes.

CHAIR ANDREA JACKSON: That one is now off the table?

ATTY JOE DEVLIN: As of yesterday. I called Andrew to get an update and he told me he had spoken to you.

EXECUTIVE DIRECTOR ELIZABETH LINT: That's correct.

ATTY JOE DEVLIN: You know just to get an update on when it might be. He just said, I can't tell you. The guy's back in Korea, and it is ready to be signed and he's not responding to me.

So we sent him a notice and said that your client is out of contract. We are going with this other offer for -- it is a d/b/a that going to be called Guyu Taku (phonetic). I think it was some sort of Malaysian or Asian cuisine.

CHAIR ANDREA JACKSON: What is your expected time frame?

ATTY JOE DEVLIN: I hope to get the P&S signed within the seven days and then get the application filed within the 14 days. It will go from the offer onto the P&S agreement.

I do lots of those. How many of those have ever hit that target? You know, normally we put in 21 to 28 days to file the application. 14 days is a little tight. But do I expect certainly within -- the filing within the next 30 days? Yes.

CHAIR ANDREA JACKSON: Okay.

My concern is that the license is tied up

with the property, so to speak, that's located
at --

ATTY JOE DEVLIN: 21 Brattle Street.

CHAIR ANDREA JACKSON: Thank you. Right.

And there's a new tenant in that space who is now unable to get a license because the Bertucci's license is still tied to that spot.

So my concern is, the longer that we play this out, the longer they will have to wait as well.

ATTY JOE DEVLIN: If I may?

I think Bertucci's and the Commission's goals are aligned here. They want to go the fastest route, as do you, to get this license transferred and back in use.

I think this represents we couldn't be any closer to having an application ready to be filed.

Once that application is filed, there can

be at even on the same hearing date, heard

afterwards, an application for that location as

long as the ABCC is notified one has to be

adjudicated first.

I have been involved in many that way.

Actually, I have been involved in that with Bertucci's. And other clients. So the ABCC does recognize that and will do it that way so you don't have two licenses at the same location.

Look, the current tenant has made an offer on this, it was below what the broker thought was market and below the three offers that have been made on this license. Bertucci's was here for a restructuring within the last year, and I think Tom Demarcus came to that, but it was a debit restructuring.

You know, they are not fast casual. Most of their things are made on the premises and that

carries more expense and the downturn hit them harder. This is an important asset for them.

So understanding all of that, and understanding the new tenant's position, I hope the Commission will give us more time.

I would be happy to come back for a status hearing at the very next hearing. I would be concerned -- you know, I do a lot of this, any suggestion that the next one is a revocation, I actually thought Mr. Lee because of the revocation was kind've playing a wait and see.

I have since -- he sent me an email last night at 11:00 from Korea. It's been confirmed that's why he's not responding. He's in Korea. But it does have a tendency to chill the market when revocation is attached to it. But it is what it is.

POLICE COMMISSIONER ROBERT HAAS: You will have a much better idea by June 11 where you

are in this process?

ATTY JOE DEVLIN: Yes. And if we sign the P&S in the next seven days, I'll let Ms. Lint know.

Again, I have every confidence this license -- the attorney for the new buyer knows what he's doing.

CHAIR ANDREA JACKSON: Are there members of the public that wish to be heard on this matter?

Good evening.

ATTY KEVIN CRANE: Good evening, Madam Chair and Members of the Commission.

My name is Kevin Crane, I'm an attorney, and I represent Chazumba, LLC d/b/a Felipe's Taqueria, who is the present tenant on the premises.

As you know, I was the one that brought this to the attention of the Board the end of

February when I wrote to them regarding the lack of even applying to have it recognized as an inactive license.

And I was surprised, this has been going on since August of last year reflecting, in my book, a somewhat caviler attitude of Bertucci's towards the License Commission.

As the Chair explained, the problem is that my client can't even get a fair shot at applying for a new license if they weren't able to buy the Bertucci's license, which if they have a buyer, that's fine, but we have been hearing about this phantom buyer since last October.

It would be great if they did have a purchase and sale agreement and sold the license and it was transferred to a different premises and then my client would have a fair shot at trying for a new license according to the rules and regulations of the Commission.

I would also point out that, you know,

Bertucci's signed a renewal application under the

pains and penalties of perjury that they were

operating the premises. And, again, I think this

reflects upon an attitude towards the License

Commission as to whether they have to play by the

rules or not.

The renewal affidavit does provide for an explanation if you are not operating the premises and there was no such submission or explanation when the renewal application was submitted.

And like I say, I think it would be fine if they went ahead and sold the license to someone else and transferred it off the premises.

It is just too bad it has taken this long to get them to the table.

Thank you.

CHAIR ANDREA JACKSON: Thank you.

Do you have any questions?

FIRE CHIEF GERALD REARDON: I do not.

CHAIR ANDREA JACKSON: Any questions?

police commissioner Robert Haas: From your client's standpoint, I want to make sure I understand this correctly, you are not entirely opposed to giving them an opportunity to sell the license, or is it your view, that action be taken on the license immediately?

ATTY KEVIN CRANE: We are not opposed to them selling the license.

counsel, which might not be privy to this, we have submitted signed offers and deposit checks that we have received over the course of this.

And the Commission was aware, at least through email, that the license had closed and we were actively marketing it. But it is accurate we didn't send in a letter requesting inactive

status for some time, but that was more of an oversight, not out of any purposeful intent.

CHAIR ANDREA JACKSON: Thank you.

CHAIR ANDREA JACKSON: Good evening.

ATTY. JAMES RAFFERTY: Good evening,

Madam Chair. For the record, James Rafferty, 675

Massachusetts Avenue representing the licensee.

Mr. Cacciola is now working at our office and this is his first appearance before the Licensing Commission and he's joined with me this evening.

CHAIR ANDREA JACKSON: Welcome.

Does this mean we won't get to see you as much, counsel?

ATTY. JAMES RAFFERTY: No, no. I hope that doesn't prove to be the outcome.

This is a slightly unusual matter. The Commission will recall this is the license that was formerly held by All Asia, and approximately a year ago, I believe almost a year ago, May 13, we filed a transfer of location and change of directors and such to -- from A.W. Chin, Inc. (phonetic), to the new corporate entity in this new location on Prospect Street.

At the time we filed the application for the transfer, we also included an application for

an entertainment license, but unbeknownst to us, apparently the advertisement did not contain a reference to the entertainment application.

But if you have had an opportunity to review the transcript of that hearing, you will see that a significant portion of that hearing was actually devoted to the issues of entertainment where the manager was describing the change in musical genre that he anticipated occurring from the All Asia rock-and-roll to a more jazz adult-oriented entertainment.

As I said, it was unbeknownst certainly to us, this applicant, and I suspect to the Commission at that time, that there was this defect in the notice, and it was only as a result of a recent communication from Ms. Lint. So what we did is, we took the original entertainment application that was filed last year and simply refiled it and we're here tonight to ask the

Commission to approve the entertainment as discussed at the last hearing and set forth in our application.

CHAIR ANDREA JACKSON: So, Ms. Lint, do you recall from the minutes, was the entertainment piece discussed?

EXECUTIVE DIRECTOR ELIZABETH LINT: It was discussed at great length.

ATTY. JAMES RAFFERTY: I have the highlighted sections of the transcript.

The first comment is from myself and then a few pages in, the manager, then goes in to describe the change of -- your predecessor was very thorough in his inquires around things of this nature, so we talked about entertainment, types of entertainment, demographics, who is likely to be there.

CHAIR ANDREA JACKSON: I remember reading this.

FIRE CHIEF GERALD REARDON: Counselor, is this the location that you enter from Prospect Street on that building?

ATTY. JAMES RAFFERTY: Yes.

FIRE CHIEF GERALD REARDON: This is a new build-out?

ATTY. JAMES RAFFERTY: This is a new build-out. They just told us this week they are beginning construction. We did have a delay.

The license was probably approved by the ABCC, the transfer in February, and they received a building permit in March. And there was a little back and forth with the contractor, but the client informed us today they expect construction will commence in a week. They are hoping for a fall opening.

ATTY. JAMES RAFFERTY: From the --

EXECUTIVE DIRECTOR ELIZABETH LINT:

Cantabridgean Hospitality.

20.

ATTY. JAMES RAFFERTY: They haven't done business yet, but --

ATTY. JAMES RAFFERTY: \$10? Okay.

EXECUTIVE DIRECTOR ELIZABETH LINT:

There's more than that. But not a lot.

ATTY. JAMES RAFFERTY: Okay.

EXECUTIVE DIRECTOR ELIZABETH LINT: 10,

ATTY. JAMES RAFFERTY: I'm not aware they have any assets, but we'll take that up at the Assessor's Office and I wouldn't be surprised if their record weren't perfectly on target.

Application: Wasabi at Porter, LLC, Xi Li, manager, has applied for a new wine and malt

beverages as a restaurant license at 2088

Massachusetts Avenue. Applicant is seeking

CHAIR ANDREA JACKSON: Good evening.

ATTY LAUREN BOICE: Good evening. My name is Lauren Boice, B-O-I-C-E.

Counsel for Wasabi at Porter, LLC. And this is my client Xi Li, X-I. Last name L-I.

XI LI: X-I. Last name L-I.

CHAIR ANDREA JACKSON: Tell us about the plan, please.

a small business. This is not a chain. So if there was any confusion about Wasabi at Porter, LLC, it is a stand-alone business, and this is being run by my client as the manager.

He will be on the premises probably more than he's living in his home in Quincy, and he's starting this business in order to provide for his family. He was moved here from New York in order to be with his family while his daughter goes to college and wants to start a restaurant.

Annapurna was before, and all he's looking for from the Commission is to get the same beer and wine license that Annapurna enjoyed but was not transferrable from Annapurna, and to get sidewalk usage, which they had, but he's looking for less sidewalk usage than they did. And I believe we also applied for an entertainment license, but I don't believe that's on the agenda.

I do have the application, a copy of it, if you would like.

EXECUTIVE DIRECTOR ELIZABETH LINT: No, I have it.

CHAIR ANDREA JACKSON: How was it

advertised?

EXECUTIVE DIRECTOR ELIZABETH LINT: I'm looking.

CHAIR ANDREA JACKSON: While Ms. Lint is looking, let me ask you a couple questions.

Has your client operated a restaurant before?

XI LI: Yes, I operated several kinds. First time is in --

CHAIR ANDREA JACKSON: Speak up, please.

Second time is Manhattan, New York. And third time is New Jersey.

XI LI: First time in Connecticut.

CHAIR ANDREA JACKSON: What types are restaurants were those?

XI LI: All Japanese.

ATTY LAUREN BOICE: And my client has experience with alcohol service from his previous

restaurant experience, which he can address to the Commission as well.

CHAIR ANDREA JACKSON: Yes. Tell me about your experience with alcohol as well.

XI LI: First was in Connecticut for a couple years. I serve full liquor license.

CHAIR ANDREA JACKSON: Was the liquor license in your name?

XI LI: My partner name. I'm the manager.

FIRE CHIEF GERALD REARDON: You were the manager of record, though, for the license?

ATTY LAUREN BOICE: I don't believe so.

What he's saying is, he was the manager of the

restaurant so he was responsible with his partner

who was the manager of record. And that's why

I'm here, to clarify that answer.

EXECUTIVE DIRECTOR ELIZABETH LINT: Do you have a copy of the ad?

ATTY LAUREN BOICE: I do have a copy of the ad. (Forwarding).

EXECUTIVE DIRECTOR ELIZABETH LINT: We didn't advertise the entertainment.

CHAIR ANDREA JACKSON: So we can't address that this evening?

EXECUTIVE DIRECTOR ELIZABETH LINT: Well, two TVs can be done actually. Below level, can be done.

CHAIR ANDREA JACKSON: So we're good. Very good. Thank you.

POLICE COMMISSIONER ROBERT HAAS: As you recount your restaurants, can you tell me how -- what the status of those restaurants are and why you separated business with those restaurants?

The one in Connecticut, how long was that operating for?

XI LI: Connecticut was a couple years. Like two or three years.

POLICE COMMISSIONER ROBERT HAAS: Then what happened to it?

XI LI: Because my wife, we both own a house in New York, so we sold to the partner.

POLICE COMMISSIONER ROBERT HAAS: Okay.

XI LI: My brother-in-law.

POLICE COMMISSIONER ROBERT HAAS: Then the one in Manhattan?

XI LI: After September 11, the business going down, so I moved to Connecticut -- moved to New Jersey.

POLICE COMMISSIONER ROBERT HAAS: How long did you operate the restaurant in Manhattan?

XI LI: Manhattan, six months.

POLICE COMMISSIONER ROBERT HAAS: And then it closed?

XI LI: I sold the business.

POLICE COMMISSIONER ROBERT HAAS: You

sold it?

XI LI: Yes. I moved to New Jersey.

POLICE COMMISSIONER ROBERT HAAS: Okay.

XI LI: I was there six years.

POLICE COMMISSIONER ROBERT HAAS: You had

that restaurant for six years?

XI LI: Yes.

POLICE COMMISSIONER ROBERT HAAS: What is the status of that restaurant?

XI LI: I sold that. I go to here because my kid's education. She be in Boston.

POLICE COMMISSIONER ROBERT HAAS: Okay, each of those restaurants you served alcohol?

XI LI: Only Connecticut.

POLICE COMMISSIONER ROBERT HAAS: Only Connecticut?

XI LI: Yes.

POLICE COMMISSIONER ROBERT HAAS: You never held a license in your name then, a liquor license in your name?

XI LI: No.

FIRE CHIEF GERALD REARDON: So the restaurant in New Jersey was relatively successful for six years?

XI LI: Yes. Good. It's very good.

CHAIR ANDREA JACKSON: Who will be working with you in the restaurant? Are you going to manage it on your own?

XI LI: My wife and my friend.

CHAIR ANDREA JACKSON: Your wife and a friend?

XI LI: Yeah, and I have friend.

FIRE CHIEF GERALD REARDON: 38 seats inside, that's what was approved previously?

ATTY LAUREN BOICE: If I may address that? It is a few seats less than Annapurna had because it they had to take out seats to put in the sushi bar counter, so they lost square footage because of work space.

CHAIR ANDREA JACKSON: You recognize that Cambridge is a little unique that in order to serve wine or malt or any alcohol you have to have 21 Proof training.

ATTY LAUREN BOICE: He has already contacted Mr. Green in order to get on for the training on that program.

XI LI: Yes.

FIRE CHIEF GERALD REARDON: So your plan is probably just to do minor cleaning and painting, not major renovation at this location?

XI LI: Not major. Just sushi bar and clean and painting some stuff.

FIRE CHIEF GERALD REARDON: I'm trying to remember, do they have a fryolator or hood system at Annapurna, deep fry?

XI LI: Deep fry?

FIRE CHIEF GERALD REARDON: Yeah, a fryolator, did they have one at that location?

XI LI: No, not yet.

CHAIR ANDREA JACKSON: And how will deliveries be made? In the front? In the rear?

ATTY LAUREN BOICE: My understanding of the configuration of the building, and I believe this is in at least one of the applications here, there's a back door at the side.

FIRE CHIEF GERALD REARDON: On Walden Street?

ATTY LAUREN BOICE: Exactly. And the deliveries will be made through that door to the kitchen.

FIRE CHIEF GERALD REARDON: Do you have a sample menu available?

ATTY LAUREN BOICE: I do. (Forwarding).

FIRE CHIEF GERALD REARDON: It's going to

be a full-service restaurant in terms of --

ATTY LAUREN BOICE: Yes.

CHAIR ANDREA JACKSON: When is the

expected opening date?

XI LI: We try to do June 1st.

ATTY LAUREN BOICE: That may be ambitious.

XI LI: July 1. I'm sorry.

CHAIR ANDREA JACKSON: Okay.

EXECUTIVE DIRECTOR ELIZABETH LINT: I don't know if we would hear back from the ABCC that soon. We might but you don't know.

realistic thinking August 1 being a viable date.

My client might be suggesting that he should be done with his construction by July 1 and he may be able to open the restaurant without a liquor license and begin serving the community.

CHAIR ANDREA JACKSON: Any questions?

POLICE COMMISSIONER ROBERT HAAS: Have you tried to buy a license?

XI LI: Too much.

POLICE COMMISSIONER ROBERT HAAS: The criteria for a license, Ms. Lint?

EXECUTIVE DIRECTOR ELIZABETH LINT: It's proof of need, lack of harm, overwhelming neighborhood support, and a showing that you have exhausted all possibilities of purchasing a license.

ATTY LAUREN BOICE: My client attempted to purchase a license. The ones he was able to find that weren't attached to restaurants, where you had to buy the license and then take the restaurant business itself, were approximately \$80,000, which would be cost prohibitive for him given that he's only operating a 1,000 square foot restaurant. He can't afford that kind of overhead expense. That's what it comes down to. And that's why we are only looking for what Annapurna had in the other location.

POLICE COMMISSIONER ROBERT HAAS: And the

other three criteria?

ATTY LAUREN BOICE: I believe there was need. He needs --

POLICE COMMISSIONER ROBERT HAAS: Not his need.

EXECUTIVE DIRECTOR ELIZABETH LINT: Not his need.

POLICE COMMISSIONER ROBERT HAAS: The community.

ATTY LAUREN BOICE: I misunderstood.

Again, this is what Annapurna had, so it was obviously a need in the community at some point in time, so we're only looking, like I said, for what Annapurna had.

And as far as support of the community, we have reached out to the Porter Square -- I'm going to mess this up, the two letters in that acronym, and the City Council we'll be meeting with them.

I believe a couple of the neighbors, who are adjacent to the back of the restaurant are here this evening, and at least one has expressed desire to have this restaurant open and be available.

POLICE COMMISSIONER ROBERT HAAS: I was debating whether or not that's going to be overwhelming support.

ATTY LAUREN BOICE: Again, we're only looking for what Annapurna had. And this is -- if the criteria are to be read that each one must be met in an exhaustive way, then I'm not sure that's possible.

I mean, what they are looking for is just to have a business, to do business, to contribute to the community, to occupy a place that is otherwise not having a viable restaurant in it and provide for his family. And he can't do that without a beer and wine license in order to make

the kind of restaurant more up-scale Japanese sushi restaurant that he's planned with his business plan.

POLICE COMMISSIONER ROBERT HAAS: I want to -- I'm trying to figure out how we can satisfy those requirements based on what you are representing.

I'm not disputing the fact that there was a restaurant there before, but things change.

Cuisine changes. Neighbors change. The fact there was a restaurant there before that had a beer and wine license doesn't mean it is transferrable an.

ATTY LAUREN BOICE: I totally understand that Annapurna's license was not transferrable, which is why we are here today to get a new one.

POLICE COMMISSIONER ROBERT HAAS: Right.

ATTY LAUREN BOICE: I don't know how else

to show support from the community.

POLICE COMMISSIONER ROBERT HAAS: A lot times what applicants will do is they actually get petitions from the area, and then have the neighbors sign off on it and demonstrate they are a supporter of the concept and idea.

It does a couple things. 1, it allows your client to introduce himself to the neighborhood and garner that kind of support.

And 2, it demonstrates to us that the neighborhood doesn't see the harm by virtue of the fact that they are in support of it. That's the second criteria. It is almost linked together.

So it would seem to me that if you get the neighborhood to be supportive of the concept,

I think we can easily get across the obstacle of whether there's lack of harm.

ATTY LAUREN BOICE: Can we look at the

fact that the people who are going to be here speaking for or against the restaurant are indicative of the community and the absence of them --

POLICE COMMISSIONER ROBERT HAAS: I don't know if we can have a few people speak on behalf of an entire neighborhood. They can voice their opinions.

ATTY LAUREN BOICE: The neighborhood is predominately business, except for the abutters to the condo behind there. And those are the only residential neighbors in the area. So trying to get support from the business neighbors would be, I think, difficult because they might see it as an unnecessary competition in the area.

POLICE COMMISSIONER ROBERT HAAS: What a lot of applicants will do, though, is they will stand in front of the location and ask

passerbyers to see if they would sign a petition, and again, it would be an indication to your client whether or not -- it does two things: 1, it advertises the fact he's coming there, and secondly, he can show that people that at least frequent the area would be supportive of the concept.

There's a number of ways to get to that point. I just think that we do have the criteria and it has to be satisfied some way, and I think --

FIRE CHIEF GERALD REARDON: Is Annapurna still open?

EXECUTIVE DIRECTOR ELIZABETH LINT: No.

CHAIR ANDREA JACKSON: Do you have any additional questions?

POLICE COMMISSIONER ROBERT HAAS: No.

CHAIR ANDREA JACKSON: I would like to take some public testimony.

Are there any members of the public that wish to be heard on this matter?

Please come forward.

Good evening. Please state your name for the record.

CATHERINE FUNG: Catherine Fung, F-U-N-G. C-A-T-H-E-R-I-N-E.

CHAIR ANDREA JACKSON: And why are you here this evening?

CATHERINE FUNG: I live on 5 Walden

Street, which is the building in the back, and I

am voicing my support for the license.

I have been living there four years, and so I saw Annapurna, they were occupying it, and then it changed to Third Eye or something.

CHAIR ANDREA JACKSON: Uh-huh.

CATHERINE FUNG: And I noticed that business was always kind've scant for both of those businesses.

And so I would be happy if this business were to succeed, so, yes, I'm voicing my support.

And because I'm also a member of the board of trustees of the building, I want to make sure the concerns of maybe some of the residents be heard, not so much to voice opposition, but to open up discussions about particular issues of noise and this is extended hours to 1 a.m., and I think that's --

ATTY LAUREN BOICE (Speaking to Mr. Li):
You need to say it out loud.

XI LI: We are not open to 1 a.m.

CATHERINE FUNG: You are not going to?

CHAIR ANDREA JACKSON: You're not going to what?

XI LI: We are not going to open until 1 a.m.

CHAIR ANDREA JACKSON: So what are the proposed hours?

ATTY LAUREN BOICE: This is news to me.

My client was -- you are applying for a 1 a.m. license. If you chose to change your business hours, then we can come back before the Commission and change the hours.

POLICE COMMISSIONER ROBERT HAAS: Before we even grant the license, if he's not intending to operate during those hours, you have to make sure he posts the hours he will operate.

ATTY LAUREN BOICE: I understand.

XI LI: So --

ATTY LAUREN BOICE: I believe my client is actually intending to at least operate the restaurant through 1 a.m. I think perhaps what the issue there was about liquor service, which might not necessary be until 1:00.

CHAIR ANDREA JACKSON: I can take additional public testimony if you would like to confer with your client.

ATTY LAUREN BOICE: Thank you very much.

CHAIR ANDREA JACKSON: You are all set unless you have anything else to offer or add.

CATHERINE FUNG: My question was based on the question of the hours because it is a residential neighborhood, we have families, and we're right on Mass. Ave, so there might be concern about noise or foot traffic coming through. Especially since it is going to be open with 1 a.m. with the liquor license, there might be a different demographic of folks coming through. That might impact the atmosphere of that particular neighborhood.

And so that's mostly what I wanted to have a discussion about.

But, of course, that would depend whether or not those hours are indeed --

POLICE COMMISSIONER ROBERT HAAS: How did you get acquainted with the applicant?

CATHERINE FUNG: I got a letter in the mail.

POLICE COMMISSIONER ROBERT HAAS: Did all residents in your building get a letter in the mail?

CATHERINE FUNG: I don't know if everybody did. I know the trustees did.

CHAIR ANDREA JACKSON: Thank you very much.

Please come forward.

NANCY WARECK: Hi.

CHAIR ANDREA JACKSON: Good evening.

NANCY WARECK: Nancy Wareck, W-A-R-E-C-K. Google that, please.

This gentleman agreed to remove the waste at least twice a week and not have that repeat and agreed to work with the rodent problem. It is a city problem. We have them. And, again, we treat our property.

issue. There was a preexisting restaurant.

Another one wants to come in. I don't object to that if the restaurant would, in fact, work with we, the public, in helping to ameliorate the problems that we have. And this gentleman promised me he would.

And the nonsmoking also, we are a nonsmoking building, and Brian assured me none of his workers would smoke near our backyard.

Thank you.

CHAIR ANDREA JACKSON: Thank you very much.

NANCY WARECK: You are very welcome.

CHAIR ANDREA JACKSON: Are there any other members of the public that wish to be heard on this matter?

Do you have additional questions?

POLICE COMMISSIONER ROBERT HAAS: No.

ATTY LAUREN BOICE: Let me address the

hour issues.

CHAIR ANDREA JACKSON: Did you hear that, their hours of operation are going to be 11 p.m.

CATHERINE FUNG: Thank you.

FIRE CHIEF GERALD REARDON: That's for weekends as well as weekdays?

XI LI: Weekdays maybe 10:00.

ATTY LAUREN BOICE: Weekdays 11:00.

NANCY WARECK: There's something I forgot to mention.

CHAIR ANDREA JACKSON: If you could re-identify yourself for the record and speak up.

NANCY WARECK: Nancy Warwick, 5 Walden

Street. Annapurna was graffitied, we, therefore,

Galluccio, G-A-L-L-U-C-C-I-O. I'm a partner with

Galluccio & Watson at 1498 Cambridge Street and

I'm joined by Jeremiah Tracy.

JEREMIAH TRACY: Jerry Tracy, T-R-A-C-Y, for the project at 35 JFK Street, Cambridge.

ATTY ANTHONY GALLUCCIO: Honorable

Members of the Commission, first of all, I wanted

to say thank you for continuing our matter for a

couple meetings.

The owners and manager had a concept change for the restaurant so we thought it was best to make sure that the Commission was up to speed with our latest thinking.

As a matter of housekeeping, if I can present the notification to abutters of which I

have had no direct contact by way of concern or communication.

I would like to present, if I could, for the record a new d/b/a, the Noodle Project, LLC will still be the license holder. We submit a new d/b/a tonight. The business name will be Break-Fast, so if I could just present that for the record, and I also have menus for the Members of the Commission as well.

Just briefly, again, there was a submission and advertisement for the Noodle Project for hours of operation from 11 to 11.

The owners and manager made a decision to shift concepts. I called this sort of an Ode to Leo's. It is more of a breakfast concept, which we think is in needed. After further investigation, it was found there was some other noodle concepts nearby and there was a need for something in The Square, and speaking to the

Harvard Square Business Association, to have some kind of a breakfast option directly in The Square and so we shifted gears.

I would note that the requested hours at this time are 7 a.m. to 7 p.m. on Friday and Saturday. Sunday to Thursday, 7 a.m. to 4 p.m.

So it is a shift back to those earlier hours.

EXECUTIVE DIRECTOR ELIZABETH LINT: Can you repeat that? 7 a.m. to 7 p.m.?

ATTY ANTHONY GALLUCCIO: Sunday to Thursday. I did it backwards.

And Friday and Saturday 7 to 7.

EXECUTIVE DIRECTOR ELIZABETH LINT:

That's the same.

FIRE CHIEF GERALD REARDON: 7 to 7 all week?

ATTY ANTHONY GALLUCCIO: 7 to 4.

POLICE COMMISSIONER ROBERT HAAS: 7 to 7

weekdays?

ATTY ANTHONY GALLUCCIO: And Sunday through Thursday 7 a.m. to 4 p.m. I'm sorry. It is more commensurate with what was going on previously.

I did urge that the client to come as close to what we knew the hours would be and these are hard hours, which I know the Commission likes.

I would note Leo's Place did have a 7 a.m., so we think we are okay in that respect. It is a shift from our original concept.

I would like to introduce, if I could,

Jerry Tracy, who is going to open up the

restaurant and manage the restaurant and he's

joining me tonight.

I do have copies of his resume as well for you, if you would like those.

I should note for the record, the floor

plan, seating, all stays the same. There's no changes at all. Just some clean-up work and business will convene.

FIRE CHIEF GERALD REARDON: What's the anticipated opening if you get approval?

JEREMIAH TRACY: The end of June.

Literally a coat of paint and moving equipment
in.

ATTY ANTHONY GALLUCCIO: This was a concept that we felt it was important to get this particular location up and running quickly and get into a service position for The Square immediately.

I know the manager had strong feelings about this concept, and the client made a shift, so we're pretty happy with this.

We may come back and ask for some extended hours but we think this is the right starting point for us.

EXECUTIVE DIRECTOR ELIZABETH LINT: In this situation as well, there's a letter from Mr.

Muche in regard to the ramp, there's a slight issue with it.

I would be happy to give this to you and you can work with him to.

ATTY ANTHONY GALLUCCIO: Absolutely.

EXECUTIVE DIRECTOR ELIZABETH LINT: I don't know, are you in contact now with the people at Leo's Place because I have an outstanding tax bill?

ATTY ANTHONY GALLUCCIO: For Leo's Place?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.
