Before you are the Commissioners: Chair Nicole Murati Ferrer, Chief Gerald Reardon and Commissioner Chris Burke:

CHAIR NICOLE MURATI FERRER: We are being recorded.

EXECUTIVE DIRECTOR ELIZABETH LINT: You have my file first?

CHAIR NICOLE MURATI FERRER: I do. I took whatever from that.

ERIC PROPP

Propp on behalf of the Garment District has applied for one day licenses for July 21 and August 18. These are in addition to the two one days licenses that have already been approved for the location and we have requested more information on that.

CHAIR NICOLE MURATI FERRER: Yeah. So what we got from him?

EXECUTIVE DIRECTOR ELIZABETH LINT: He's just using it as a way to stimulate business in the summer when it's slow.

CHAIR NICOLE MURATI FERRER: Okay. I have no issues with these applications. I would vote to grant.

POLICE COMMISSIONER CHRIS BURKE: Agreed.

CHAIR NICOLE MURATI FERRER: Granted.

BOARD OF LICENSE COMMISSIONERS DISCUSSION OF AMENDMENTS TO ALCOHOL AND ENTERTAINMENT RULES AND REGULATION OF THE LICENSE COMMISSION

EXECUTIVE DIRECTOR ELIZABETH LINT:

Discussion of the proposed amendments to the rules and regs.

CHAIR NICOLE MURATI FERRER: Okay. So I think -- this is this is my cheat sheet type of thing.

You know, I think last time when we met on May 2, and I know, Commissioner Burke, you weren't part of that meeting, but I believe you read the minutes and have come -- read everything else afterwards and you have been part of the other meetings anyways.

I think we pretty much agreed that it was a good idea to add the common victuallers and

innholders and lodging house licenses as licensees. I say we go forward on that.

The edits don't change the substance of the rules. So rules 2, 3, 4, 5, 6, 7, 8, 12, 14, 15, 16, 18, 32, 33, 35, 36, 39, 43, 45, 46, 47, Rule 3 of the Noise Section, Rule 2 of the Entertainment Section and Addendum C.

The edits to that with no substance to any of them, and I think that we went through those and I say we go forward on that.

The no changes to the rules to 10, 11, 22, 23, 24, 30, 41, 44 and 45, those still makes sense so I would keep that as-is.

And then -- so those are the easy ones.

And I would say that we go forward and approve
those as we had them or as we have them

currently. So why don't we vote on that.

FIRE CHIEF GERALD REARDON: Agreed.

POLICE COMMISSIONER CHRIS BURKE: Agreed.

to the proposed, quote/unquote, substantive changes to 1, 9, 19, 20, 25, 26, 27, 28, 29, 30, 31, 34, 37, 38, 42, 48 and Addendum Em I would say that we go forward on that as well, including the subsequent proposed changes that we made after that May 2 meetings based on comments by the Commission. So I would vote to go forward on those.

FIRE CHIEF GERALD REARDON: Agreed.

POLICE COMMISSIONER CHRIS BURKE: Agreed also.

CHAIR NICOLE MURATI FERRER: And then with regard to deleting rules 12, 13, 40, Noise Section Rule 1, Entertainment Sections Rules 1, 3, 4 & 5, Addendum A, Addendum B, Addendum D and the Policy Section, I would say we go on that.

And the reasons for it I think are very well outlined in our explanations as the proposed changes and rules that we drafted after that May 2 meeting. And I would say we, you know, we adopt those deletions based on what we discussed at that May 2 meeting and what's in our document so I say we go forward on that.

FIRE CHIEF GERALD REARDON: Agreed.

POLICE COMMISSIONER CHRIS BURKE: Agreed.

CHAIR NICOLE MURATI FERRER: And then were regard to the new rules that created and proposed as to the subject of transfer of privilege, food requirements for common victualers and innholders, register requirements for innholders and lodging houses, Happy Hour regulation exceptions, hindering investigations, and crowd control, again I would say we go forward on that for the reasons we stated at our

May 2 meeting and later on put in our memo.

FIRE CHIEF GERALD REARDON: Agreed.

POLICE COMMISSIONER CHRIS BURKE: Agreed.

thing I did want to discuss in terms of this a little bit more is with regard to the no value and no transferrable licenses. At that May 2 meeting we talked about two ways to do it, that either they just full blown, as of January 1, become just regular licenses or that they kind've die out with regard to -- or when the business dies, that the license dies with it. I say we go with the latter, which is what we agreed on at our May 2 meeting.

I think that maybe administratively it'll be kind've a little more burdensome on our staff, but I think it's the safest way and the most equitable way to deal with this at this point and

I think for the reasons we stated in our explanation to the rules after that May 2 meeting, I think it makes sense to continue with the way that we proposed to kind've phase out those licenses.

I know we received comments on it recently, so I just wanted to highlight that.

POLICE COMMISSIONER CHRIS BURKE: I would agree with the changes proposed.

FIRE CHIEF GERALD REARDON: I would agree.

CHAIR NICOLE MURATI FERRER: And then one other thing that has been raised recently with regard to this, are the annually fees for the licenses.

I agree we need to look at annual feels but what I would propose is that the annual feels right now that we actually sit down and take a

better look at this. Chris O'Neil, from our office, I asked him to do kind of a study of the licenses around the neighboring cities and towns and try and figure out, and obviously, this also needs a review by the Law Department in terms of if these needs to be commensurate with the process and everything.

So I would say that we look at the fees and make sure that by November, which is renewal season, that we have it all squared away, so that when they renew, if we are taking either lower fees or standard fees, or something like that, that they are in place for the 2017 license year.

So what I would do is, the current licenses, you know, obviously, the licenses that are already paid, they've already paid for this year. Any license that we issue after today, basically, I say we have the fees that in our fee

that fee schedule through the end of 2016, and then just make sure before November we review it and decide whether or not those fees will continue in place or whether they'll be changed or unchanged or whatnot. Does that sound good?

EXECUTIVE DIRECTOR ELIZABETH LINT: The Board of Commissioners will have a discussion regarding the necessity to advertise the following license categories as there is no statutory requirement: Common victualer, change of common victualer hours, increase of seats, vendor/peddler, antique, secondhand goods, used car dealer, farmer winery for farmer's markets.

CHAIR NICOLE MURATI FERRER: So I just wanted to maybe start talking about this. We don't need to make a decision today.

But these licenses they don't have a requirement to be -- when they are seeking for these, there's no requirement to have them

advertised in the newspaper.

And so, for me, for example, a CV, which can be as little as 50 dollars, the hearing and advertisement is \$175. It makes no sense to me.

I wouldn't propose to take away the component of the application that they have to notify their abutters and submit something to us proving that they notified the abutters, and whether that's in the form of an affidavit or notice to abutters, green cards, or just basically a certification by them saying, yes, we did this, I think that should be enough.

With regard to the change of a CV hour, I would say unless it's before 8 a.m. or after 11 p.m., or a substantial one, so I think that one is a little tricker.

I think if you're going into a space that's already licensed as a CV or had been

licensed as a CV that had 8 to 10 and you are seeking 8 to 11, that one hour and like -- so, I don't know. It is, obviously, something that we all have to thing about, but I just don't see --I don't see the reason for the extra cost and burden on the licensee and also the delay because, since we do it through the Cambridge Chronological, and they have to receive the advertisement basically a week before they get advertised, so it ends up pushing back the hearing for a lot of these applicants a couple weeks.

Same with the vendor/peddlers, the antique, the secondhand goods. The used car dealer, did we confirm that there was no statutory on that one?

And then the farmer -- winery for farmer's markets, this is the one that we grant

through that our state law that is for agricultural events that they have to prove to the state that they are an agricultural -- that they qualify for it.

Again, especially with the short season on farmer's markets, I just think it is highly burdensome on the applicants.

FIRE CHIEF GERALD REARDON: So this is still advertised on the website, our website?

CHAIR NICOLE MURATI FERRER: Yes. So it would still go agenda that needs to be posted at least 48 business hours. So, for example, you know sometimes that could end up being four days because of the weekend.

So, yeah, it would still be notice pursuant to the open meeting law.

FIRE CHIEF GERALD REARDON: I'm fine as long as the abutters -- there's proof that the

abutters are getting notifications.

CHAIR NICOLE MURATI FERRER: So I'll work on a more detailed proposal then for us to take a look at. Do you have any comments?

POLICE COMMISSIONER CHRIS BURKE: I agree with you, the abutters it is important to get their input, any changes, and I don't think we need to -- the burden of advertising, I think that what we're trying do is satisfy that the folks in the neighborhood are aware of what's going on, so I think that would be satisfied by the notifications to the abutters.

CHAIR NICOLE MURATI FERRER: I'll work on something more detailed and then maybe we'll -- probably July 18, I'll have something written down we can all agree on.

FIRE CHIEF GERALD REARDON: Yes.
