CHAIR NICOLE MURATI FERRER: Second cal1.

We'11 cal1 you back. Thank you.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: Tria Cambridge Concessions, LLC,
doing business as Hotel Tria, holder of a common
victualler all alcohol 1 icense at 220 Alewife Brook Parkway.

Jennifer Marie Kavanaugh, manager, has
applied for a change of beneficial interest.

Change of $a d / b / a$ to Freeport Hotel and
alteration of premise description to four-story
building with a restaurant, lounge on first floor

1,272 square feet, breakfast lounge 839 square
feet, garden area 687 square feet, 121 guest
rooms located on the second, third and fourth
floors with one entrance and three exits, total
square footage of approximately 23,700.

ATTY ANDREW UPTON: Good afternoon.

CHAIR NICOLE MURATI FERRER: Good
afternoon.

Please state and spell your names for the
record.

ATTY ANDREW UPTON: Good afternoon, Madam

Chair and Chief. Andrew Upton, U-P-T-O-N, for the applicant. With me is Cathy O'Brien. Cathy is a "C"?

CATHY O'BRIEN: Yes.

ATTY ANDREW UPTON: Regional manager for the owner and Jennifer Kavanaugh, Kavanaugh with a "K," approved manager on the 1icense at the hote1.

CHAIR NICOLE MURATI FERRER: Mr. Upton --

Ms. Kavanaugh, you are remaining the manager of record?

JENNIFER MARIE KAVANAUGH: (Nodding.)

CHAIR NICOLE MURATI FERRER: I need to hear you.

JENNIFER MARIE KAVANAUGH: Correct.

CHAIR NICOLE MURATI FERRER: Thank you.

And then why don't you go ahead, Mr.

Upton.

If I can say one thing before we get
started, my name is Cathy O'Brien. I'm the vice
president of operations for this hospitality.

I wanted to apologize on the process that we followed through this. It was not certainly intentional. We were busy doing a renovation.

We put multimilition dollars into the new
property. We are very excited how it came out.

So I just want to formally apologize for how the architect withdrew in our corporate office. It wasn't intentional. And as soon as it came to our attention, we kind of came back and made sure that we were in 1 ine with you folks here, so $I$ just wanted to formally apologize.

CHAIR NICOLE MURATI FERRER: Thank you.

Go ahead, Mr. Upton.

ATTY ANDREW UPTON: We applied for three
things: One is the change of name. Formerly the

Hotel Tria. We would 1 ike to change it to the Hotel Freepoint or the Freepoint Hotel.

Because we have hired a well-known

Cambridge chef as consultant in the development
to perk up the restaurant and food service, his contract calls for a percentage of sales.

So after consultation with Attorney Lint
and the $A B C C$, we discovered that had to be disclosed as a beneficial interest. And so we
filed a CORI form and beneficial interest for him.

The other was a change of the floor plan because of the -- the lobby has been renovated.

The envelope of the building itself has not changed, but there have been substantial
furniture and cosmetic and some structural
alterations on the inside of the building.

CHAIR NICOLE MURATI FERRER: So

Mr. Gaudet is gonna have a percentage of the sales of everything?

ATTY ANDREW UPTON: Of food and beverage.

CHAIR NICOLE MURATI FERRER: Yep.

And the ownership is not changing, just
the d/b/a and we're keeping the innholder as a separate 1 icense, is that correct?

ATTY ANDREW UPTON: Yes.

Everything else, the manager, the
ownership, al1 the other beneficial interests in the upper tier, exactly the same.

CHAIR NICOLE MURATI FERRER: Okay.

And then the alcohol hours, are those remaining the same.

CATHY O'BRIEN: We have not changed those alcohol hours.

CHAIR NICOLE MURATI FERRER: Okay. Do you have any questions?

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: None.

CHAIR NICOLE MURATI FERRER: Anyone in
favor of this petition?
(No response)

MIRATEL GUERRIER: I'm here.

CHAIR NICOLE MURATI FERRER: Swear them

CHAIR NICOLE MURATI FERRER: Please sit
down.

Good afternoon. Please state and spel 1
your names for the record.

MIRATEL GUERRIER: Miratel M-I-R-A-T-E-L.

Last name Guerrier G-U-E-R-R-I-E-R.

CHAIR NICOLE MURATI FERRER: Thank you.

You may take a seat.

ATTY DENNIS BENZAN: Good afternoon,

Madam Chair.

Attorney Dennis Benzan on behalf of

Miratel Guerrier.

THE REPORTER: Counse1, please spe11 your name for the record, please.

ATTY DENNIS BENZAN: Yes. B-E-N-Z-A-N.

CHAIR NICOLE MURATI FERRER: Thank you.

OFFICER BENNY SZETO: Benny Szeto,

Cambridge PD. S-Z-E-T-O. B-E-N-N-Y.

CHAIR NICOLE MURATI FERRER: Thank you.

Go ahead, Officer.

OFFICER BENNY SZETO: Mr. Mirate1

Guerrier was denied renewal of his Hackney
license for having four moving violations in the last seven years.

CHAIR NICOLE MURATI FERRER: How did they break down?

OFFICER BENNY SZETO: One in 2011 for
speeding.

And also failure to stop.

CHAIR NICOLE MURATI FERRER: Also in
$2015 ?$

OFFICER BENNY SZETO: Yes, 2015. Excuse
me.

CHAIR NICOLE MURATI FERRER: Mr.

Guerrier, you didn't answer in your renewal application whether your Massachusetts 1 icense has ever been suspended or revoked.

Has it ever been suspended or revoked?

MIRATEL GUERRIER: No.

CHAIR NICOLE MURATI FERRER: And do you have a medical condition that prevents you from safely operating a motor vehicle?

MIRATEL GUERRIER: No.

CHAIR NICOLE MURATI FERRER: Counse1, if
you want to start.

ATTY DENNIS BENZAN: Thank you, Madam

Commissioner.

First, my understanding is that Miratel
had a moving violation that dates back to 2001
that's showing it has not been paid and it is my understanding that he has recently paid that, is that correct?

MIRATEL GUERRIER: Yes.

CHAIR NICOLE MURATI FERRER: Are you
referring -- that's what had his 1 icense in nonrenewal status when he applied, is that correct?

ATTY DENNIS BENZAN: Yes. His license is currently active. I wanted to give you a ittle quick ground regarding Mr. Miratel Guerrier.

Mr. Guerrier is a American citizen, has
been in the United States for over 30 years, has been a Hackney driver for 25 years.

He's been living in the United States for most of his life. He's an upstanding citizen with no criminal record.

He has a wife and four sons. Two in college. One graduated from Burlington High

School and headed to college and one son is nine years old.

He's a devoted family man, has raised his sons to be model citizens, none of whom has ever been involved in the criminal justice system.

He has managed to raise and support his
family driving his Hackney cab during the day and night. And as you know, these are increasingly difficult times for many cab drivers and he relies on his income to support his family.

And if he cannot continue to serve the

City of Cambridge and surrounding areas as a Hackney cab driver, he could lose his home.

So what we are asking is that he be
allowed to continue to drive but his license be renewed and that he be placed on a one-year probationary period.

CHAIR NICOLE MURATI FERRER: Thank you.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Officer Szeto, do you have a recommendation?

OFFICER BENNY SZETO: I agree with one year.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Okay.

CHAIR NICOLE MURATI FERRER: So I think based on the fact that it was -- the last time was in 2015, and the recommendations of Officer Szeto, and everything else, I vote to grant with one-year probation, also in line with how we voted in the past.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Uh-huh.
CHAIR NICOLE MURATI FERRER: Okay. So
renewal granted with one-year probation. So no moving violations for one year.

MIRATEL GUERRIER: Thank you.
CHAIR NICOLE MURATI FERRER: If you hold
on, we'll give this to you and you can go
upstairs and get your license.

## APPEAL: JEAN CICERON

EXECUTIVE DIRECTOR ELIZABETH LINT: Jean

Ciceron?

JEAN CICERON: Yes.

CHAIR NICOLE MURATI FERRER: Please stand
up, sir, and raise your right hand.
(Jean Ciceron, sworn)
CHAIR NICOLE MURATI FERRER: Thank you.

You may sit down.

Please state your name for the record and
spell it as well.

JEAN CICERON: Jean J-E-A-N. Martinesse

M-A-R-T-I-N-E-S-S-E. Ciceron C-I-C-E-R-O-N.

CHAIR NICOLE MURATI FERRER: Thank you.

You may sit down.

ATTY DENNIS BENZAN: Good afternoon.

Again Madam Chair, Attorney Dennis Benzan on behalf of Jean Ciceron:

CHAIR NICOLE MURATI FERRER: Thank you.

OFFICER BENNY SZETO: Benny Szeto, B-E-N-N-Y S-Z-E-T-O.

CHAIR NICOLE MURATI FERRER: Thank you.

Go ahead, Officer Szeto.

OFFICER BENNY SZETO: Mr. Jean Ciceron
was denied his renewal for having 8 moving
violations within the last seven years.

There was two in 2010. One for speeding.
And one for failure to stop.

And three in 2011. One for failure to
stop. And two for failure to yield to pedestrians.

One in 2012 for a lane violation.

And 2013 there were two. Failure to
stop. And lane violation.

ATTY DENNIS BENZAN: I have one question for the officer. The last is dated --

OFFICER BENNY SZETO: (Indicating.)

CHAIR NICOLE MURATI FERRER: Officer, you need to respond to the question verbally so we can hear.

OFFICER BENNY SZETO: 7-24-13. That was
failure to stop and lane violation.

CHAIR NICOLE MURATI FERRER: They were
the same day?

ATTY DENNIS BENZAN: Yes, according to my record here. And there had been no moving violations since that time?

OFFICER BENNY SZETO: Last one -- in between 2012, July 30.

CHAIR NICOLE MURATI FERRER: Officer

Szeto, when you reviewed Mr. Ciceron's file, did you discover anything else?

OFFICER BENNY SZETO: He was given a one-year probationary. He has not gotten any moving violations since he fulfilled his one-year probationary period.

CHAIR NICOLE MURATI FERRER: When was the one-year probation?

OFFICER BENNY SZETO: I don't have the exact dates. I think I might have -CHAIR NICOLE MURATI FERRER: If I tell you his one-year probationary was November 1,

2015, would that sound right?
OFFICER BENNY SZETO: Yes. Approximately
yes.
CHAIR NICOLE MURATI FERRER: There are no
moving violations since the July?
OFFICER BENNY SZETO: No.
CHAIR NICOLE MURATI FERRER: Thank you.

Go ahead.

ATTY DENNIS BENZAN: Thank you, Madam
Chair. I want to give you a little background about Mr. Ciceron.

Mr. Ciceron has been a longtime member of
the Cambridge community. He has been driving a cab since 2005. He's married with two children. He resides at Newtowne Court.

Again, he has been an upstanding citizen
struggling to pay his bills given how difficult
it has been for the taxicab industry.

He is asking that he be placed on a one-year probationary period, which we found to be reasonable given that he had no moving violations during the last probationary period.

I think he understands how important it is for this Commission that he drive safely and that he continue to serve the citizens of Cambridge with the best and highest quality of service.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Szeto, your recommendation?

OFFICER BENNY SZETO: One-year
probationary is fine.

CHAIR NICOLE MURATI FERRER: Based on
what we've heard and the way the board has voted,

I would grant it with a one-year probation.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Agree.

CHAIR NICOLE MURATI FERRER: No moving
violations for one year. If you hold on --

Counselor, do you have any other matters?
ATTY DENNIS BENZAN: I don't.

CHAIR NICOLE MURATI FERRER: If you walk both of your clients upstairs, they can be he1ped.

ATTY DENNIS BENZAN: Thank you.

Application: Lamplighter Brewing Company, LLC, doing business as Lamplighter Brewing Company holder of a Farmer Series Pouring permit and common victualler license at 284 Broadway has applied for a change of hours on Mondays from 7 a.m. to 2 p.m. to 7 a.m. to 3 p.m. and 3 p.m. to 12 a.m. for private events only.

Amendment to their entertainment 1 incense to include trivia on Tuesday evening and an alteration of premise to building at 284

Broadway.

Single story 10,032 square feet of brick and concrete structure situated on a

10,684-square foot plot of land with brewing, bottling room 5,339 square feet, tasting room with bar 1,060 square feet.

Additional tap room space with seats

1,000 square feet. Kitchen 177 square feet,
three bathrooms, break room, and storage in rear 1,300 square feet.

Building is a rough rectangle,
approximately 73 feet wide facing the street and
going back 152 feet with a cutout in the
back-right corner that is 13 feet wide by 39 feet
long.

CHAIR NICOLE MURATI FERRER: Okay, good morning.

Please state your -- good afternoon.

Please state your names for the record.

ATTY SEAN HOPE: Good afternoon, Madam

Chair and Mr. Commissioner.

For the record, Attorney Sean Hope, Hope

Legal Law Offices in Cambridge. I'm here this
afternoon on behalf of the petitioner Lamplighter Brewing Company, LLC.

We have the two owners. We have Mr.

Andrew Jones.

ANDREW JONES: J-O-N-E-S.

KAYLA MARVIL: Kayla Marvil K-A-Y-L-A

M-A-R-V-I-L.

CHAIR NICOLE MURATI FERRER: Okay.

Before you go on your spiel, only because I need clarity. Right now, your 1 iquor 1 icense allows
you to serve 1 iquor from 11 a.m. to midnight on

Mondays.

ANDREW JONES: We don't --

CHAIR NICOLE MURATI FERRER: Hold on.

Hold on.

But your common victualler allows you to serve food from 7 a.m. to 2 p.m.

ATTY SEAN HOPE: On Mondays.

CHAIR NICOLE MURATI FERRER: Okay. So am

I to understand that what we're doing is that we
are moving -- are we moving both hours, the

1iquor -- you can't serve 1 iquor at 7 a.m. on

Monday, but what are we doing with the hours.

ATTY SEAN HOPE: Yeah, I know. So for
the Monday hours we are extending from --
currently it is to 2 p.m., we are extending that
one hour to 3 p.m. on Mondays. No 1 iquor being
served at 3 p.m. That's the only change, is the
hour change. From 2 to 3 .

And then on Mondays from 3 to midnight,
we are looking to private events only able to
have our CV as well as serve alcohol from 3 p.m.
to midnight.

CHAIR NICOLE MURATI FERRER: So what you
are telling me is, that on Mondays, right now,
and going forward as well, you have no intention
of serving any alcohol before 3 p.m.?

ATTY SEAN HOPE: That's correct.

CHAIR NICOLE MURATI FERRER: So the hour
that is on your current - currently on your

1iquor 1 icense is basically wrong.

ATTY SEAN HOPE: What?

CHAIR NICOLE MURATI FERRER: So the
alcohol right now -- and again, this could very
wel1 be because of our electronic system clumps
together certain days of the week. But it has
you on Monday opened at 11 a.m.

KAYLA MARVIL: That's not right.
CHAIR NICOLE MURATI FERRER: But, no, you
have the 7 a.m. because we went with the CV hours.

KAYLA MARVIL: That's correct.
CHAIR NICOLE MURATI FERRER: Okay. So
you want to extend your CV one hour, so from 7 a.m. to 3 p.m., and then 3 p.m. to midnight.

Wouldn't that be just 7 a.m. to midnight?
ATTY SEAN HOPE: Yeah.

KAYLA MARVIL: We won't be open to the public from 3 p.m. to midnight. It would be just private functions. So we weren't exactly sure how to apply for that.

CHAIR NICOLE MURATI FERRER: I think it
doesn't matter. I think it is 7 a.m. to
midnight, right?

ATTY SEAN HOPE: I think they wanted to be mindful that we had hours they weren't open and someone came to say they were not open and then the Commission would say that you need to be open for the hours you have registered, so I think that was the distinction.

CHAIR NICOLE MURATI FERRER: I mean, we
can certainly put a condition saying that the 3
p.m. to midnight is for private functions only.

And I mean, as long as you are telling
the public and it is -- whether you post your
hours on your website or your door or your menus or all of the above, as long as it is very clear, then, you know, that's appropriate.

But what's inappropriate is to present to
the public that you are going to be open seven to midnight and then when someone comes up, basically tell them "no," so...

ATTY SEAN HOPE: Okay.
CHAIR NICOLE MURATI FERRER: That takes
care of my question on that.

I'm sorry. Go ahead.
ATTY SEAN HOPE: In addition to the hours on Mondays and the private events on Mondays, we are also seeking to alter our entertainment license to add trivia one day a week.

Presently that day is Tuesday, but we
would like the flexibility, if they chose to only hold it one out of the seven days a week. As
well as there's an alteration of premises. As
the Chair said, this is a licensed premises.

They have a Farmer's Brewer license as well as the ability to serve alcohol, and the petition is to add an additional storage space.

And the additional space that is currently storage they would now like to use for
-- as well the CV as well to serve alcohol.

The approximate size of that interior
space is relatively the same size as their
existing space that's facing the street.

Part of the rationale for that is that
due to the success of the business, they have

1ines of queuing and people are having a
difficult time finding seats. There are only 35
seats in the current tap room, so the petition
would be to extend the tap room into the interior
space to accommodate the additional demand.

CHAIR NICOLE MURATI FERRER: When I look
at your premises in the front, this is on the
left side, right, to the cafe?

KAYLA MARVIL: No. It is actually back
further. If you walk down the hallway past the bathrooms, there's another space. It is completely interior.

CHAIR NICOLE MURATI FERRER: Okay. Which day are you doing trivia?

KAYLA MARVIL: Tuesday and we are fine
keeping it on Tuesday.

CHAIR NICOLE MURATI FERRER: So Tuesday
is the day that you have been having it and
that's the day you intend to continue having it?

KAYLA MARVIL: Yes.

ATTY SEAN HOPE: The question is that
they -- if the market for us has changed it from a Tuesday or a Wednesday, what would be that process?

CHAIR NICOLE MURATI FERRER: So I can't
recall our last hearing and when's the day people were having a real problem with you guys having the trivia. Was it Sunday?

KAYLA MARVIL: Yeah, it was Sunday. We
won't do that.
CHAIR NICOLE MURATI FERRER: I know you
don't specify it on your application. I was just
wondering if that's -- I was wondering the
rationale behind it and what's happening.

Then the seating added, you had to go
through the BZA process. Has that been
completed?
ATTY SEAN HOPE: That's right.

We were granted our special permit on
March 20. The processing time for the Legal
Department and the City Clerk, we have not
started our appeal period yet, so we were
approved but the appeal period hasn't run.
I think if we were approved, the zoning
only controls seats, not use. So we would be
allowed to use the space with no seats,
hypothetically, so that if the Commission sought
to approve us today and we were appealed, it wouldn't change our ability to use that space.

It would only change people's ability to sit in that space.

I would also like to add, we failed to apply to amend our CV to include this additional space. Also, we failed to timely include the entertainment license, which would be the very
same as the front space, but it would be
identical to what we have in the existing tap room, that CV and that entertainment license. If
it pleases the Commission, we could come here, go ahead and apply and come back before --

CHAIR NICOLE MURATI FERRER: No. I mean,

I think we can administratively say that, you
know, if you are applying for the change of
premises throughout your three licenses that we can do that here. I see no issue with that.

Any questions?

want to sit down with flow charts before I vote on this. I don't see a particular reason why. I have been in the community for close to four years now. I'm really excited to have this brewery in the facility that's been there.

It builds a great vibe in the community and I'm excited to see them be able to service the community with more events and more space in the near future.

It has been incredible just the change in personality on that street as well it being a point to draw in a lot of the local folks and have a place for reading, eating and drinking and just getting to know some of our local neighbors more.

So I'm excited to see them be able to
service that community in an even larger fashion.

CHAIR NICOLE MURATI FERRER: Thank you.

DAVID PINKUS: My name is David Pinkus, P-I-N-K-U-S.

I would 1 ike to thank you, by the way,
for your service in the City of Cambridge. I'm a direct abutter. I'm the single-most impacted person by their request because their current and their proposed windows for their tap rooms are directly opening into my backyard and I'm in complete support of these guys.

The change in the neighborhood has been
phenomenal. We used to be a little strip of auto body shops.

And now there are families with strollers and people coming in and out and the place is
lively. It is fantastic.

CHAIR NICOLE MURATI FERRER: Are you
ready to vote on these?

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: Yes.
CHAIR NICOLE MURATI FERRER: So looking
back on this and the evidence presented and the way the statute and the case law is, I don't know that there's -- there's substantial evidence to find that they served these particular people. Or, that they knew at the time of service that they were intoxicated to the point that they didn't need to serve them anymore. I am concerned that this appears to be a pattern. I am concerned that there were four individuals, three of which were taken by ambulance. I am a little disappointed in the licensee's kind of, I don't have, iffy-affy attitude during the hearing about the situation, but with that said, I think there's no -- I don't know that we can vote but -- in terms of a
violation, so if there's no violation, however, I
would like to see the licensee provide us with current, and if not, to send his employees for recertification of TIPS or 21 Proof or something 1ike that. By "employees" I mean everyone that serves the alcohol and also his door staff.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I agree.

I did go back and speak to the sergeant
in charge and we talked about the situation and he felt that, you know, although you can't put any direct evidence that they came out through the door but certainly there would be strong circumstantial evidence that they probably were, at least two of the three inside, and I go with what Mr. Rafferty's told me last time, that they've had no disciplinary actions at that site, and the sergeant in charge said they have very
few calls there.

However, I'm 1ike you, I am concerned.

It is just -- it is just, a reasonable prudent
man, three people drop down in front of an
alcohol establishment at closing, I think we have to do something about it. And you have to do it on your end, I think. It doesn't need to be imposed by us.

The Chair made a good point, the TIPS training, maybe a little more supervision.

I think it has to come out of your
establishment.

Again, I think a reasonable prudent
person is gonna say it is highly unlikely three people are going to drop in front of your -- all at the same time or in the same time frame.

CHAIR NICOLE MURATI FERRER: Okay. No violation.

Would you be okay with having them,
within 45 days, give us their proof of TIPS and

21 Proof certification or enrollment in either of those.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I would concur.

LARRABEE: That's impossible.

I did find a violation and $I$ was going to suggest a warning, based on the lack of disciplinary record, for this particular licensee, for similar type of situations.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I'm sympathetic to this one.

I think you made the point, it was cold,
people were waiting for Uber, taxis and whatever.

However, you are creating it because you are pushing them out. You said you 1 ike to get them out before ten minutes on the hour. Isn't that what you testified to?

MR. MCCARTHY: Yes.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: So they are all going out at the same time?

MR. MCCARTHY: Everyone, yeah.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: So in some form or fashion, again because we can't police it every moment of the time, you have to have someone to at least keep them off the street.

MR. MCCARTHY: Yes.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I'm not a lawyer, but I think you
probably have some 1 liability. You shove them out the door and they get hit by a car, maybe you have some liability. So $I$ think, again, it is on you, I concur. You have no previous disciplinary.

I also understood when you look at the
picture, it was very hard to tell who were employees and who were patrons. There's no distinguishing uniform. Maybe that should be something you should think about.

I definitely think this was on you.

You've got to keep -- you got to get them out,
but you have to keep them out of the street
somehow, and $I$ don't want to create business for us, but if they are spilling out in the street, I
think it is -- you may want to call the police
and say "I got a crowd out on the street."

Because we don't want anybody getting hit by a
car or a truck or anything else or a bicycle or that kind of thing. I would concur that a strong warning and hopefully we won't see you again.

LARRABEE: And $I$ have spoken to the investigating officer -- or actually I spoke to his supervisor who spoke to the investigating officer that is Christopher Sullivan. I did take into account, you said maybe you did not know you struck the vehicle, $I$ did take into account that Officer Sullivan said, for some reason, there was not a forthcoming on behalf of your client. I don't know if that's language maybe. Whatever.

So I did look up the case. The case is an open case until July 15.

I think it is only fair that once that
case is resolved that we come back and revisit this.

It is an open case, and it does have to
do with his driving of a Hackney vehicle.

It does have striking, in this case, striking of bicyclist.

ATTY HARRY SHUMAN: If I may.

CHAIR NICOLE MURATI FERRER: Okay, then
let's take your name.

ATTY HARRY SHUMAN: Harry Shuman, I'm an
attorney and $I$ 'm representing the petitioner

Archange Toussaint, T-O-U-S-S-A-I-N-T.

THE REPORTER: Just spel 1 your last name.

ATTY HARRY SHUMAN: S-H-U-M-A-N.

The matter came on for trial in November
of 2016.

At that time, $I$ suggested to my client
one of his options was to continue without a
finding.

Had I considered the possibility he would
lose his livelihood, I probably would not have
taken that course of action and would 'vet tried the case.

He had no record. He had been driving a
taxicab since 1988. He owns his own cab. He
owns his own home. He's a family man. He never
had any record of any violation. He has a spotless record.

This incident took place and he was apparently, at least he alleges to me, and I believe him, that he was unaware of what happened. There were no scratches to his vehicle. There were no marks. The other person,
if you look at the police report, it indicated
that at the scene of the accident the police officer said he wasn't injured.

The financial considerations were taken
care of by his auto insurance company.

Right now this man has not worked for
months and he's got his 1 ivelihood at stake and his taxicab business and his ability to support his wife and family is in jeopardy.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: The board is sympathetic to the plight of cab drivers. We understand that.

Unfortunately, for the client, this is a
fairly serious charge, and the case is still
open.

He took a continued without a finding for a period of time, which if he doesn't get into anymore trouble or have any -- and I think that's only fair for us to adopt that as a standard since the case is still open.

If we, on behalf the community say, sure
go ahead and give you your 1 incense and somehow he gets involved in something as soon as we do that,

I mean, I think that our -- we would not look
like we were doing our due diligence.

I believe -- I don't want him to lose his
house. I want him to work. I think I personally
think we have to wait until the case is resolved and continued without a finding has gone away and we can certainly -- I believe you.

There's a long record. It is very hard for -- a long unblemished record. It is very hard for a taxicab driver not to have tickets and accidents. It is very hard. It is remarkable that he hasn't.

But I have to say, I go with the court's holding on this, and unfortunately, I personally think we have to wait until July 15 until it is resolved.

ATTY HARRY SHUMAN: I think it is not July.

CHAIR NICOLE MURATI FERRER: It is

November.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: November?

ATTY HARRY SHUMAN: I think Officer

Sullivan inadvertently used July in his response and corrected himself in a subsequent email. But it is November 15 of this year.

## INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I thought it was July. I'm sorry.

ATTY HARRY SHUMAN: That's okay. It was inadvertence on his part.

If you want a copy of his letter I have
it.

CHAIR NICOLE MURATI FERRER: I have the

1etter. I was trying to look for the court information.

I'm with Commissioner Larrabee on this.

I mean, I'm not unsympathetic but I think
this is an open case with a serious moving violation, which is sort of the crux of his job type of thing.

And I understand that he may not have any
other type of criminal record. He does have other moving violations, which don't come into play because they are out of the time period that we look at.

But this is a community where we have
bikers all the time, and part of our job in
handing out these licenses is public safety.

And I think when this case is over,
officially over, provided there are no further
issues, $I$ think Mr. Toussaint should come back to
this Commission and we would revisit his renewal app1ication.

But that would be my vote at this time.

INTERIM POLICE COMMISSIONER BRENT

LARRABEE: I think we have taken that stance in other cases and $I$ think that's a reasonable instance.

I'm really terribly sorry it is November.

I'm - I can't handle that. I would have to
leave it the way it is. I'm sorry. So I concur.

CHAIR NICOLE MURATI FERRER: The appeal
is denied. And the Commission may revisit when the case is over upon application by Mr .

Toussaint.
