And then the old feed will feed the new buildings, which it's in place to the property, but we won't have to do anything in the public way.

the buildings that are coming down you're going
to use the existing conduit over there to refeed.

ANTHONY VATALARO: To feed them when the
new buildings are up, yeah, which is closer to Clifton Street, that feed.

approximately 80 feet westerly on a private property belonging to 201 Broadway into the building at 201 Broadway.

Does that run on private property -- it
looks like it's on the other property from this?

HERB BERTONI: That runs down the
property line and has been eliminated. We're coming in on the corner of the building on the property.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

On the private side?

HERB BERTONI: On the customer side, so we won't be encroaching on the 161 property.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That's definitely the Verizon manhole you need to get into, huh?

HERB BERTONI: Yes, yes. I looked at
this in the field trying to get out there with

Paul. And we have a coil in that manhole. It's
just -- we need to break out to go down the
street. Part of Portland Street has already --
it's fairly new, no patches. I don't know when
it was paved. But right past the catch basin
there's a seam there where the old and new, so
we're looking to come down right around the catch
basin and jump in the sidewalk, and we will put a
brand-new sidewalk, and that way we won't be on
the roadway.

So when I talked to Paul about that, he
said, "Go there and talk a look and see what you
can do." And we'll meet with him once it's
approved and go over the all the specific
details, but it will be pretty straightforward and clean.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: How
is that building fed now?

HERB BERTONI: From very -- we don't
really know. We found conduits inside the
building. We don't know where they go or how
they get in there. There's a false facade when
that building was renovated and the conduits just

```
pop up inside --
```

CITY ELECTRICIAN STEPHEN LENKAUSKAS: But
they do have service, they have Verizon service in this building currently?

HERB BERTONI: Yeah. So what we're going to do is find one of the conduits on the private property that runs down here in the front of the building and tap into one of them, and pull it right into the private property. That's the goal on this one, so everything will be done in the sidewalk.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This conduit runs -- this conduit is going to be moved onto the sidewalk that shows in the gutter line there?

HERB BERTONI: That's after we reviewed
it in the field.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It
has since been relocated to the sidewalk?

HERB BERTONI: Right. So it will be a brand-new sidewalk and we won't be giving up any of the streets.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

The trucks are trying to stay on the Hampshire side with their petition. You said you have a letter from Verizon?

SHAWN ALLES: Yeah. We explored Verizon using their existing conduit, and they came back with negative results for us.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No
results at all, not even negative?

SHAWN ALLES: That we can't use their
conduit.

HERB BERTONI: There's nothing available
and $I$ did verify in the field that they have
three conduits coming in, each one has cable in
it, so they $\operatorname{can}^{\prime} t$--

CITY ELECTRICIAN STEPHEN LENKAUSKAS: IS

```
one of them red?
```

HERB BERTONI: No, I did look at that.

But one does have a Comcast in it, and once you get on the private property, it becomes the property owner's conduit. So that's what we're going to do is get on the property and accept that conduit and jump into it and pull it into the building.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

What is your deadline for this one?

HERB BERTONI: First week of May. And
we've got two customers in there we need to hook up.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: SO

Verizon said that their conduits are full?

HERB BERTONI: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: But
they can't tell you where they go?

HERB BERTONI: No.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No
notice, taking parking out, arriving on street cleaning day so they were unable to clean the street. There were a number of issues and the complaint came forward.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

There was a disturbance, too. They lingered
after the job and they were making an awful lot
of noise disturbing the neighborhood.

JOE LUCCHESE: With trucks?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Not
with trucks. Hanging around. The conversations were not too pleasant from what I understand. It doesn't help things along. Move them in and move them out. Notify them as in most of the areas you're going to be working in, it goes a long way.

CHAIR ANDREA JACKSON: Is there a motion
made on this one?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Move to approve.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Approve typical conditions.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Typical conditions.

CHAIR ANDREA JACKSON: And notice
provided to residents.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Correct.

CHAIR ANDREA JACKSON: Motion's been made and seconded.

All those in favor signify by saying aye. CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

CHAIR ANDREA JACKSON: So we start this next section we probably should note we have received two letters of opposition, and I believe it goes to at least one -- we can wait until we get to that specific one. I didn't want it to fall in between. One was an email sent in from a resident of Market Street in opposition asking why it can't be underground. They wanted to know if it can be underground. This pertains to Area 4. "The damage these wires cause to Cambridge trees is severe and this would aggravate it. We
urge the Commission not to allow installation of additional equipment over streets and residential neighborhoods like ours that are already burdened by ugly utility poles and area cables.

Second, we have double poles at the
northeast corner of Market and Columbia that are unsightly and appear dangerous. It is our
understanding that these orphaned poles are to be replaced. Please let us know if this is
incorrect."

Another letter that was received again
from someone from Area 4 concerned about the prospect of adding to the already unsightly area of cables in their neighborhood. They attached a photograph showing a view outside of their window. This is someone who lives on Columbia Street. And I agree this is rather unsightly. And, again, the question of whether or not the cables can be put underground.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That wasn't sent to us via email, was it?

EXECUTIVE DIRECTOR ELIZABETH LINT: That
came in the mail.

CHAIR ANDREA JACKSON: This one came in
the mail.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Is it possible to have Dana scan it and send it and forward it to us?

CHAIR ANDREA JACKSON: Absolutely.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I
believe these would be reviewed and continued for
licensing from the original petitions? Do we
take one at a time? Are they all new petitions?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

They're all new petitions.

CHAIR ANDREA JACKSON: Same end result, though.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

They will be.

## SUPERINTENDENT OF STREETS WILLIAM DWYER:

Didn't we do this a few months ago and we
continued it?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yep, for review and for licensing.

CHAIR ANDREA JACKSON: You can do it as a
blanket petition instead of listing each and every single one out.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Are we best off to continue these and meet with

Crown Castle?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Two pages left or one?

## CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This is just the one. There's six petitions.

Six different areas. First time around the first
petition $I$ believe it's for approval to approach
